## **Summary of main issues**

- 1. The Transformation of Health and Social Care Services was identified in the previous Scrutiny Board's Terms of Reference for 2011/12 and was included within its work schedule for that year. Throughout the year, the Scrutiny Board considered a number of matters associated with this aspect of work, including update reports on the work of the Transformation Board and a range of reports about the integration of health and social care services.
- 2. The work undertaken in 2011/12 was collated and presented as a draft report to a meeting of the previous Scrutiny Board held on 16 May 2012. This detailed the Board's findings and recommendations resulting from the evidence gathered during 2011/12.
- 3. However, Scrutiny Board Procedure Rule 13.2 states that "where a Scrutiny Board is considering making specific recommendations it shall invite advice from the appropriate Director(s) prior to finalising its recommendations. The Director shall consult with the appropriate Executive Member before providing any such advice. The detail of that advice shall be reported to the Scrutiny Board and considered before the report is finalised". Due to the timing of drafting the report, it was not possible to observe with this aspect of the Scrutiny Board Procedure Rules. As such, the Scrutiny Board resolved:
  - (i) That, subject to the minor amendments highlighted at the meeting, the report presented be approved as the final draft inquiry report to form the basis for consultation with the appropriate Directors for their comments.

- (ii) That the final draft report, and associated comments from Directors, be submitted to the first meeting of the Scrutiny Board in the new municipal year for formal approval.
- 4. The revised draft report is attached as Appendix 1 for consideration by the Scrutiny Board. Any advice received from appropriate the Director(s) will be reported at the meeting for consideration, before the Scrutiny Board finalises its report.
- 5. Once the Board publishes its final report, the appropriate Director(s) and/or NHS bodies will be asked to formally respond to the Scrutiny Board's recommendations within three months.

## Recommendations

6. Members are asked to consider and agree the Board's report and associated recommendations on the Transformation of Health and Social Care Services in Leeds.
