In September 2011 the DfE invited Children's Services to make a revised application based upon a smaller provision which would align with the revised bed requirements projected by the YJB as part of its review of all its nationwide contracts. The current capacity of the existing Secure Home is 36, however, a revised scheme based on a 24 Bed provision with a total estimated cost of £14.8 million was submitted for approval. However, following this meeting Leeds DfE awarded a reduced amount of £12.55 million to rebuild East Moor Secure Children's Home
