

Electrical installations will comply with current requirements.
d) The prevention of public nuisance
The operators will take steps to prevent noise nuisance being caused to the occupiers of nearby properties through the appropriate control of music levels.
e) The protection of children from harm
Anyone who appears to be under the age of 21 and who is attempting to buy alcohol must be required to produce "proof of age" before such sale is made in accordance with the Check 21 Proof of Age scheme and related guidance issued by West Yorkshire Police.
