#### 2. Please provide a brief description of what you are screening

The Local Account takes the form of a statement regarding the Adult Social Care in Leeds and outlines the services that are available to all citizens of Leeds. The account also informs the citizens of Leeds regarding what Adult Social Care has done and achieved in the previous 12 months and what priorities have been identified for the next 12 months. Adult Social Cares aim is to ensure the maximisation of positive outcomes of these priorities for citizens of Leeds as that are aspirations that are applicable to all citizens across all groups.

The document in itself will have no direct impact upon the equality strands, it will be made accessible under the standards accessibility protocols, however the priorities outlined are likely to impact differentially upon individuals through out Leeds. Rather than undertake a broad brush equality impact assessment and then have to

undertake more specific assessments. Adult social Care is to rely upon those specific impact assessment which are being undertaken on the individual actions that will contribute to achieving the priorities

### 3. Relevance to equality, diversity, cohesion and integration

All the council's strategies/policies, services/functions affect service users, employees or the wider community – city wide or more local. These will also have a greater/lesser relevance to equality, diversity, cohesion and integration.

Adult Social Care treats all individuals as individuals irrespective of culture, ethnicity, disability assessing their holistic needs, considering no other criteria. The issue of equality is monitored to ensure that we are in fact reaching out to all and that all communities are aware of and are able to access the services available and that no barriers are being put in place. This is supported by developments in our electronic recording systems and equality impact assessment process. In addition quality assurance work includes examining equality issues taking every opportunity to identify and highlight potential barriers,.

This however must be tempered with some caution and the need for a great deal of research in a time of constrained resources. Out of those over 65 receiving ASC 11766 people, 478 are non white individuals with an open case with Adult Social Care these break down into 216 other 213 Black 45 Asian and 4 mixed. Whilst this indicates an under representation this is across all services home care residential etc across the range of issue for all the groups that make up these groups. The impact assessment process ensures that we are aware of these issues top provide information on which to base decisions regarding how we provide or commission services. The use of equality Impact process of assessments and screening tools allow us to identify specific barriers and remove or mitigate as far as possible.

In addition Adult Social Care does fund some universal services to which individuals can self refer without an assessment. Given the present financial climate these services are being very carefully looked at in terms of prevention and reducing the need for assessed services. Often such services provide very specific services for specific groups and as such any changes in these will impact disproportionately on individuals some of whom will also have Facs eligible needs.
