2. Please provide a brief description of what you are screening

The Homes and Communities Agency has proposed the transfer of four listed buildings in Holbeck to the Council. The buildings are currently a liability to the HCA and in particular cause the HCA's surrounding development site to be unattractive to developers as the listed buildings are considered to be too great a liability for a commercial developer to take on.

Transfer of the buildings will be accompanied by a dowry from the HCA to fund the costs of maintaining the buildings, and refurbishing the Engine House some time in the future when the HCA's site is redeveloped and the Engine House can compliment such a development. The HCA and Council will agree the dowry sum before the buildings are transferred, but there is still a risk there will be insufficient money available in the dowry to maintain the buildings.

In accepting a transfer of the buildings the Council is supporting the redevelopment of Holbeck Urban Village as the HCA site will be more attractive to developers and can act as a catalyst to stimulate other development in the Village.
