Good morning Councillor,

The scheme focuses solely on the existing TRO's in operation in Otley and bringing them all into one order. It does examine whether or not these restrictions are still required, as it is anticipated that the Otley parking strategy will do that.

As you may be aware, Leeds City Council took on powers of Decriminalised Parking Enforcement (giving it the Authority to enforce waiting and parking restrictions) in March of 2005. Chapter 15 of the Department for Transport Operation Guidance to Local Authorities: Parking Policy and Enforcement requires all Local Authorities wishing to take on Civil Parking Enforcement to review, update and consolidate all their TRO's, thus ensuring that they are legal and correct.

In addition, the Chief Parking Adjudicator for England and Wales has recently been critical of many Local Authorities and has stated to Parliament:

"While Circular 1/95 made it completely clear that before taking on DPE councils should update and consolidate their Traffic Regulation Orders, not all councils fully go through the exercise. Adjudicators observe that the format and variety of approaches to drafting Traffic Regulation Orders know no bounds. While some councils have meticulously consolidated their old orders into a single neatly word processed and concise new order, others soldier on with literally hundreds of old TRO's, which have, over the years been amended, varied or modified." And "The style of drafting can be obscure and opaquely complex"

Leeds City Council did not review and consolidate their TRO's before they took on powers of decriminalized parking in March of 2005 and currently has over 3000 TRO's in operation within the City. Many of these orders are over 40 years old and are written in a style that can be deemed difficult to understand. A large number of the older orders are covered in hand written notes from when they have been amended. These hand written notes can make them even more difficult to understand and it is not uncommon for a Parking Adjudicator to refuse to read them and as a consequence for the Authority to lose the case. A good example of the problems facing Leeds City Council is Great George Street in the City Centre, which has 18 separate TRO's along its length.

As a consequence of the above, I have been assigned to consolidate these orders as a matter of urgency.

I hope this brings some clarity to the matter.

Gary's work on the TRO system is city-wide and is to update the whole process so that it becomes fit for purpose in the 21st century, both in terms of day-to-day management, information retrieval and being robust enough for modern enforcement. Work to consolidate the many orders in the city centre is nearing completion and other areas are now being tackled. In essence (and not wanting to diminish the complexity of the task that Gary and his team are carrying out!) this is an administrative task which combines the various existing Orders into a single one for the area. There is no scope in this particular process to change anything on the ground as that would require public consultation which, as you are aware, can become protracted and difficult.

Once this process has been carried out for a given area, any future changes can be done as amendments to the consolidated Order. Most of these older orders are often covered in hand written notes, as and when they parts that have been amended/revoked. This can make them even more difficult to understand and it is not uncommon for a Parking Adjudicator to refuse to read them and as a consequence for the Authority to lose the case.

Due to the complexity of the existing TRO records along with their numerous revocations and amendments, it would simplify matters considerably if all of these diverse Orders were consolidated into one Order. This would make the administration of the Authorities TRO records much easier to maintain and would ensure that we no longer lose Parking Adjudication cases as a consequence of having poorly presented TRO's. Gary's work on the TRO system is city-wide and is to update the whole process so that it becomes fit for purpose in the 21st century, both in terms of day-to-day management, information retrieval and being robust enough for modern enforcement. Work to consolidate the many orders in the city centre is nearing completion and other areas are now being tackled. In essence (and not wanting to diminish the complexity of the task that Gary and his team are carrying out!) this is an administrative task which combines the various existing Orders into a single one for the area. There is no scope in this particular process to change anything on the ground as that would require public consultation which, as you are aware, can become protracted and difficult.

Once this process has been carried out for a given area, any future changes can be done as amendments to the consolidated Order. Whilst this does not change the legal process, it is much better administratively and allows the whole process to be managed digitally, rather than the cumbersome paper process that currently exists.

Please find attached a plan showing LCC land ownership in pink. The viewing area is not included and is, therefore, in private ownership.

The road was stopped up in 1980 as part of the work to re-align roads for the runway extension. The parking restrictions on the roads around the airport were introduced in 1982 as part of the same development.

The TRO specifically refers to 'Yeadon Cemetery access road (formerly part of Cemetery Road)' and it should have the no waiting/loading lines and signs on it. In their absence, the restriction cannot be enforced on this section of road. As and when the restrictions around the airport are reviewed in the future, the status of this area needs to be considered so that its use is reflected in the restrictions upon it.

Dear Councillors

The airport viewing area is not adopted highway. I'll see if our colleagues in Land Registry can advise if it is under Council ownership. If it is, they will be able to advise which Department it is vested in.

There is a TRO on the area, the same as Cemetery Road and other roads around the airport. It is No waiting, Loading or Unloading at any time. The markings associated with the Order are missing or very badly worn on the 'viewing area' and only some of the signs are still in place so the Order is not enforceable. From a Traffic perspective, replacing the lines and signs is possible, but we are concerned that we would deny a long-enjoyed facility and create an unrealistic enforcement issue. A side issue is that the requirement on this type of order for double yellow lines and double kerb checks. There are no kerbs to this area and, therefore, the requirement is for kerb checks marked on the ground adjacent to the verge with double yellow lines spaced from them. In such a small area, such a marking would appear ludicrous.

I am aware of some anti-social behaviour issues associated with the cemetery in the past, but not of any concerns with the general use of this area.
