#### Annex 1 – Mandatory Conditions

- Only individuals licensed by the Security Industry Authority may be used at the premises to guard against:-
  - unauthorised access or occupation (e.g. through door supervision), or
  - outbreaks of disorder, or
  - c. damage
- No supply of alcohol may be made under this licence
  - At a time when there is no designated premises supervisor in respect of the premises licence, or
  - At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children -

- games or activities which require or encourage, or are designed to require or encourage, individuals to -
  - drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
  - drink as much alcohol as possible (whether within a time limit or otherwise);
- provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);
- provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;
- provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on
  - i. the outcome of a race, competition or other event or process, or
  - the likelihood of anything occurring or not occurring;
- selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.

- The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.
- The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

- The responsible person shall ensure that
  - a. where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures:
    - beer or cider. 1/2 pint;
    - gin, rum, vodka or whisky: 25 ml or 35 ml; and
    - iii. still wine in a glass:125 ml; and
  - customers are made aware of the availability of these measures

#### **Embedded Restrictions**

- Alcohol shall not be sold or supplied except during the hours stated on this licence and:
  - a. On Christmas Day, 12 noon to 3 p.m. and 7 p.m. to 10.30 p.m.
  - On New Year's Eve from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day (or, if there are no permitted hours on the following day, midnight on 31st December).
- The above restrictions do not prohibit:
  - the taking of the alcohol from the premises, (unless the alcohol is supplied or taken in an open vessel,) during the first thirty minutes after above hours;
  - the consumption of the alcohol on the premises by persons taking meals there during the first thirty minutes after the above hours, if the alcohol was supplied for consumption ancillary to those meals.
  - consumption of the alcohol on the premises by, or, the taking, sale or supply of alcohol
    to any person residing in the licensed premises;
  - the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of alcohol so ordered;
  - e. the sale of alcohol to a trader or club for the purposes of the trade or club;
  - the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale
    or supply of alcohol is carried out under the authority of the Secretary of State or an
    authorised mess of members of Her Majesty's Naval, Military or Air Forces;
  - g. the taking of alcohol from the premises by a person residing there; or

- the supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied;
- i. the supply of alcohol for consumption on the premises to persons employed there for the purposes of the business carried on by the holder of the licence, or the consumption of liquor so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the premises.
- Suitable non-alcoholic beverage, including drinking water, shall equally be available for consumption with or otherwise as an ancillary to meals served in the licensed premises.
- 12. The premises must be bona fide used for the purpose of habitually providing the customary main meal at midday or in the evening, or both for the accommodation of persons frequenting the premises.
- The premises must be bona fide used for the purpose of habitually providing for reward board and lodging including breakfast and at least one of the other customary main meals.
- 14. Where the number of children attending the entertainment exceeds 100 the licensee shall ensure that the provisions of Section 12 of the Children and Young Persons Act 1933 are complied with.

#### Conditions consistent with the operating schedule relating to the licensing objectives

#### The prevention of crime and disorder

- A suitable CCTV system will be maintained and be operational on the premises at all times when licensed activities are being carried out.
- The siting and standard of the CCTV system will be agreed with WYP prior to installation and will comply with that agreement at all times.
- Changes to the siting and standard of CCTV systems may only be made with the written consent of West Yorkshire Police.

- Security footage will be made secure and retained for a period of time to the satisfaction of WYP.
- A Supervisors Register will be maintained at the licensed premises, showing the name, addresses and up-to-date contact details for the DPS and all personal licence holders.
- 20. The Supervisors Register will state the name of the person who is in overall charge of the premises at each time that licensed activities are carried out, and this information will be retained for a period of twelve months and produced for inspection on request to an authorized officer.
- A policy for searching patrons at the entrance to premises will be adopted.
- The Licensee will inform West Yorkshire Police of any search resulting in a seizure of drugs or offensive weapons.
- A suitable receptacle for the safe retention of illegal substances will be provided and arrangements made for the safe disposal of its contents as agreed with West Yorkshire Police.
- Any police instructions or directions given via the link will be complied with whenever given.
- All incidents of crime or disorder will be reported via the link to an agreed police contact point.
- The licensee will adopt a proof of age scheme which is approved by WYP and West Yorkshire Trading Standards (WYTS).
- 27. The Licensee's staff will ask for proof of age from any person appearing to be under the age of 21 who attempts to purchase alcohol at the premises.
- 28. The Licensee's staff will ask for evidence from any person appearing to be under the age of 18 who attempts to purchase alcohol at the premises.
- 29. Drinks, open bottles and glasses will not be taken from the premises at any time. Empty bottles and glasses will be collected regularly and promptly. Glass and other sharp objects will be stored and disposed of safely using suitable receptacles. Receptacles will be secured and not accessible to the customers.
- The Licensee will prominently display notices which inform customers that open bottles or glasses may not be taken off the premises.
- Plastic or toughened glasses/bottles will be used in all outdoor areas.
- Plastic or toughened glasses or bottles will be used when requested by West Yorkshire Police (e.g. football match days).
- Notices indicating the existence and effect of an Alcohol Designated Public Places Order will be displayed at the exits to the premises.
- 34. At any time that the Premises Licence has effect, the sale of alcohol for consumption on the premises will be ancillary to the service of table meals.
- 35. At any time that the Premises Licence has effect a minimum of 60 covers shall be maintained at the premises

#### The prevention of public nuisance

- Ensure that no nuisance is caused by noise or vibration emanating from the premises.
- 37. Noise from the premises shall be inaudible at the nearest noise sensitive premises (i) after 23:00 hours and (ii) at any time when entertainment, as defined by paragraph 2 of schedule 1 of the Licensing Act 2003, takes place on more than 30 occasions per year.

- 38. Ensure that all licensable activities are conducted and operated so as to prevent the transmission of audible noise or perceptible vibration through the fabric of the building or structure to adjoining properties.
- No bottles shall be placed in the external receptacle after 23:00 hours to minimise noise disturbance to adjoining properties
- 40. Ensure that the rating level of noise from plant and machinery is no higher the 5dB below the lowest background level at the most affected noise sensitive premises during the operation of the plant. Plant and machinery shall be regularly serviced and maintained to continue to meet the rating level.
- Ensure that the premises are operated as to prevent the emission of odours which are a nuisance at nearby premises or to persons in the immediate area.
- 42. Ensure that business waste is stored inside closed containers awaiting collection; that litter arising from people using the premises is cleared away regularly that promotional materials such as flyers do not create litter; and that other street advertising is carried out lawfully.
