The screening focuses on the Executive Board report seeking approval for the submission of the Transport and Works Act Order (TWAO) application and associated Planning and Highway applications for the NGT.

Metro and Leeds City Council are working in partnership to develop a high quality rapid transit system for Leeds known as NGT. The scheme is seeking to provide a high quality transport system that will support the growth of Leeds' economy and improve the local environment by helping to address congestion.

The scheme comprises of two routes, the North Route which runs from Holt Park to the city centre and the South Route, serving Hunslet and Stourton. Major park and ride sites will be provided at Stourton and Bodington to the north of the city.
