#### **Environmental Action Officer's Report**

The main causes of the key issues identified by residents are bins left on streets and fly tipping. Officers have issued section 46 notices on domestic properties who have been leaving the bins out in the streets on non-collection days and fixed penalty notices will be issued to repeat offenders.

Over the next 6 months officers will be visiting the area weekly to identify property's that have already been issued legal notices and issued fines or prosecute.

All fly tipping incidents will be investigated and where ever possible evidence taken and offenders dealt with through tough legal action

Officers will also be look at why people are fly tipping in the area and ensuring local residents are fully aware of the councils free bulky collection service and opening times of the household waste sites.

The time line plan for the next resident survey trackers are early November 2013 and then early May 2014.
