The Executive Board report provides background information and sets out details of the strategy. The report sets out the raft of policy and practical interventions the Council has undertaken to promote and accelerate housing growth to meet the city's needs including proposals to support the development of social and affordable housing. As a landowner and service provider, it is proposed to identify ways in which these sites can make a more positive local regeneration contribution, assist efforts to reduce deprivation and assist in meeting local housing needs of all demographic groups. Overall in delivering a substantial increase in the stock of council housing, the programme will assist the Council in delivering its social housing service.

The delivery of housing through this programme could have positive implications for equality groups who are economically disadvantaged. The programme will enable a coordinated approach to stimulating investment incorporating an approach to disposing of brownfield sites some of which currently impact negatively on local communities. Development proposals will be subject to local consultation offering a catalyst for community engagement and capacity building, through locality working.
