2. Please provide a brief description of what you are screening

This assessment is screening the request to approve the model for continuing Leeds City Council's investment in to Neighbourhood Network services from 1st October 2018. The report proposes a grant approach to future investment funding, commencing 1st October 2018 to 30th September 2023 in the first instance.

Neighbourhood Network services consists of 37 geographical areas covered by voluntary organisations providing preventative services primarily for older people. These services are outcome-focused and aim to:

- Reduce social isolation;
- Increase involvement and engagement;
- Increase choice and control;
- Improve health and wellbeing.

The delivery of these outcomes is within the context of bringing the benefits of a

prosperous, vibrant and attractive city to all the people of Leeds. This includes working towards ensuring all communities are thriving and harmonious places where people are happy to live.

- The services are currently provided to adults aged 60 and over across the city of Leeds. They are delivered at a range of sites with support such as transport provided to help people access sites. People of any age can access the services to gain information and support for people over the age of 60. This is currently monitored on a quarterly basis, which would continue to be the case with any future investment.
- Neighbourhood Network services provide volunteering opportunities for all members of their respective local communities.
- A requirement of Neighbourhood Network services is that they be governed by local people representing the local community, either in the form of management committees or local advisory groups. Service development is expected to take place through consultation and feedback from service users. As part of the funding award process bidders will be required to evidence commitment to equality, diversity, cohesion and integration. This applies to all aspects of the service, including recruitment and working with individuals accessing the services.

• **Key findings**

- Neighbourhood Network Schemes primarily support adults aged 60 and over living within the Leeds Metropolitan District Area. However the services benefit a range of individuals, including service users, carers, partners, families and neighbours representing a range of ages. These benefits include employment and volunteering opportunities.
- Schemes provide the opportunity for strengthening community cohesion. This is achieved through the provision of local groups and activities shaped and developed by working closely with the local community.
- The Neighbourhood Network Schemes have shown themselves to be welcoming and accessible over the lifespan of the current contracts.

- requires the organisations that form the Neighbourhood Network to continue to evidence their commitment to equality practices as part of ongoing monitoring.
