2019/20 Admissions policy consultation



Briefing note

Each year the local authority is required to determine its admissions arrangements by 28th February for the coming year's intake. For admission in September 2019, the Leeds City Council Admission Policy must be determined by 28th February 2018. Where any changes are proposed, these must be consulted on for a period of 6 weeks.

Having reviewed the outcomes of the admission round for 2017, there is no intention to propose significant changes to the Leeds City Council Admissions policy for 2019/20, although there is a need for some minor amends to introduce greater clarity and accuracy.

Below is a summary of the changes intended for inclusion in the consultation:

Addresses – information added to outline that if it is found that a false address has been given with the aim of fraudulently securing a school place, that place may be withdrawn, even if the child has already started at the school. This information has always been included in our supporting information, but not in the policy.	√	√
