The Leeds Living Programme aspires to unlock and accelerate residential development in the city centre. The report demonstrates how this approach is in line with Council strategy/ policy such as the Inclusive Growth Strategy and South Bank Regeneration Framework, and supports the delivery of sites in the Leeds Core Strategy.

Equality, diversity, cohesion and integration is central to the proposals in ensuring that homes and infrastructure is accessible for all and the city connects and integrates with surrounding communities. This is highlighted below:

Housing considerations

The proposals contained in the report outline how the council proposals to assist the unlocking and acceleration of housing delivery in the city centre, which includes the provision of affordable housing to ensure that housing is accessible for all. The Leeds Living programme contains the aspiration to deliver 20% affordable housing in the city centre to meet the needs of a diverse community. The Council will work with developers, landowners, RPs and Homes England to meet these aspirations

Infrastructure considerations

At project level the infrastructure proposals will need to ensure that they are delivered in line with access and safety statutory requirements and the initial designs include these requirements which will be developed further following the business case stage. The infrastructure aims to promote sustainable travel, including walking and cycling, and ensure that infrastructure is accessible to all. Moreover, improvements aim to improve connectivity between the city centre and surrounding neighbourhoods. Consideration is also being given to the delivery phase, with the resilience programme being developed to mitigate any negative impact on the city centre through infrastructure delivery. Detailed consideration of EDCI will be included in the development of all infrastructure projects (subject to funding).

Key findings

As set out above, the infrastructure proposal included in the Leeds Living programme will be managed to ensure that EDCI is taken into account throughout all the design stages in line with statutory requirements for highways schemes and accessibility. This will be considered at programme and project level. Moreover, infrastructure aims to improve connectivity and integration between the city centre and surrounding neighbourhoods.

The Leeds Living programme also sets out the aspiration to deliver homes for all, which will give all equality groups the opportunity to access housing in the city centre.

It is therefore considered that the proposals in the Leeds Living business case for Housing Infrastructure Funding will have a neutral and/or beneficial impact on EDCI. As projects and proposals develop further (if the business case is successful) further EDCI impacts will be considered and reported as the detail evolves. This will be reported alongside a further update to Executive Board.

Actions

The Council has undertaken public consultation on key city centre policy and strategy in the city centre, including the South Bank Regeneration Framework and Our Spaces strategy The vast majority of infrastructure proposals included in the HIF business case are part of the proposals included in these documents. However, as details of the infrastructure are developed further consultation will take place through the highways and

planning processes. Moreover a communications and engagement process will be developed for the programme if the business case submission is successful and EDCI considerations will be factored into the consultation programme to ensure accessibility in choice and timing of venues and the format and content of publicity material.

If the Business case is successful positive messages will be promoted through the Leeds City Centre Vision website as well as other LCC media channels.
