This screening concerns the director of City Development authorising the Council, to enter a formal contract with DWP if we are successful in winning a funding bid for Enhanced Local Flexibilities for the Unemployed Programme and enter into a Service Level Agreement (SLA) with City of Bradford Metropolitan District Council and Blue Apple Training and BAT as programme Delivery Partners.

If successful the programme will incur expenditure of up to £5.56m by the Council, inclusive of £2.78m maximum match funding over the next three years and six months, 2019-2022;
