Summary of main issues

- 3. As set out within the Call In request form, only elements of the decision referenced within the Executive Board Minutes as resolution 10(a), 10(b), 10(c) and 10 (e) have been Called In. These are set out below:
 - 10(a) That the additional secondary places which are required in order to reduce the amount of children being allocated a school place out of area, be noted;
 - 10(b) That the necessary authority to spend be approved, together with approval also being given to incur expenditure of £6,835,000 from Capital Scheme number 33176/BGE/CBN to deliver the works associated with a 60 place 'bulge' at Cockburn Academy for September 2020;
 - 10(c) That the proposal for the freehold transfer of the land identified within the submitted report, which forms part of the former South Leeds Golf Course to

Cockburn Multi Academy Trust be approved, to allow the delivery of the sports field provision required as part of the proposals as detailed within paragraph 3.1.4 of the submitted report;

- 10(e) That the programme dates, as detailed in the submitted report, in relation to the implementation of these resolutions, which represent the critical path for project success and must be adhered to where possible, be noted.
- Subject to there being no further Call In request, the remaining elements of the decision outlined in Minute 10 of the Executive Board meeting on 24th June 2020 may be implemented once the Call In period has lapsed.
- 5. Appropriate Members and officers have been invited to attend the meeting in order to explain the decision and respond to questions.
