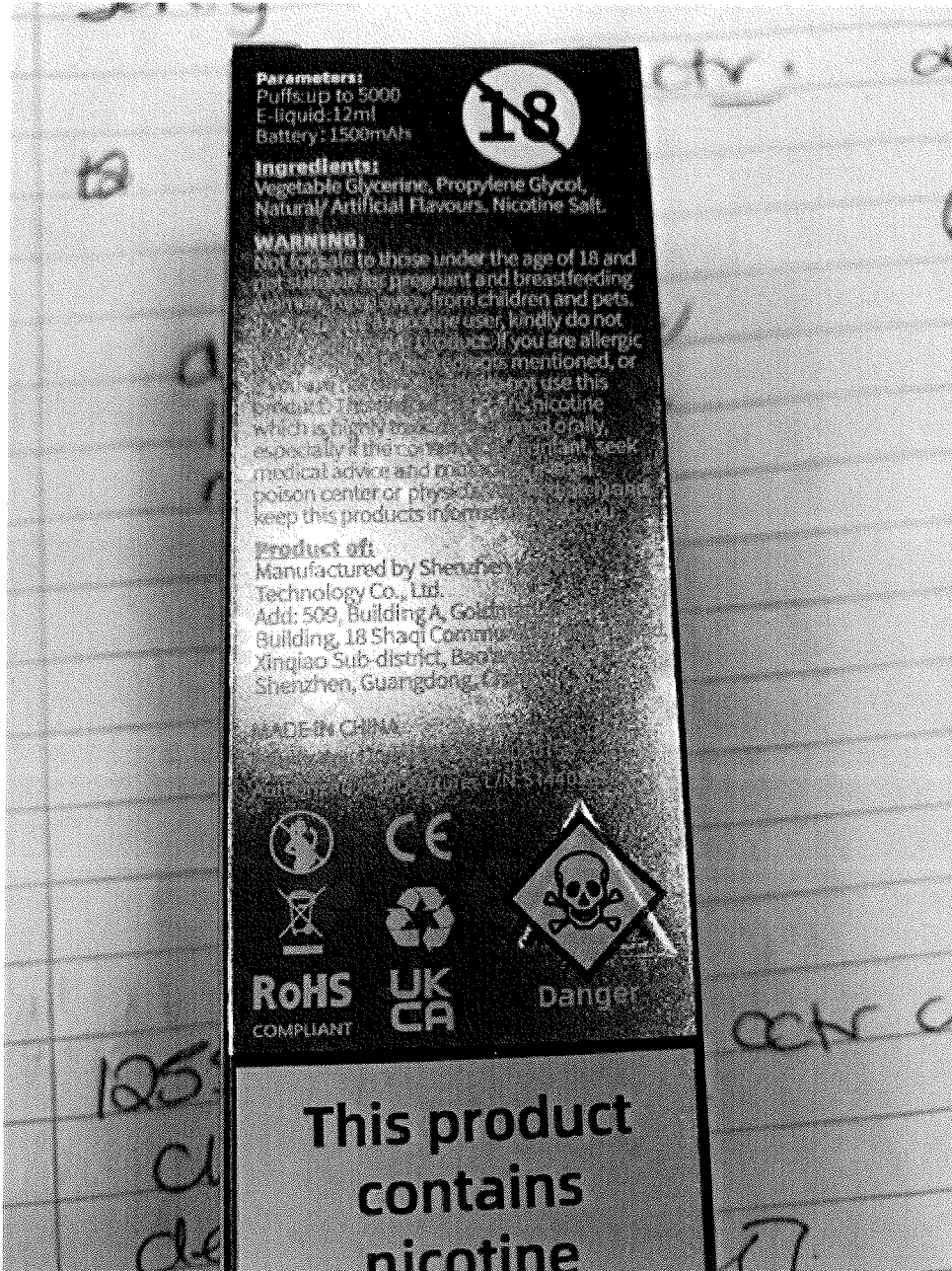

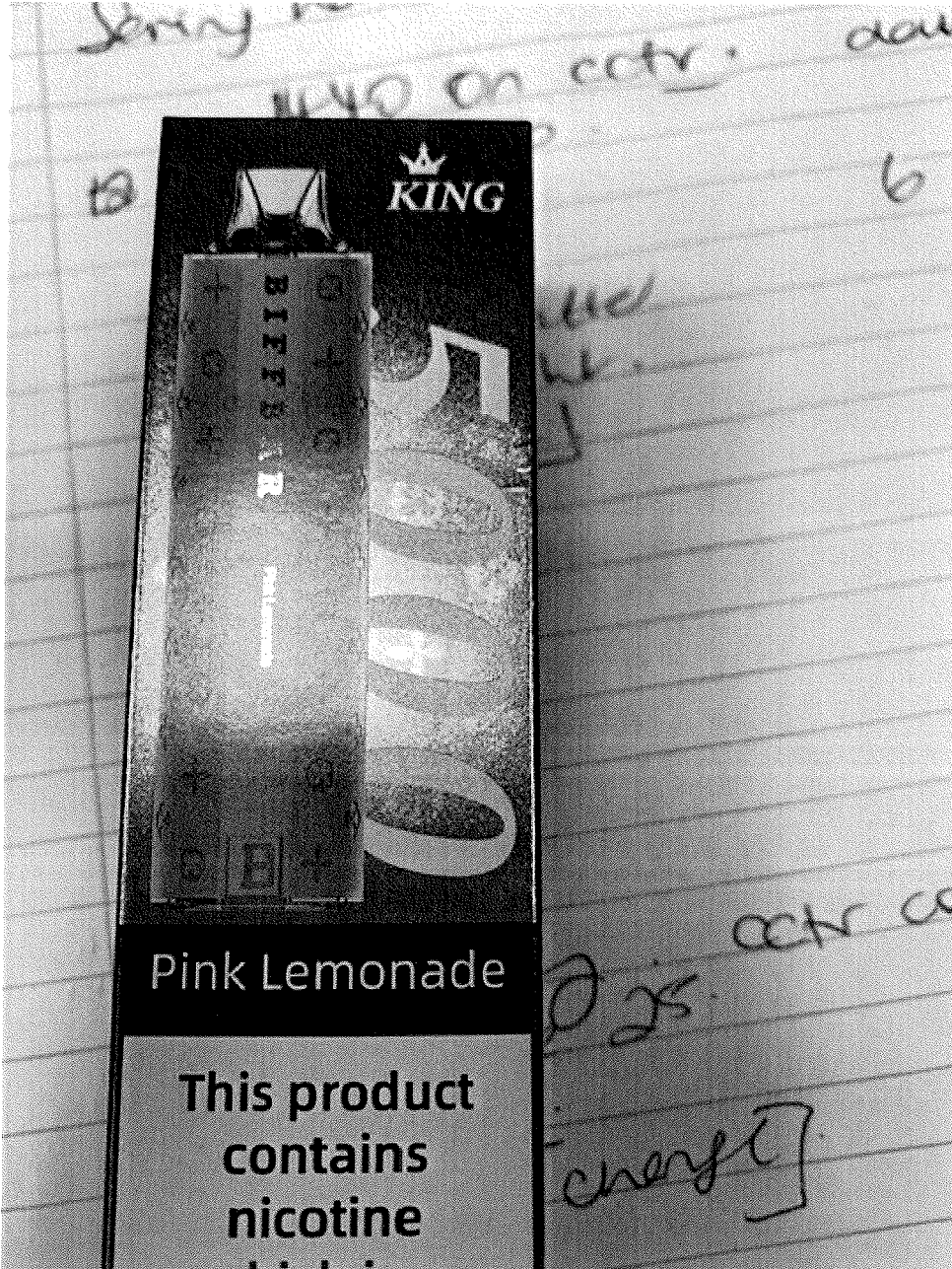

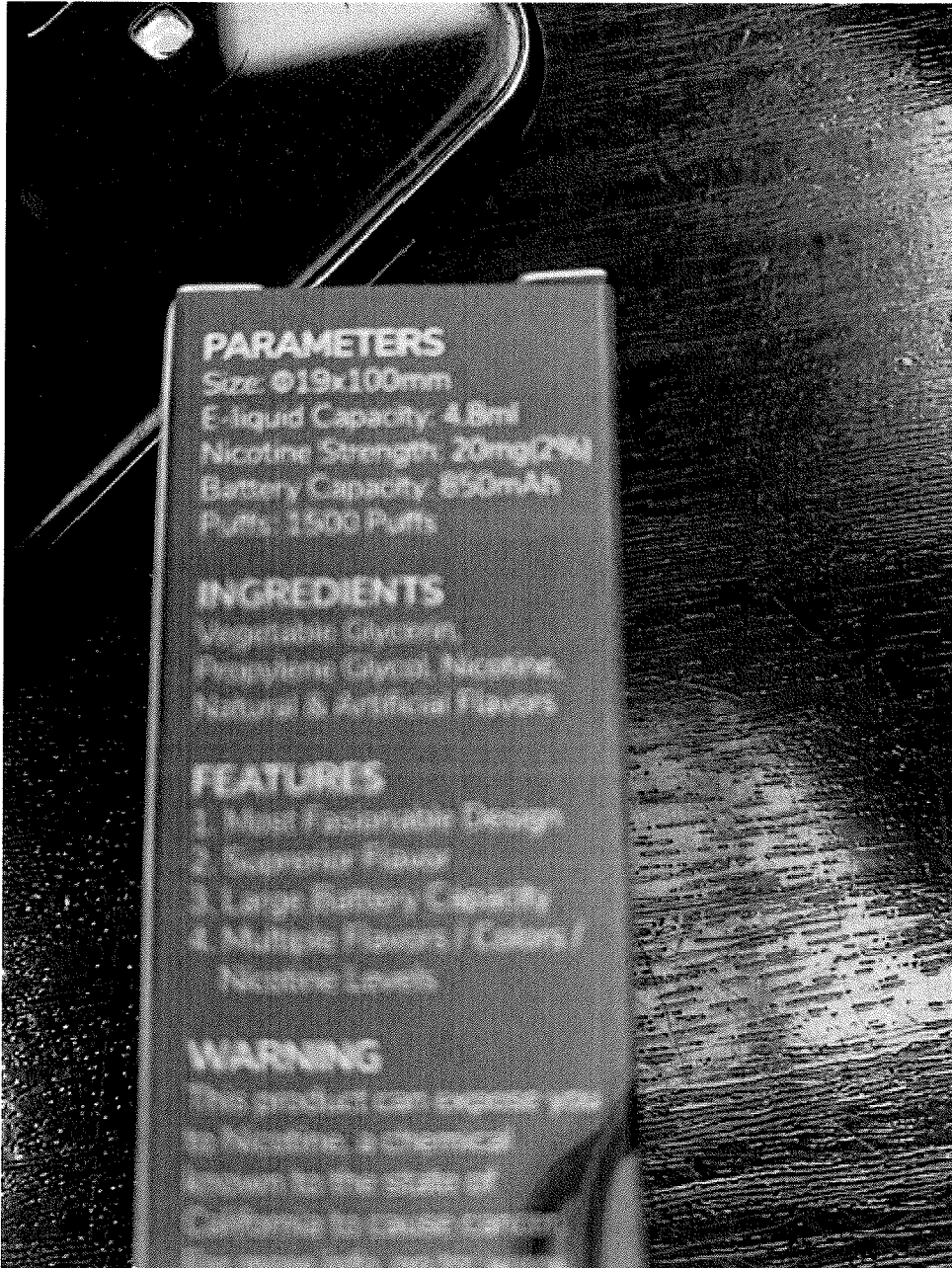

I am the above-named Police Constable, attached to Neighbourhood Police Team 2, covering Gipton and Harehills Ward areas and employed by West Yorkshire Police.

I have been on duty on 15th September 2023 working a tour of duty of 1800x 0200 as part of Operation Jemlock.

I was in company with PS  Ellis and in a marked police vehicle, patrolling key areas for Anti-social and criminal behaviour within the HAREHILLS ward area.

At approximately 00:16 on Saturday 16th September 2023 I have been a passenger in the marked police vehicle travelling on HAREHILLS LANE and noticed the lights were switched on and that customers were still coming and going out of GOLD CLASSIC, 315 HAREHILLS LANE, HAREHILLS, LEEDS, LS9 6AA. I have questioned the opening and closing times and conducted an open-source search using GOOGLE to see if this store should have been open. This information was not readily available during this search.

It was clear that the lights were on, and I was able to see customers from the vehicle we were travelling in. It was dark at this time, so any store fronts that were illuminated were obvious to me.

As far as I am aware, this would have been beyond the open and close times the licence held on the date of seeing it open, states for GOLD CLASSIC. Due to the store being illuminated and the front door being unlocked and seeing customers walking in and out of the store, I would suspect that the store was still trading.
