4 Declaration of Interests

Councillor Carlisle left the meeting during the discussion of this application and took no part in the discussion or decision making.

5 Apologies for Absence

There were no apologies.

6 Minutes of the Previous Meeting

RESOLVED – That the minutes of the meeting held on 2 March 2022 be confirmed as a correct record.

7 Open Forum

In accordance with the Community Committee Procedure Rules, the Chair allowed a period of up to 10 minutes for members of the public to make representations or ask questions within the terms of reference of the Community Committee.

The following was discussed:

- Concern that electric vehicle charging points across the area were currently out of order including those at the Stourton Park and Ride site. This was due to vandalism and the awaiting of new parts. It was reported that this had been raised with the Chief Officer, Sustainable Energy & AQ Resources and also with the West Yorkshire Combined Authority.
- Update on the Active Travel Neighbourhood previously proposed for Cross Flatts – it was reported that there had been a number of consultations regarding the proposals and there had been concerns regarding vehicle turning points and double parking. More than 70% of those consulted had been against the proposals and it had not been felt appropriate to proceed with the scheme. There was a possibility of reconsidering but there would need to be a different set of proposals.

8 Update on LEEDS 2023 Year of Culture

The report of the Chief Officer Culture and Economy provided the Community Committee with an update on Leeds 2023 and sought input from Elected Members and residents.

The following were in attendance for this item:

The Community Committee was given a presentation on Leeds 2023 – Year of Culture. Highlights included the following:

- The background behind the Leeds 2023 Year of Culture following the 2015 bid for European City of Culture.
- Financial commitment from the Council and the leverage of significant funding from public and private sector partners.
- The cultural impact on the city and celebrating the diverse heritage with the people of Leeds at the heart of it.
- Promotion of the City and attracting visitors.
- The aim to engage at least 75% of the local population to be involved in Leeds 2023.
- Roadshows that had taken or were due to take place to promote Leeds 2023.
- Programme of events there would be hyperlocal events across all Wards and a two day Weekender event in August 2023.

 Volunteering opportunities and the recruitment of a Neighbourhood Host for each Ward.

In response to comments and questions, the following was discussed:

- Involvement of Councillors in shaping events.
- Increasing people's perception of culture.
- Involvement of young people.
- Community engagement.
- Neighbourhood hosts would be remunerated at the national living wage rate and training would commence in November/December this year.
- Further fundraising was ongoing. Sources included the Arts Council, local businesses and corporate sponsors.
- Using local Neighbourhood Forums, galas and other events for consultation and promotion of LEEDS 2023.
- The need to target and engage with people from deprived communities who would be less likely to have an interest.
- There would be thorough evaluation of LEEDS 2023 including economical, ecological, social and educational impacts. Feedback would be invited on how it had impacted people's lives. Key Performance Indicators would be available on the LEEDS 2023 website.
- There would be a skills programme and there was close work with the Council and West Yorkshire Combine Authority with regards to skills and employment.
- Getting the message across to people and promoting LEEDS 2023 in day to day venues such as hairdressers and shops.

Members thanked the team for their presentation.

9 Inner South Community Committee Finance Report

The report of the Head of Locality Partnerships provided the Community Committee with an update on the budget position for the Wellbeing Fund, Youth Activity Fund, Capital Budget as well as the Community Infrastructure Levy Budget for 2022/23.

Robbie Hawley, Localities Officer presented the report.

The following was discussed:

- Members attention was brought to the minimum conditions required for delegated decisions to be taken. These were outlined in paragraph 14 of the report and Members were invited to review and approve the conditions.
- Members were informed of the approved budget for 2022/23 which worked out at £57,643 per ward.

- How to encourage organisations to become sustainable with regard to ongoing revenue cots and also encouraging and assisting new organisations to bid for funding.
- Wellbeing Budget Ring Fences for 2022/23 Members were supportive of the budget ring fences for 2022/23 as outlined in the report.
- Projects for consideration. The following was discussed:
 - St Luke's Charity Shop Accessible WC £5,000 was requested to be split between Beeston & Holbeck and Hunslet & Riverside Wards. It was not felt that there would be a benefit to Beeston & Holbeck and it was proposed to approve £2,500 from Hunslet & Riverside.
 - The Middleton Rugby Engagement Project members requested that this application be deferred so that extra information could be requested.
 - Great Get Together Cross Flatts Park, Beeston £3,500 was requested from Beeston & Holbeck and Hunslet & Riverside wards. Although Members were supportive of the project there was some concern with regard to the lack of notice and consultation with Ward Members. It was proposed to provide £500 funding from each of the Wards concerned.
 - Inner South Area New Activity Equipment £19,582 was requested. Members expressed some concern regarding the breakdown of costs and requested the application be deferred so that further information could be provided.
 - Hydro Citizens £3,500. Members were supportive of this application and it was proposed that funding be used from the Community Infrastructure Levy budget.
 - All other projects were recommended for approval.
- Delegated decisions approved since the last meeting.
- Remaining funds in the Youth Activities Fund, Capital and Community Infrastructure Levy Budgets.

Inner South Community Committee - Update Report

Purpose of report

- 1. To bring to members' attention an update of the work which the Communities Team is engaged in, based on priorities identified by the Community Committee. It also provides opportunities for further questioning, or to request a more detailed report on a particular issue.
- 2. This report provides regular updates on some of the key activities between Community Committee meetings and functions delegated to Community Committees, Community Champions roles, community engagement, partnership and locality working.

Main issues

Children and Families - Champion: Cllr G Almas

- 3. A Children's and Families sub-group meeting was held on 6th July to discuss the Youth Summit for 22/23 to set date, and how this will be delivered in for young people.
- 4. The summits are an opportunity for young people to engage with each committee on their priorities for budget spend in relation to the Youth Activity Fund (a delegated

- budget that is given to each committee). Youth Summits provide an excellent platform to consult with many young people in each respective committee event/area.
- 5. The Inner South Youth Summit has been arranged for 8th November 2022 at The Civic Hall.

Environment and Community Safety Champion: Cllr Iqbal (Environment & Community Safety)

6. A verbal update will be provided at next Inner South Community Committee and a sub-group will be booked in following the Inner South Community Committee.

Health and Wellbeing & Adult Social Care - Champion: Cllr Burke

- 7. A sub-group was arranged for 23rd August 2022 however, the meeting was cancelled and will be rearranged in due course.
- 8. The Vitamin D Campaign has continued, and various engagement/digital drop-in sessions have taken place at HAMARA, Holbeck Together and Middleton Elderly Aid and other smaller community groups. Key themes have been identified through these engagement activities and the feedback survey responses have been complied.

Update from Key Services

Police Update

- 9. The off-road bike team has funding for its full-time supervisory structure, as well as an uplift in staffing and equipment. ASB through motorcycles and quad bikes remains the number one source of ASB for the district. There are force discussions around tactical options for dealing with pursuits of these vehicles. Offenders are often without a helmet, and it is a reasonable assumption that they are juvenile and therefore lacking in driving/riding skill/experience. This makes pursuits extremely dangerous, with a high probability of serious injury, not just to the rider/passenger, but to the public and the police. This is not an easy problem to solve, but there remains an appetite to improve the current position. A recent team operation located 19 stolen high-powered motorcycles, with a total value in excess of £150,000.
- 10. Travellers: New legislation is in use and has been used since its inception. What appears to be a winning formula is the sharing of reports of ASB/crime from MPs, Police and Elected members. This has really helped me to make some quick decisions around use of Section 61 powers. Officers attend regularly and use bodyworn video to capture the condition of the sites, which can then be used to support the removal. A shared communication strategy throughout helps to maintain trust and confidence in our collective approach.
- 11. Day of action: This was a really effective day of action with the use of force and district resources. Multiple arrests were made, numerous weapons recovered and significant visible presence was achieved throughout the NPT area. The numerous

positive results were shared via the force social media accounts and included a professional video from our media imaging team. The reach of these posts was over 150,000 local people and sent a message around the action my teams are taking to reduce the most harmful crime types.

- 12. The cuckooing forum is up and running, which should help to protect vulnerable people from cuckooing, identify new trap houses early and to take a partnership approach to reducing the harm/ASB caused.
- 13. Weapons/violence: Some very good work has been carried out around diversion and enforcement.

Beeston and Holbeck

NPT Priorities

14. To act on community intelligence to tackle and disrupt the illegal supply of drugs in the Beeston and Holbeck area. We will be increasing high visibility patrols in the area and using a number of different tactics to disrupt the drugs supply including executing warrants where we have intelligence. 15. To continue to work in partnership to tackle the problems caused by on-street sex working in the Holbeck area of Leeds. Dedicated officers will conduct intelligence led, high visibility patrols in the Holbeck area and will respond to community concerns raised through the dedicated phone number.

Ongoing Updates from NPT Priorities above

16. Weekly tasking meetings have been held with partners to create bespoke action plans for individuals involved in sex working. Enforcement action has been taken against individuals committing offences in the area.

Hunslet and Riverside

NPT Priorities

- 17. To reduce persistent begging in the Dewsbury Road area through proactive high-visibility patrols and partnership working, we shall work to engage with those involved in persistent begging in the area, encouraging those individuals to access support services and taking action against those who continue to persistently beg.
- 18. To act on community intelligence to tackle and disrupt the illegal supply of drugs and the linked anti-social behaviour which affects those living in the community. We will conduct high visibility patrols in the area and use a number of different tactics to disrupt the drugs supply, including executing warrants where we have intelligence. You can help us by reporting any information or concerns you have directly to us or by using Crimestoppers on 0800 555 111 or www.crimestoppers-uk.org

Updates from previous priorities

- 19. As a result of increased patrols, crime prevention advice being given to residents and businesses in the Fox Way Industrial area we have seen a decrease in theft offences in this particular area however we will continue to monitor this and still provide high visibility patrols to deter offenders.
- 20. Drug supply Officers have utilised a variety of policing tactics, including warrants and stop search to disrupt drug supply in the area. We have also worked with partner agencies resulting in closure orders being obtained in relation to problem addresses linked with drugs and drug related anti-social behaviour.

Middleton and Belle Isle

NPT Priorities

21. To target Anti-Social Vehicle use, speeding and inconsiderate driving of off road biker, scooters, quads and electric bikes in and around Sharp Lane / Middleton parks and Belle isle road near to the Aberfield's. We will be increasing patrols in the areas on conjunction with the off road motorcycle teams.

- 22. To disrupt and engage with nuisance youths at Acre road, Sisson's, Middleton park avenue area and the surrounding streets in particular the disruption and criminal damages to the buses. If you have any information in relation to this issue please ring 101 or Crime Stoppers on 0800 555 111 or crimestoppers-uk.org
- 23. To disrupt and engage with nuisance youths in the Middleton Park Circus around the shops. Monthly community meeting on the 1st Monday of each month, 1800hrs at the Middleton elderly aid in conjunction with the Middleton community group.
- 24. To target the anti-social behaviour around the shops and Bitmo on Belle Isle Road

Updates on continuing priorities

25. Anti-social vehicle use— We have maintained a Police presence in the area and work is ongoing to trace the location the bikes are stored

CCTV Update

- 26. The Leedswatch service is currently undergoing a review which is looking at all aspects of the service, including the operation of the control room, effectiveness of its cameras.
- 27. The review is also to include a reporting strand which will serve to agree the way forward to provide information regarding CCTV to Councillors and Partners.
- 28. This report covers the different types of incidents captured by CCTV operators in real time for the cameras located in the Inner South area committee area, for quarter 2 2022/2023.

List of current cameras in the Inner South area

29.31 cameras were used to report the incidents that have been captured in the Inner South area committee within this quarter.

GDPR – Information Sharing

30. The introduction of the GDPR 2018 regulations reviewed the area of information sharing and therefore restricted the detail of what can be provided. As a result, the content of this report may not have the detail of specific incidents previously reported but provides a summary of the types of incidents within the area.

- 31.CCTV also contributes towards Police enquiries as requests are made for footage which may not have been observed "real time". These incidents are not included in this report but can contribute towards arrests being made in the Inner South Area.
- 32. Following the recent announcement of the new Full Fibre Network provider being awarded to BT work will now commence to upgrade all CCTV cameras from analogue to digital. This will significantly improve the image quality and increased effectiveness of cameras in the Ward.

Requests for new Cameras

- 33. The Surveillance Camera Commissioner is appointed by the Home Secretary to ensure that surveillance camera systems in public places keep people safe and protect and support them.
- 34. Following changes to Data Protection legislation the council needs to ensure that all its CCTV systems are managed in line with the Commissioner's recommendations to ensure there are no data breaches (this includes CCTV systems in all Leeds City Council assets including libraries, sports centres, council vehicles fitted with CCTV, etc.).
- 35. A dedicated CCTV compliance team has been established within Leeds City Council.
- 36. The compliance team also work closely with Information Governance to assist in ensuring all system owners are compliant with their codes of practice, policies, and procedures.

Public Health

Covid-19 focused work

- 37. Public health is continuing to focus on reducing or eliminating the barriers some communities face in accessing Covid 19 vaccination, alongside work to support 'Living with Covid'. An analysis of vaccine uptake on a MSOA level revealed several areas with lower uptake. Measures to assist with access barriers include locating pop-up vaccination sites in community places situated near the residential areas of concern.
- 38. The covid vaccine nurses were present at the Beeston festival (25.06.22) and the Hunslet festival (02.07.22) where they administered 7 and 21 vaccines respectively.
- 39. Work is ongoing to deliver a Family Fun event in partnership with Hamara. Alongside the Covid nurses, there will be a school nurse and relevant service representation to engage local residents. There will also be street games, an ice-cream van and a bouncy castle.

Better Together

- 40. The Better Together providers of Health For All, Holbeck Together, Asha and St Lukes Cares have delivered their first collective quarters monitoring of the year. 39 groups are currently running, they form a mixture of groups from the previous contract and new groups. 23 groups are fully supported and 14 are light touch supported a move to sustainable groups.
- 41. Attendance figures show that they are attracting new members to both established groups and new groups with overall, good attendance figures.

Your Space

- 42. The Your Space team have introduced new groups for year 4 of the contract. A Holbeck based, Womens' wellbeing group and Holbeck home cooking group is creating friendships and reducing self-reported loneliness among the attendees. Your Space teamed up with Active Leeds to deliver walker leader training to ten participants with very positive feedback and new walks being added to the menu of options.
- 43. A group in Belle Isle has celebrated its one-year anniversary by deciding to run themselves. Thus freeing up some time to allow the Your Space worker develop a new group a book club.

Beeston and Middleton Local Care Partnership

- 44. There are now four subgroups formed from this partnership;
 - 1. The **Digital health Hub** ongoing, but no further updates.
 - **2. Mental health and wellbeing**. Following the workshop meeting, family and children provision was agreed as the focus. Discussions are focused on improving the pathway between GP referral and services.

- 3. Health Inequalities Bid. A new year of funding from the Integrated Care Board and a bid submitted by Public Health, in partnership with Active Leeds and Groundworks has been successful. The initiative is supported by the LCP and Middleton PCN. Leeds Encouraging Exercising People (LEEP) will provide a GP referral pathway for presenting patients with diabetes or hypertension to a Clinical exercise facilitator who will develop, in conversation with the patient a bespoke exercise regime. Groundworks will provide gardening opportunities, while funding as subsided the cost of an Active Leeds membership to £5 per month. For more information, please email Nicola.kellyjohnson@leeds.gov.uk
- **4. Domestic Violence and abuse**. This newly formed group is set to have an initial focus on the Middleton Park ward area. The group has meet once and has agreed it Terms of Reference. Agreeing objectives is the current step which will be used to create an action plan for delivery. For more information, please email Nicola.kellyjohnson@leeds.gov.uk

Locality-based projects

Green spaces in Middleton Park Ward

45. A recent health needs assessment highlighted the negative thoughts and concerns of the available green spaces in Middleton Park Ward. Working alongside BITMO, Parks and Countryside, local Councillors and other partners, Public Health are leading work to develop a consultation on the options available to local residents to improve the green spaces available.

Beeston Hill Pharmacy project

- 46. Following the undertaking of a health needs assessment in Beeston Hill residents raised concerns about the length of time taken to see a GP which led onto discussions about pharmacy services in the area. The Public Health Localities and Primary Care team, working alongside NHS partners, have begun discussions on how best to promote pharmacy services to residents in the area to offer an alternative to a GP appointment for minor ailments.
- 47. Following the roll out of the Community Pharmacy Consultation Service (CPCS) in the area there is scope to work with community groups and third sector partners to raise awareness of the services offered within local pharmacies. Resources and information to support the work are currently being looked at and the Public Health and Localities officers are working with local pharmacists to set up information sessions to be delivered in the area.

Belle Isle and Middleton Community Network

48. With many of the organisations involved in the network raising concerns about reengaging with residents in the area and opportunity has been taken to attend the Breeze event in Belle Isle. Part of the purpose will be to consult on the green space work but there is also an opportunity for network members to attend and promote the activities they have on offer while engaging residents in conversations about issues facing them at this current time.

Public Health messages

Air Quality and Health survey

- 49. Leeds City Councils Public Health Team are currently undertaking a health needs assessment to understand the level of need across Leeds in relation to air pollution.
- 50. As part of this, it is important to gather views of local residents as well as those working to support the health and wellbeing of Leeds residents in relation to how they feel about air pollution in the city. The feedback will be used to evaluate local knowledge around air pollution and how this can impact on health.
- 51. The survey can be accessed on the link below. By completing this and encouraging any users of your service to do the same you will be supporting us in making recommendations on improving health outcomes for the people of Leeds. https://surveys.leeds.gov.uk/s/airqualityandhealth/

Air Quality Alert System

- 52. Air quality is the largest environmental health risk in the UK, shortening lives and contributing to chronic illness. Whilst it can be harmful to everyone, some individuals are at greater risk either because they are exposed to greater quantities of polluted air in their daily lives or because they are more vulnerable to its side effects due to medical conditions such as respiratory and cardiovascular disease.
- 53. To support with raising awareness and public health messaging around Air Quality, we have launched an Air Quality Alert System for Leeds. Those who subscribe to the alert system will receive an email when the air pollution in Leeds is forecast to be high or very high, providing them with public health advice on what to do to reduce their exposure and contribution throughout the air pollution episode.
- 54. We ask you subscribe to this service and to encourage users of your service you are working with to do the same, especially if this group are vulnerable to the effects of air pollution because they have a respiratory or cardiovascular illness. You can sign up by visiting the Air Quality sign up section on the Leeds Clean Air Website here Protect yourself from air pollution (leeds.gov.uk).

Health Protection Board Report

55. The purpose of the Health Protection Board report (link below) is to provide an overview of the Health Protection Board Covid-19 response, as well as the status of the wider priorities focusing on protecting the people of Leeds including infectious diseases, environmental hazards and other areas of health. This report highlights the current position of health protection in Leeds, key achievements and targets for the period of 2022-2023, setting out recommended actions for the next 12 months. Stay Well this Winter Grants now open

- 56. Leeds Community Foundation has launched the 2022 Stay Well this Winter Grants, with funding from LCC Public Health. The grants will support a range of community-based projects in Leeds. Applicants should target support to vulnerable people who are most at risk of becoming unwell over winter due to cold and severe weather.
- 57. Grants can be from £500 to £2,500 for local and city-wide projects. For exceptional, innovative city-wide proposals the panel will consider applications of up to £5,000.
- 58. The deadline for applications is 18 August at 12 noon. Funding will be awarded in early October and all projects should be completed by 31 March 2023. Further information, including a link to the online application form, is available here.

COVID-19 update

A reminder of the key messages around Covid:

- 59. Although it feels like life is returning to normal, Covid is still with us.
- 60. The virus spreads easily when people are together in enclosed spaces such as on public transport or even indoors at home.
- 61. Getting up to date with your vaccinations is the best defence against infection, to keep yourself and your family healthy.
- 62. The medical professionals at the vaccination clinic will be happy to answer any questions you have about the vaccines. You can also read more on the NHS website.
- 63. Although UKHSA no longer post daily Covid updates, announcements are available <u>here</u> and national surveillance data and reports are available <u>here</u>.

Building Vaccine and Screening Confidence for Higher risk populations - Free webinar

65. Building on the success of the Covid-19 Vaccination Webinar workshops responding to Vaccine Hesitancy, we have worked in partnership with Health Education England to commissioned a similar workshop to align with what will be a highly important Autumn/Winter vaccination programme for 2022/3. We particularly wish to target participants who come into contact with low vaccine and screening uptake populations, including: areas of high deprivation, ethnic minority groups, parents of

2&3 year olds and school age children, those in at risk categories and care home settings.

Concept and Objectives:

- 66. The primary objective of the Autumn booster programme this year will be to increase protection against severe COVID-19 disease for those at higher risk. In addition there is an added need to address the inequalities in uptake of flu vaccination.
- 67. Vaccine hesitancy amongst some eligible populations can present a risk to population health and more often negatively impact some of our poorest communities and/or risk groups. Our conversations our powerful, therefore the provision of skills training that uses the principles of Making Every Contact Count (MECC) and Motivation Interviewing (MI) is an important skill that can be utilised to combat disinformation and myths and whilst providing the necessary reassurance and confidence in what is a safe and effective vaccine.

68. The skills training covers:

- How can we work together to build vaccine confidence, what we know and how this links to health inequality
- Core skills and processes (OARS, Evoke-Provide-Evoke, Decisional Balance, and the 3As)
- Skills practice Building confidence in the vaccine
- Resources that staff can use to respond to questions and concerns
- 69. The session will be interactive and include modelled conversations that showcase the core skills and processes being used. The application of this work can be farreaching. Although this is focused on Flu Vaccinations, these skills can be utilised for childhood immunisations, Covid vaccine, cancer screening and other health-promoting activities
- 70. This provision has been funded by Health Education England Y&H in partnership with the NHS Public Health Programmes Team Y&H. Each workshop can caterer for 30 people and lasts for 1.5 hours, dates available from the 12th September 2022 10th January 2023. Employment and Skills Update

Universal Credit

71. The number of people who are claiming Universal Credit (UC) due to unemployment, as of June 2022, in the Inner South Community Committee area is 6,980. Whilst the largest increase in claimants of UC was in June 2020 (65%), the number of claimants continued to increase and remains high. There is a small decrease of 5 claimants in June 2022 on the previous month.

- 74. The Covid pandemic and restrictions have had an impact on both reporting years (2020/21 and 2021/22) making a comparison year on year very difficult. Even though there is some progress with re engagement and access to programmes and activities it is still significantly less than pre Covid.
- 75. During April 2021 March 2022: 11,818 people accessed the Service, 2,198 of whom were residents from the Inner South. 3,473 people were supported into work, 680 of whom were residents from the Inner South. Customers were supported into work across all sectors with the largest numbers in health and care, food retail, logistics, distribution, and transport. Supported 2,485 people to improve their skills, 386 of whom were from the Inner South.
- 76. Leeds Employment Hub is a single point of contact for all funded programmes and Jobshops that provides tailored and comprehensive support into employment or education to all Leeds residents. Employment Hub Advisors deliver the programme by providing one to one support, tailored preventative and remedial support to Leeds residents who are disadvantaged in the labour market.

- 77. The Employment Hub Advisors are co-located within 10 Jobcentres Plus across the City. All Jobshops are open, 5 days a week for face to face appointments which include Dewsbury Road, City Centre, Hunslet and St Georges Community Hubs. The Community Hub Mobile bus is now running Monday-Friday the schedule stop includes: Holbeck Community Centre, Thursday 9:30 15:30.

- 81. Future Talent Leeds is launching on Thursday 8th September 2022. It is a website which brings businesses, education and skills providers and organisations together to strive for a city where everybody can thrive in a rapidly changing labour market. The website contains the Future Talent Plan, which sets out our ambitions for Leeds around supporting our people and businesses as well as aligning the city's education and training infrastructure. It displays the range of partners which have signed up to the plan, showing what organisations are doing to improve talent and skills in Leeds over the next few years. Organisations are encouraged to use the website to sign up to the plan and pledge their own actions which will be published alongside each other.
- 82. Also available on the website is live news, case studies and resources for organisations to make use of. The website will be live from 8th September: https://inclusivegrowthleeds.com/future-talent-plan
- 83. The Adult Learning programme continues to deliver an effective, broad, and inclusive curriculum to support the continuation of learning through an online platform in collaboration with subcontracted partners. Courses were delivered through a range of models to include online, face to face and through distance learning, opening new opportunities for adults to learn and develop their confidence.
- 84. Between September 2021 July 2022, in the Inner South, 96 courses were delivered at 22 venues. 473 residents have completed a course. In addition, there were 149 courses delivered on-line, city wide. From September 2022, there will be a range of online and face to face courses available at community venues, for further information please visit: https://leedsadultlearning.co.uk/

- 85. Developing You Health and Wellbeing, a pre-employability programme which helps people to become happier, healthier and move closer towards employment. For residents living in Inner South the courses are being delivered at St Matthews Community Centre.
- 86. Developing You Learning Disabilities, a pre-employability programme between Employment and Skills, Pyramid of Arts, People Matters and United Response includes work readiness and health and wellbeing. The course is delivered face to face at Thackray Medical Museum.
- 87. Between April 2021 March 2022, 256 new businesses were supported to recruit new staff, provide support for staff facing redundancy and developing initiatives to address staff shortages and filling a high number of vacancies within key sectors.

Health and Care Sector

88. The Healthier Working Futures project that was funded through the UK Community Renewal Fund that focused on unemployed / economically inactive young adults (aged 16-25) to raise awareness of the health and care pathway through engagement programmes and taster days delivered by 3rd sector organisations. This was a 6-month project that concluded at the end of June and engaged with 625 young people.

Construction Sector

89. A new programme, Construction Ready aimed at getting people into opportunities in construction. The 10-day programme took place 4 - 15 July 2022 at Leeds City College Printworks campus. Planning is taking place for further programmes to be delivered.

Hospitality Sector

90. The Restaurant Ready programme, a 5-day course, aims to upskill individuals to successfully enter the hospitality sector through providing practical experience within Leeds City College's café and restaurant facilities. The programme provides an opportunity for participants to be signposted to work trials and interviews with employers. Planning is taking place for a sixth cohort to be delivered 12 – 16 September 2022.

Economies for Healthier Lives

91. The council was successful for applying for funding from the Health Foundation as part of their Economies for Healthier Lives programme, which has funded four places in the UK to undertake projects that can demonstrate how economic interventions can help to address health inequalities in disadvantaged communities. The Leeds project, Good Jobs, Better Health, Fairer Futures, aims to strengthen connections between the Leeds Inclusive Anchors Network of large civic institutions (including the council, NHS Trusts, universities and colleges, and utilities) and the city's most disadvantaged communities through economic measures such as quality jobs, skills development or the creation of new businesses.

Events

- 92. SEND (Special Educational Needs and Disabilities) Next Choices event took place at Leeds First Direct Arena on 23rd June 2022. This was the first time a city-wide event aimed at supporting young people who have special educational needs and disabilities has taken place. A total of 66 exhibitors participated, offering jobs, apprenticeships, volunteering, training opportunities and wider support and 1,800 young people attended.
- 93. Jobsfair took place on Thursday 18th August 2022 in the City Centre Community Hub. A range of vacancies and opportunities were promoted with Leeds City Council, the Army, Plusnet, Aspire Healthcare, and First Direct. Jobshop staff were in attendance to support people with CVs and job applications. Information was also available from training providers, such as Prince's Trust, Scope, Get Technology Together, and Jobcentre Plus for those wanting to improve their skills.
- 94. Leeds Digital Careers Festival a week-long festival and recruitment event will be held between 12 –16 September 2022 and will be aimed at those new to the digital sector, eager to find a job or training opportunities in the wide range of digital technology organisations which the city has to offer. Roadshows with a range of workshops and sessions hosted by local employers and providers will be taking place in several locations across the city including Dewsbury Road Community Hub and Leeds City College, Printworks Campus. An event will also be held at Leeds First Direct Arena on 15th September 2022, to book please visit: https://leeds.digital.careers.google.com
- 95. In the lead up to the festival in September, a number of tech, coffee and chat sessions were held over the summer which included digital skills for life and work, how to setup, use and manage your social media, tech workshop and how to keep yourself and your family safe online at Printworks Campus and Dewsbury Road Community Hub.
- 96. Leeds Creative Skills Festival (LCSF) will take place 14-18 November 2022 which will showcase opportunities within the creative and culture sector, with the main event at the First Direct Arena on the 17th November 2022. The LCSF is aimed at young people aged 16-24 to encourage take up from school leavers and graduates to retain talent in the city. There will be a range of activities and events from educational engagement activities, visits and site tours, work experience opportunities to support to the sector on how to recruit a diverse workforce and Apprentices, information about self-employment and freelancing and Q&A panel session(s). A booking link will be published and promoted nearer the time.

Community Engagement - Beeston & Holbeck

- 98. Further to the hand delivered copies noted in the last update, an online version of the summer Holbeck Community Newsletter was released on 08/07/22 and shared throughout the local community Facebook groups, reaching an additional 1,700 people with the local good news.
- 99. The Holbeck Moor electricity supply was energised in time for the Holbeck Gala on 2 July reducing the need for diesel generators on site. Members of the Communities Team attended the gala. It is hoped that following promotion more local groups will also begin to access the electricity supply and be able to enhance their activities. Having the facility will enable more activities to take place on The Moor. Bookings can be made through Parks & Countryside via eventsinparks@leeds.gov.uk / 0113 378 6002.
- 100. The Cottingley lamp post banner campaign was also completed since the last Community Committee meeting, where a competition with pupils from Cottingley Primary Academy resulted in five designs being made into 2m tall banners suspended from five lamp posts across the estate. This achieved almost 900 views on Social Media and received positive feedback, including interest from another neighbourhood.
- 101. A small but rewarding project regarding dog fouling and litter was completed at Beeston Recreation Ground. The recreation ground is a shared spaced with Beeston Primary School for their games lessons and sports day events. The Beeston & Holbeck members acted on intelligence received about the site and commissioned new signage to help remind people to leave the area clean feedback from the school reported a marked improvement following their installation.

Community Engagement - Middleton Park Ward

Request for Temporary CCTV on Belle Isle Road

- 102.An application for temporary CCTV on Belle Isle Road on the Aberfield gate junction has been approved by the Inner South Community Committee following a significant rise in the number of reported incidents of Anti-Social Behaviour. The incidents include quad and motorbikes causing issues for local residents, passing motorists and damage to the grassed area.
- 103. The camera will assist Police Officers to gather intelligence to identify the perpetrators.

Community Engagement - Holbeck & Middleton Park

Reducing the flood risk from Wortley Beck

104. The next stage of the Flood Risk Study is to share details with the public via a web-based consultation. The consultation can be accessed at Have Your Say Today - Wortley Beck Flood Risk Study - Leeds City Council Flood Resilience (commonplace.is)

- 105. The page outlines the work so far on the study and plots the options that are being taken forward on an interactive map.
- 106.Members of the public can select the area that they'd like to know more about, and give their feedback. They can also plot their own pin if they have additional thoughts on a solution. You can watch this explainer video of how commonplace works for more information.

Neighbourhood Centres Co-ordinator

- 107. An update continues to be circulated on a weekly basis to businesses across all the Inner South wards (Beeston & Holbeck, Hunslet & Riverside and Middleton Park).
- 108. The Neighbourhood Centres Co-ordinator visits district centres on a regular basis to see how businesses are doing, discuss issues including shop vacancies and promote the support available.
- 109. Dewsbury Road Town Team has held several meetings and working in partnership with Ward Members to see improvements to Dewsbury Road which includes a Councillor led initiative resolving issues and improving the Beeston Hill shopping area.
- 110. Final preparations are being made for delivery of the Town & District Centres 2 projects to improve the appearance of Dewsbury Road shopping area including bike racks, a new banner display and additional benches and litter bins.
- 111. Businesses not previously visited in Cross Flatts have now been visited to see how sales are going and any issues faced.

This means that this is the **second** most popular Community Committee page.

There are two things to note in general:

- 'reach' is the number of people the post was delivered to
- 'engagement' is the number of reactions, comments or shares

Engagement tends to be a better way of gauging if people are interested and have read the posts because they wouldn't have interacted with it otherwise. For example, a post might reach 1,000 people but if they all scroll past and don't read it, the engagement is 0 and it hasn't been an effective way for the Community Committee to communicate.

However, all posts can be read without any further interaction.

The **most popular post** since the 22nd July 2022 was the posting regarding *The Inner South Youth Service Summer Program,* this has:

- Been shared 29 times
- Reached a total of 7,785 people
- Received 27 likes

2025

Purpose of report

- To share the refresh of the draft Age Friendly Strategy & Action Plan 2022-2025, with Community Committee members and gain feedback.
- Request support and promote the work of Age Friendly within the city.
- Note the Public Health approach to building winter resilience.

Main issues

Age Friendly Strategy and Action Plan 2022-2025

- Around one in three people in Leeds are aged 50 and over. In addition, the number of Leeds residents aged 80 and over will increase by about 50% in the next 20 years.
- Age Friendly Leeds is one of the eight priorities in the Best Council Plan 2020-25. The vision is for Leeds to be a place where people age well: where older people are valued, feel respected and appreciated, and are seen as the assets they are.
- Leeds is a member of the World Health Organisation (WHO) Age Friendly Cities programme and has used and adapted the age friendly cities framework to identify and address barriers to the well-being and participation of older people.
- The draft Age Friendly Leeds Strategy 2022-2025 has been reviewed and refreshed.
 Overseen by the Age Friendly Board, the review process has been informed by <u>The State of Ageing in Leeds</u> report and consultation findings, alongside a number of other consultations (please see below).

- The strategy sets out six key priority areas: housing; public and civic spaces; travel and road safety; active, included, and respected; healthy and independent ageing and employment and learning. Each priority is headed by a domain lead.
- Key objectives have been identified for each priority area including key actions for year one, two and three of the strategy.
- Domain leads have been identified and are now working to implement the actions set out in the plan.
- The governance for the draft Age Friendly Strategy and Action plans is via the Age Friendly Board, chaired by Cllr Jenkins, Deputy Executive Member for Adults and Children's Social Care and Health Partnerships. The role of the board is to provide strategic leadership and set the strategic direction for the Age Friendly Leeds work programme and to ensure the objectives of the action plan are being met.
- The full draft Age Friendly Strategy and Action Plan can be accessed via the link below.

Age Friendly in Practice

There are lots of ways that local communities can become involved in very practical ways to strengthen the age friendly approach. These are part of the Friendly Communities work lead by Leeds Older People's Forum (LOPF) which include:

- The Age Friendly Ambassador Programme: over 200 Age Friendly Ambassadors in Leeds have signed up to take action in their local community and help raise awareness and spread the Age Friendly message.
- Becoming a Dementia Friend: with around 8,500 people in Leeds living with dementia, this is an issue that effects a huge number of people therefore raising awareness and taking local action is incredibly important.
- Age and Dementia Friendly Businesses: local businesses can sign up; they receive
 a guide and develop an action plan to be more age and dementia friendly. For
 example: a local Optometrist who has changed their practice to make home visits for
 people who are housebound or a local GP surgery who is now offering longer
 appointments for people living with dementia and their carers.
- The Come in and Rest Scheme: local businesses and services can show they are welcoming to older people who many want to pop in and sit down for a while. We have sticker for windows to show this. This helps people get out and about with confidence as they know there is somewhere to sit and rest if they need it.
- Leeds Older People's Age Friendly Steering Group: for older people living in Leeds
 to share their views, ideas, experiences, or skills to help make Leeds more Age
 Friendly. The group meet monthly over zoom. One of the members recently won the
 Living Streets Charles Maher Award for her campaigning to improve the safety of her
 local streets.

LOPF would welcome the support of local Councillors to promote these opportunities in their communities so people and business can get involved in as many ways as they feel able.

Older People and Winter Resilience

As we approach the winter period Public Health are working with partners to support older people in Leeds to be as resilient as possible this winter. The cost of living crisis together with the impact that cold weather can have on older people requires a system wider approach to ensure proactive and preventative support is provided to those most at risk this winter. In addition, the ongoing Covid-19 pandemic can add and pose additional risk to those who are clinically and socially vulnerable.

There are a range of services which support older people who are more at risk to cold weather including:

- Information and Advice Service Age UK Leeds (AUKL receive a small grant from PH (through A&H grant agreement) to deliver and promote an accessible, free, impartial and up-to-date information and advice service to older people, their families, carers, representatives and also professionals on a range of issues including:
 - · Health and social care
 - Money matters
 - State Benefits (including form completion)
 - Housing rights
 - Rights to local services
 - Family and personal matters
 - Consumer issues
- Home Plus Leeds Home Plus (Leeds) is a service aimed at enabling and
 maintaining independent living through improving health at home, helping to prevent
 falls and cold related health conditions. Care & Repair work in partnership with
 Groundwork NEWY and Age UK to provide: Aids & Adaptations in the home to
 reduce the risk of fall, Hazard Repairs, Heating and Energy efficiency and support
 people living with dementia by assessing for and providing home-based
 interventions. This is a citywide service.
- Lunch Clubs Public Health fund the annual Lunch Club Grants (administered by Leeds Community Fund) offering a small financial contribution to support voluntary groups who provide a hot nutritious meal and social activities for old people in Leeds in a communal environment for an average delivery of 40 weeks per year.

Other opportunities to ensure organisations and communities can support older people during the winter period include:

 Signing up to receive Cold Weather Alerts - these alerts are comprised of different levels of response and actions needed based on cold weather thresholds. These responses are set within the Cold Weather Plan for England. The thresholds have been developed to trigger an alert when severe cold weather is likely to significantly affect people's health. The alerts take account of temperature along with other cold weather threats such as ice and snow.

- Supporting the workforce to have confident and compassionate conversations by watching a short animation, anyone working or volunteering in Leeds can increase their knowledge of the evidence based, high impact interventions to support people in Leeds during winter. Free resources can then be accessed from the Public Health resource centre as well as winter planning checklists which could help you or members of your wider team. More information can be found on the Public Health Resource Centre webpage under 'Seasonal Health (summer and winter planning)' Watch the animation https://rebrand.ly/LeedsWinterWorkforceAD
- The Public Health Resource Centre (PHRC) offers support to anyone with a
 responsibility for or professional interest in public health or promoting health and
 wellbeing in Leeds, including students and volunteers. The PHRC stocks a wide
 variety of leaflets, posters and resources that can support different audiences, topics
 and challenges we face during Winter these include flu, malnutrition, falls
 prevention and fuel poverty.
- Encouraging organisations to apply for 'Stay Well this Winter' grants. Funded by Leeds City Council Public Health and administered by Leeds Community Foundation Trust. The grants of between £500 to £5,000 will support a range of communitybased projects in Leeds that target support to vulnerable people who are most at risk of becoming unwell over winter due to the cold and severe weather. Further information can be found at <u>Stay Well this Winter Grants | Leeds Community</u> <u>Foundation (leedscf.org.uk)</u>
- Become a winter friend the public facing winter friends campaign aims to motivate and support people to look out for others in their community and take small actions to support those more vulnerable during the winter period through the evidence based, high impact interventions linked to winter.

Corporate considerations

a. Consultation and engagement

The Age Friendly Strategy has been informed by the <u>State of Ageing in Leeds</u> report. The Centre for Ageing Better working in partnership with Leeds City Council and Leeds Older People's Forum have produced this report that looks at what life is like for people aged 50 and over in Leeds, so we can focus our efforts to make Leeds the Best City to Grow Old in. Collating key evidence and data to understand people's experiences of growing older in the city.

Following the publication of the report a consultation with 44 Leeds residents was undertaken to discuss the findings of the report and to understand people's experiences of growing older in the city.

A range of consultation and engagement activity has taken place which contributes to the development of Age Friendly Strategy. These include:

 The Age Friendly Partnership which brings together the statutory, voluntary and private sector to address a variety of priorities identified by older people in relation to make Leeds an age friendly city. The partnership meets on a quarterly basis and reports key successes and challenges to the Age Friendly Board and the Health and Wellbeing board. Each meeting is themed around a topic.

- Age Friendly Ambassadors supported by Leeds Older People's Forum
- Age Friendly Steering Group coordinated by Leeds Older People's
- Leeds Older People's Forum Board of Trustees
- Public Consultation for Leeds Parks and Green Spaces findings of the consultation were used to develop the AF Strategy and action plan
- Consultation on the housing priorities were linked to the Housing Strategy consultation that also informed the draft AF Strategy and action Plan
- Discussions have taken place through the Corporate Joint Consultative Committee Meeting and the Older Workers Staff Network to develop Employment and Learning domain
- Engagement and consultation session as part of Connecting Leeds Transport Strategy, the Vision Zero Road Safety Strategy and cycling strategy.
- Briefing for Councillor Arif Executive Member for Public Health and Active Lifestyles at Public Health.
- Briefing for Councillor Venner, Executive Member for Adults & Children's Social Care and Health Partnerships & Cllr Jenkins, Deputy Executive Member for Adults and Children's Social Care and Health.

b. Equality and diversity / cohesion and integration

- The strategy is underpinned by a number of cross cutting themes including tackling health inequalities and contributes towards several strategies and approaches within the city such as the Health and Wellbeing Strategy, the Inclusive Growth Strategy and work to become a Marmot city.
- The Age Friendly Strategy and associated action plain aims to ensure everyone
 can benefit from an age friendly city where people age well, regardless of where
 they live or their protected characteristics, enabling older people to be valued,
 feel respected and appreciated, and are seen as assets.
- By taking a cross council approach the strategy aims to influence widely to ensure age, as a protected characteristic, is considered in strategic priorities and plans.
- The strategy and action plan works with partners to recognise the barriers faced by older people who are, or are at risk of, being vulnerable, marginalised or disadvantaged, and put interventions in place to remove or reduce these barriers.

c. Council policies and city priorities

 Age Friendly Leeds is one of the eight interconnected priority areas of work set out in the <u>Best Council Plan 2020-2025</u> This work supports the vision of the Leeds Health and Wellbeing Strategy 2016-2021, contributing to outcome 2: People will live full, active and independent lives, and outcome 5: People will live in healthy, safe and sustainable communities. It also supports the Inclusive Growth Strategy's priority that Leeds is the best city for Health and Wellbeing by 2030.

Recommendations

- To consider what work is currently underway to support age friendly, winter planning and the cost-of-living crisis in local areas and how we could build on these further.

Inner South Community Committee - Finance Report

Purpose of report

1. This report provides the Community Committee with an update on the budget position for the Wellbeing Fund, Youth Activity Fund, Capital Budget, as well as the Community Infrastructure Levy Budget for 2022/23.

Main issues

- 2. Each Community Committee has been allocated a wellbeing budget (revenue and capital) and Youth Activities Fund which it is responsible for administering. The aim of these budgets is to support the social, economic and environmental wellbeing of the area and provide a range of activities for children and young people, by using the funding to support projects that contribute towards the delivery of local priorities.
- 3. A group applying to the Wellbeing Fund must fulfil various eligibility criteria, including evidencing appropriate management arrangements and financial controls are in place; have relevant policies to comply with legislation and best practice e.g. safeguarding and equal opportunities and be unable to cover the costs of the project from other funds.
- 4. Wellbeing funding cannot be paid retrospectively. An application form must be submitted and approved by the Community Committee before activities or items being purchased through wellbeing funding are completed or purchased.

- 5. The amount of wellbeing funding provided to each committee is calculated using a formula agreed by Council, taking into consideration both population and deprivation of an area.
- 6. Capital (CRIS) injections are provided as a result of council assets being sold. 5% of the sale price (up to a maximum of £100k) of a council asset is pooled city-wide and redistributed to the Community Committee areas on the basis of deprivation. The Community Committee will receive a new capital injection every 6 months.
- 7. Each Community Committee has also been allocated a Community Infrastructure Levy budget. For each CIL contribution, Leeds City Council retains up to 70-80% centrally, 5% is needed for administration and 15-25% goes to be spent locally. The money will be vested with the local Town or Parish Council if applicable, or with the local Community Committee and spend decided upon by that body. This local money is known as the 'Neighbourhood Fund' and should be spent on similar projects to the Wellbeing Fund (capital).
- 8. In the Inner South this means that the money will be administered by the Inner South Community Committee.
- 9. Following consultation, the Communities Team will work with members of the community committee, to develop a plan to spend CIL funding on local infrastructure projects. This will be on a case by case basis.
- 10. Projects eligible for funding by the Community Committee could be community events; environmental improvements; crime prevention initiatives, or opportunities for sport and healthy activities for all ages. In line with the Equality Act 2010, projects funded at public expense should provide services to citizens irrespective of their religion, sex, marital status, race, ethnic origin, age, sexual orientation or disability; the fund cannot be used to support an organisation's regular business running costs; it cannot fund projects promoting political or religious viewpoints to the exclusion of others; projects must represent good value for money and follow Leeds City Council Financial Regulations and the Council's Spending Money Wisely policy; applications should provide, where possible, three quotes for any works planned and demonstrate how the cost of the project is relative to the scale of beneficiaries; the fund cannot support projects which directly result in the business interests of any members of the organisation making a profit.
- 11. Any request for funding would involve discussions with appropriate ward members. Where projects do not have support from the Community Committee and are not approved, applicants are offered further discussions and feedback if this is requested.
- 12. In order to provide further assurance and transparency of all decisions made by the Community Committee, any projects that are not approved will be reported to a subsequent Community Committee meeting.

- 13. Sometimes urgent decisions may need to be made in between formal Community Committee meetings regarding the administration of Wellbeing and Youth Activity budgets, and also regarding the use of the Community Infrastructure Levy (CIL) Neighbourhood Fund which has been allocated to the Committee. Concurrently with the Committee, designated officers have delegated authority from the Director of Communities, Housing and Environment to take such decisions.
- 14. The Community Committee has approved the following 'minimum conditions' in order to reassure Members that all delegated decisions would be taken within an appropriate governance framework, with appropriate Member consultation and only when such conditions have been satisfied:
 - a) Consultation must be undertaken with all committee/relevant ward members prior to a delegated decision being taken.
 - b) A delegated decision must have support from a majority of the community committee elected members represented on the committee (or in the case of funds delegated by a community committee to individual wards, a majority of the ward councillors); and
 - c) Details of any decisions taken under such delegated authority will be reported to the next available community committee meeting for members' information.
- 15. Members are reminded that the necessary scrutiny of applications to satisfy our own processes, financial regulations and audit requires the deadline for receipt of completed applications to be at least five weeks prior to any Community Committee. Some applications will be approved via Delegated Decision Notice (DDN) following consultation with Members outside of the Community Committee meeting cycle.

Wellbeing Budget Position 2022/23

- 16. The total revenue budget approved by Executive Board for 2022/23 was £172,930. This works out at £57,643 per ward.
- 17. **Table 1** shows a carry forward figure of £191,420.75 which includes underspends from projects completed in 2021/22. £117,681.25 represents wellbeing allocated to projects in 2021/22 and not yet completed. The total revenue funding available to the Community Committee for 2022/23 is therefore £246,669.50. A full breakdown of the projects approved or ring-fenced is available on request.
- 18. It is possible that some of the projects may not use their allocated spend. This could be for several reasons, including the project no longer going ahead, the project not taking place within the dates specified in the funding agreement, or failure to submit monitoring reports. Due to this the final revenue balance may be greater than the amount specified in Table 1.
- 19. The Community Committee is asked to note that there is currently a remaining balance of £119,761.08 The ward split is as follows: Beeston & Holbeck (£41,404.40), Hunslet & Riverside (£32,028.07) and Middleton Park (£46,328.60). A full breakdown of the projects is listed in Table 1.

The regularity of the groups offers a chance for longer term relationships to be built with positive role models, create a new network of support, increase aspirations, and improved opportunities for some of the most vulnerable young people in our communities.

Monitoring Information

28. As part of their funding agreements, all projects which have had funding approved by the Community Committee are required to provide update reports on the progress of their project. These reports are so that the Community Committee can measure the impact the project has had on the community and the value for money achieved.

29. Detailed below are some of the project updates that the Communities Team has received since the last meeting of the Community Committee in June 2022:

Holbeck Food Bank (Beeston & Holbeck and Hunslet & Riverside)

- 30. Holbeck food bank has helped several thousand people and families since it began in 2012, supplying and delivering to residents in Beeston & Holbeck and Hunslet & Riverside. There has been a significant increase in demand during and since the pandemic.
- 31. These service users are residents who are in severe food poverty, who are referred by relevant agencies in the area and who otherwise might not have been able to access/travel to the foodbank to collect their parcel, due to lack of money or transport.
- 32. The project successfully delivered over 800 food parcels during the funding period which was delivered by 5 members of the Holbeck Food Bank Team.

33. Acre Road CCTV, LeedsWatch (Middleton Park)

The purpose of the grant was to install temporary CCTV on Acre Road, as this was a site of significant Anti-Social Behaviour and criminal damage. Issues include groups of young people throwing stones and other paraphernalia at buses, taxis, cars and residential properties.

After 6 months of deployment no incidents have been received or logged, which suggests that the behaviours and issues that were to be addressed have potentially been displaced.

The Police said 'From a police perspective, the camera has done a great job for us in reducing crime and ASB in this area. All the local youths were quickly made aware of its presence and the behaviour was displaced. Thanks again for all your work on this. I know the residents have had a much better 6 months since the camera was installed'

Youth Activities Fund Position 2022/23

- 34. The Youth Activity Fund is allocated based on population data at Ward level for young people aged between 8-17 years of age. The community committee YAF allocations have stayed the same as the previous year.
- 35. The total Inner South YAF budget approved for 2022/23 was £54,640. The ward balances which are below, are based on the number of 8-17 year olds per ward.
- 36. The total available for spend in the Inner South Community Committee 2022/23, including carry forward from previous year, is £106,639.85.
- 37. The Community Committee is asked to note that so far, a total of £49,487 has been allocated to YAF projects in 2022/23, as listed in **Table 2**.

- 38. The Community Committee is also asked to note that there is a remaining balance of £27,671.85 in the Youth Activity Fund.
- 39. The balances for wards are as follows: **Beeston & Holbeck: (£125.23), Hunslet & Riverside: (£7,970.96) and Middleton Park: (£19,575.66).**
