On this occasion there were no members of the public present at the meeting.

22 Minutes of the previous meeting

**RESOLVED** – To approve the minutes of the meeting held on 13<sup>th</sup> June 2022 as a correct record.

23 Highways - Annual Improvement Consultation

The report of the Executive Manager, Highways provided the Inner North East Community Committee with an update on the Highways Annual Improvement Consultation.

The presentation which was appended to the submitted report was shown at the meeting and the Community Committee were invited to make comments.

The Community Committee were informed of the following points:

- The consultation on next years' programme closed on 2<sup>nd</sup> September. Lists of the proposed works had been provided to Councillors and Parish Councils at the start of July requesting comments.
- Members were provided with an explanation of the Well-Managed Highway Infrastructure Code of Practice. 36 recommendations include: Lifecycle Plans, Inspections, Risk Management and Defect Repair.

Draft minutes to be approved at the meeting to be held on Monday, 28th November, 2022

- Explanation of how the Highway Infrastructure Asset Management Strategy aligns with the corporate vision and contributes to the vision for Leeds. It was noted that key factors of the strategy in Regional Context, Sustainability and Climate Emergency and Communication and Engagement.
- Funding allocations include City Region Sustainable Transport Settlements (CRSTS) and Leeds Capital.
- Members noted that the service is currently undertaking more preventative work which is surface dressing. It was noted that the life of a road is generally 10 years.
- The service is continually reviewing all streets, and these are added to a sheet with a colour code to show what stage of repair the road is in.
   All roads are inspected by an engineer and a scoring system is used and checked over a 3 year cycle. The service wish to get to the position that only 10% of roads are in poor condition.
- Each year all Members receive lists of roads requiring work and the priority given to them. Members are requested to make comments. Members were advised that all emails are noted and responded to.

Responding to direct questions from the Community Committee further information was provided:

- 60% of the work is carried out by internal DLO with 40% external contractors. It was noted that work was checked on site regularly.
   Members acknowledged that the checks were the same for both roads and pathways. The Council are also responsible for checking work carried out by the utility companies on the highways.
- Members were advised that letters are sent to residents informing them when work is to be undertaken and what the work will be, whether preventative or full refurbishment.

Members were of the view that works for traffic calming measures should be carried out whilst refurbishment works are being undertaken. It was acknowledged that Traffic Engineering do have a budget for traffic calming measures. The Chair requested an action to take traffic calming measures forward.

It was suggested that the letter which is sent to residents should be sent to Cllr Rafique so that he could suggest some ways in which the letters could be improved.

### 24 Age Friendly Leeds Strategy & Action Plan 2022-2025

The report of the Director of Public Health presented to the Inner North East Community Committee the refresh of the draft Age Friendly Strategy and Action Plan 2022-2025 to gain feedback. The report also requested support and promotion of the work of Age Friendly within the city.

The Community Committee were provided with the following points:

Draft minutes to be approved at the meeting to be held on Monday, 28th November, 2022

- Around 1 in 3 people are aged 50 and over. The number of Leeds residents aged 80 and over will increase by about 50% in the next 20 years.
- Age Friendly Leeds is one of the eight priorities in the Best Council Plan 2020-2025. The vision for Leeds is that it is a place where people age well, older people are valued, respected, appreciated and seen as assets.
- The draft Age Friendly Leeds Strategy 2022-25 has been reviewed and refreshed which has been informed by The State of Ageing in Leeds report. The process has been overseen by the Age Friendly Board chaired by Cllr Jenkins. The role of the Board is to provide strategic leadership and set the strategic direction for the Age Friendly Leeds work programme and ensure that the objectives are being met.
- Leeds is a member of the World Health Organisation Age Friendly
   Cities programme and has used and adapted the framework to identify
   and address barriers to the well-being and participation of older people.
- The strategy sets out six key priority areas: housing; public and civic spaces; travel and road safety; active, included and respected; healthy and independent ageing and employment and learning. Each of the priorities is headed by a domain lead. Domain leads have been identified and are working to implement the actions set out in the plan. The domain leads will feedback on a quarterly basis.
- The Leeds Older Peoples Forum (LOPF) gives practical ways for the local community to become involved to strengthen the age friendly approach and Councillors were invited to support and encourage people and businesses to get involved in:
  - The Age Friendly Ambassador Programme
  - o Becoming a Dementia Friend
  - Age and Dementia Friendly Businesses
  - The Come in and Rest Scheme
  - Leeds Older People's Age Friendly Steering Group
- Public Health are working with partners to support older people in Leeds to be as resilient as possible this winter. It was recognised that the cost-of-living crisis together with the impact that the cold weather can have on older people will require an approach to ensure proactive and preventative support is provided to those most at risk this winter. It was noted there are a range of services to support older people during cold weather including:
  - Information and Advice Service run through Age UK Leeds who can offer information and advice on a range of issues such as:
    - Money Matters
    - State Benefits
    - Housing Rights
    - Consumer issues
  - Home Plus Leeds whose aim is to enable and maintain independent living through improving health at home.
  - Lunch Clubs Public Health fund the annual Lunch Club Grants offering a financial contribution to support voluntary groups to provide hot nutritious meals and social activities for older people in a communal environment for 40 weeks per year.

- Sign up to receive Cold Weather Alerts
- 'Stay Well this Winter' Grants
- Become a winter friend

Cllr Jenkins attended the meeting and updated the Community Committee on the following issues:

- Cost of living and fuel crisis including priority register for energy companies and a pilot scheme looking at the use of slow cookers.
- Access buses and although there have been some difficulties with this service, it should be up and running again soon.
- Bus Fare Campaign to remove the charges for concessionary bus pass users before 9.30am on weekdays. It was noted that from Monday tickets would be charged at £2 per journey and £4 per day.
- Closure of ticket offices at railway stations.

The Community Committee discussions included:

- Resting places and toilet facilities for use by the elder in the community and the city centre.
- The need to address issues in relation to transport for the elderly.
- Access to clubs which can provide activities, exercise, and interaction with other like-minded people.
- Information for older people on the best diets for them.
- Free places for swimming and gentle exercise classes
- Give credit to businesses who make available resting places and use of facilities.
- More benches in local areas.

The Community Committee were of the view that social prescribing, although useful was inconsistent across the city.

Members requested more details on:

- Ambassador Programme
- Training in relation to becoming a Dementia Friendly Ambassador
- Come in and rest schemes
- To know if wards are represented on older people and age friendly steering groups
- To receive an Age Friendly Pack

Cllr Dowson as Chair challenged the Members to try to add 5 businesses per ward for the Come in and Rest initiative.

It was noted that the Community Committee were holding a cost of living workshop on Tuesday 4th October to discuss the current crisis and see how the voluntary sector could work collaboratively to offer support to those most in need.

- The Community Safety Sub-Group had held a workshop in relation to Anti-Social Behaviour. Cllr Rafique as Community Safety Champion provided the Community Committee with an update on the workshop.
- It was acknowledged that Cllr Harland the Executive Member for Communities was addressing the links between Community Committee Champions and Executive Board Members.

### **Inner North East Community Committee - Finance Report**

### **Purpose of report**

1. This report provides the Community Committee with an update on the budget position for the Wellbeing Fund, Youth Activity Fund as well as the CRIS and Community Infrastructure Levy Budget for 2022/23.

#### Main issues

- 2. Each Community Committee has been allocated a wellbeing budget (revenue and capital) and Youth Activities Fund which it is responsible for administering. The aim of these budgets is to support the social, economic and environmental wellbeing of the area and provide a range of activities for children and young people, by using the funding to support projects that contribute towards the delivery of local priorities.
- 3. A group applying to the Wellbeing Fund must fulfil various eligibility criteria, including evidencing appropriate management arrangements and financial controls are in place; have relevant policies to comply with legislation and best practice e.g., safeguarding and equal opportunities and be unable to cover the costs of the project from other funds.
- **4.** Wellbeing funding cannot be paid retrospectively. An application form must be submitted and approved by the Community Committee before activities or items being purchased through wellbeing funding are completed or purchased.

- **5.** The amount of wellbeing funding provided to each committee is calculated using a formula agreed by Council, taking into consideration both population and deprivation of an area.
- **6.** Capital (CRIS) injections are provided as a result of council assets being sold. 5% of the sale price (up to a maximum of £100k) of a council asset is pooled city-wide and redistributed to the Community Committee areas on the basis of deprivation. The Community Committee will receive a new capital injection every 6 months.
- 7. Each Community Committee has also been allocated a Community Infrastructure Levy budget. For each CIL contribution, Leeds City Council retains up to 70-80% centrally, 5% is needed for administration and 15-25% goes to be spent locally. The money will be vested with the local Town or Parish Council if applicable, or with the local Community Committee and spend decided upon by that body. This local money is known as the 'Neighbourhood Fund' and should be spent on similar projects to the Wellbeing Fund (capital).
- **8.** In the Inner North East Community Committee this means that the money for Chapel Allerton, Roundhay and Moortown will be administered by the Inner North East Community Committee.
- 9. It was agreed at the Inner North East Community Committee March 2018 that CIL monies for Chapel Allerton, Roundhay and Moortown would be spent in the Community Committee ward that it was generated in. At the INE Finance Sub Group meeting on 9 July 2020 it was agreed that decisions for CIL needs to be agreed at the relevant ward meeting or by contacting the 3 Ward Councillors. The exception is if the funding is over £25k it needs to be agreed at INE Finance Sub Group and ratified at INE Community Committee meeting.
- 10. Projects eligible for funding by the Community Committee could be community events; environmental improvements; crime prevention initiatives, or opportunities for sport and healthy activities for all ages. In line with the Equality Act 2010, projects funded at public expense should provide services to citizens irrespective of their age, disability, gender reassignment, marriage and civil partnership, pregnancy and maternity, race, religion or belief, sex, and sexual orientation; the fund cannot be used to support an organisation's regular business running costs; it cannot fund projects promoting political or religious viewpoints to the exclusion of others; projects must represent good value for money and follow Leeds City Council Financial Regulations and the Council's Spending Money Wisely policy; applications should provide, where possible, three quotes for any works planned and demonstrate how the cost of the project is relative to the scale of beneficiaries; the fund cannot support projects which directly result in the business interests of any members of the organisation making a profit.
- **11.** Any request for funding would involve discussions with appropriate ward members. Where projects do not have support from the Community Committee and are not approved, applicants are offered further discussions and feedback if this is requested.

- **12.** In order to provide further assurance and transparency of all decisions made by the Community Committee, any projects that are not approved will be reported to a subsequent Community Committee meeting.
- 13. Sometimes urgent decisions may need to be made in between formal Community Committee meetings regarding the administration of wellbeing and youth activity budgets and regarding the use of the Community Infrastructure Levy (CIL) Neighbourhood Fund which has been allocated to the Community Committee. Alongside the Committee, designated officers have delegated authority from the Director of Communities and Environment to take such decisions.
- **14.** The Community Committee has previously approved the following 'minimum conditions' in order to reassure Members that all delegated decisions would be taken within an appropriate governance framework, with appropriate Member consultation and only when the following 'minimum conditions' have been satisfied:
  - a. consultation must be undertaken with all committee/relevant ward members prior to a delegated decision being taken.
  - b. a delegated decision must have support from a majority of the Community Committee elected members represented on the committee (or in the case of funds delegated by a Community Committee to individual wards, a majority of the ward councillors).
  - c. Details of any decisions taken under such delegated authority will be reported to the next available Community Committee meeting for members' information.
- 15. Members are reminded that the necessary scrutiny of applications to satisfy our own processes, financial regulations and audit requires the deadline for receipt of completed applications to be at least five weeks prior to any Community Committee. Some applications will be approved via Delegated Decision Notice (DDN) following consultation with Members outside of the Community Committee meeting cycle.
- 16. Wellbeing Fund applications and Youth Activity Fund applications are considered at Finance and Policy Sub Group meetings, a sub group of the Community Committee. This group comprises a nominated Elected Member from each of the wards in the Inner North East Community Committee; Chapel Allerton, Moortown and Roundhay. The sub group makes the recommendations to award funding for projects which is then ratified by the Inner North East Community Committee.
- 17. Members are asked to review the minimum conditions as set out in paragraph 14 of this report, consider whether any amendments are required and approve such conditions for operation in 2022/2023. These conditions would need to be satisfied prior to an urgent delegated decision being taken in between formal Community Committee meetings in respect of the administration of Wellbeing and Youth Activity budgets and also the use of the CIL Neighbourhood Fund which has been allocated to the Committee.

**18.** The Inner North East Community Committee Finance Sub Group would like to make Members aware that in future years there may be a decrease in funds allocated to the ward pot funding due to the reduction in Wellbeing Budget over the last 5 years.

### **Wellbeing Budget Position 2022/23**

- **19.** The total revenue budget approved by Executive Board for 2022/23 was £81,850.00. **Table 1** shows a carry forward figure of £82,641.15 which includes underspends from projects completed in 2021/22. £7,705.60 represents wellbeing allocated to projects in 2021/22 and not yet completed. The total revenue funding available to the Community Committee for 2022/23 is therefore £156,785.55. A full breakdown of the projects approved or ring-fenced is available on request.
- 20. It is possible that some of the projects may not use their allocated spend. This could be for several reasons, including the project no longer going ahead, the project not taking place within the dates specified in the funding agreement, or failure to submit monitoring reports. Due to this the final revenue balance may be greater than the amount specified in Table 1.
- **21.**Community Committee is asked to note that, at the time of writing the report, there is currently a remaining balance of £35,712.48. A full breakdown of the projects is listed in Table 1 and is available on request.

**Project Description:** Meanwood Valley Trail Heritage, Wellbeing and Inclusivity Plan

The Meanwood Valley Trail Heritage, Wellbeing and Inclusivity Plan is part of an overarching project which will improve and protect the green corridor for biodiversity, and support the health and wellbeing of the communities surrounding it. We want to bid for around £3-5million from the National Lottery Heritage Fund and to do that we need to gather evidence, engage with local people and create plans. We have already produced an overarching Landscape strategy (funded by and Awards for All grant to Meanwood Valley Partnership) – you can see a summary here <a href="https://storymaps.arcgis.com/stories/cbe0be22f7404b8ca110efc9063f1e5a">https://storymaps.arcgis.com/stories/cbe0be22f7404b8ca110efc9063f1e5a</a> and the subsequent Biodiversity and Climate Resilience Plan which was funded by Yorkshire Wildlife Trust and Environment Agency.

Funding from the Inner NE Area Committee would pay towards -Engagement events in Meanwood and the Sugarwell Hill area along with a crayfish event in Meanwood Park. This would involve an environment specialist and up to 10 volunteers who could become crayfish ambassadors.

The wider project will include a detailed survey of footpaths, ways into the trail from local neighbourhoods and other aspects which effect the human experience along the trail by landscape architects to inform plans to increase access by a wider range of people and improve disabled access where possible.

# **Inner North East Community Committee – Update Report**

## **Purpose of report**

- 1. To bring to members' attention an update of the work which the Communities Team is engaged in, based on priorities identified by the Community Committee. It also provides opportunities for further questioning, or to request a more detailed report on a particular issue.
- 2. This report provides regular updates on some of the key activities between Community Committee meetings and functions delegated to Community Committees, Community Champions roles, community engagement, partnership and locality working.

Main issues
Updates by theme
Children and Families - Councillor Zara Hussain

#### **Youth Service**

- 3. Staff from the Youth Services team have been actively engaging with young people during the Halloween/Bonfire night period about how to keep themselves safe and steer away from ASB activities. Additional support has been provided by the Neighbourhood Policing Team who were carrying out extra patrols in areas that have had an increase in ASB in the past during these busy periods.
- 4. Youth services will be attending the INE Youth Summit, and they will have a stall there to promote their youth club activities/provision.
- 5. All the core youth club sessions are taking place across the 3 wards.

- 6. The Inner North East Youth Summit took place on Thursday 17<sup>th</sup> November at the Civic Hall in Leeds. It was well attended by 60 children from 5 primary and 2 secondary schools in the Inner North East area.
- 7. The inspiring event engaged with local schools to support their pupils to attend the event as representatives of children and young people in their area, a lot of the pupils were on their own school councils. Pupils learnt about local democracy and council services through a presentation led by the Voice and Influence Team, as well as learning about previously funded youth activities and have a say on what activities they would like to see funded in their local area in the future. The young people also had the opportunity to ask the Lord Mayor and the ward councillors various questions about their respective roles and on local and national issues of importance to them.









# **Environment: Councillor Jordan Bowden Cleaner Neighbourhoods Team**

- 8. De leafing has started and the team have a schedule for the streets/roads that will need to be focused on. Ward members are encouraged to go through the usual reporting channels so that any referrals can be raised and actioned.
- 9. Ongoing issues with housing land located between 27/29 Reginald Street, awaiting housing to authorise new fencing to be erected to prevent any future issues.
- 10. Back Newton Groves issues have now been resolved with the owner and there will be on going monitoring.
- 11. CNT have extra resources across the City for Cover over the Bonfire Period, all contact numbers have been distributed to the police and other partners as required.

#### **Enforcement**

- 12.CNT has had great success with a vacant property on Stainbeck Lane whereby the owner has now agreed to sell the property with an auction house and all legal papers have been signed.
- 13. CNT have additional capacity to focus on Enforcement work as they have had a new member join their team recently.

# WINTER FRIENDS SCHEME TO BE LAUNCH TO STAY SAFE DURING THE WINTER

14. Winter Friend scheme recruits' volunteers who are friendly and helpful member of the community who assist the elderly or the most vulnerable with day-to-day tasks from gritting a neighbour's path when it gets icy to sharing local knowledge or a warming winter recipe! They are thoughtful and approachable volunteers – sensing when someone needs a bit of support and offering a hand without expecting anything in return.

#### **Cost of Living Workshop**

15. The INE Community Committee held a cost of living workshop for staff/volunteers who work in the third sector at the Polish Centre, Chapeltown on Monday 4<sup>th</sup> October. It was well attended by 20 people and guest speakers came from Money Buddies, Citizen Advice Bureau, Clinical Commissioning Group, Give a Gift (local charity) and Fareshare.





#### FREE THERAPY SESSIONS FOR THOSE WHO CARE FOR OTHERS.

- 16. There are six free therapy sessions on offer with the possibility of another six free sessions after consultation with the client and therapist if you are experiencing feeling difficult to cope with after caring for others during the Covid-19 epidemic. There is also an opportunity to have an initial informal wellbeing 'chat' with a counsellor if you are unsure.

- 18. The key messages are these:
  - The service is completely free and confidential, wherever you work, and offers
    advice and support that can help with a range of issues. The Hub is for everyone –
    including volunteers.
  - The staff support line operates every day, 8am-8pm and is staffed by trained listeners. Call free on 0808 196 3833.
  - You can self-refer for one-to-one therapy. Referrals are actioned within one
    working day and a first appointment will be offered for within a week. This is their

#### **Community Safety: Councillor Mohammed Rafique**

- 19. LASBAT currently has 24 active cases across the Inner North East area. No real trends in terms of case type nor location.
- 20. New cases opened in the last 3 months

Chapel Allerton – 5 cases of which 4 x ASB, 1 x Hate.

- 21. LASBT took part in the Police Control HUB set up at the Reginald Centre over the Bank Holiday/Carnival Weekend.
- 22. Zermatt Street noise seizure and impending prosecution of the tenant of the Together Housing property.
- 23. Sackville Street inspected a set of 4 properties with the Rogue Landlord Unit that had previously been used for cannabis cultivation to confirm they were being brought back to use as decent housing.
- 24. Potternewton Heights An injunction against a tenant has been postponed for now due to some excellent joined up working with Adult Social Care arranging for carers to see the tenant on a more regular basis which is having a positive effect on behaviours and vastly reducing complaints of ASB.

# Tenant Engagement Update COVID-19.

#### **Engagement / Involvement**

- 25. Still no meeting commencement date for Button Hill TRA though in contact with Chair.
- 26. While numbers of formal groups are low in the area the tenant engagement officer continue to work with the numerous local community groups and organisations.
- 27. On-line walkabouts now agreed with Housing Managers. One will be carried out in each HAP area per quarter. Currently talking to office about which areas to prioritise. Once it has gone live information will be passed on to Councillors.

#### **Housing Advisory Panels**

- 28. INE HAP started the year in April with a budget of £30,761.85 (including a carry-over from last year of £1,026.89).
- 29. Spend up to and including meeting of 7 November 2022 £18,908.26 (61.47%)
- 30. Recent approvals included:
  - a. Contribution to upgrade of Norma Hutchinson Park,
  - b. Part funding of INE Thank You Event,
  - c. Stonehill's installation of barrier to prevent unauthorised access.
- 31. Still have vacancies for Housing Leeds residents on Inner North East Housing Advisory Panel.

#### **Community Payback / Green Guardians**

32. Community Payback – No additional contract with Housing though some work still being completed. Working on backlog of projects.

33. Green Guardians is a project set up by Groundwork Leeds to assist vulnerable residents with overgrown gardens. The project ended at the end of September. INE area did get the referrals required. They currently await the final report.

#### **Working In Partnership**

- 34. Regular conversations with Localities Officers in both areas on potential projects, bids etc.
- 35. Continued work with community organisations e.g., InterAct, BCA etc
- 36. Worked/attended a number of community events through the summer including Chapel Allerton Festival, Meanwood Olympics and Roundhay Park celebrations.
- 37. Continue to assist groups identifying funding opportunities through Funding Leeds.

38. Leeds City Council welcome hub for Ukrainian arrivals to Leeds. Working collaboratively with internal and external key stakeholders to offer a warm welcome to Ukrainian refugee arrivals.

### **Chapel Allerton Library – August to October 2022**

- 56. 1st Aug 15th Aug 22nd Aug Summer Reading Challenge drop in session run for pupils from St Matthews school, as part of targeted SRC project work. Craft activity and book engagement sessions encouraging children to join and complete the challenge and maintain their reading over the school holidays.
- 57.6th Aug Rainbow-themed Storytime to celebrate kindness and diversity on Leeds Pride weekend. Around 35 in attendance, very positive feedback.

Digi drop in: 26th Sep.

- 58. First Steps with Digital: course delivered to 3 learners (absolute beginners) over three weeks in September.
- 59. **Chapel Allerton Arts Festival:** Chapel Allerton Library hosted a number of very successful and well attended events in partnership with the festival. These included author Daisy Hildyard in conversation with Stu Hennigan (31<sup>st</sup> Aug), a Crochet workshop run by Emma and Nat from the Art Library (1<sup>st</sup> Sep), a Sphero Sorcery coding and storytelling event for children, and hosting acoustic music performances by five artists as a venue on the Café Run (both 3<sup>rd</sup> Sep). It was brilliant to see the library space hosting this range of activity, and to draw such a wide and varied audience.

60. **PATH Yorkshire**: Intro to library session delivered to member of ESOL for Refugees group, 20<sup>th</sup> September.

#### Oakwood Library – August to October 2022

61.9<sup>th</sup> Aug – Fly Away Home: librarian led junk modelling activity based around flight engineering, linking in with Summer Reading Challenge. Sold out in advance, 6 families in attendance on the day, a total of 16 attendees (11 children and 5 adults).

#### **Other Updates**

#### **Business Centre**

62. The Neighbourhood Centres Co-ordinator (NCC) regularly checks on empty premises in the 3 district centres (and other areas of the city) and is revisiting shops and offices in Chapel Allerton before Christmas to see how business is doing and add new ones to the update link. Whilst the majority of chains and banks wishing to reduce their high street presence left during the lockdowns, their vacancies have largely been quickly filled by independents who in many cases bring a fresh offer. But mounting pressures on businesses and landlords include lockdown-based loan and debt repayments and low footfall due to rising prices. The NCC is linking with the businesses and Council departments to find ways to increase shop-local encouragement to residents, B2B, including online sales etc.

Information to help business areas and develop partnership working between the public and private sector continues to be circulated to businesses wishing to receive it in Moortown, Chapel Allerton and Roundhay.
