## 37 Matters arising from the Minutes

Further to Minute No. 28, Approval of Pay Policy Statement 2024/25, the following information had been provided to Members with regard to employer contributions to the pension scheme:

As the scheme is funded at c. 113%, we understand that the district finance directors have raised this with the fund in their private conversations. The fund director has responded that funding levels won't be considered again until the next actuarial review period (March 2026). As such the issue has not been progressed or raised at any formal meeting/committee either in Leeds or at WYPF.

The current rates are set for both employees and the employer in the pension regulations and therefore cannot be changed. Regulation 9 in relation to employee contributions and regulation 67 in relation to the employers contribution, sets out the basis of the contributions (see below).

Leeds City Council received notification from the West Yorkshire Pension Fund confirming the employer contribution rates from 1 April 2023 to 31 March 2026. Finance have confirmed the employer contribution rates included in the budget for 24/25 are increasing by .1% from 15.7% to 15.8% and this is confirmed in the budget papers.

# **Regulations – for information**

Regulation 9 (1) – Subject to regulation 10 (temporary reduction in contributions (50/50) scheme)), an active member must pay contributions to the scheme in respect of an employment at the contribution rate applicable to the annual pensionable pay that member is receiving in the pay period in which 1<sup>st</sup> April falls for that employment (or in the case of an active member whose membership commences after 1<sup>st</sup> April in any year, on the annual pensionable pay the member receives at the commencement of that membership)

Regulation 67 (1) – A Scheme employer must contribute to the appropriate fund in each year covered by a rates and adjustment certificate under regulation 62 (actuarial variations of pension funds) or 64 (circumstances in which revised actuarial valuations and certificates must be obtained) the amount appropriate for that authority as calculated in accordance with the certificate and paragraph (4)

# 38 Review of the Constitution

The report of the City Solicitor sought agreement from the General Purposes Committee about the detailed amendments falling within the agreed scope of the review of the Constitution. The details relate to amendments to Part 2 Article 13 of the Constitution and Part 4 (b) the Executive and Decision Making Rules.

The recommended option for change is considered the most appropriate in responding to the drivers for the review, having considered a wide range of options, having done extensive engagement and benchmarking work. It will strike a reasonable balance between speeding up decision making, reducing bureaucracy and resource required, retaining openness and engagement with the public and being in line with statutory requirements.

In addition, the report also updated the Committee about changes to the Contract Procedure Rules (Part 4(h)) which are to be approved by the Chief Finance Officer under delegated powers.

In response to a question, it was confirmed that there would not be any changes to call-in requirements.

# Brief summary

Following the adoption of an amended Article 15 by Full Council on 26<sup>th</sup> May 2022 this report updates General Purposes Committee of the use of the powers under Article 15.2.3 of the Constitution by the Monitoring Officer since they were last reported on 26 July 2023.

# Recommendations

General Purposes Committee are requested to note the use of the powers of the Monitoring Officer.

# What is this report about?

- 1. Article 15.2.3 provides power for the Monitoring Officer to update the Constitution under the following circumstances:
  - i. as a result of legislative change or decisions of the Council or Executive to enable him/her to maintain it up to date;
  - ii. for the purposes of clarification only; or
  - iii. where the Monitoring Officer is of the opinion such changes are de minimus and required for administrative or updating purposes only and for which there is unanimous agreement between the Leader of each political group or
  - iv. to Part 5(d) Protocol for the Roles of Members and Officers in Decision Making in consultation with the Leader of the Council, Opposition Members of Executive Board and the Chief Officer Financial Services.
- 2. This report updates General Purposes Committee as to the use of the above power by the Monitoring Officer since 26 July 2023.

- 3. Since then, the Monitoring Officer has approved five amendments to the Constitution pursuant to Article 15.2.3, the detail of which is set out in paragraphs 4 7 below.
- 4. On 18 March 2024 two consequential changes were made (i) to the Members' Allowances Scheme to reflect Full Council's consideration and approval of recommendations made by the Independent Remuneration Panel The Delegated Decision Notice (DDN) reference D57283 can be accessed <u>here</u> and (ii) to amend the Budget and Policy Framework following Full Council's approval of the Best City Ambition Update 2024. The Delegated Decision Notice (DDN) reference D57286 can be accessed <u>here</u>.
- 5. On 15 May 2024 changes were made throughout the constitution to update references to organisations, post titles and to reflect legislative changes. The DDN reference D57443 can be accessed <u>here</u>.
- 6. On 3 June 2024 changes were made to Article 6 (Scrutiny Boards) and the Scrutiny Board Procedure Rules to reflect legislative changes introduced by the Health and Care Act 2022. The DDN reference D57492 can be accessed <u>here</u>.
- 7. Finally, on 12 June 2024 a minor amendment to the Executive and Decision Making Procedure Rules was made to rectify an erroneous paragraph reference. The DDR reference D57502 can be accessed <u>here</u>.

# Elected Member Appointments to Outside Bodies

# Brief summary

This report outlines the General Purposes Committee's role in relation to Elected Member appointments to Outside Bodies and seeks agreement to schedules detailing those organisations that the Council will continue to make an appointment to; and agreement of the nominations to those organisations which fall to this Committee to make an appointment to.

Determination of the appointments is based on specific criteria set out in the Appointments to Outside Bodies Procedure Rules and supports the aims of the Best City Ambition to work with all communities as a team for Leeds and by supporting what the Council and its partners are focussing on during the 2024/25 Municipal Year to improve outcomes.

**Recommendations –** The Committee is asked to:

- a) Note the process set out in the Appointments to Outside Bodies Procedure Rules which this Committee follows when making appointments, attached at Appendix 1 of this report,
- b) Note the information contained in **paragraph 11** relating to organisations that either no longer require Elected Member representation or a change to the number of seats available,
- c) Note the current position with regards to new and existing Outside Bodies which required appointments since the last General Purposes Committee and were confirmed through the delegated decision process as outlined in **paragraph 12**,
- d) Consider the current position in relation to Elected Member appointments to Outside Bodies and 'Other Bodies' detailed in paragraph 4 and Appendix 2 and where appointments fall to General Purposes Committee to make; and
- confirm that the Council will continue to make an appointment to those organisations listed as "Strategic and Key" partnerships.
- consider and approve those Members which they would wish to appoint to serve on the organisations listed in Appendix 2
- e) Confirm the designation of those Outside Bodies included within the schedule at Appendix 3 as "Community and Local Engagement" and confirm that appointments to these bodies will be approved by the relevant Community Committees.

# What is this report about?

- 1 Under the Appointments to Outside Bodies Procedure Rules, General Purposes Committee is requested to review the list of notified Outside Bodies (and 'Other Bodies') on an annual basis and to determine whether the Council should make/continue to make an appointment to those bodies. Throughout the year, General Purposes Committee may consider any changes necessary to the appointments.
- 2 Determination is based on one or more of the following criteria being met:
  - the proposed appointment is a statutory requirement;
  - the proposed appointment would be consistent with the Council's policy or strategic objectives; and/or
  - the proposed appointment would add value to the Council's activities.
- 3 The process by which this is undertaken is detailed in the Appointment to Outside Bodies Procedure Rules – a copy of the full Procedure Rules is attached at **Appendix 1**.
- 4 The current schedule of Outside Bodies and 'other bodies' to which this Committee makes appointments is attached at **Appendix 2**. This schedule was last agreed by General Purposes Committee on 26<sup>th</sup> July 2023.
- 5 In relation to these appointments the Committee is asked to:
  - confirm that the Council will continue to make an appointment to those organisations listed;
  - confirm the allocation of responsibility for appointments to General Purposes Committee;
  - consider and determine those Members which they would wish to appoint to serve on the organisations listed in **Appendix 2**; and
  - confirm the allocation of responsibility for appointment to the organisations listed in **Appendix 3** to the Community Committees
- 6 Members are reminded that where an Outside Body has been categorised as a 'Strategic and Key Partnership', the appointment will be made by General Purposes Committee and these are identified in Appendix 2. In cases where an Outside Body has been categorised as 'Community and Local Engagement' (as shown in Appendix 3), the appointment will be made by the appropriate Community Committee subject to this Committee confirming the allocation of responsibility for appointment to the organisations to the Community Committees.
- 7 The appointment procedure advises General Purposes Committee to have regard to the principle of securing an overall allocation of places which reflects the proportion of Members from each Political Group on the Council as a whole, and to have regard to a Member's current interests prior to making any appointment to avoid any potential conflict of interest.
- 8 Elected Members should normally fill all available appointments and all appointments are subject to annual change unless otherwise stated in the constitution of the external organisation. Each appointment (including in-year replacements) runs for the municipal year, ending at the next Annual Council Meeting.
- 9 It is recognised that Party Groups may not wish to take up vacancies which are made available to them. In such circumstances, vacancies will be notified to this Committee and agreement sought as to whether the vacancy will be filled.

- 10 Group Whips were contacted in advance of this meeting seeking consideration of their Group nominations in readiness for consideration by General Purposes Committee, or to confirm they are to remain the same. Notifications are set out in the 2024/25 nominations column within Appendix 2. An updated schedule will be circulated in advance of the meeting to ensure the Committee considers the latest position.
- 11 The Committee is advised that those organisations listed below have given notification that they no longer meet or no longer require the Council to nominate/appoint an Elected Member;
  - Nell Bank Centre On 22<sup>nd</sup> August 2023, the Council was notified that the Nell Bank Charitable Trust had taken over full financial and operational responsibility for the Nell Bank Centre and now appoints its directors and members directly. The constitution of the Nell Bank Charitable Trust no longer requires a Leeds elected Member to be appointed.
  - Housing Advisory Panels Local Housing Advisory Panels ceased to operate at the end of March 2024 and revised Tenant Engagement arrangements are in place. Previous references to them in Appendix 3 (schedule of Outside Body appointments delegated to the Community Committees) have been removed.
  - Inclusive Growth Delivery Partnership the Partnership no longer operates.

# Appointments made since the last General Purposes Committee in July 2023

- 12 Paragraph 4.5 of the Appointments to Outside Bodies Procedure Rules delegates authority to the City Solicitor to confirm appointments during the Municipal Year, and in line with the requirements of paragraph 4.5 (iv) theses are listed below:
  - 09 08 23 Leeds Heritage Theatres Board Appointment of Councillor Dowson and Councillor Stephenson.
  - 31 08 23 The Robert Salter Charity Councillor McCluskey replaced Councillor Dowson.
  - 07 11 23 Armed Forces Champions Appointment of Councillor Blackburn.

13 Determination of the appointments is based on specific criteria set out in the Outside Bodies Procedure Rules and supports the aims of the Best City Ambition to work with all communities as a team for Leeds and by supporting what the Council and its partners are focussing on during the 2024/25 Municipal Year to improve outcomes.

- 15 Prior to this meeting of General Purposes Committee, Group Whips were contacted seeking consideration of their Group nominations, or to confirm they are to remain the same.
- 16 Additionally, Group Whips are consulted in relation to any appointments made outside of a Committee meeting and are provided with the Outside Body and Other Bodies appointments schedule in May/June each year in order to consider appointments and vacancies in readiness for the annual review.

#### What are the resource implications?

17 There are no resource or value for money implications as a result of this report.

## What are the key risks and how are they being managed?

18 There are no risk implications as a result of this report.

#### What are the legal implications?

- 19 Full Council has delegated responsibility to General Purposes Committee for:
  - determining which outside bodies should have Member representation and, by determining the category of each such outside body, determining how such appointments should be made; and
  - making appointments to outside bodies categorised as Strategic and Key Partnership.
- 20 If a Councillor is nominated to an Outside Body by the Council, then that Councillor is covered by The Local Authorities (Indemnities for Members and Officers) Order 2004. For example, should someone attempt to take civil action against a Councillor personally in their role as a Council appointed trustee/director of an Outside Body; then the Council would cover the cost of defending the action against that Councillor, and if the action were successful the Council would cover any compensation which the Councillor had to pay. The only exceptions to this are to any action or failure to act which "constitutes a criminal offence; or is the result of fraud, or other deliberate wrongdoing or recklessness on the part of that Member.
- 21 The indemnity applies to any company, trust or charity to which a Member is appointed and applies in respect of director or trustee appointments.

If a Member becomes a trustee or director but has not been nominated by the Council, then the indemnity will not apply, and the Member should check that the trust, company etc. has got appropriate insurance cover for its trustees/directors.

This report relates to a Council function and therefore, is not available for call-in.

# **Options, timescales and measuring success**

# What other options were considered?

22 The alternative option of not to make appointments has been discounted as this would not support the aims of the Best City Ambition.

# How will success be measured?

23 In making appointments to Outside Bodies, the Council will put Elected Members at the heart of partnership working with local communities, Third Sector and Voluntary Sector partners, allowing greater engagement and involvement in discussions on work towards common goals.

# What is the timetable and who will be responsible for implementation?

- 28 As soon as possible after this meeting,
  - Democratic Services (via Group Office Managers) will notify Members of the appointments,
  - Democratic Services (via Governance Services) will advise each Outside Body/Other Body of the appointment (s) to their organisation.

# APPOINTMENTS TO OUTSIDE BODIES PROCEDURE RULES

#### 1.0 Scope

- 1.1 These Procedure Rules relate to those external organisations and partnerships (referred to as *Outside Bodies*) which have requested the Council to appoint an Elected Member (or suitable nominee<sup>1</sup>) to them
- 1.2 For the avoidance of doubt, these Procedure Rules do not apply to appointments which are reserved to Council. These are listed separately in Part Three (Section 1) of the Constitution Responsibility for Local Choice Functions.
- 1.3 Additionally it is recognised that, often at a local level, individual Elected Members may be personally approached to attend meetings of a variety of organisations in their personal capacity rather than in their capacity as a Councillor. Such instances are not covered within the scope of these Procedure Rules.

#### 2.0 Determination of Outside Bodies to which an Appointment should be Made

- 2.1 The Head of Democratic Services will maintain a list of all Outside Bodies to which the Council appoints an Elected Member.
- 2.2 Each year the General Purposes Committee will review the list of notified Outside Bodies and will determine whether the Council should make/continue to make an appointment to those bodies.
- 2.3 Determination will be based on one or more of the following criteria being met:
  - the proposed appointment is a statutory requirement;
  - the proposed appointment would be consistent with the Council's policy or strategic objectives; and/or
  - the proposed appointment would add value to the Council's activities.
- 2.4 Requests from an Outside body to make an appointment received after such an annual review will be referred to the relevant Director who will:
  - Provide advice on whether the Outside Body meets one or more of the criteria in Rule 2.3; and;
  - Identify the Lead Officer to work with the appointed Member should an appointment be made to the Strategic and Key Partnerships category.
- 2.5 Such requests will then be referred to the General Purposes Committee for determination by reference to the same criteria.

<sup>&</sup>lt;sup>1</sup> Which shall include an appointment of an individual, who is not an elected member, made upon the nomination of an elected member when such a nomination is a requirement of statute and/or the Trust Deed of a registered charity.

# 3.0 Determination of how an Appointment should be made

- 3.1 Where an organisation is deemed to have met one or more of these criteria, the General Purposes Committee will allocate it into one of the following categories.
  - **Strategic and Key Partnerships** participation contributes to the Council's strategic functions, priorities and community leadership role.
  - **Community and Local Engagement** not necessary to fulfil strategic or key partnership role but, nonetheless, beneficial in terms of leading, engaging and supporting the community from an or ward perspective
- 3.2 Where an Outside Body has been categorised as **Strategic and Key Partnership**, appointment to it will be made by the General Purposes Committee.
- 3.3 Where an Outside Body has been categorised as **Community and Local Engagement**, appointment to it will be made by the appropriate Community Committee.
- 3.4 Where a political group has been allocated a position to fill, then that position must be filled by Elected Members from the political group that has been allocated the place.
- 3.5 Should a political group wish to cede a place to another political group or where an appointment of an individual other than an elected Member is being considered, then such appointments must be made by either the General Purposes Committee, or if delegated, by the Community Committee with that authority.
- 3.6 Where it is not clear as to which particular Community Committee should make an appointment, the General Purposes Committee will refer the request to the relevant Community Committee Chairs who will determine which is the appropriate Community Committee to make the appointment. This will be reported to the next meeting of the Community Committee.

# 4.0 The Appointment Procedure

## Strategic and Key Partnerships

- 4.1 The General Purposes Committee will first consider whether it is appropriate for an appointment to be of a specific office holder<sup>2</sup> either by reference to the constitution of the outside body concerned or in the light of any other circumstances as determined by the General Purposes Committee. Such appointments will then be offered on this basis.
- 4.2 Nominations will then be sought for the remaining places. The General Purposes Committee should have regard to a Member's current interests prior to making any appointment. The General Purposes Committee will have regard to the principle of

securing an overall allocation of places which reflects the proportion of Members from each Political Group on the Council as a whole.

- 4.3 All appointments are subject to annual change unless otherwise stated in the constitution of the external organisation. Each appointment (including in-year replacements) runs for the municipal year, ending at the next Annual Council Meeting.
- 4.4 A vacancy occurring during the municipal year will normally be referred to the General Purposes Committee for an appointment to be made, having regard to the principles as described above.
- 4.5 The City Solicitor will have delegated authority to make an appointment in the following circumstances:
  - (i) where an appointment has been agreed by the General Purposes Committee as a Whips nominee and the appropriate group Whip subsequently submits a nomination;
  - (ii) where a group Whip wishes to replace a Member previously approved by the General Purposes Committee with another Member of the same group; and/or
  - (iii) where an organisation requires an appointment prior to the next meeting of the General Purposes Committee, subject to this appointment being agreed by all Group Whips or their nominee.
  - (iv) That any instances of this delegation being used be reported to the next meeting of the General Purposes Committee

# Community and Local Partnerships

- 4.6 The Community Committee will first consider whether it is appropriate for an appointment to be of a specific office holder<sup>3</sup> either by reference to the constitution of the outside body concerned or in the light of any other circumstances as determined by the Community Committee. Such appointments will then be offered on this basis.
- 4.7 Nominations will then be sought for the remaining places, having regard to trying to secure an overall allocation of places which reflects the proportion of Members from each Political Group on the area as a whole.
- 4.8 All appointments are subject to annual change unless otherwise stated in the constitution of the external organisation. Each appointment (including in-year replacements) runs for the municipal year, ending at the next Annual Council Meeting.
- 4.9 A vacancy occurring during the municipal year will normally be referred to the Community Committee for an appointment to be made, having regard to the principles as described above.

## Appointments to Outside Bodies Procedure Rules

- 4.10 Community Committees may review the list of organisations to which they are asked to make appointments at any time and make recommendations to the General Purposes Committee.
- 4.11 The City Solicitor will have delegated authority to make an appointment where an organisation requires an appointment prior to the next meeting of the relevant Community Committee, subject to all Members of that Community Committee being consulted on the proposals.
- 4.12 That any instances of this delegation being used be reported to the next meeting of the relevant Community Committee.

## **Support for Elected Member Appointees To External Organisations**

**Lead officer:** A lead officer will be identified by the relevant Director for all relevant appointments in the Strategic and Key Partnerships category.

This officer will work closely with the appointed Member(s) to provide briefings and support. Further advice will also be offered by the Chief Finance Officer and/or the City Solicitor as appropriate.

**Briefings**: For organisations in the Community and Local engagement category, a lead officer will not be allocated unless the Director and/or relevant Executive Member for the service area deem that this will be beneficial. However, the representative may still seek support and briefings from Council officers.

**Induction:** Partner/external organisations are expected to provide an induction into their affairs for newly appointed Council representatives. In the case of Strategic and Key Partnership Category appointments it is the lead officer's responsibility to ensure that an induction is arranged.
