Looked After Children and the EU Settlement Scheme

What is this report about?

Including how it contributes to the city's and council's ambitions

- Previously, with free movement, EU nationals could visit or live in the UK without needing a visa. All this has changed. EU nationals already living in the UK must now take the proactive step of applying to the EU Settlement Scheme (EUSS) and securing either presettled (if they have been in the UK for less than 5 years) or settled status. This includes children.
- The Children's Society has brought this matter to the attention of the Chair of the Children and Families Scrutiny Board, raising concerns that many EU national children or the children of EU nationals will find themselves without status come 1 July 2021, focusing particularly upon looked after children and care leavers, as many may not be able to depend upon their parents to apply on their behalf or will be reliant upon a local authority to do so.
- The Director of Children and Families has therefore been invited by the Chair to provide an overview of the current position in Leeds for the Scrutiny Board's consideration.

Recommendations

Members are requested to consider the information presented and discuss whether any further scrutiny work is warranted.

Why is the proposal being put forward?

- 1. The Children's Society has approached the Chair of the Children and Families Scrutiny Board to bring to his attention recent research undertaken by The Children's Society which found that less than 40% of the looked after children and care leavers identified as needing to secure status have in fact made applications to the EUSS, therefore raising concerns that many of these children and young people could become undocumented once the EUSS closes on 30th June 2021.
- 2. An update document for local authorities on this matter has been published by The Children's Society, which outlines examples of best practice already taking place within local government, and recommendations for immediate actions which local authorities can take regarding the EUSS and looked after children/care leavers. This document has been appended for Members' information (see Appendix 1).
- 3. The Children's Society also references the EU Settlement Scheme Home Office looked-after children and care leavers survey 2021. From 8 February to 23 April 2021, the Home Office undertook a follow up survey of Local Authorities in England, Wales, Scotland and of Health and Social Care Trusts in Northern Ireland to provide an update on the estimated number of looked after children and care leavers eligible to apply to the EU Settlement Scheme (EUSS). The latest survey results, last updated on 13th May 2021, are published on the Gov.UK website¹.
- 4. The Children's Society has highlighted that, according to the recent survey results, there are still 13 children in care or recently leaving care in Leeds who are eligible and yet to apply to the EUSS. Furthermore, 21 children who have applied for the EUSS have had their applications not result in status, which represents a little under half of all applications made by Leeds City Council. With the deadline for EUSS closing on 30th June, concerns have been raised that many of these children and young people will become undocumented.
- 5. In view of the above, the Director of Children and Families has been invited by the Chair to provide an overview of the current position in Leeds for the Scrutiny Board's consideration. A briefing paper has been provided by the Director and is appended to this report for Members' information (see Appendix 2).
