And also they could park in our driveway it will be hard so for our every day life.

We appreciate if the council could stop from giving the licence out please for the safety of our children and our safety we are asking politely review again or withdraw the application.

I have lived in the Scott Hall area since I was a child and growing up, I can say the Caribbean Cricket Club is responsible for several public disturbances that have only grown worse over the years.

When I was a child playing on the field near the goal posts several years ago, they approached and told me to leave their property. I was no where near the Cricket Club. The field is public property, they only own the Cricket Pavilion.

Through the years they have had people whom attend their club that cause issues in the area for the people who live here. They have Car engines revving throughout the night, people littering and using the field as a public toilet. They have been seen urinating behind peoples back gardens various times over the years.

But the current main issue is the music as I believe the music makes the people there act like this by treating the area like it is a nightclub.

They applied for a licence years ago to play music till 11pm. They have got that license and since then have been playing music beyond 11pm. They have been playing music to various times early in the morning such as 12am or 1:30am beyond the legal time that the current licence allows. This has disturbed people trying to sleep in the area, with the music and all the noise people make because they treat the Club like its an all night party.

If they got a licence to play music into the early hours of the morning, then the situation would become worse as people would be partying there till times like 5am in the morning. Causing more noise and mess with people drinking, littering, revving car engines and playing music loudly later into the night. This will cause more people to lose sleep at night and cause more mess in the area.

Please don't grant the Caribbean Cricket Club this licence it will only make things worse for the residents in the area.

Dear Madam/Sir,

I am writing on behalf of myself and my two immediate neighbours, neither of whom have computers. We have only just become aware of a dark blue notice stuck quite high, and facing towards the main road, on a telegraph pole near the main road [REDACTED] - thus not something we would even be able to see and read as we negotiate the uneven pavement surface coming from Scotthall Road into the Avenue.

We wish to lodge a strong complaint against the extension of hours being sought by the Club for alcohol and music - particularly the Friday and Saturday times to 2a.m., which would actually be nearer 3a.m. or more by the time they all come out of the building and talk on the grass while revving up their car engines! We are residents [REDACTED] whose gardens are the nearest to back on the Club grounds - only yards away and on a lower level - thus ensuring that all the noise directly hits our walls. I've have on occasions in the past gone to ask them to lower the bass sound volume control as the heavy drum beats vibrate right through our homes, and that's at around midnight! - and the party lingers on until 1a.m.

I am asking that you please reconsider giving the Caribbean Cricket Club this licence as it will just make live more difficult for me, my family and the people in the area.
