2. Please provide a brief description of what you are screening

The Council has submitted a successful bid for grant funding to the Public Sector Decarbonisation Fund 3c of circa £7 million with a requirement for match funding of 12%

The grants and match funding will facilitate the decarbonisation of 8 schools and 3 corporate buildings through replacement of all fossil-fuel heating systems with electricity operated heat pumps and installation of solar panels and other energy efficiency technologies and building fabric improvements.

a) Inclusive Growth was incorporated by selecting sites from across the city, ensuring that communities from across Leeds benefit from the decarbonised heating provision in local schools and corporate buildings.

b) These projects will deliver carbon savings through removing predominantly

gas-fired heating systems and replacing them with low-carbon air source heat pumps, and through the installation of solar panels and energy efficiency measures such as insulation and LEDs to reduce consumption.
