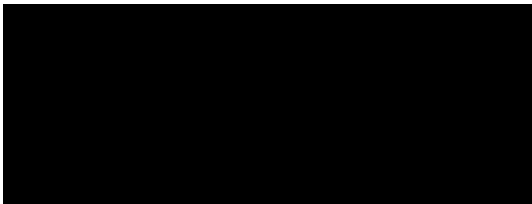
Please find attached signed consent for all proposed control measures / conditions proposed by the police under the Licensing Act 2003.

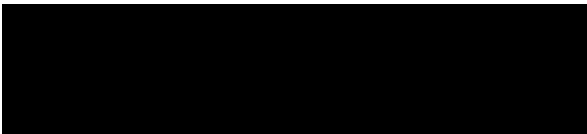
