CONFIDENTIAL AND EXEMPT ITEMS

The reason for confidentiality or exemption is stated on the agenda and on each of the reports in terms of Access to Information Procedure Rules 9.2 or 10.4(1) to (7). The number or numbers stated in the agenda and reports correspond to the reasons for exemption / confidentiality below:

9.0 Confidential information – requirement to exclude public access

9.1 The public must be excluded from meetings whenever it is likely in view of the nature of the business to be transacted or the nature of the proceedings that confidential information would be disclosed. Likewise, public access to reports, background papers, and minutes will also be excluded.

9.2 Confidential information means

- (a) information given to the Council by a Government Department on terms which forbid its public disclosure or
- (b) information the disclosure of which to the public is prohibited by or under another Act or by Court Order. Generally personal information which identifies an individual, must not be disclosed under the data protection and human rights rules.

10.0 Exempt information – discretion to exclude public access

- 10.1 The public may be excluded from meetings whenever it is likely in view of the nature of the business to be transacted or the nature of the proceedings that exempt information would be disclosed provided:
 - (a) the meeting resolves so to exclude the public, and that resolution identifies the proceedings or part of the proceedings to which it applies, and
 - (b) that resolution states by reference to the descriptions in Schedule 12A to the Local Government Act 1972 (paragraph 10.4 below) the description of the exempt information giving rise to the exclusion of the public.
 - (c) that resolution states, by reference to reasons given in a relevant report or otherwise, in all the circumstances of the case, the public interest in maintaining the exemption outweighs the public interest in disclosing the information.
- 10.2 In these circumstances, public access to reports, background papers and minutes will also be excluded.
- 10.3 Where the meeting will determine any person's civil rights or obligations, or adversely affect their possessions, Article 6 of the Human Rights Act 1998 establishes a presumption that the meeting will be held in public unless a private hearing is necessary for one of the reasons specified in Article 6.
- 10.4 Exempt information means information falling within the following categories (subject to any condition):
 - 1 Information relating to any individual
 - 2 Information which is likely to reveal the identity of an individual.
 - 3 Information relating to the financial or business affairs of any particular person (including the authority holding that information).
 - 4 Information relating to any consultations or negotiations, or contemplated consultations or negotiations, in connection with any labour relations matter arising between the authority or a Minister of the Crown and employees of, or officer-holders under the authority.
 - 5 Information in respect of which a claim to legal professional privilege could be maintained in legal proceedings.
 - 6 Information which reveals that the authority proposes
 - (a) to give under any enactment a notice under or by virtue of which requirements are imposed on a person; or
 - (b) to make an order or direction under any enactment
 - 7 Information relating to any action taken or to be taken in connection with the prevention, investigation or prosecution of crime

Summary of Main Issues

This is an application for the grant of a premises licence made by NYK Leeds Limited, for NYK Leeds, Ground Floor, 106 Burley Road, Burley, Leeds, LS3 1JP.

This application proposes Late Night Refreshment and the Performance of Recorded Music. The hours applied for can be noted at 3.2 of this report.

Responsible Authorities and Ward Members have been notified of this application.

Agreements have been reached with West Yorkshire Police and the Environmental Protection Team to adopt additional measure and to reduce the terminal hour of the Performance of Recorded Music. As result, the representations by those authorities have been withdrawn.

In respect of other persons, the application has attracted three individual representations from members of the public which remain a matter outstanding for the Sub Committee's consideration.

1 Purpose of this Report

- 1.1 To advise Members of an application made under section 17 of the Licensing Act 2003 ("the Act") for a new premises licence in respect of the above mentioned premises.
- 1.2 Members are required to consider this application due to the receipt of valid representations.

2 History of the Premises

2.1 This is the first application for a premises licence for these premises.

3 The Application

- 3.1 The applicant's name is NYK Leeds Limited.
- 3.2 In summary the application is for:

Late Night Refreshment Everyday 23:00 – 02:00

Performance of recorded music Everyday 11:00 – 23:00*

*terminal hour reduced as per the agreement reached with the Environmental Protection Team.

3.3 A redacted version of the application has been attached at **Appendix A**.

4 Location

4.1 A map which identifies the location of this premises is attached at **Appendix B**.

5 Representations

5.1 Under the Act representations can be received from anyone but they must be relevant and, in the case of a member of the public, must not be frivolous or vexatious.

Representations from Responsible Authorities

- 5.2 Representations have been received from West Yorkshire Police and Environmental Protection Team in their capacity as a responsible authority.
- 5.3 Any representation may be negotiated prior to the hearing and in this instance the operating schedule has been amended to include the measures agreed with West Yorkshire Police. A copy of the agreement may be found at **Appendix C**.
- 5.4 Agreements have also been reached with the Environmental Protection Team for the applicant to adopt additional measures and to reduce the terminal hour of Recorded Music. A copy of the agreement can be found at **Appendix D**.

Other Representations

- 5.5 The application has attracted three representations from members of the public (described as 'other persons' in the legislation), which are opposed to this application mainly on the grounds of public nuisance and public safety.
- 5.6 Two representations have been received from members of the public who have expressed concern that they may be at risk of retribution should their details be made public. As such their personal details have been redacted and they will remain anonymous. For this reason, despite their strength of feeling they will not be attending the hearing and would like their representations to be considered fully in their absence.
- 5.7 In order to protect personal data, redacted copies of the representations are attached at **Appendix E** and original copies will be provided to the Licensing Sub Committee in advance of the hearing.

6 Licensing Hours

- 6.1 Members are directed to paragraphs 6.8 to 6.15 of the Statement of Licensing Policy which states the criteria that will be applied to any decision for new applications or variations which include extending hours.
- 6.2 In brief the Policy states at 6.14 that restrictions may be made to the proposed hours of use where, after receiving relevant representations, the council considers it appropriate for the promotion of the licensing objectives to do so.
- 6.3 The council will take into account the existing pattern of licensed premises in an area when considering what is appropriate to promote the objectives. Applications which are significantly out of character for a locality will need to demonstrate that granting the hours sought will not adversely impact on the licensing objectives.
- 6.4 A list of premises in the local area and their licensed hours and activities is provided at **Appendix F**.

7 Equality and Diversity Implications

7.1 At the time of writing this report there were no implications for equality and diversity. Any decision taken by the licensing subcommittee will be in accordance with the four licensing objectives as prescribed by the Licensing Act 2003.

8 Options Available to Members

- 8.1 The Licensing Sub Committee must take such of the following steps as it considers appropriate for the promotion of the licensing objectives:
 - Grant the application as requested.
 - Grant the application whilst imposing additional conditions and/or altering in any way the proposed operating schedule.
 - Exclude any licensable activities to which the application relates.
 - Reject the whole or part of the application.
- 8.2 Members of the Licensing Sub Committee are asked to note that they may not reject the whole or part of the application merely because they consider it desirable to do so. It must be appropriate in order to promote the licensing objectives.





We therefore confirm that we are submitting a formal representation against the application on the grounds of-:

- 1. the prevention of crime & disorder
- 2. public safety
- 3. the protection of children from harm

However, we are of the opinion that the licensing objectives could be met should the applicant be prepared to incorporate certain identified measures within their operating schedule as additional conditions.

Please find enclosed a document which at **Part 1** contains the suggested measures which this authority considers are proportionate and appropriate to the nature of the application.

Having considered the application under the Licensing Act 2003 for the above premises, West Yorkshire Police considers that the following measures are relevant, proportionate and necessary in order to promote the following licensing objectives-:

the prevention of crime & disorder public safety the protection of children from harm

A suitable closed circuit Television (CCTV) system will be in operation at the premises at all times when it is being used for the provision of licensable activities and/or when members of the public are permitted to be on the premises. The CCTV system will record images to cover all areas of the premises to which the public have access (save for toilets), including the immediate external areas of the premises. The CCTV system will be capable of retaining images for a minimum of 31 days, will be of good quality and will contain the correct time and date stamp information. The CCTV system and images will be kept in a secure environment to which members of the public will not be permitted access. At least one member of staff will be on duty at the premises at all times who is capable of operating the system and downloading images recorded by it. These images will be downloaded and provided, on request, to an officer of a responsible authority.

The CCTV shall be checked weekly to ensure it is working correctly and a log maintained of those checks. This log will be kept on the premises for a 12 month period and produced for inspection when requested to do so by an authorised officer.

A register shall be maintained on the premises to record all incidents and accidents. Records should include matters such as anti-social behaviour, admission refusals, ejections, seizure of prohibited items, casualties/unwell customers, welfare and safeguarding matters, accidents, and safety incidents. The records shall include the date, time, and location of the incident; nature of the incident; personal details and contact information for all people involved including any witnesses, SIA and Personal Licence numbers, any crime number and details of police officers attending. A note of the action taken, and where relevant a note of the actions to prevent any reoccurrence should also be included. The records shall be available for inspection by any authorised officer of the responsible authorities and shall be securely retained by the licence holder for a period of 12 months after the last entry. Incident and accident records shall be kept in a bound register with consecutively numbered pages.

No unaccompanied children are allowed on the premises after 2100 hrs. Notices are to be displayed to this effect.

Regular checks are to be made of the outside area during the hours of darkness to discourage groups gathering and loitering outside the premises.

During opening hours. the premises will be well illuminated to the satisfaction of West Yorkshire Police and kept free from graffiti.

Seating for20 people shall be maintained within the premises.

West Yorkshire Police are satisfied that the proposed measures are not adequately dealt with by other legislation.

By signing the declaration enclosed overleaf at **Part 2**, the applicant agrees to incorporate the proposed measures as conditions within the Operating Schedule for the said premises.

Objection to late license for the above take away on Burley Road

I and many other neighbours are concerned about the application to trade at until 2 AM each evening, as set out below in no particular order.

Due to concerns of possible retribution, please ensure that my name and address is not published and not available to the take away.

The first few days of trading

Ever since this take away opened the owners have showed complete disregard and disrespect to the local community. From the first day of opening there was a large van with loudspeakers blaring out unbelievably loud music, travelling around the neighbourhood and parking outside the premises for extended period of time. A number of requests were made to stop or turn the music down but nothing happened. This greatly disturbed residents amenity for a number of day. It was as loud as having a music festival stage round the corner. I mention this as this pattern of disrespect to the local community has continued consistently since then (see below).

Disregard for the licensing system

Despite being advised by the council and local people that they did not have a license to trade beyond 23.30, the business continued to do so. Every eve since opening the business has been open way beyond 1 AM. This disregard for the law and the community is part of a pattern of this business. A respectable business would have ceased trading after 11.30 until (and if) a license was granted. But not this one...

Environmental hazard

Due to incorrect storage and disposal of oil drums over a number of months, the drain has been clogged with fat and other substances

has been slippy and often dangerous for Pedestrians, cyclists, wheelchair users and vehicles generally. An enforcement notice was made and there has been some improvements but the problems still continue, albeit less frequently (many photographs have been provided to environmental health over a number of months to demonstrate this).

The storage of oil drums has also attracted rats and other vermin. Not helped by the lid of the bins not always being closed, despite the enforcement notice. As recently as 15 July, pic supplied to environmental health re continued storing of oil drums in a hazardous way (pic taken 14 July showing incorrect storage of oil drums).

Noisy flue

The flue is very noisy and only a The flue is significantly noisier at night when the take away is busy and much less so during the day (when an environmental health visit was made it was conducted in the afternoon and was totally the wrong time to have visited. The air quality has taken a significant hit in the evenings since the opening of the takeaway. This is in an area where there are already restaurants and takeaways with charcoal grills pumping toxic air into the There appears to be no account taken of the cumulative effect this has on the local area. An area where health outcomes are already poor, some of the worst in the city. The amount of takeaways in the area has added to this negatively and must be a consideration for the licensing committee moving forward.

Building works

The disregard for continues with minor building works taking place, with bags of rubble at the back of the takeaway for weeks, with stones, dust and other materials being swept into the long suffering drain.

There seems to be a pattern where planning approval is granted for takeaways with limited opening, only for a subsequent application to be made at a later date for late opening. This needs careful monitoring and decisive action as it tends to affect inner city and deprived communities the most. The very areas that need positive, affirmative action to tackle health, well being and general issues of multiple deprivation.



I have previously reported this outlet to Enforcement as they don I t currently


have a license for late opening and I would have preferred this was enforced rather than the owner be permitted to apply for an extension until 02:00

I am somewhat puzzled as to why the owner is applying for a music licence, the premises is a take-away and doesn \Box t play music currently? Music until 02:00 adjacent to a residential area would gravely impact on people s quality of life. There is a Primary School on Burley Road not far from this site (Rosebank Primary School) - would it be fair to have music until 02:00 when families with small children are trying to sleep?

The request to remain open until 02:00 to serve food is also problematical. Most of the sales will be via Uber Eats or other courier companies. This will inevitably create noise and disturbance as the couriers arrive to pick up their orders etc. Plus the ventilation flue from no 106 is which means the residents get the full benefit of greasy chicken smells every time they open their window if the premises are open. This will have a severe impact on local resident \Box s amenity and should be rejected. This extension is also out of step with most other fast food outlets in the area who don t have 02:00 opening. Permitting NYK Leeds to remain open until 02:00 may well be used as an example by other fast food outlets in this area to extend opening times. Although 106 Burley Road fronts onto a busy main road, it \Box s back entrance is firmly within a residential area of Leeds whose inhabitants don \Box t deserve to be negatively impacted in this way.
