#### 1.0 Purpose of This Report

To explain to the Board the role of the Board in considering the objections to these proposals and making recommendations to the Executive Board to assist the Executive Board in reaching a decision in relation to the proposals.

#### 2.0 Background Information

#### Changes to Allerton Church of England Primary School to expand the school

In December 2017, the Executive Board considered a report on the outcome of consultation on proposals for expansion of primary provision from September 2018, and approved the publication of a statutory notice in respect of the proposal. This report describes the representations made to those notices, and asks the Board to consider the proposal and the objections and make recommendations to Executive Board

A statutory notice was published for the expansion of Allerton Church of England Primary School. The proposal is expand the capacity from 420 to 630 increasing the admission number of from 60 - 90.

There were two responses to the statutory notice which opposed the change.

This proposal is now submitted to the Board to consider the proposal and the objections received and to make recommendations to the Executive Board.

# Subject: Outcome of Statutory Notice on proposal to increase places at Allerton Church of England Primary School

#### Summary of main issues

This report contains details of proposals brought forward to meet the local authority's duty to ensure sufficiency of school places. The changes that are proposed form prescribed alterations under the Education and Inspections Act 2006. The School Organisation (Prescribed Alterations to Maintained Schools) (England) Regulations 2013 and accompanying statutory guidance set out the process which must be followed when making such changes. The statutory process to make these changes varies according to the nature of the change and status of the school and the process followed in respect of these proposals is detailed in this report. The decision maker in these cases remains the local authority (LA).

Consultation on a proposal to expand Allerton Church of England (C of E) Primary School from a capacity of 420 pupils to 630 pupils by increasing the admission number from 60 to 90 with effect from September 2018 took place from 26 June 2017 to 21 July 2017. At its meeting on 13 December 2017 Leeds City Council's Executive Board gave permission for the local authority, as proposer, to publish a Statutory Notice in respect of the proposal. A Statutory Notice was published on 8 January 2018. Publication of the Notice marked the start of a four week formal consultation, also known as the 'representation' stage as prescribed in the 'Prescribed Alterations' regulations. During this four week period which ended on 5 February 2018 anyone could object to or comment on the proposal. Two objections and two comments were received.

#### 1 Purpose of this report

1.1 This report describes the representations made during the representation period in relation to the proposal to expand Allerton C of E Primary School and asks School Organisation Advisory Board (SOAB) to consider the responses and make a recommendation to Executive Board on a final decision on the proposal.

#### 2 Background information

- 2.1 The proposal has been brought forward to ensure that the LA meets its statutory duty to provide sufficient school places.
- 2.2 The proposal is to permanently expand primary provision at Allerton C of E Primary School from a capacity of 420 pupils to 630 pupils with an increase in the admission number from 60 to 90 with effect from September 2018.
- 2.3 The expansion of Allerton C of E Primary School has been proposed as it is a good school (Ofsted January 17) and was judged to be Outstanding in the Statutory Inspection of Anglican and Methodist Schools (SIAMs) report (January 17). The school is popular with local families, situated within an area of high demographic need.
- A consultation on the proposal took place from 26 June 2017 to 21 July 2017. During that time 92 responses were received of which 34 respondents supported the proposal, 36 respondents disagreed with the proposal and 22 respondents neither agreed nor disagreed with the proposal.
- 2.5 Concerns and a response to those concerns were detailed in a report to Executive Board in December 2017. Executive Board approved the recommendation to publish a Statutory Notice in respect of the proposal.
- A Statutory Notice was published on 8 January 2018. Publication of the Notice marked the start of a four week formal consultation, also known as the 'representation' stage as prescribed in the 'Prescribed Alterations' regulations. During this four week period which ended on 5 February 2018 anyone could object to or comment on the proposal.
- 2.7 As set out in the Department for Education's statutory guidance for proposers and decision makers a final decision must be made within a period of two months of the end of the representation period or they must be referred to the Schools Adjudicator, therefore by 4 April 2018.

#### 3 Main issues

- 3.1 The representation period provided the opportunity for all stakeholders to consider further the expansion of primary provision at this school.
- 3.2 Two objections were received during this period, and two responses containing comments on the proposals. The responses that contained comments were from local residents, who expressed highways related concerns relating to; congestion at peak times, cars parking on both sides of the road blocking driveways, parked

cars restricting the bus route and making the road dangerous due to restricted view, cars parking on double yellow lines, lack of crossing or crossing patrol, single entrance to school being an issue for both cars and pedestrians. One suggestion made was to expand the existing Park and Ride car park and to create a pedestrian entrance to the primary school. A copy of the objections are appended to this report and concerns outlined below.

- 3.3 **Concerns**: That additional children at the school will increase traffic during peak times; Road safety in light of existing and future parking issues; Existing and likely increase to inconsiderate/illegal parking e.g. parking on double yellow lines and blocking drives; Traffic entering and exiting the school's single vehicular access point is dangerous; Increased congestion and decreased traffic flow; Anti-social behaviour connected with parking near to the school; Problems with buses passing safely near to the school; Pedestrian access to the school via a small gate is dangerous; Lack of pedestrian crossing points; Lack of policing of existing permits and double yellow lines; LCC should consider creating separate entrances to the school in order to distribute traffic more evenly.
- 3.4 **Response**: In the report to Executive Board following consultation, concerns about Highways issues were addressed as follows:
- 3.5 "The LA acknowledges the concerns relating to an increase in traffic in the area due to existing traffic issues and we will work with colleagues in Highways Services to look at ways of managing this where appropriate. Highways would take account of the existing bulge cohorts in terms of assessing the highway impact. During the consultation a number of suggestions were made regarding how increases to traffic could be managed which included:
  - A review of the current park and ride arrangement off King Lane and potential to create a formal pedestrian walk-through from the park and ride onto Lingfield Approach;
  - Further use of double yellow lines near to the school;
  - Assessment of the traffic verges on Lingfield Approach and Lingfield Drive and potential to create parking/drop off;
  - A review of the current bus routes/times at pick up/drop off;
  - Potential for making the gate at the back of school more accessible to create an additional entrance to school:

If the proposals were taken forward a full traffic survey and transport statement would need to be produced for any planning application which would need to demonstrate how the increases to traffic could be mitigated and which would include a consideration of these and any other potential solutions for helping to manage the increases to traffic and congestion. Parents and local residents would have the opportunity to formally comment on any planning applications".

3.6 The Highways Team has further indicated that a transport assessment would be carried out to fully assess the existing situation and the impact that the proposed

development would have on the surrounding roads. This would include the current bus routes in the area. Following the assessment, a package of measures to mitigate the effects of the development would be put forward, the emphasis being on promoting and encouraging sustainable travel to and from the site such as walking, cycling and public transport and reducing the need for travelling to and from the site by private car. As part of the initial consultations, existing safety concerns were raised and a review of the parking, crossing facilities and traffic management measures will be required to determine the off-site highway works required to mitigate the proposed increase.

3.7 A decision not to proceed at this stage may result in fresh consultations on new proposals, and places may not be delivered in time. It may also result in further bulge cohorts being delivered in other local schools which would be more costly in the longer term. The LA's ability to meet its statutory duty for sufficiency of school places in the short term may be at risk.

#### 4 Corporate Considerations

#### 4.1 Consultation and Engagement

- 4.1.1 The process in respect of the proposals has been managed in accordance with the relevant legislation and with local good practice.
- 4.1.2 The Statutory Notice was published in the Yorkshire Evening Post on 8 January 2018. Copies of the Statutory Notice were displayed at the entrance to the school and on lampposts in the area near to the school. The full proposal was posted on the school's website and on the Leeds City Council website and parents informed, along with any stakeholder who responded to the original consultation where contact details were provided. Other local schools and the Dioceses were also informed about the proposals.
- 4.1.3 Stakeholders had the opportunity to comment or object to the proposals either in writing or by email.
- 4.1.4 During the consultation ward members gave their broad support for the proposals providing that the Highways and parking issues were addressed. Details of the Statutory Notice were subsequently shared with local ward members and parish councillors. No further comments were received.

#### 4.2 Equality and Diversity / Cohesion and Integration

4.2.1 The EDCI screening form for the proposals at Allerton C of E Primary School has been completed and is attached as an appendix to this report.

#### 4.3 Council policies and Best Council Plan

- 4.3.1 This proposal offers good value for money through its capacity to support achievement of the Best Council outcome to give everyone the chance to do well at every level of learning, gaining the skills they need for life.
- 4.3.2 This proposal is being brought forward to meet the LA's statutory duty to ensure there are sufficient school places for all the children in Leeds. Providing places

close to where children live allows improved accessibility to local and desirable school places, is an efficient use of resources and reduces the risk of non-attendance.

- 4.3.3 This proposal contributes to the city's aspiration to be the best council, the best city in which to grow up and a child friendly city. The delivery of pupil places through the Learning Places Programme is one of the baseline entitlements of a child friendly city. By creating good quality local school places we can support the priority aim of improving educational achievement and closing achievement gaps. In turn, by providing young people with the skills they need for life, this proposal provides underlying support for the council's ambition to produce a strong economy by compassionate means. A good quality school place also contributes towards delivery of targets within the Children and Young People's Plan such as our obsession to improve behaviour, attendance and achievement.
- 4.3.4 It is important when bringing any proposals forward that there is a degree of certainty that any change would not have a negative impact on teaching and learning.
- 4.3.5 Allerton C of E Primary School was rated good in its January 2017 Ofsted inspection and was judged to be outstanding in the Statutory Inspection of Anglican and Methodist Schools (SIAMs) report in January 2017. The Governing Body and Senior Leadership Team are confident that its dedicated staff team can meet the needs of every child who attends the school, managing the change whilst maintaining standards.

#### 4.4 Resources and value for money

- 4.4.1 Pre-feasibility budgets, based on high-level calculations, are estimated at £3.9m for the proposed expansion of Allerton C of E Primary School. This was reported to Executive Board in December 2017.
- 4.4.2 The proposed scheme would be subject to planning permission which would need to be granted prior to the commencement of construction works. Once the feasibility stage was complete and schemes proceeded to the detailed design phase, budgets would be realigned to reflect that all parties have agreed the final design and cost estimates, which would take account of site investigations and survey information, in accordance with standard project and risk management principles. Schemes would also be subject to relevant stakeholder consultation.
- 4.4.3 This expansion would be funded from the Learning Places Programme, primarily through Basic Need Allocations. The precise funding packages would be confirmed at the design freeze stage, and detailed in the relevant Design and Cost reports.

#### 4.5 Legal Implications, Access to Information and Call In

4.5.1 The processes that have been and will be followed are in accordance with the Education and Inspections Act 2006 as set out in the School Organisation (Prescribed Alterations to Maintained Schools) (England) Regulations 2007, and

- amended by School Organisation (Prescribed Alterations to Maintained Schools) (England) Regulations 2013.
- 4.5.2 Leeds City Council's Executive Board is the decision maker for proposals relating to school expansions. It has established SOAB to consider proposals where objections are received during the representation period following publication of a Statutory Notice. After hearing any objections and the case for the authority, SOAB then makes any recommendations to Executive Board. If the decision maker does not make a decision on the proposals within two months of the end of the representation period, the matter must be referred to the Schools Adjudicator.

#### 4.6 Risk Management

- 4.6.1 This proposal has been brought forward in time to allow places to be delivered for 2018. A decision not to proceed at this stage may result in fresh consultations on new proposals, and places may not be delivered in time. It may also result in further bulge cohorts being delivered in other local schools which would be more costly in the longer term. The LA's ability to meet its statutory duty for sufficiency of school places in the short term may be at risk.
- 4.6.2 The majority of the school site at Allerton C of E Primary School is protected playing pitches. Early consultation with Sport England would be required to obtain approval to build on the existing playing pitches in order for the proposed expansion to progress.
- 4.6.3 There is also a corporate risk associated with failing to provide sufficient school places in good quality buildings that meet the needs of local communities.

#### 5 Conclusions

Our ambition is to be the best city in the country. As a vibrant and successful city we will attract new families to Leeds, and making sure that we have enough school places for children is one of our top priorities. This proposal has been brought forward to meet that need to ensure that children in Leeds have the best possible start to their learning, and so deliver our vision of Leeds as a child friendly city. These proposals would also offer choice and diversity to parents.

#### 6 Recommendations

6.1 The Children and Families Service believe that the issues raised during the consultation and representation periods do not present insurmountable barriers and that these can be addressed. We ask School Organisation Advisory Board to consider the issues raised and to recommend to Executive Board that these proposals be approved.

# Proposal to expand Allerton Church of England (Voluntary Controlled) Primary School

# Consultation period 26 June 2017 to 21 July 2017

This consultation document tells you the reasons for the consultation and explains the decision making process.

For your views to be taken into account please respond by 4pm on Friday 21 July 2017

#### **Background**

The Education Act 1996 places a duty on local authorities to ensure there are sufficient school places for all children living in its area. The local authority is also required to promote choice and diversity, and therefore must also ensure that there are a range of options available to parents.

#### What is being proposed and why?

Leeds City Council has permanently increased primary places across the Alwoodley and Roundhay areas over a number of years and more recently bulge cohorts (see glossary) have been agreed at a number of local schools to address the ongoing demand for places.

A review of births and children aged under 5 based on NHS data, as well as admissions data spanning the last few years, has highlighted the need for additional primary school provision in the Alwoodley area. The number of children living nearest to Allerton C of E Primary School and Alwoodley Primary School outweighs the number of available places for the foreseeable future, and over the past few years we have seen an additional pressure on available places for children living in the east of the Alwoodley area. In addition, following a public consultation by the Governing Body to reduce its Published Admissions Number from 45 to 30, Brodetsky Jewish Primary School will have 15 less available places from 2018.

By September 2017, Allerton C of E Primary School will have admitted additional children above its published admission number into its Reception class on three separate occasions. These bulge cohorts were supported by the Head Teacher and Governing Body and as the Local Authority have admitted these bulge cohorts and provided physical accommodation, it is appropriate for us to consult on whether this should become a permanent change, as the statutory guidance from the Department for Education recommends.

It is for this reason that a consultation on the permanent expansion of Allerton C of E Primary School is taking place to gauge the views of parents, local residents and other stakeholders.

It is proposed that **Allerton C of E Primary School permanently** expands from a capacity of 420 to 630 pupils, with an increase to the admission number from 60 to 90 in its reception class from September 2018, creating 30 additional places. The school would grow incrementally, from the lower year groups. Due to the bulge cohorts that the school has already admitted, it would take five years from 2018 for the school to reach its full capacity.

#### Further information on the proposal

#### Reasons for consulting on an expansion of Allerton C of E Primary School

Allerton C of E Primary School is a good school (Ofsted January 17) and was judged to be Outstanding in the Statutory Inspection of Anglican and Methodist Schools (SIAMs) report (January 17). The school is popular with local families, situated within an area of high demographic need. The school has been willing to work with the authority to ensure a sufficiency of places by supporting bulge cohorts in 2014, 2016 and 2017 and has worked hard to improve its offer to local parents, including developing provision for 2 year olds and offering 30 hours of early years care for parents who work - to be implemented from September 2017.

The Local Authority recognise that the current infrastructure/school building cannot accommodate a permanent expansion to 3FE and that changes/additions to the building will have to happen if this proposal progresses. Initial work suggests that a number of options are possible and a detailed design for the new building would need to be developed.

We acknowledge that there may be concerns relating to an increase in traffic in the area due to existing traffic issues and we will work with colleagues in Highways Services look at ways of managing this where appropriate. A full traffic survey and transport statement would need to be produced for any planning application which would need to demonstrate how the increases to traffic could be mitigated. Highways would take account of the existing bulges in terms of assessing the highway impact.

#### Frequently asked questions

#### When creating more school places, what information is taken into account?

When identifying possible options, the following are considered:

- NHS birth and housing data, to identify where in the city the extra places are needed
- which schools have the physical capacity to be expanded
- the availability of other council owned land and whether any of this land could contribute to the provision of places
- the impact that expanding one school might have on other schools in the area
- any proposals for Free Schools that we are aware of

#### Does an increase in school places mean that class sizes would be bigger?

No-the school would grow by 30 pupils in the Reception year group. This would mean three classes of up to 30 children in each. Infant Class Size Legislation relates to Reception, Year 1 and Year 2 and states that there can be only 30 children in an infant class with one qualified teacher.

#### Why are we not proposing a new school or an expansion of another local school?

A new school is not proposed because options are available to increase existing school provision in the area, which carries less risk in the set up phase than building a new school. Other schools within the area have been considered for a permanent expansion however due to site, highways and locality issues have been ruled out at this time. As we have already admitted three bulge cohorts at Allerton C of E PS, and provided physical accommodation it is appropriate for us to consult on whether this should become a permanent change, as the statutory guidance from the Department for Education recommends.

#### How will academic standards and the school's core values be maintained?

Allerton C of E is confident that its dedicated staff team can meet the needs of every child who attends the school. The leadership team will continue to rigorously monitor the progress of children, ensuring high standards of teaching and learning are consistently delivered as children progress through each phase of school. The school is part of Noctua Teaching School Alliance, and its experienced middle and senior leaders are committed to improving outcomes for children in the school, but also share their skills and knowledge with colleagues in other schools through the Senior Leadership programme. The school welcomes the opportunity to enable more children to benefit from its commitment to developing respect, caring, tolerance, kindness, honesty and openness.

### Would the existing accommodation be increased to manage the increase in pupil numbers?

Accommodation requirements would be agreed in consultation with the school leadership team and governing body as part of the expansion process. Funding would be focussed on ensuring that the required numbers of classroom teaching spaces were put in place.

#### How would road safety issues be addressed?

In addition to the school expansion proposal, any building work would be subject to the normal planning permission process, and the Highways Department is a statutory consultee on all Planning Applications. Planning approval requires officers from Highways to formally comment on all applications. Measures identified by the highways department as a requirement for approval, would be incorporated in the scheme of works.

#### How will the need for secondary places be addressed?

The increased demand for school places is now being seen in secondary schools and we are now reviewing secondary places across the city. When we establish where and when these additional places are needed we will follow the same process of consultation as we do for primary school places.

#### Will stakeholders be able to see the plans for the additional accommodation?

Yes, drop-in sessions have been arranged where initial design work will be available. These are, however, very much an outline of what could be delivered, to demonstrate that it is possible to create the additional accommodation on site. They are not final design solutions. The detailed design of any additional school buildings or remodelling of existing buildings would be subject to a statutory planning process.

#### Would the building work cause disruption to the school and pupils?

The school has continued to expand and improve the buildings since 2007, with successful building projects every year. It is not always possible to do all building work during school holidays, although as far as possible any works that are likely to be very noisy or disruptive would be carried out whilst pupils and staff are away. Any building work carried out while the school is open would be completely segregated from the pupils and staff to ensure safety, and disruption to teaching and learning would be minimised. The contractors we would be using are very experienced in working around existing and operational schools. Building work that is due to take place during the summer in 2017 is not connected with this proposal.

#### Will proposed housing in the area affect this consultation?

It should also be noted that within Leeds City Council's Site Allocations Plan as part of phase two, a site on Alwoodley Lane has been identified with a capacity of 285 houses. Part of this site has been reserved for school use, however it is not clear when or if this site will be brought forward within the plan period up to 2028 and a review of school places will take place if planning permission is sought at any time. The uncertainty around timescales for this site and the immediate pressure on school places means that it would be difficult to include it in planning for school places in the immediate to medium term in this area.

#### **Summary of main issues**

This report contains details of proposals brought forward to meet the local authority's duty to ensure sufficiency of school places. The changes that are proposed form prescribed alterations under the Education and Inspections Act 2006. The School Organisation (Prescribed Alterations to Maintained Schools) (England) Regulations 2013 and accompanying statutory guidance set out the process which must be followed when making such changes. The statutory process to make these changes varies according to the nature of the change and status of the school and the process followed in respect of these proposals is detailed in this report.

The decision maker in these cases remains the local authority.

#### Recommendations

Executive Board is asked to:

- Approve the publication of a Statutory Notice on a proposal to expand primary provision at Allerton Church of England Primary School from a capacity of 420 pupils to 630 pupils with an increase in the admission number from 60 to 90 with effect from September 2018.
- Note the responsible officer for implementation is the Head of Learning Systems.

#### 1 Purpose of this report

1.1 This report contains details of proposals brought forward to meet the Local Authority's duty to ensure a sufficiency of school places, which support the achievement of the Best Council priority to improve educational achievement and close achievement gaps. This report describes the outcome of the consultation regarding proposals to expand primary school provision at Allerton Church of England (C of E) Primary School and seeks permission to publish a statutory notice in respect of these proposals.

#### 2 **Background information**

- 2.1 Leeds City Council has permanently increased primary places across the Alwoodley and Roundhay areas over a number of years and more recently bulge cohorts, (where a school admits children above its published admission number as a temporary increase) have been agreed at a number of local schools to address the ongoing demand for places.
- A review of births and children aged under 5 based on NHS data, as well as admissions data spanning the last few years, has highlighted the need for additional primary school provision in the Alwoodley area. The number of children living nearest to Allerton C of E Primary School and Alwoodley Primary School outweighs the number of available places for the foreseeable future, and over the past few years there has been an additional pressure on available places for children living in the east of the area. In addition the Governing Body of Brodetsky Jewish Primary School, as its own admitting authority, recently ran a public consultation to reduce its Published Admission Number from 45 to 30. The LA did not support this change however this will take effect from 2018.
- 2.3 By September 2017, Allerton C of E Primary School will have admitted additional children above its published admission number into its Reception class on three separate occasions. These bulge cohorts were supported by the Head Teacher and Governing Body and as the Local Authority (LA) admitted these bulge cohorts and provided physical accommodation, it was appropriate for the LA to consult on whether this should become a permanent change, as the statutory guidance from the Department for Education recommends.
- 2.4 For these reasons, a consultation on the permanent expansion of Allerton C of E Primary School took place from 26 June to 21 July 2017 to understand the views of parents, local residents and other stakeholders. This included use of the WordPress on-line forum and the Council's on-line survey system. A number of drop-in sessions were held at the school to discuss the proposals and were attended by parents, carers, school staff, local residents and a local councillor. Information was distributed widely including; via the school website and newsletter, to other local schools, via local Early Years providers, on the Leeds City Council website, the Family Information Service website, Twitter and Facebook. Meetings were held with the governors, staff and school council of Allerton C of E Primary School. Banners were placed at the entrance to the school to advertise the consultation and leaflets highlighting the consultation, and the timings of the consultation drop-in meetings were distributed to 854 local dwellings. A local community centre was also asked to promote the consultation.

#### 3 Main issues

- 3.1 The expansion of Allerton C of E Primary School is proposed as it is a good school (Ofsted January 17) and was judged to be Outstanding in the Statutory Inspection of Anglican and Methodist Schools (SIAMs) report (January 17). The school is popular with local families, situated within an area of high demographic need. The school has been willing to work with the authority to ensure a sufficiency of places by supporting bulge cohorts in 2014, 2016 and 2017 and has worked hard to improve its offer to local parents, including developing provision for 2 year olds and offering 30 hours of early years care for parents who work to be implemented from September 2017.
- 3.2 The Governors and Senior Leadership Team (SLT) are confident that its dedicated staff team can meet the needs of every child who attends the school. The leadership team will continue to rigorously monitor the progress of children; ensuring high standards of teaching and learning are consistently delivered as children progress through each phase of school. The school is part of Noctua Teaching School Alliance, and its experienced middle and senior leaders are committed to improving outcomes for children in the school, but also share their skills and knowledge with colleagues in other schools through the Senior Leadership programme. The school welcomes the opportunity to enable more children to benefit from its commitment to developing respect, caring, tolerance, kindness, honesty and openness.
- 3.3 The LA recognises that the current infrastructure/school building cannot accommodate a permanent expansion to 3 forms of entry (FE) and that changes/additions to the building will have to happen if this proposal progresses. Initial work suggests that a number of options are possible and a detailed design for the new building would need to be developed.
- 3.4 The LA acknowledges that there are some concerns relating to an increase in traffic in the area due to existing traffic issues and we will work with colleagues in Highways Services to look at ways of managing this where appropriate. Highways would take account of the existing bulge cohorts in terms of assessing the highway impact. If the proposals were taken forward a full traffic survey and transport statement would need to be produced for any planning application which would need to demonstrate how the increases to traffic could be mitigated and which would include a consideration of these and any other potential solutions for helping to manage the increases to traffic and congestion.
- 3.5 During the consultation there were 92 responses received via paper form, email and on-line survey. Leaflets advertising the consultation were distributed to over 850 local dwellings. 34 respondents supported the proposal to increase the number of school places, 22 respondents neither agreed nor disagreed with the proposal and 36 respondents disagreed with the proposal. A total of 255 comments were made about various considerations including highways issues, location and sufficiency of places, environment and site considerations, impact on school operation. A summary of comments made and concerns raised is below. A copy of the anonymised responses received can be requested from the Sufficiency and Participation Team at educ.school.organisation@leeds.gov.uk.

- 3.5.1 Summary of the main themes/comments from those in support:
  - Location/Sufficiency will help to address a lack of school places in the area and generally across North Leeds Alwoodley/Roundhay;
  - Environment/site considerations school has enough space to expand / will not impact on green space;
  - Impact on school operation size of hall and impact on facilities would need
    to be reviewed as some felt that there could be a detrimental impact on lunch,
    play and after school arrangements; concern about impact on teaching and
    learning if numbers increased; whether the school would be able to meet the
    demand for extra-curricular and out of school places; possible negative
    impact on teaching and learning;
  - Highways concerns raised about increases in traffic, congestion, safety, inconsiderate parking, anti-social behaviour, general infrastructure and impact on access to the school and local roads.
- 3.5.2 Summary of the main themes/comments from those who neither agreed nor disagreed with the proposal:
  - Impact on school operation expanding school removes year on year uncertainty and will allow school to effectively plan ahead; size of hall and impact on facilities would need to be reviewed as some felt that there could be a detrimental impact on lunch, play and after school arrangements; whether school would be able to meet demand for extra-curricular and out of school places; school may feel more impersonal if expanded; would provide children with better opportunities for activities within school e.g.sports if expanded; Allerton C of E has performed well with bulge cohorts and could manage an expansion;
  - **Highways** concerns raised about increases in traffic, congestion, safety, inconsiderate parking, anti-social behaviour, general infrastructure and impact on access to the school and local roads.
- 3.5.3 Summary of the main themes/comments from those who disagreed with the proposal:
  - Location/Sufficiency concern that other schools are not being considered for expansion; concern that public money is being spent when there are places available at other local schools;
  - Environment/site considerations concern about loss of green space / play space due to additional buildings; concern that site is not big enough for expansion; concern about increase in air pollution due to increase in traffic; building work will disrupt local residents;
  - Impact on school operation size of hall and impact on facilities would need to be reviewed as some felt that there could be a detrimental impact on lunch, play and after school arrangements; concern that additional children may mean that safety in school is compromised on a daily basis; concern around disruption to the school and the day to day running; whether school would be able to meet demand for extra-curricular and out of school places; school may feel more impersonal if expanded; concern about impact on teaching and learning if numbers increased;

- **Highways** concerns raised about increases in traffic, congestion, safety, inconsiderate parking, anti-social behaviour, general infrastructure and impact on access to the school and local roads.
- 3.6 The main concerns raised by respondents and a response to those concerns are summarised as follows;
- 3.6.1 **Concerns about location and sufficiency:** That other local schools are not being considered for expansion and/or that public money may be spent on expanding Allerton C of E when there are places available at other local schools.

**Response:** The number of children living nearest to Allerton C of E Primary School and Alwoodley Primary School outweighs the number of available places for the foreseeable future, and over the past few years there has been additional pressure on available places for children living in the east of the area. Other schools within the area have been considered for a permanent expansion however due to site, highways and locality issues have been ruled out at this time. It is acknowledged that there may be places available in other local schools in future vears, however Allerton C of E has admitted three bulge cohorts in recent years which has resulted in the provision of additional physical accommodation. As such it was appropriate for us to consult on whether this should become a permanent change, as the statutory guidance from the Department for Education recommends. It is also important to recognise that the council has a duty under the Education and Inspections Act 2006 to secure diversity in the provision of schools and increase opportunities for parental choice. Alwoodley has a range of existing types of provision (Community, C of E, Catholic, Jewish, Sikh Ethos) and although Allerton is a church school it is voluntary controlled and therefore does not admit children under a faith priority.

3.6.2 **Concerns about environment and site issues:** That there may be a loss of green space/play space due to additional buildings; that building work will disrupt local residents; whether the site is big enough for a permanent expansion.

Response: An accommodation solution has not yet been determined. A detailed design for any new building would need to be developed and would be sited as close to the existing school as possible. We would consult with colleagues in planning and from Sport England to ensure the optimum location was chosen for the expansion to ensure that any loss of green space was minimised and to minimise any impact on the site. One of the roles of planning is to review the proximity of any proposed school extension in relation to surrounding properties to take into account impact on residents. The expansion of the school would involve extensive building work and wherever possible extremely disruptive work would be carried out in school holidays or out of hours. Delivery times would be managed to avoid conflict at the beginning and end of the school day and we would seek to ensure that the work is phased to minimise the impact on both pupils, staff and local residents. Working hours would be subject to planning conditions. The overall site has been reviewed in accordance with school design guidance and is deemed to be large enough to accommodate a 3FE expansion.

3.6.3 Concerns about impact on school operation: That the size of hall and impact on facilities would need to be reviewed as some felt that there could be a detrimental impact on lunch, play and after school arrangements; that additional children may mean that safety in school is compromised on a daily basis; that the school may feel more impersonal if expanded; impact on teaching and learning if numbers increased; disruption to the school and the day to day running.

Response: Additional classrooms and indoor spaces created would need to conform to minimum building requirements. As part of the design phase requirements for all internal facilities such as toilets, library, hall and kitchen requirements would be assessed and where necessary improvements or additions made in line with school design guidance. The school has continued to expand and improve the buildings since 2007, with successful building projects every year and any building work carried out while the school is open would be completely segregated from the pupils and staff to ensure safety, and that disruption to teaching and learning would be minimised. The headteacher and SLT would determine how after school clubs and wrap around care would operate as well as ensuring lunch times are managed appropriately as they currently do.

We understand that some parents have concerns about how the 'feel' of the school might change and how the school would ensure that teaching and learning wasn't impacted by the increase to numbers. The leadership team will continue to rigorously monitor the progress of children, ensuring high standards of teaching and learning are consistently delivered as children progress through each phase of school and welcomes the opportunity to enable more children to benefit from its commitment to developing respect, caring, tolerance, kindness, honesty and openness. The school admitted bulge cohorts in 2014 and 2016 and went on to be judged as a Good school (Ofsted January 17) and an Outstanding school (SIAMs January 17). The Governing Body is confident in the school and the ability of the staff to manage this change.

3.6.4 **Concerns about Highways issues:** Impact of increases in traffic and congestion; safety of children; inconsiderate parking; anti-social behaviour; general infrastructure issues and impact on access to the school and local roads.

**Response:** As noted earlier in the report, the LA acknowledges the concerns relating to an increase in traffic in the area due to existing traffic issues and we will work with colleagues in Highways Services to look at ways of managing this where appropriate. Highways would take account of the existing bulge cohorts in terms of assessing the highway impact. During the consultation a number of suggestions were made regarding how increases to traffic could be managed which included:

A review of the current park and ride arrangement off King Lane and potential to create a formal pedestrian walk-through from the park and ride onto Lingfield Approach;

Further use of double yellow lines near to the school;

Assessment of the traffic verges on Lingfield Approach and Lingfield Drive and potential to create parking/drop off;

A review of the current bus routes/times at pick up/drop off;

Potential for making the gate at the back of school more accessible to create an additional entrance to school;

If the proposals were taken forward a full traffic survey and transport statement would need to be produced for any planning application which would need to demonstrate how the increases to traffic could be mitigated and which would include a consideration of these and any other potential solutions for helping to manage the increases to traffic and congestion. Parents and local residents would have the opportunity to formally comment on any planning applications.

3.6.5 **Concerns about the consultation:** That the consultation document lacks detail/contingency, that the consultation was poorly promoted and a tick box exercise.

**Response:** The consultation document seeks to highlight the main reasons for consulting on a permanent increase to Allerton Church of England Primary School within context. It is accepted that the document could have included more detail about contingency plans should the proposed expansion not progress and we will seek to ensure that future consultations include this detail. That said we do not believe that this level of detail would have materially altered the consultation or its outcomes since the focus of the consultation was whether we expand the school permanently after having offered bulge cohorts on 3 separate occasions.

The consultation was carried out over four week period and included a number of drop-in sessions held at different times and information was distributed widely, including via the school website and newsletter, to other local schools, via local Early Years providers, on the Leeds City Council website, the Family Information Service website, Twitter and Facebook. Banners were placed at the entrance to the school to advertise the consultation and leaflets highlighting the consultation, and the timings of the consultation drop-in meetings were distributed to 854 local dwellings. A local community centre was also asked to promote the consultation.

The LA takes seriously its duties to engage with the people and communities most affected by its proposals which is why, although not a statutory requirement, we ran a consultation at this stage.

3.7 As part of the consultation council officers met with the Governing Body (GB) and a formal response to the consultation was received. The GB noted that it is 'confident in the schools and ability of the staff to manage this change while maintaining our already excellent teaching standards' and that it supports the expansion with the following considerations:

The GB is aware of the concerns from staff and parents and that increasing the school may result in a loss of a 'local family feel' but is aware of the need to balance this with supporting the need to provide additional places;

The GB has agreed to bulge cohorts on three separate occasions and has had to manage staffing and the school leadership team and a permanent expansion would help it to forward plan in a more managed way;

The GB is concerned about the impact of additional traffic and how this might be managed and would like the LA to address this as a serious concern;

The GB and staff have worked hard 'to create a safe, welcoming and productive environment' and would want to retain the café, art studio and nurture space and wish the size of the hall to be reviewed as part of a building solution in line with outcomes outlined in the School Development Plan.

If the proposals were to proceed the LA would work closely with the GB and leadership team throughout project delivery to ensure that the school is fully involved in all aspects of the expansion. This process covers all aspects of constructing the new accommodation, including the design of the proposal and how construction is managed in a 'live' school environment. The school leadership team will be an active participant in this process throughout the project lifecycle.

3.8 As part of the consultation council officers met with the School Council (SC) to discuss the proposals and 21 responses were submitted by SC on behalf of students (not included in the tally of responses above). Four responses were in support, 9 responses were not sure and 9 responses were not in support. The main themes raised in the responses and at the meeting were as follows:

There would be more opportunity to make more friends and learn more languages; PE times might be shorter; Would there be enough space at lunchtimes and play times and would the school feel too crowded? Would lunch times have to be split further? Concern that traffic problems would be worse due to more cars; Concern that the school would need more teaching staff and whether they would be as nice as the staff currently at the school, or stricter; Would the school be able to afford additional equipment and electricity? Are the school grounds large enough to make the school bigger? Would the hall be big enough for assemblies; More children might make it more difficult to go to church and we might need more coaches for trips.

#### 4 Corporate Considerations

#### 4.1 Consultation and Engagement

- 4.1.1 The process in respect of all the proposals has been managed in accordance with the relevant legislation and with local good practice.
- 4.1.2 The consultation was carried out over four week period and included use of the WordPress on-line forum and the Council's on-line survey system. A number of drop-in sessions were held at the school supported by officers from Highways, Children and Families Service and the Built Environment Teams, to discuss the proposals. These were attended by parents, carers, school staff, local residents and one of the local councillors. Information was distributed widely, including via the school website and newsletter, to other local schools, via local Early Years

providers, on the Leeds City Council website, the Family Information Service website, Twitter and Facebook. Meetings were held with the governors, staff and school council of Allerton C of E Primary School. Banners were placed at the entrance to the school to advertise the consultation and leaflets highlighting the consultation, and the timings of the consultation drop-in meetings were distributed to 854 local dwellings. A local community centre was also asked to promote the consultation.

- 4.1.3 The view of local ward members was sought and there was broad support for the expansion of Allerton C of E Primary School provided that the Highways and parking issues are addressed. A response to the Highways issues is detailed earlier in this report.

- 4.2 Equality and Diversity / Cohesion and Integration
- 4.2.1 The EDCI screening form for the proposals at Allerton C of E Primary School has been completed and is attached as an appendix to this report.
- 4.3 Council policies and Best Council Plan
- 4.3.1 This proposal offers good value for money through its capacity to support achievement of the Best Council outcome to give everyone the chance to do well at every level of learning, gaining the skills they need for life.
- 4.3.2 This proposal is being brought forward to meet the LA's statutory duty to ensure there are sufficient school places for all the children in Leeds. Providing places close to where children live allows improved accessibility to local and desirable school places, is an efficient use of resources and reduces the risk of non-attendance.
- 4.3.3 This proposal contributes to the city's aspiration to be the best council, the best city in which to grow up and a child friendly city. The delivery of pupil places through the Learning Places Programme is one of the baseline entitlements of a child friendly city. By creating good quality local school places we can support the priority aim of improving educational achievement and closing achievement gaps. In turn, by providing young people with the skills they need for life, these proposals provide underlying support for the council's ambition to produce a strong economy by compassionate means. A good quality school place also contributes towards delivery of targets within the Children and Young People's Plan such as our obsession to improve behaviour, attendance and achievement. It is important when bringing any proposal forward that there is a degree of certainty that any change would not have a negative impact on teaching and learning. Allerton C of E Primary School was rated Good in its January 2017 Ofsted inspection and was judged to be Outstanding in the Statutory Inspection of Anglican and Methodist Schools (SIAMs) report in January 2017. The GB believes that it can manage the change whilst maintaining standards.

#### 4.4 Resources and value for money

- 4.4.1 Cautious indicative budgets, based on high-level calculations, are estimated at £3,882,616.93 for the proposed expansion of Allerton C of E Primary School. The proposed scheme would be subject to planning permission which would need to be granted prior to the commencement of construction works. Once the feasibility stage was complete and schemes proceeded to the detailed design phase, budgets would be realigned to reflect that all parties have agreed the final design and cost estimates, which would take account of site investigations and survey information, in accordance with standard project and risk management principles. Schemes would also be subject to relevant stakeholder consultation.
- 4.4.2 This expansion would be funded from the Learning Places Programme through Basic Need Allocations. The precise funding packages would be confirmed at the design freeze stage, and detailed in the relevant Design and Cost reports.

#### 4.5 Legal Implications, Access to Information and Call In

- 4.5.1 The processes that have been and will be followed are in accordance with the Education and Inspections Act 2006 as set out in the School Organisation (Prescribed Alterations to Maintained Schools) (England) Regulations 2007, and amended by School Organisation (Prescribed Alterations to Maintained Schools) (England) Regulations 2013.
- 4.5.2 This report is subject to call in.

#### 4.6 Risk Management

- 4.6.1 The proposal to increase primary provision in the Alwoodley area has been brought forward in time to allow places to be delivered for 2018. A decision not to proceed at this stage may result in a fresh consultation on new proposals, and places may not be delivered in time. It may also result in further bulge cohorts being delivered in other local schools which would be more costly in the longer term. The LA's ability to meet its statutory duty for sufficiency of school places in the short term may be at risk.
- 4.6.2 A majority of the school site is protected playing pitches. Early consultation with Sport England would be required to obtain approval to build on the existing playing pitches in order for the proposed expansion to progress.
- 4.6.3 There is also a corporate risk associated with failing to provide sufficient school places in good quality buildings that meet the needs of local communities.

#### 5 Conclusions

Our ambition is to be the best city in the country. As a vibrant and successful city we will attract new families to Leeds, and making sure that we have enough school places for children is one of our top priorities. These proposals have been brought forward to meet that need, and following the appropriate consultation we now seek to move them to the next stage. They would ensure that children in

Leeds would have the best possible start to their learning, and so deliver our vision of Leeds as a child friendly city.

Although there were slightly fewer respondents who supported the proposal than those who did not support it, a majority of those respondents were concerned about the impact of additional traffic in the area. It is our view that the risk of not providing the additional places in an area of such high need outweighs the concerns relating to the traffic and highways issues. We acknowledge that there are limited options for managing the increases in traffic but that there may be some scope to introduce measures in mitigation as detailed earlier in this report. The proposal therefore remains strong and addresses the LA's statutory duty to provide sufficient primary places and to provide places close to where children live, allow improved accessibility to local and desirable school places, manage resources effectively and to reduce the risk of non-attendance.

#### 6 Recommendations

- 6.1 Executive Board is asked to:
  - Approve the publication of a Statutory Notice on a proposal to expand primary provision at Allerton Church of England Primary School from a capacity of 420 pupils to 630 pupils with an increase in the admission number from 60 to 90 with effect from September 2018.
  - Note the responsible officer for implementation is the Head of Learning Systems.

The proposal is to increase the number of primary places in the Alwoodley area.

Leeds City Council has permanently increased primary places across the Alwoodley and Roundhay areas over a number of years and more recently bulge cohorts have been agreed at a number of local schools to address the ongoing demand for places.

The demographics of the area were considered when working up the proposal, along with parental preference trends, numbers of births and children aged under 5 based on NHS data and admissions data, and it was concluded that additional capacity is required. The types of schools in the area were also considered, to ensure we adhere to our legal

duty of ensuring parents are offered choice and diversity.

By September 2017, Allerton C of E Primary School will have admitted additional children above its published admission number into its Reception class on three separate occasions. These bulge cohorts were supported by the Head Teacher and Governing Body and as the Local Authority have admitted these bulge cohorts and provided physical accommodation, it was appropriate for us to consult on whether this should become a permanent change, as the statutory guidance from the Department for Education recommends.

We consulted those affected on this proposal from 26 June 2017 to 21 July 2017, including parents and carers of pupils, governors and staff at the school, nearby schools, the Diocese, Councillors, MP and local residents. Information was also sent to local Early Years providers for them to pass to parents who may be impacted by the proposals. Information was posted on the Family Information Service website and social media was used to publicise e.g. Leeds City Council Facebook page, Child Friendly Cities twitter, community committees facebook and twitter.

To ensure maximum engagement with families we asked the school to promote the consultation on the proposal through their usual methods of communication such as the school website and newsletter. Documents used during the consultation were available from the school and via links to the council's webpage. These documents could be requested in different languages. Informal consultation drop in sessions took place which provided an opportunity for stakeholders to meet council officers, ask questions and to tell us what they thought of the proposal. These sessions were planned at school drop off and pick up times and a session took place in the evening to ensure we were available to speak to people at convenient times and to assist working parents/carers and residents.

Stakeholders were able to give their views on the proposals by completing a consultation response form available either from the school offices or at the drop in sessions where assistance was offered if required. In addition, consultees were informed that they could put their views forward via email, post, on-line blog or on-line survey.

There were a total of 92 responses with 34 of the respondents supporting the expansion, 36 not in support and 22 unsure.

# Key findings

The area around the school is a diverse, multi ethnic and multi faith community and an expansion of the existing school will ensure that it continues to support the needs of its community by providing more places for local children. Any new accommodation would meet the Equality Act 2010 and would therefore be accessible for all.

By September 2017, Allerton C of E Primary School will have admitted additional children above its published admission number into its Reception class on three separate occasions. This proposal would ensure that additional primary places are permanently created in the Alwoodley area for primary aged children from September 2018 onwards. If the proposal is agreed, the school would grow from Reception upwards over a period of 5 years.

The proposal would have a positive impact on promoting choice and diversity for local families who are applying for a school place. Allerton C of E Primary School is a good school (Ofsted January 17) and was judged to be Outstanding in the Statutory Inspection of Anglican and Methodist Schools (SIAMs) report (January 17). The school is popular with local families, situated within an area of high demographic need. The school has been willing to work with the authority to ensure a sufficiency of places by supporting bulge cohorts in 2014, 2016 and 2017 and has worked hard to improve its offer to local parents, including developing provision for 2 year olds and offering 30 hours of early years care for parents who work - to be implemented from September 2017.

An increase in admission numbers would mean that more pupils would benefit from the high standard of education provided at the school.

# Actions

# Statutory proposals for a prescribed alteration

# **School and Local Authority details:**

**School:** Allerton Church of England Primary School, Lingfield Approach, Leeds, LS17 7HL **Local Authority:** Leeds City Council, The Director of Children and Families, Sufficiency and Participation Team, c/o Leeds Town Hall, PO Box 837, Leeds, LS1 9PZ.

# **Description of alteration:**

The proposal is to permanently increase the capacity of Allerton Church of England Primary School, a voluntary controlled school, from 420 to 630 pupils with effect from 1 September 2018. The current admission number for the school is 60 into Reception each year (aged from four) and the proposed admission number for Reception each year is 90 (aged from four). This permanent increase would apply to Reception classes from September 2018 and it would therefore take several years for the school to reach its full capacity. It should be noted that the school has already admitted additional children into its reception class during three separate years (2014, 2016, 2017) and therefore is already part of the way towards the upper limit of 630 pupils that this proposal recommends.

No new or additional site is required for these changes. The school will expand on its existing site. Some additional building and/or remodelling of existing buildings will be required. This will be phased in agreement with the school, and be subject to the normal planning permission process.

#### Evidence of demand:

Leeds City Council has permanently increased primary places across the Alwoodley and Roundhay areas over a number of years and more recently bulge cohorts, (where a school admits children above its published admission number as a temporary increase) have been agreed at a number of local schools to address the ongoing demand for places.

A review of births and children aged under 5 based on NHS data, as well as admissions data spanning the last few years, has highlighted the need for additional primary school provision in the Alwoodley area. The number of children living nearest to Allerton Church of England Primary School and Alwoodley Primary School exceeds the number of available places for the foreseeable future, and over the past few years there has been an additional pressure on available places for children living in the east of the area. In addition the Governing Body of Brodetsky Jewish Primary School, as its own admitting authority, recently ran a public consultation to reduce its Published Admission Number from 45 to 30. The Local Authority did not support this change however this will take effect for admissions from September 2018.

This proposal would help to address the longer term need for more school places as outlined above.

#### Effect on other schools:

Alwoodley has a range of existing types of primary provision including Community, Church of England, Catholic, Jewish and Sikh Ethos. Allerton Church of England Primary School is a voluntary controlled school and therefore does not admit children under a faith priority.

The council has a duty under the Education and Inspections Act 2006 to secure diversity in the provision of schools and increase opportunities for parental choice. Creating 30 additional permanent

places each year at Allerton Church of England Primary School will provide more choice for local families and help ease the ongoing demand for places. Based on the expected demand for school places across Alwoodley and to the east of the area, along with the success of temporary additional places in recent years at Allerton Church of England Primary School, Leeds City Council would anticipate that an increase in places at this school will not have any negative impact on other local schools.

# Objectives:

The council has a duty under the Education and Inspections Act 2006 to secure diversity in the provision of schools and increase opportunities for parental choice. Creating 30 additional permanent places each year at Allerton Church of England Primary School will provide more choice for local families and help ease the ongoing demand for places.

The proposal to increase primary provision in the Alwoodley area has been brought forward in time to allow places to be delivered for 2018. A decision not to proceed at this stage may result in a fresh consultation on new proposals, and places may not be delivered in time. The Local Authority's ability to meet its statutory duty for sufficiency of school places in the short term may be at risk if this proposal did not go ahead.

Vehicles park on both sides of the road across the street and makes it impossible for traffic to flow. This causes congestion at the crossroads directly outside the school and makes it difficult and dangerous for pedestrians to cross. I believe that to increase the size of the classrooms and school intake will only add to the chaos. This is a serious concern and needs to be addressed with the Highways and Police departments as part of any planning. The school is aware of the problem and the real threat to the safety of the children There are currently yellow lines and permit holder only parking outside my home which is adjacent to the school. Some parents park their cars on the road illegally whilst taking and collecting their children to/from school. No body is policing this and so the problem continues.

On a personal note, I find it very frustrating when I witness people parking with no regard to the law. Especially when I arrive home to find people blatantly parked in the residents only permit area. I have endured numerous accounts of verbal abuse and even been threatened with violence when I have pointed out that they should not park there. Even the buses park on the road markings when taking the school children on outings. On more than one occasion I have not been able to get into my car through the driver side as the buses have parked too close to it. I have addressed this with the school who state there is not enough room to turn the bus in their car park, despite having extended it a few years ago. I know this not to be true as I have witnessed a bus drive into the school and turn before parking there to pick up the children.

Increasing the size of the school will only exacerbate the existing problems and should be taken into consideration.

Dear Sir/Madam,

As a resident on Lingfield Approach I do not think a doubling of the current pupils by 210 is a viable proposal.

Unfortunately the parking and traffic situation is extremely congested by cars, owned by both parents and residents parking on both sides of the road during the peak times of drop off and pick up. This has made it impossible to drive through both Lingfield Approach and the parallel road Lingfield View.

I do believe the possible addition of another 200 or so cars at these peak times will increase the congestion on, Lingfield Approach and Lingfield View and also spread that further out. When I return from work at the peak time of school pick up it is impossible to get through and cars often have to reverse to let oncoming traffic through... Buses have also had to reverse... This with children and parents crossing the road and doors open to get children in their cars is an accident waiting to happen.

Another issue is current parents do not observe the permit parking restrictions in force on either side of the road on approach of the school entrance and this will also get worse. This is particularly hazardous as children frequently run across this particular part of the road without looking and an increase in vehicles in this area is extremely dangerous.

I do not believe that the surrounding roads can support another 200+ cars without posing an increased risk to safety. Parents reluctance to park farther from the school is already evident. Restriction of parking through double yellow lines is possible but it is unlikely to stop parents from parking there..parents do not observe the permit parking in force mainly due to the fact there is no one who patrols the area regularly to enforce it, so parents do not take it seriously.

While it is a great achievement for the school to want to expand/double it's intake... It might be possible if there were a few different entrances as some other schools have... i.e., nursery, reception, Yr 1,Yr 2 and another entrance for Yr 3&4 and a final entrance for Yr 5 & 6. This would spread out the traffic congestion. This however is unlikely to happen as providing different entrances would be expensive.

As the school stands with one entrance I do believe the proposal is not viable on the grounds if safety. I hope Leeds City Council thinks seriously about the safety issue and plan accordingly either way.

I also hope that the Leeds City Council will look at the current parking situation at these peak times. The current situation is at breaking point and desparately requires some attention and planning.
