Brief summary

- This annual assurance report, provides assurances in relation to planning decision making and enforcement arrangements.
- Using the cycle of internal control framework, Members are provided with assurance as to the adequacy of policies and practices and measures in place to ensure that the framework is clearly defined and communicated, embedded and monitored with appropriate escalation processes in place and that it is reviewed and refined to ensure continuous improvement and assurance for the period April 2021 to March 2022.
- A number of process and systems changes have been made during the reporting period as a result of the ongoing impacts of COVID, the ongoing budget and resourcing pressures faced by the service and unprecedented level of applications submitted during the year. All changes made retain the assurance of delivering high quality outcomes within a robust governance framework.
- The planning services' decision-making framework sets out systems and processes which ensure information is shared in a clear and consistent fashion. The decision-making framework seeks to ensure that the service is open, honest and trusted.

What is this report about?

- 1 The Chief Planning Officer has responsibility to ensure that the Council's arrangements for dealing with and determining planning and compliance matters are lawful and up to date, fit for purpose, effectively communicated, routinely complied with and monitored and has internal arrangements in place to provide assurance in the decision-making process and to mitigate any potential risk of challenge on the grounds of partiality or bias.
- 2 Attached as Appendix 1 is the annual assurance statement for Development Management and Planning Enforcement functions of the Council for the period April 2021 to March 2022. The statement outlines the key internal controls and processes in place to mitigate risks and to provide assurance that systems and processes for decision making on planning decision and enforcement activity are in place.
- 3 Actions suggested by the Local Government and Social Care Ombudsman have been put into place as a result of finding the service at fault in two cases in 2021-22. Such remedies seek to further strengthen an already robust governance process and as such they pose little or no risk to the Council, however, further work has been carried out to provide greater consistency, transparency and assurance in the planning process.

What impact will this proposal have?

- 4 Members will be guided through the report using the cycle of internal control framework, which will provide the assurance to the adequacy of policies and practices, measures to ensure that the framework is clearly communicated, embedded and monitored with appropriate escalation processes in place and is reviewed and refined to ensure continuous improvement and assurance. This framework ensures compliance with statutory and other guidance.

How does this proposal impact the three pillars of the Best City Ambition?

Health and Wellbeing Inclusive Growth Zero Carbon

- 5 The Development Management service contributes to all of the Council's Best City Ambition Priorities either directly or indirectly through the delivery of high-quality homes and through sustainable place-making to deliver safe, strong communities. Its work in delivering planning permissions for social housing and assisted living accommodation as well as delivering permissions for new schools, supports the Council and partners to meet its ambitions. Through working with other Council services, Development Management also facilitates, through the legal agreement process, employment opportunities for local people. The planning process is closely tied with the health and wellbeing and climate change agendas through the implementation of the policies in the Local Plan. Whilst there are no specific issues arising from this report, it should be emphasised however, that through the Local Plan Update 1, policies to tackle the scale and urgency of the Climate Emergency are being updated and enhanced to support the Zero Carbon ambition of rapid progress towards carbon neutrality by 2030.
