We have already had problems with noise in the past with the premises of the former Stinkies Night Club and continue to have issues with the events held in the town centre, with music and tannoy systems that can be heard from Millenium Square, Clarence Dock and Brewery Wharf and more recently the Mint Festival.

Th railway arches accentuate any noise and we do not want further problems with a premises even closer to our homes with even more music and alcohol licenses.
