

As such, it is entirely contrary to the local Cumulative Impact Policy, which resists additional licensing in the area.

Councillors Abdul Hanna, Jonathan Pryor and I wish to object to the application from Nisa to extend its hours for selling alcohol.

The Cumulative Impact Area which restricts the number of premises supplying late night alcohol applies to the location of Nisa. We see no reason to waive the CIA conditions in this case.

Extending the hours would, in our opinion as local councillors, have an adverse effect on the amenity of the majority of local residents, including children.

This is a mixed area containing transient residents such as students and other young people, and permanent residents of all ages, including families with young children. Most residents, whether students, other transient residents or permanent residents, are responsible, considerate individuals. However we do receive a high volume of complaints from residents, some of whom are transient, students and young themselves, while others are permanent, about the noise of house parties at night and in the early or not so early hours of the morning, and these parties all feature alcohol. To increase the ready availability of this in a location like Nisa's would in our view cause significant public nuisance.

Housing is dense here, with many terraced and semis packed into a confined space. Noise travels easily. In addition, there is a far higher than average amount for f broken glass on the streets from wine and other bottles, which is a danger to people, animals and vehicles alike.

We think that the extension of licensing hours would increase these problems.

We agree with objections submitted by LCC licensing officers and the police.
