There are relatively few such opportunities for young people in the Boston Spa area and it is no doubt a positive way of mitigating against anti-social behaviour causing a public nuisance. Giving young people chances for sporting activities in a supportive environment reduces the risk of harm to them that might come from boredom or excessive reliance on online activities. Many cricket clubs have folded in recent years.

This club has over 100 juniors every year, including girls teams. But the business model for the survival of cricket clubs is heavily dependent on a licensed clubhouse to provide income on match days and training sessions. This application needs to be approved if the community is to continue reaping the benefits provided by this club in the years ahead.
