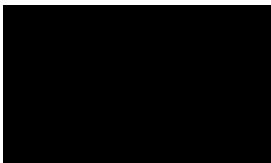
Objections to licensing application

As a Meanwood resident I frequently pass the precinct and the area where the shop is located. There are already many retail establishments within a very close area that sell alcohol; at least 5 bars, 2 supermarkets, 4 mini markets, 2 bargain booze shops and the provision of another outlet adds nothing to the health and well-being of the area.

The area where the shop is located is very close to where all day drinkers already congregate and the provision of another outlet allowing them to get alcohol at 6am can only encourage antisocial behaviour and bad health outcomes. There is already an issue in the precinct with damage to the planters and littering etc which is likely to increase with more people in the centre of Meanwood under the influence of alcohol.

Alcohol is the cause of many problems, poor health, anti social behaviour and at its worst violent activity. Encouraging people to drink at all hours throughout the day can only exacerbate those problems.

The shop is on a route to school and the area close to the shop on Green Road houses a number of vulnerable adults. There are also houses and flats directly opposite and above the shop who will suffer with potentially increased noise and nuisance from people buying and consuming alcohol nearby. The shop is neither compatible nor needed in the area.

I wish to register a formal objection to the Section 17, Part 3 licensing of the above premises to sell alcohol.

Reasons:

Alcohol can already be purchased from several retail outlets in close proximity to this address and serves the local area sufficiently for this need. There is a Waitrose supermarket directly opposite the address. There is an Aldi supermarket around the corner. There is a Meanwood News and Booze outlet around the corner. There is a retail outlet, Bahi's, around the corner. All of these are within 3-4 minutes walk of each other. And there is a Morrison's Daily store a 5 minute walk away. All of the above include easy access news, sweets, some groceries. There is also a Post Office just along from the above address.

There have recently been extensive remodelling road work in the immediate area, part of the reasoning being to make Meanwood a more accessible and attractive shopping / leisure centre. More attractive that is for retail and social entertainment (cafes / bars). Please contribute to enhancing Meanwood rather than simply adding 6am to 11pm cheap booze.

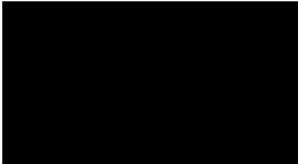
