The current owners Flying Tandoori have been in the same place for over a decade. They have always put their residents first. They have a rota in place to do Trash Walk every hour or when required. They clean up outside when they start at 4pm and then when they finish but the hourly system has been in place over a decade that is followed and implemented daily.

When they first took over there was a lot of ASB/ noise nuisance due to Oakwood Pub across the road, which has been turned into a McDonald's operating a 24 service with a drive thru.

When McDonald's took over the Oakwood Pub they had extreme problems with ASB, Drugs dealing in the car park, joy riding in the car park and numerous shootings, stabbings and armed robberies. Over time McDonald's have turned these challenges into positive and the restaurant is a popular destination for families.

Flying Tandoori have never had these issues outside their premises due to mainly over 90% of their business is delivery orders.

Flying Tandoori have an extremely mature team of dedicated delivery drivers who have worked with them over a five year's service at least and are from the local area with young

children.

Flying Tandoori have not received any complaints from customers, residents, or other businesses regarding their services over the past decade. Their extraction system is fully maintained and is the same system that has had upgrades to date, they have not had a single complaint regarding its reliability or noise as it is very economical and quiet.

We as the Ward Councillors believe that they are not any different from any other responsible business and they have shown over time that they care about the environment they do their business and have shown this practically.

As elected members at the point of writing this email we are not aware of any responsible authority, West Yorkshire Police, LASBT or Public Health making an objection to their extension.
