77 Chair's Opening Remarks

80 Apologies for Absence

Apologies for absence were received from Councillors Atha and Golton. The Chair also read out a number of apologies received from officers and members of the public which were duly noted by the Committee.

81 North West Inner Area Committee Well-Being Budget

Referring to minute 69 of the meeting held on $1\overline{7}^{th}$ February 2005, the Director of Neighbourhoods and Housing submitted a report on the North West Inner Area Committee Well-being Budget.

 - short-term funding of £20k for twelve months to assist the work of those organisations identified in Appendix 2.1 and Appendix 3 to be allocated on a case by case basis
- (h) That the Well-being capital projects already agreed, in principle, as outlined in Appendix 4 be noted and that the three outstanding projects for 2005/06 be considered at the next meeting in April 2005.
- (i) That approval be given to the monitoring procedure as outlined in 5.1 of the report.
