# 1. Summary of Main Issues

- 1.1 The vision for Leeds is that by 2030 it is a Child Friendly City. The methodology for delivering this vision is defined in The Children and Young Peoples Plan which details five headline outcomes one of which is that Children and Young People will do well at all levels of learning and have the skills for life.
- 1.2 The Scrutiny Board (Children and Families) understand as a result of inquires into Child Poverty, School Attendance and Increasing the number of young people in Education, Employment and Training that good support for parents and children early in a child's life is important. The Marmot Review 'Give Every Child the best start in life' states that "Later interventions although important, are considerably less effective where good early foundations are lacking". The Board are also very aware that children growing up in disadvantaged families are less likely to succeed in later life as they do not have the same level of support or benefit as others. A number of reports have been produced which make clear that early help and intervention is crucial to get families out of the cycle of poor outcomes. These reports have become the focus of subsequent foundation years documentation identifying required change, produced by the Department of Health and the Department for Education.

- 1.3 Considering these factors at its meeting on the 20<sup>th</sup> of June 2012, the Scrutiny Board resolved to undertake an inquiry looking at foundation years (age 0- 5) and how services in Leeds are provided to promote the best start in life for children, to equip them with the skills to succeed and promote their social mobility.
- 1.4 The following matters were specifically highlighted as areas of interest:
  - The universal and targeted health, wellbeing and developmental support in place for children and their families during foundation years (0-5) in Leeds.
  - Levels of support and engagement with families particularly those that are disadvantaged or hard to reach
  - Provision and delivery services, particularly those delivered in partnership with others such as the NHS and private and voluntary sector, the promotion of services and how accessible these services are.
  - To determine how well Leeds is working to identify challenges and take appropriate measures to improve outcomes for children and their families.
  - To identify how take up of free early education provision can be improved in the more deprived areas of Leeds.
- 1.5 Additional guidance has been sought from the Head of Service (Early Help Service) in order to recommend areas of focus for the inquiry.

The Board also notes the inquiry published in June 2009, Education Standards – Entering the Education System and the Health Inequalities work undertaken by the Scrutiny Board Health & Wellbeing and Adult Social Care in April 2012 which is relevant to this inquiry.

- 2.2 Note that the terms of reference may incorporate additional information during the inquiry should the Children and Families Scrutiny Board identify any further scope for inquiry or request further witness or evidence.

#### 1.0 Purpose of this report

- 1.1 At its meeting on the 20<sup>th</sup> of June 2012, the Scrutiny Board resolved to undertake an Inquiry looking at foundation years (age 0- 5) and how services in Leeds are provided to promote the best start in life for children, to equip them with the skills to succeed and promote their social mobility.
- 1.2 The purpose of the inquiry is to make an assessment of and, where appropriate, make recommendations on the following areas:
  - The universal and targeted health, wellbeing and developmental support in place for Children and their families during foundation years (0-5) in Leeds.
  - Levels of support and engagement with families particularly those that are disadvantaged or hard to reach
  - Provision and delivery services, particularly those delivered in partnership with others such as the NHS and private and voluntary sector, the promotion of services and how accessible these services are.
  - To determine how well Leeds is working to identify challenges and take appropriate measures to improve outcomes for children and their families.
  - To identify how take up of free early education provision can be improved in the more deprived areas of Leeds.
- 1.3 The Board also notes the Scrutiny inquiry published in June 2009, Education Standards Entering the Education System which examined the following areas:
  - How information on attainment is collected by childcare providers, and in particular what impact the introduction of the Early Years Foundation Stage (EYFS) will have on this
  - How this information is shared with primary schools
  - How attainment is measured within primary schools, both on entry to foundation stage and at KS1
  - More broadly, how the transition between pre-school provision and primary provision is managed
  - How children at risk of underachievement are identified at an early stage, and how information relating to them is shared between the different services involved
  - How information about the needs of all children aged 0-7 and their families is collected and used by other services.
- 1.4 During April 2012 a working group of the Scrutiny Board (Health and Wellbeing and Adult Social Care) considered evidence specifically relating to health inequalities for children under 5 years of age. During this session information relating to the Family Nurse Partnership was considered, an approach which was wholly supported by the working group. A number of proposed draft recommendations have been determined which will be taken into account during this inquiry. The main outcomes are as follows:

- The city needs to target services towards the most deprived communities to tackle the entrenched social inequalities that form the wider determinants of health poverty, poor housing, poor environment, low educational outcomes, unemployment, low aspiration.
- the Family Nurse Partnership (FNP) approach is wholeheartedly supported, with
  the outcome of the formal review to be reported back to the Health and
  Wellbeing and Adult Social Care Board. Subject to the outcome of the review of
  the pilot areas, consideration to be given to expanding the approach across the
  City.
- Concern about the significant impact on families in the more deprived areas of Leeds who are at higher risk of suffering health inequalities.
- Concern about access to information and services in the more deprived areas of Leeds.

#### 2.0 Comments of the relevant Director and Executive Member

2.1 In line with Scrutiny Board Procedure Rule 12.1 where a Scrutiny Board undertakes an Inquiry the Scrutiny Board shall consult with any relevant Director and Executive Member on the terms of reference.

#### 3.0 Timetable for the inquiry

- 3.1 The Inquiry will take place at the Scrutiny Board (Children and Families) meeting on the 27th of September, 11<sup>th</sup> of October and 15<sup>th</sup> of November with a view to issuing a final report in January 2013.
- 3.2 The length of the Inquiry may change.
