Summary of main issues

This report advises Members that a temporary event notice has been received and Leeds City Council Environmental Protection Team have served an objection notice on the grounds of public nuisance.

1 Purpose of this report

- 1.1 To advise Members of a temporary event notice served under section 100 of the Licensing Act 2003 ("the Act") in respect of the above mentioned premises.
- 1.2 Members are required to consider this application due to the receipt of an objection notice from the Environmental Protection Team.

- 2.1 The proposed premises user is Merita Kasa.

- 2.5 There is no premises licence in force for these premises.

3 Representations

- 3.1 West Yorkshire Police and LCC Environmental Protection Team have received a copy of the notice.
- 3.2 Environmental Protection Team consider that allowing the premises to be used in the manner set out in the temporary event notice will undermine the prevention of public nuisance licensing objective and have issued an objection notice. Members' attention is drawn to Appendix C.





Licensing Act 2003 - The Prevention of Public Nuisance Name and Address of Premises: Premier Banqueting Suite, Stoney Rock Lane, Burmantofts, Leeds, LS9 7TZ

We have received a notice of a temporary event to take place at the Premier Banqueting Suite from 20:00 on Sunday 1st January, until 01:00 on Monday 2nd January. The event is described as 'a New Years Eve Celebration including sit down meal and supply of alcohol', for up to 300 people. Licensable activities intended to be carried out include the sale of alcohol, provision of regulated entertainment, and provision of late-night refreshment.

The Premier Banqueting Suite is located is a residential area, with the nearest residences located adjacent to the premises.

Previous events at the Premier Banqueting Suite have given rise to multiple complaints, over a number of years, about noise from loud music, and noise from guests leaving the premises in the early hours. Owing to the likelihood of noise nuisance issues occurring, an abatement notice was served on the Premier Banqueting Suite on 27th July 2022.

Based on the history of noise issues from late night events held at the premises, the proximity of nearby residences, and the event's late finishing time, we have concerns that the above event may cause disturbance to residents arising from:

- Noise from music
- Noise from people as they leave the premises late at night
- Noise from vehicles transporting people from the area late at night.

Therefore, this department does not believe that the licensing objective for the prevention of public nuisance will be met should the proposed event take place and consequently, is formally serving notice that we object to this TEN application.
