Dear Mr Jalal

Further to my visit to the above shop today and our telephone conversation, please may I remind you of the request that you send me an email with a screenshot of your cctv showing footage from the 11th December 2023 or a screenshot of the system calendar showing it is recording from at least the 11th December 2023.

Please note the specific condition on your Premises Licence which states:-

7. The CCTV system will have sufficient storage retention capacity for a minimum of 31 days continuous footage which will be of good quality.

When you are in breach of one or more conditions you are operating other than in accordance with your Licence which is an offence under Section 136 of the Licensing Act 2003, namely:-

- (1) ***A person commits an offence if -***
- (a) ***he carries on or attempts to carry on a licensable activity on or from any premises otherwise than under and in accordance with an authorisation, or***
 - (b) ***he knowingly allows a licensable activity to be so carried on.***
- (4) ***A person guilty of an offence under this section is liable on summary conviction to imprisonment for a term not exceeding six months or to an unlimited fine, or to both.***
- (5) ***In this Part "authorisation" means -***
- (a) ***a premises licence,***
 - (b) ***a club premises certificate, or***
 - (c) ***a temporary event notice in respect of which the conditions of section 98(2) to (4) are satisfied.***
