Glass and Bottle Holder

Small glass hanging area above bar between takeaway area and counter to softly devide the space



Counter


Counter to be in Brass or marble affect to be hard wearing and neutral

Above Bar

Four pendant lights hanging to give direct light on to top of bar and service area

Bar

Curved bar to welcome. Left side to be higher to demark takeaway service area. Bar to be tiled. Dark blue tiles shown below, relecting the light. The dark blue works very well with Brass details



Wall Art

Large graphic of name on the wall behind the counter to be visable as soon as enter space



Back wall to be tiles in off white tiles, with open shelving in front of it behind the bar for storage

Use of soft seating which will help with the acoustics, meaning it isn't too echo. Also bring in pattern and colour through the fabric on the bench and the chairs. Option to put a real statement chair in the back

Curtain Dividers

Two curtain dividers used between seating and w.c. and at entrance to stop the draft. Curtain material to be velvet and dark blue, to be heavy and also absorb noise.





Wall Lights

Warm wall lights used on the wall above the soft seating to give a warmth to the space

Window Lights

Beautiful bright statement lights over the three tables in the window



Flooring

Tiled floor throughout - floor to be split different tile used in takeawy area/ entrance to main space. Tiles in takeaway area to be more detailed.




