I am a police officer in the West Yorkshire Police, currently stationed at Killingbeck Police Station, Leeds on the Crossgates, Whinmoor and Temple Newsam neighbourhood policing team.

On Sunday 8<sup>Th</sup> May 2011 at around 17:00 hours I was in company with PCSO DEVLIN when we attended at Wood view care home to visit the licensee of the bar within the home.

The licensee DOUGIE RICHARDSON was very defensive upon meeting him. Inside the bar are which is located near the main entrance there was around 30 people most of the people being in on group in the corner of the bar. There were only 3 residents in the foyer area and to me this seems very strange being in a care home.

Mr Richardson seem very on edge wanting to prove all the time that he has done nothing wrong and that he does not let drunk people in. He went on to show me that residents have complained about people taking chairs outside and that this was not possible but he managed to get the chair outside and started then to go on about the CCTV.

Whilst I was there the group of people in the corner of the bar were very loud but in good spirits, there was three or four people in the door smoking and playing music from there mobile phones. This to me was disrespectful to the people of the home. Whilst I think that the idea of a Signature:
