INTRODUCTION

I am an Operations Manager, employed by Select Service Partner Limited ("SSP"). My responsibilities include the operational leadership and management of the North of England region for SSP which encompasses 50 multi-branded units in 15 railway stations, of which Leeds City is one. SSP operate numerous units at City Station including the White Rose, Burger King, M&S Simply Food, Pumpkin and Camden Food.

This application is for the grant of a Premises Licence for a KFC restaurant to be situated on the North Concourse of City Station. As set out in the witness statement of Kris Dungey, KFC will be operated under a franchise agreement and will be accessible only from the station. It will replace the existing licensed Whistlestop unit and the Premises Licence for Whistlestop will be surrendered when the KFC starts trading, if this application is granted.

OPERATION OF PREMISES

We have applied for late night refreshment from 23.00 to 02.00 daily to give flexibility to cater for persons using and working from City Station. Train services operate throughout the night from the station to Manchester Airport and York (one every hour and a half approximately). There are additionally approximately 30 passenger services between 11pm and 2am.

As set out in the application, a CCTV system will be installed and maintained on the Premises. In addition, the station itself is covered extensively by CCTV with 360 cameras in operation, including coverage of the North concourse area where the KFC will be based.

Furthermore, the company operate a "lone worker" policy. The minimum staffing for the KFC would generally be 5 employees up to the last hour of business and a minimum of 3 employees (including a team leader) for the last hour. The unit will have a trained team leader (unit duty manager) on shift at all times.

The General Manager of the KFC will be the current manager of the Burger King at City Station, Phil Connell. As set out above, the Burger King is currently authorised for the hours now applied for i.e. from 23.00 to 02.00 daily. Although we do not operate until 02.00 on a daily basis, we have done so on certain occasions. We are currently opening until midnight Sunday to Thursday and until 01.00 Friday and Saturday without complaint. As far as I am aware, we have not received any complaints from the Leeds' Police Licensing Service or the British Transport Police in relation to the operation of the Burger King.

As shown on the plan submitted with the Licence application, the KFC unit will consist of the back of house kitchen area, a counter and dedicated self-contained seating area. There will be 32 seats available for customers who wish to eat in.

The company has procedures in place to ensure queues are properly managed. Queue barriers will be used to control the shape of the queue and all unit duty managers are required to carry out and record regular shift walk-throughs to ensure customers are called forward at the earliest possible time. The service standard for the KFC stand is that a customer will spend a maximum of 5 minutes in the queue and will be served within 60 seconds of payment.

There are numerous other alternative venues for late night refreshment in the City Centre outside of the Station (a number of which we understand are already authorised for late night refreshment until or beyond 02.00 daily). For example, on Boar Lane adjacent to the station, there is Greggs authorised until 04.30 daily; St Ives Pasty Bakery authorised until 04.00 Friday to Sunday; and a Subway authorised until 04.00 daily. There is a further Subway on Duncan Street authorised until 05.00 daily; and Mumtaz Jaldi Jaldi on Nevill Street authorised until 05.00 daily.

We would anticipate that the majority of our customers would be passengers/ other station users. Other persons would have a choice of numerous alternative venues for late night refreshment in the vicinity.

CONCLUSION

As the KFC will be located wholly within City Station and will replace the existing licensed Whistlestop, 1 do not believe that the granting of this application would adversely affect the licensing objectives or add to the cumulative impact of licensed premises in the City Centre.

For the reasons set out above and in the statement of Kris Dungey, I would ask the Committee to grant the application.

INTRODUCTION

I am a Regional Operations Manager, employed by Select Service Partner Limited ("SSP"). My responsibilities include responsibility for extensive rail catering operations throughout the Midlands and North.

SSP have operated units at transport hubs across the UK for approximately 5 years, although the management structure has been in place for almost 20 years as the company was previously owned and operated by the Compass Group. Current brands include M&S Simply Food, Burger King, Uppercrust, Costa Coffee, Millies Cookies and Starbucks.

This application is for the grant of a Premises Licence for a KFC restaurant to be situated on the North Concourse of City Station. KFC is a well known fast food brand, which will be operated under a franchise agreement at City Station by SSP.

The outlet is accessible only from within the station and there is no public entry or exit into the unit other than the main entrance on the North Concourse. The position of the unit within the station is shown on the site location plan at Annex A of this statement.

The KFC will be located in a unit that SSP currently operate as a "Whistlestop". The Whistlestop is a convenience store and as such, the unit has the benefit of a Premises Licence for the sale of alcohol and recorded music daily from 08.00 to 00.00 midnight; and for late night refreshment, also until midnight (Licence Number PREM/01244/VO1). The Premises Licence for the Whistlestop will be surrendered when the KFC opens, if this application is granted. A copy of the Whistlestop Licence is attached at Annex B of this statement for ease of reference.

APPLICATION FOR PREMISES LICENCE

The application that has been made is for late night refreshment only from 23.00 to 02.00 daily. The hours applied for mirror those that are authorised for late night refreshment for the Burger

King at City Station, also operated by SSP. A copy of the Burger King Licence is attached at Annex C of this statement for ease of reference.

The application is made in these terms to give flexibility to cater for persons using City Station. Train services operate throughout the night as detailed in the statement of Jay Heathcote.

SSP operate over 300 licensed outlets at railway stations nationwide. The company has detailed brand standards and due diligence procedures and work with British Transport Police and Network Rail across the country to ensure compliance on an ongoing basis. Where British Transport Police have crime and disorder grounds to request that a unit is closed temporarily, the company would do so voluntarily. For example Leeds played Manchester United (20/9/11) and at the request of the Police SSP closed the White Rose Bar at 22.00.

The company has operated a number of Premises Licences at City Station since 2005 when the Licensing Act 2003 came into force. Prior to that, we operated Justices Licences at the station for over 15 years. Throughout that time, as far as I am aware, we have never been subject to any review application or enforcement action at the station by any responsible authority or interested party.

REPRESENTATIONS

Health & Safety Service

We have agreed a condition with the Health & Safety service as follows:

Being a responsible business, Select Service Partner Limited has comprehensive policies, procedures and audit systems in place to protect public safety. These include arrangements for pre-opening checks, electrical safety, accident recording and first aid arrangements, and slips and trips in public areas. The unit Manager will ensure that Company's Health and Safety policies and procedures relating to public safety are being followed.

Police Licensing Service

I understand that the police have made a representation to this application on the basis that the premises falls in the City Centre Cumulative Impact zone.

However, we do not believe that the granting of this application will have an adverse impact on the licensing objectives in the cumulative impact zone for a number of reasons:

- 1. If this application is granted, the current Premises Licence for the Whistlestop (which authorises alcohol, music and late night refreshment until midnight daily) will be surrendered when the KFC starts to trade.
- 2. The unit is located wholly within the City Statio and can only be accessed from the North Concourse. There is no direct access from the street, as shown on the site plan annexed to this statement.
- 3. There are existing units in the Station authorised for late night refreshment until the times applied for. The Burger King, also operated by SSP, is authorised for late night refreshment until 2am daily. We also understand that the McDonalds (operated by a third party) is authorised to provide late night refreshment until 02.00 on Thursdays and 02.30 on Fridays and Saturdays.

- 4. In our experience, customers using station facilities for late night refreshment are generally passengers and persons who would be in the station in any event, including train drivers, network rail and station staff.
- 5. The unit will be self-contained with a dedicated seating area as shown on the plan submitted with the application. We also have procedures to manage queues at the premises, as set out in the statement of Jay Heathcote, to minimise the impact of the premises on the station concourse.

CONCLUSION


I do not believe that the granting of this application would adversely affect the licensing objectives or add to the cumulative impact of licensed premises in the City Centre. This is not a new-build premises – it will replace a convenience store which is licensed for late night refreshment, the sale of alcohol and recorded music until midnight

SSP have considerable experience in managing station premises and indeed already operate the Burger King at City Station which is authorised to provide late night refreshment for the same times.

For the reasons set out above and in the statement of Jay Heathcote, I would ask the Committee to grant the application.




