## Summary of main issues

1. This report seeks the Committees approval to a correction being made to the signed minutes of the meeting of the East Inner Area Committee held on 8 September 2011

## Recommendations

2. The East Inner Area Committee (EIAC) is requested to approve an amendment to Minute 33 of the meeting held 8 September 2011 in line with the Decision Schedule of the same meeting, in order to read: "To approve a grant for the Rainbow Hearts Women's Group in the following way – to award 50% (£4962.50) of the grant requested to be split equally between the Gipton & Harehills and the Burmantofts & Richmond Hill wards and to review the success of the scheme in due course"

## 1 Purpose of this report

1.1 This report sets out the request for the correction.

## 2 Background information

2.1 EIAC considered the Wellbeing Fund Capital and Revenues Budget at the meeting held on 8<sup>th</sup> September 2011 and discussed several projects seeking funding. The minutes of the meeting were approved as a correct record on 20<sup>th</sup> October 2011 and subsequently signed by the Chair. The Committee discussed the Rainbow Hearts Women's Group application as recorded in the minute:

#### Extract minute 33

Rainbow Hearts Women's Group – Lucy Fishwick attended the meeting to provide clarification on the provision of services in the Harehills and Burmantofts areas. The ward members discussed the split of provision for the Group and agreed to a 50:50 split across the Gipton & Harehills and Burmantofts & Richmond Hill wards, to be reviewed in due course

2.2 This outcome was correctly recorded in the Decision Schedule for the meeting as being –

To approve a grant for the Rainbow Hearts Women's Group in the following way – to award 50% (£4962.50) of the grant requested to be split equally between the Gipton & Harehills and the Burmantofts & Richmond Hill wards and to review the success of the scheme in due course

2.3 It has recently come to light that a mistake was made in the resolution of minute 33 which states that approval was given for the whole amount requested (£9,925.00) to be awarded to the Group

#### 3 Main issues

- 3.1 The error has come to light as officers are at the point of releasing funding to the scheme and requires amendment in order to reflect the discussion and outcome that Members agreed.
- 3.2 The signed minutes will stand as the original record of the meeting held on 8<sup>th</sup> September 2011. The correction, if approved; will be dealt with as a separate decision of today's meeting and will be minuted as such. The new minute will refer back to minute 33 of the meeting held on 8<sup>th</sup> September 2011. An annotation will be made on the minutes of 8<sup>th</sup> September 2011 directing future readers to the subsequent amendment

As the recommendations of this report are merely requesting an amendment to the formal minutes of the 8 September 2011 meeting, this matter is not eligible for Call-In
