CONFIDENTIAL AND EXEMPT ITEMS

The reason for confidentiality or exemption is stated on the agenda and on each of the reports in terms of Access to Information Procedure Rules 9.2 or 10.4(1) to (7). The number or numbers stated in the agenda and reports correspond to the reasons for exemption / confidentiality below:

9.0 Confidential information – requirement to exclude public access

9.1 The public must be excluded from meetings whenever it is likely in view of the nature of the business to be transacted or the nature of the proceedings that confidential information would be disclosed. Likewise, public access to reports, background papers, and minutes will also be excluded.

9.2 Confidential information means

- (a) information given to the Council by a Government Department on terms which forbid its public disclosure or
- (b) information the disclosure of which to the public is prohibited by or under another Act or by Court Order. Generally personal information which identifies an individual, must not be disclosed under the data protection and human rights rules.

10.0 Exempt information – discretion to exclude public access

- 10. 1 The public may be excluded from meetings whenever it is likely in view of the nature of the business to be transacted or the nature of the proceedings that exempt information would be disclosed provided:
 - (a) the meeting resolves so to exclude the public, and that resolution identifies the proceedings or part of the proceedings to which it applies, and
 - (b) that resolution states by reference to the descriptions in Schedule 12A to the Local Government Act 1972 (paragraph 10.4 below) the description of the exempt information giving rise to the exclusion of the public.
 - (c) that resolution states, by reference to reasons given in a relevant report or otherwise, in all the circumstances of the case, the public interest in maintaining the exemption outweighs the public interest in disclosing the information.
- 10.2 In these circumstances, public access to reports, background papers and minutes will also be excluded.
- 10.3 Where the meeting will determine any person's civil rights or obligations, or adversely affect their possessions, Article 6 of the Human Rights Act 1998 establishes a presumption that the meeting will be held in public unless a private hearing is necessary for one of the reasons specified in Article 6.
- 10. 4 Exempt information means information falling within the following categories (subject to any condition):
 - 1 Information relating to any individual
 - 2 Information which is likely to reveal the identity of an individual.
 - Information relating to the financial or business affairs of any particular person (including the authority holding that information).
 - Information relating to any consultations or negotiations, or contemplated consultations or negotiations, in connection with any labour relations matter arising between the authority or a Minister of the Crown and employees of, or officer-holders under the authority.
 - Information in respect of which a claim to legal professional privilege could be maintained in legal proceedings.
 - 6 Information which reveals that the authority proposes
 - (a) to give under any enactment a notice under or by virtue of which requirements are imposed on a person; or
 - (b) to make an order or direction under any enactment
 - Information relating to any action taken or to be taken in connection with the prevention, investigation or prosecution of crime

Summary of Main Issues

This is an application for the grant of a premises licence made by David Timothy Dodson for 41 Armley Ridge Road, Armley, Leeds, LS12 3LD.

The application explains that the premises will operate as a mini market and grocery store.

Responsible authorities and Ward Members have been notified of this application.

The application has attracted representations from a responsible authority, the Leeds West MP, the three ward councillors and several local residents, all of which object to the application entirely.

1 Purpose of this Report

- 1.1 To advise Members of an application made under Section 17 of the Licensing Act 2003 ("the Act") for a new premises licence in respect of the above mentioned premises.
- 1.2 Members are required to consider this application due to the receipt of representations.

2 History of the Premises

2.1 This is the first application for a premises licence for these premises.

3 The Application

- 3.1 The applicant's name is Mr David Timothy Dodson.
- 3.2 The proposed designated premises supervisor is Mr David Timothy Dodson.
- 3.3 In summary the application is for:

Sale by Retail of Alcohol (for consumption off the premises)
Monday to Sunday 06:00 until 23:00 hours

Non-standard timings

No non-standard timings for bank holidays or special occasions are proposed.

- 3.4 A redacted version of the application has been attached at Appendix A.
- 3.5 The applicant proposes to promote the licensing objectives by taking the steps identified in Section M of the application form.

4 Location

4.1 A map which identifies the location of these premises is attached at Appendix B.

5 Representations

5.1 Under the Act, representations can be received from anyone but they must be relevant and, in the case of a member of the public, must not be frivolous or vexatious.

Representation from Responsible Authorities

- 5.2 Outright representation has been received from the Communities & Environment Team, expressing concerns the area where the premises is situated is suffering from issues relating to anti-social behavior and alcohol related crime.
- 5.3 The representation submitted by the Communities & Environment Team can be found at Appendix C of the report.

Other representations

- 5.4 The application has attracted representations from the Leeds West MP, the three local ward councillors and several local residents (described as 'other persons' in the legislation).
- The representations from the Leeds West MP and local ward councillors includes a joint objection and individual objections opposing the application on the grounds of alcohol related issues. A copy of these representations are attached at Appendix D for Member's consideration.
- 5.6 It should be noted that Councillor Louisa Cunningham has notified the Licensing Authority that she will be representing the views of local constituents at the hearing.
- 5.7 The application has attracted a total of 10 valid representations from local residents who primarily express concerns in relation an increase in crime and antisocial behavior in the area.
- 5.8 It should be noted that three objectors have indicated that they wish to remain anonymous throughout the full application process for fear of repercussions.
- In order to protect personal data, a redacted copy of all public representations are attached at Appendix E. Original copies will be provided to Licensing Sub-Committee in advance of the hearing.

6 Licensing Hours

- 6.1 Members are directed to paragraphs 6.6 to 6.13 of the Statement of Licensing Policy which states the criteria that will be applied to any decision for new applications or variations which include extending hours.
- 6.2 In brief the Policy states at 6.12 that restrictions may be made to the proposed hours of use where, after receiving relevant representations, the council considers it appropriate for the promotion of the licensing objectives to do so.
- 6.3 The council will take into account the existing pattern of licensed premises in an area when considering what is appropriate to promote the objectives. Applications which are significantly out of character for a locality will need to demonstrate that granting the hours sought will not adversely impact on the licensing objectives.
- A list of premises in the local area and their licensed hours and activities is provided at Appendix F.

7 Equality and Diversity Implications

7.1 At the time of writing this report there were no implications for equality and diversity. Any decision taken by the licensing subcommittee will be in accordance with the four licensing objectives as prescribed by the Licensing Act 2003.

8 Options Available to Members

- 8.1 The licensing subcommittee must take such of the following steps as it considers appropriate for the promotion of the licensing objectives:
 - Grant the application as requested.
 - Grant the application whilst imposing additional conditions and/or altering in any way the proposed operating schedule.
 - Exclude any licensable activities to which the application relates.
 - Refuse to specify the said person as the designated premises supervisor.
 - Reject whole or part of the application.
- 8.2 Members of the licensing subcommittee are asked to note that they may not reject the whole or part of the application merely because they consider it desirable to do so. It must be appropriate in order to promote the licensing objectives.



I am writing to state my concerns when you consider an off licence at 41 Armley Ridge Road. (PREM/04584/001)

The site adjoins one of the most problematic illegal drinking areas in Yorkshire (with one of Leeds' first and most strongly maintained CIPs) and will exacerbate the already prolific drink and asb issues on the rise in that area. Since coming out of lockdown the area is particularly suffering from drink and asb problems and emergency meetings are ongoing between the Police, LASBT, MP, Chief Executive, leader of the Council and other senior figures to look at how to lower the drink and drug related issues in that area.

Earlier this week I was on Armley Ridge Road less than 100 yards from the applicant's site, when a girl spaced out on drink or drugs held up her hand and staggered out into the road immediately in front of my car. She looked at me and then staggered on across the road to be with two men who seemed equally drunk. (I mentioned this instance to the Police and MP.)

Yesterday evening I was in a Zoom meeting with one of our ward members, a representative of the MP and various businesses to hear about asb in the area including

an attack with a hammer on Town Street. The drunkenness and asb is now most prevalent at the Western end of the Town Street shopping area in the vicinity of Armley Moor.

The fact Armley has a Cumulative Impact Policy which ends at the Moor shows the tremendous problems of drink in the vicinity. Allowing an application just outside the border will of course simply extend the problems meaning they stretch along the town centre into a residential area.

The site is beside the two churches of Christ Church and West Leeds Christadelphian Church. Both do excellent work with their congregations and also projects with members of the local community in need. Bringing an off-licence into that area would be highly disruptive.


Similarly the neighbouring Interplay Theatre is a wonderful asset to the city and especially Armley and provides help to all aspects of the community. It started with Arts Council England funding and became the first company to tour shows created specifically for audiences with additional needs on a national level. In 1984 Interplay took permanent residence in Christchurch Hall, Armley, it became a hub of research and development for creating sensory theatre and also provided community, theatre and film projects for the residents of West Leeds. Allowing potential alcohol problems to besmirch this most valued asset would be a huge loss for Leeds and everyone who gains such huge life benefits from the presence of Interplay. Youth are especially involved in projects there.

Additionally the site is on the opposite side of the road from a residential area. Surely having an off-licence there is unnecessary with one of the city's largest town centres just a stone's throw away?

Being so close to a residential area will of course bring children into increasing contact with issues arising from the nearby sale of alcohol. With drunk and drugs issues becoming increasingly rife on nearby Town Street I fear another off licence would draw the problems down Ridge Road into that residential area?

Dear Nav,

Four residents have asked if I would represent their views, whilst retaining their anonymity.

They have asked that I present an objection to the granting of the licence for this premise based on the following reasons

- That the sale of alcohol at the convenience store 41 Armley Ridge road is proposed to be everyday from 0600 to 2300 and these hours are totally unacceptable.
- On the grounds of public safety issues such as harassment to the general public by aggressive begging and general nuisance.
- The public, particularly the elderly, don't feel safe shopping in this area because of anti-social behaviour by the illegal street drinkers.
- Children should not have to observe such behaviour on their journeys to and from school.
- There are already far too many of-licences in and around Town Street and the last thing Armley needs is yet another off- licence.
- Worry that it may lead to an increase in crime and demand on services such as the Police and anti social behaviour teams.

I am willing, if possible due to Covid-19, to personally appear at any hearing to object on behalf of these residents.

1.I live very close to the proposed shop, and my main concerns are an increase in antisocial behaviour, protecting children and vulnerable adults from harm and parking issues affecting public safety.

The area of Armley Town Street is known to have issues of drink-related anti social behaviour and therefore is a designated CIP zone. These new premises are very close to that zone, and would not be helping to reduce the issues but relocating them into a more residential area. There are already three shops selling alcohol within a few minutes walk from this location, so another is not needed nor wanted.

I am also concerned by how close these premises are to Christ Church Junior School but especially near to the new bespoke housing for adults with autism, which is across the street. The

obvious effort that went into creating a calming and secure environment for these adults is at risk. This building, and the work done within it, is a local pride and joy and it infuriates me to think it is not respected.

Armley Ridge Road is a traffic hazard already, with excessive speeds along the straight stretch which includes past these premises, and the pathetic parking techniques of customers to the existing barbers, sandwich shop and the church; as they park on the junctions, on the pavement or at the bus stops. I commute to work by bicycle, and my return journey is always fraught with traffic hazards, especially passing parked vehicles outside this row of businesses and houses. So a longer line of parked cars or drivers pulling in/out as they rush to nip to this shop, would result in my safest route being down the centre of the road for a much longer distance. Imagine then adding to this some drunken antisocial behaviour and a wet dark winter rush hour. Without better parking provision this shop should not be encouraged to open.

2.I wanted to express my concern for the above application for an off-licence at 41 Armley Ridge Road between interplay theater and Christchurch. For a long time now, Armley has been dealing with the effects of alcohol abuse in the community and the effects it brings, including crime and public disorder, particularly on nearby Town Street. With numerous off-licences on Town street, and the surrounding areas (not to mention the tesco nearby that sells a liberal amount of alcohol, there really is no need for another off-licence in Armley and will merely serve as another way for people with alcohol problems to purchase alcohol and bring the reputation of this area down further.

I refer you to the open letter hosted on the West Leeds Dispatch website (https://westleedsdispatch.com/open-letter-we-want-armley-town-street-to-be-a-safe-clean-thriving-local-centre/), that is showing the great effort that local people and services are doing to improve the area, and including another off-licence where there is already an abundance of such shops would simply be another roadblock to the efforts made to improve the area and its image.

In an area trying its best to improve, this space can be used for so much more than to simply feed the habits of vulnerable people and I hope that my comments and recommendation for the application to be rejected, are heeded.

I would like to object to the proposal of an licence been granted to the proposed new store on Armley Ridge Road.

3. Armley is beset with issues around anti social behaviour, people been drunk and aggressive in public and general rowdiness.

Within a five minute walk of this building, you have two off licences, one on Armley ridge road itself, and

one on town street, on the corner of Edinburgh Grove.

A few minutes further up you have a second off licence on the corner of Moorfield Road and Town Street, opposite Charlie Cake Park.

There are countless shops in and around town street from the moor down to Branch Road, all of whom have licences for the sale of alcohol, including the 24 hour store, which causes enough problems. The Area around the proposed shop, known as 'little Scotland' in some quarters has problems with children roaming the street, drugs, rowdy antisocial behaviour, driver treating the streets as a race track.

Another outlet selling alcohol between the proposed times, will add to the problems in the area, but will also bring the miscreants who loiter on the moor, and surrounding area further up town street to get their alcohol fix and then remaining in this new 'area; causing more issues here.

4.I was wondering if you can help with the above whilst a convenience shop would be welcome I feel the sale of alcohol would not help the area especially as the proposed opening hours are 6 am -11 pm and also this would be right opposite the new autism home. I want to object but I don't want my home address open to the public.

Hello,

I am writing you to raise concerns over a recent premise application submitted to you for an off-license on Armley Ridge Road.

As a long-term resident in the area, I have seen more anti-social behaviour due to excessive drinking than I am comfortable with. My partner has been physically assaulted twice whilst walking our dog in the park behind the proposed site, by intoxicated and aggressive individuals. There is also a significant issue with the littering of empty cans and broken glass, specifically on stairways and alleys used to access green spaces.

This is predominantly an area of families, young professionals and first time buyers, however, with the recent CIP for Armley Town Street and Moor, we have seen increased traffic of non residents. They use Armley Ridge Road and surrounding back alleys to continue to drink in public and avoid police presence, with violent altercations, vandalism, public exposure, and nuisances becoming increasingly present, especially in our public green spaces.

We have been lucky to have a family run convenience store open on Armley Ridge Road in the past 18 months or so, with a conscience staff who are extremely good at avoiding sales of alcohol to those already overly intoxicated. They themselves have had a number of incidents of refusals turning into verbal abuse and threats of violence. I myself have been in the store whilst this has happened.

I am concerned that another store so close to this one with a longer opening time and license for selling alcohol would only further encourage these problems, causing more disruption and fear for hard working residents in the area, especially those with small children. It's not fair that our efforts to clean our streets, improve our green spaces and make our community safe are being undone by non-residents who travel to our quiet part of Armley to avoid being detected by the police. If you grant permission for this application, you will be adding against us and harm the efforts we have made to bring cohesion and hope to our community. There is no need, whatsoever, for any more stores selling cheap liquor.

I would further hope you will consider the potential damage you will do to the already established business only a few doors down and the effect this will have upon the family who live on site above the shop as well. What would be the point if granting this

application to fill one unit that could lead to another, or worse both, becoming vacant again?

I hope I have been able to express my concerns concisely to you, and hope you will consider them in your decision. I am a great believer and supporter of Armley and our community, and only wish for it to have a fighting chance at rejuvenation and being able to tackle social isolation and substance abuse without being handicapped with yet another premise selling cheaply priced alcohol.
