Members were referred to Appendix 1 of the submitted report, which detailed an update from LCC Youth Service. The Localities Officer provided the following information:

• A breakdown of the four areas LCC Youth Service consider a priority; reduce crime and anti-social behaviour, encourage healthy eating and

physical activity, minimise the misuse of drugs, alcohol, and tobacco and improve social, emotional, and mental health & wellbeing.

- A breakdown of the reporting period for sessions delivered across the Inner North East Community Committee area in each of the priority areas as identified above.
- The total number of attendees from the Inner North East Community Committee area were as follows:
  - Chapel Allerton 485
  - Moortown 184
  - o Roundhay 282
- LCC Youth Service face challenges with the mobile units used to deliver Youth Work across communities. There will be a review to replace the units subject to a financial cost.

The following updates were provided:

- Health and Wellbeing update (Councillor E Taylor) Following the Covid-19 pandemic, LCC Adult Social Care is still struggling, and a number of people are suffering with mental health issues. The workload on the service is very demanding and they're doing their upmost to ensure people are receiving their services across Leeds. Preventative measures are taking place to aid people suffering with mental health issues.
- Community Safety update (Councillor M Rafique) Anti-social behaviour related statistics are stable. There is a focus on issues associated with West Avenue and an update on this hasn't yet been received. A new Policing Inspector is expected. Further to this update, Councillor Taylor explained that she is the new Chair of the Police and Crime Panel and will share crime related figures in the locality with members.
- Leeds Housing Advisory Panel Update the on-line 'walkabout' closed at the end of January and the number of participants were very high. There were a high number of interactions and people placing comments and raising issues on the map. The budget for the HAP has been reduced by 10% for 2023/24.
- Community Heroes 'Thank You Event' the event was positive and successful. Members thanked the Localities Officer and recognised his great effort of pulling together the event and recognised the importance of ensuring the Third Sector are thanked for all of their work and noted events such as these may entice more people into voluntary work.
- Environment update (Councillor J Bowden) a large number of residents are positive in terms of the relaxed mowing policy and great efforts have gone into the de-carbonisation work across the city. Councillor Bowden explained he would be interested in seeing the effects of such work across schools in the Inner North East Community Committee area, particularly for those schools who have been struggling more so with energy costs.
- It was noted that in relation to the Windrush Event, all 200 tickets have now sold out, and the event will take place Friday, 16<sup>th</sup> June 2023.

- The Youth Activity Fund Consultation that was carried out online, targeted children through schools, BREEZE events etc. Young children in the Inner North East Community Committee area expressed they would like to see more events tailored to Cooking, Outdoor Adventure, Arts & Crafts, Music, Dance and Multi-Sports.
- 92 survey responses received in the Inner North East Community Committee area.

Members commended the work that had gone into the success of the Youth Summit, and it was noted that a request has been put forward to Scrutiny, to look into the great work of the Youth Summits.

The Community Committee Team Manager explained that a lot of preparation work went into identifying how the team engage with a wider group of people. it was acknowledged that typically the same group of children are targeted through the Youth Summits.

# **Inner North East Community Committee - Finance Report**

### **Purpose of report**

1. This report provides the Community Committee with an update on the budget position for the Wellbeing Fund, Youth Activity Fund as well as the CRIS and Community Infrastructure Levy Budget for 2023/24.

#### Main issues

- 2. Each Community Committee has been allocated a wellbeing budget (revenue and capital) and Youth Activities Fund which it is responsible for administering. The aim of these budgets is to support the social, economic and environmental wellbeing of the area and provide a range of activities for children and young people, by using the funding to support projects that contribute towards the delivery of local priorities.
- **3.** A group applying to the Wellbeing Fund must fulfil various eligibility criteria, including evidencing appropriate management arrangements and financial controls are in place; have relevant policies to comply with legislation and best practice e.g., safeguarding and equal opportunities and be unable to cover the costs of the project from other funds.
- **4.** Wellbeing funding cannot be paid retrospectively. An application form must be submitted and approved by the Community Committee before activities or items being purchased through wellbeing funding are completed or purchased.

- **5.** The amount of wellbeing funding provided to each committee is calculated using a formula agreed by Council, taking into consideration both population and deprivation of an area.
- 6. Capital (CRIS) injections are provided as a result of council assets being sold. 5% of the sale price (up to a maximum of £100k) of a council asset is pooled city-wide and redistributed to the Community Committee areas on the basis of deprivation. The Community Committee will receive a new capital injection every 6 months.
- 7. Each Community Committee has also been allocated a Community Infrastructure Levy budget. For each CIL contribution, Leeds City Council retains up to 70-80% centrally, 5% is needed for administration and 15-25% goes to be spent locally. The money will be vested with the local Town or Parish Council if applicable, or with the local Community Committee and spend decided upon by that body. This local money is known as the 'Neighbourhood Fund' and should be spent on similar projects to the Wellbeing Fund (capital).
- 8. In the Inner North East Community Committee this means that the money for Chapel Allerton, Roundhay and Moortown will be administered by the Inner North East Community Committee.
- 9. It was agreed at the Inner North East Community Committee March 2018 that CIL monies for Chapel Allerton, Roundhay and Moortown would be spent in the Community Committee ward that it was generated in. At the INE Finance Sub Group meeting on 9 July 2020 it was agreed that decisions for CIL needs to be agreed at the relevant ward meeting or by contacting the 3 Ward Councillors. The exception is if the funding is over £25k it needs to be agreed at INE Finance Sub Group and ratified at INE Community Committee meeting.
- 10. Projects eligible for funding by the Community Committee could be community events; environmental improvements; crime prevention initiatives, or opportunities for sport and healthy activities for all ages. In line with the Equality Act 2010, projects funded at public expense should provide services to citizens irrespective of their age, disability, gender reassignment, marriage and civil partnership, pregnancy and maternity, race, religion or belief, sex, and sexual orientation; the fund cannot be used to support an organisation's regular business running costs; it cannot fund projects promoting political or religious viewpoints to the exclusion of others; projects must represent good value for money and follow Leeds City Council Financial Regulations and the Council's Spending Money Wisely policy; applications should provide, where possible, three quotes for any works planned and demonstrate how the cost of the project is relative to the scale of beneficiaries; the fund cannot support projects which directly result in the business interests of any members of the organisation making a profit.
- **11.** Any request for funding would involve discussions with appropriate ward members. Where projects do not have support from the Community Committee and are not approved, applicants are offered further discussions and feedback if this is requested.

- **12.** In order to provide further assurance and transparency of all decisions made by the Community Committee, any projects that are not approved will be reported to a subsequent Community Committee meeting.
- 13. Sometimes urgent decisions may need to be made in between formal Community Committee meetings regarding the administration of wellbeing and youth activity budgets and regarding the use of the Community Infrastructure Levy (CIL) Neighbourhood Fund which has been allocated to the Community Committee. Alongside the Committee, designated officers have delegated authority from the Director of Communities and Environment to take such decisions.
- 14. The Community Committee has previously approved the following 'minimum conditions' in order to reassure Members that all delegated decisions would be taken within an appropriate governance framework, with appropriate Member consultation and only when the following 'minimum conditions' have been satisfied:
  - a. consultation must be undertaken with all committee/relevant ward members prior to a delegated decision being taken.
  - b. a delegated decision must have support from a majority of the Community Committee elected members represented on the committee (or in the case of funds delegated by a Community Committee to individual wards, a majority of the ward councillors).
  - c. Details of any decisions taken under such delegated authority will be reported to the next available Community Committee meeting for members' information.
- 15. Members are reminded that the necessary scrutiny of applications to satisfy our own processes, financial regulations and audit requires the deadline for receipt of completed applications to be at least five weeks prior to any Community Committee. Some applications will be approved via Delegated Decision Notice (DDN) following consultation with Members outside of the Community Committee meeting cycle.
- 16. Wellbeing Fund applications and Youth Activity Fund applications are considered at Finance and Policy Sub Group meetings, a sub group of the Community Committee. This group comprises a nominated Elected Member from each of the wards in the Inner North East Community Committee; Chapel Allerton, Moortown and Roundhay. The sub group makes the recommendations to award funding for projects which is then ratified by the Inner North East Community Committee.
- 17. Members are asked to review the minimum conditions as set out in paragraph 14 of this report, consider whether any amendments are required and approve such conditions for operation in 2023/2024. These conditions would need to be satisfied prior to an urgent delegated decision being taken in between formal Community Committee meetings in respect of the administration of Wellbeing and Youth Activity budgets and also the use of the CIL Neighbourhood Fund which has been allocated to the Committee.

**18.** The Inner North East Community Committee Finance Sub Group would like to make Members aware that in future years there may be a decrease in funds allocated to the ward pot funding due to the reduction in Wellbeing Budget over the last 5 years.

#### Wellbeing Budget Position 2023/24

- 19. The total revenue budget approved by Executive Board for 2023/24 was £74,338.00 Table 1 shows a carry forward figure of £90,769.56 which includes underspends from projects completed in 2022/23. £31,699.16 represents wellbeing allocated to projects in 2022/23 and not yet completed. The total revenue funding available to the Community Committee for 2023/24 is therefore £133,408.40. A full breakdown of the projects approved or ring-fenced is available on request.
- **20.** It is possible that some of the projects may not use their allocated spend. This could be for several reasons, including the project no longer going ahead, the project not taking place within the dates specified in the funding agreement, or failure to submit monitoring reports. Due to this the final revenue balance may be greater than the amount specified in Table 1.
- **21.**Community Committee is asked to note that, at the time of writing the report, there is currently a remaining balance of **£22,819.79**.
- 22. A full breakdown of the projects is listed in Table 1 and is available on request.

**Project Description:** Young people will improve their musical prowess and learn new technological skills, as well as gain an understanding of how the music business works.

We wish to continue offering our very successful and oversubscribed open access music workshops to young people aged 13-25, delivered from our Young People's Resource Centre (Archway on Roundhay Road). We will continue to focus on working with some of the most disadvantaged young people in inner city Leeds, including those who are living independently, are disengaged from education, are unemployed, have mental health issues and/or experiencing other difficulties. Young people decide their own programme of musical learning, working alone or with others, and along with support from 3 experienced tutors/musicians create their own lyrics and/or music, using DJ equipment, live instruments and music programmes. They will improve their musical prowess and learn new technological skills, as well as gain an understanding of how the music business works. They will perform live wherever possible, including at the Black Music Festival and Leeds Carnival, as they have done in previous years. They are also supported to upload their work onto music platforms, e.g., YouTube, with their own music videos.

We are applying for funding from yourselves for one weekly session from 4.30 – 6.30pm for 40 weeks. The amount requested covers 3 tutors, refreshments and travel (where necessary) for young people, as well as some expenses to support public performances, and an amount for replacement equipment, e.g., headphones and software upgrades.

The building and use of utilities are offered free of charge.

We envisage working with 60 young people over the period in this one session.

Project Description: Growing together at Oakwood Hall

Oakwood Hall Green Gym takes place in the grounds of a Community Links residential home and training centre. The group currently consists of 23 volunteers on the active case load who all joined the group for support with mental health. The group was meeting once a week for sessions focussing on improving physical and mental health and reducing social isolation through practical environmental activities. Through consultation with the participants in the group, through conversations with Community Link and other local residential mental health services, through mental health professionals that utilise the training centre and through local organisations supporting older people we have developed a year long programme of peer based support for older people in the Inner North East area of Leeds. The project lost funding at the end of last financial year (end of March 2023). The group has been unable to run but we have continued remote support. Several group members from the Inner North East areas of Leeds have seen a sharp decline in their mental and physical health since the sessions went on hold, with more than one needing direct medical and hospital treatment for declining health conditions that had previously been managed.

We would like to use the funding to contribute towards:

- 33 environmental action days promoting health, wellbeing and social inclusion in older people in the Leeds Inner North East wards.
- Work with the older people within the existing group and local older people's organisations in Inner North East Leeds to develop a programme of peer led support sessions for older people in Inner North East Leeds to improve health and reduce isolation.
- Run an open day for the residents of Inner North East Leeds.
- Support 8 sessions over the course of the 8 month period where older people of Inner North East Leeds will run outreach projects for people using residential mental health services in the wards.

#### Project Description: BM Wellbeing Village Event

As part of our stage 2 development of the BM Wellbeing Village concept, our aim is to develop a comprehensive website which will incorporate details of local professionals who facilitate physical/mental health services, information about diet/nutrition, updates around current local/national health guidance or initiatives, training opportunities, events staged locally and opportunities to share good practice. In addition, we will continue to engage with the local Leeds community both electronically and face to face about same. This will be

facilitated through our **'BM Wellbeing Village Annual Event'**, this year taking place at the 'Civic Hall, Leeds City Centre on the 24<sup>th</sup> September 2023 from 12:00 noon – 17:00pm.

With our aim for a match funding approach, monies received will assist specifically with hosting our annual **'Invest in Yourself'** wellbeing event on the 24<sup>th</sup> September 2023. This will include marketing material, venue hire/key-note speaker costs, refreshments for volunteers and speakers, administration, audio-visual requirements and transport costs. Our match funding will be to obtain refreshments, flyer design, event management source/purchase interactive digital engagement software and enhance our social media presence.

The itinerary for the event will include an electronic interactive engagement/ice breaker session, key-note speakers from physical/mental health services, small group break-out sessions to engage delegates, digital and hardcopy feedback opportunities, wellbeing stalls, a panel session, testimonies from clients and a raffle. My partner Errol Brown and I will project manage the event and benchmark costs for website development/equipment requirements. We have secured four volunteers to assist us on the lead up to the event and on the day.

We aim to attract approximately 200 delegates to the event which will include representation from delegates who identify as a member of one or more of the protected characteristics (as defined by the Equality Act 2010).

**Project Description:** Holy Rosary Community Room Refurbishment

We are seeking support to help us maximise the potential of the Community Room at the rear of the Holy Rosary Church in Chapeltown. The Community Room was first created as a subdivision of the nave of the church in 1987. Over the years it has been a greatly valued space for parish and a growing number of community activities. It has been very well used but it is now in urgent need of refurbishment. We have received a growing number of requests from local charities and third sector organisations e.g., Feel Good Factor to use the large space for groups and activities which reduce social isolation, promote health, address the impact of the cost-of-living crisis. The proposed works comprise of 1. Conversion of the existing WCs into two accessible toilets suitable for the needs of those with mobility issues, and those caring for young children (the focus of this grant request). 2. Replacement of the existing kitchen including the installation of a water boiler. 3. Installation of a separate boiler and heating system so the Community Room can be heated independently from the Church. This will be significantly more energy efficient and help us to control the temperature in the room better. 4. Replacement of the flooring throughout. 5. Redecoration of the Community Room and smaller associated rooms. 6. Creation of a new independent entrance which will further enable local external community groups and organisations to use the space. The works will ensure that the Community Room is once again fit for purpose and better equipped to welcome groups of all ages, cultures, abilities and need. Indeed, we are already in discussion with several partner organisations who are keen to use our space to facilitate activities that will benefit the local community. We expect

this to include Stay-and-Play sessions, a Friendship Group, and also a Community Market to combat food poverty. One local charity (Feel Good Factor) has expressed interest in running weekly social groups and a men's group from the Community Room, since it will provide a space larger than they currently have in their premises locally. Another local faith group would like access to the Community Room, which will include a kitchen, to host a weekly lunch for isolated older people. Following the refurbishment, community groups such as the 'Knit and Natter' group and soup lunches will be able to resume. The Community Room is also greatly valued by the local Eritrean Community and used for its weekly "Community Family Day" which includes intergenerational activities and language and culture lessons for children and young people. Similarly, our Community Room is home to the local Faith and Light Group which has forty regular members and brings together people with an intellectual disability, their families and friends. We are also home to a Community Table Tennis club who meet weekly.

# Inner North East Community Committee – Update Report

#### Purpose of report

#### Main issues Updates by theme Children & Young People: Councillor Zara Hussain

- 3. Leeds's annual Breeze in the Park event took place on Monday 31<sup>st</sup> July (12pm to 5.30pm) at Scott Hall Playing Fields. The event featured a packed schedule of sports, games, art, music and other fun activities, all designed to add some memorable extra sparkle and shine to the school holidays. Children and their parents braved the rainy weather and attended in their hundreds to enjoy the activities that was on offer.
- 4. The Breeze in The Park events had two main sessions, one running from midday to 2.30pm and the second from 3pm to 5.30pm. The adverse weather didn't deter local

children from attending the event albeit the attendance was low compared to the previous year.

#### During April 2022 – March 2023

- Supported 2,999 people into work, 260 of whom were residents from the Inner North East. Customers were supported into work across all sectors with the largest numbers in, construction, health and care including childcares, manufacturing, ICT, digital and comms.
- Supported 3,753 people to improve their skills, 404 of whom were from the Inner North East.
  - 8. Leeds Employment Hub is a single point of contact for all funded programmes and Jobshops which provides tailored and comprehensive support into employment or education to <u>all</u> Leeds residents. Employment Hub Advisors deliver the programme by providing one to one support, tailored preventative and remedial support to Leeds residents who are disadvantaged in the labour market. The Employment Hub Advisors are co-located within the Jobcentre Plus centres across the city. Further funding has been secured which will see the role of the Advisors continue until at least March 2025.
  - All Jobshops are open, 5 days a week for face-to-face appointments which includes Reginald and City Centre Community Hubs. There is a pop up Jobshop at Moor Allerton Community Hub on Thursday 9:00 – 17:00.
  - 10. Community Learning provision continues to deliver an effective, broad, and inclusive curriculum to support the continuation of learning in collaboration with subcontracted partners. Courses were delivered through a range of models which include face to face, online and through distance learning, opening new opportunities for adults to learn and develop their confidence.
  - 11. Between April 2022 March 2023, in the Inner North East, 36 courses were delivered at 12 venues. 489 residents have accessed a course. In addition, there were 50 courses delivered on-line.
  - 12. ESOL support will continue to be delivered at City Centre Hub, Chapeltown Childrens Centre, Hillcrest Academy and Gipton Childrens Centre from September 2023.

- 13. Between April 2022 March 2023, 15 Developing You Health and Wellbeing courses, a pre-employability programme which helps people to become happier, healthier and move closer towards employment were delivered across the city, 123 people completed the course and 24 of whom were supported into work. Developing You courses were developed and delivered to people with Learning Disabilities, 18 people completed the course and are being supported by the Employment Hub to support progression to further learning, employment or volunteering.

- 15. Delivering in partnership the Connecting Communities to Health and Care Careers work focuses on narrowing inequalities with a one system approach across the sector, adapting recruitment methods and building on the good practice in the system, targeting the Priority Wards. The pathways that are being delivered provide people with a supported programme into Administration and Care roles within the NHS and Adult Social Care. There are functional skills (Maths, English and ESOL) support provided to upskill individuals to the required entry level for their pathway of choice. Since February 2022, 422 people, 51% of whom were from the Priority Wards have attended the information sessions, 167 have achieved a qualification and 174 people have been supported into work. New pathways that have been developed for Children's Residential, Care Practitioner roles and Care Navigators within GP Practices and will be delivered from September 2023. - 16. Within the last year the Service has supported 342 new businesses including recruiting new staff, providing support for staff facing redundancy, developing initiatives to address staff shortages and filling a high number of vacancies within key sectors.

#### **Delivered Events and Activities**

- **Informed Choices** supported school careers events and parents evenings and delivered Apprenticeship awareness sessions, engaging with 10,535 young people, 458 parents/carers and 409 teachers.
- **Next Steps** support for young people following GCSE or A Level results is hosted on Start in Leeds <u>Next Steps after School or College</u>.
- Connecting Communities to Health and Care Careers delivered 28 information sessions between January and July 2023 at 7 venues across the city, five of the LCC Community Hubs, Age UK and One Community Centre
- Jobs Fairs 19 recruitment events delivered since April 2023 at 10 venues across the city, seven LCC Community Hubs, Wetherby Community Hub, Farnley Community centre and the White Rose Shopping Centre.
- Leeds Community Learning and Employer Provider Apprenticeships Celebration Awards 2023 took place on 18<sup>th</sup> July 2023 at Civic Hall to celebrate the

accomplishments of all learners and tutors and embrace their future progression into further/higher education, volunteering and/or employment.

- **SEND Next Choices Event**, Getting Ready for Adult Life took place on 29<sup>th</sup> June 2023 at Leeds First Direct Arena. The event was aimed at supporting young people who have Special Educational Needs and Disabilities (SEND). A total of 67 exhibitors participated, offering jobs, Apprenticeships, volunteering, training opportunities, leisure activities and along with other specific support. 2,200 young people attended with very positive feedback.
- **Financial Wellbeing Events** delivered in partnership with Credit Union, Yorkshire Water and Leeds City Council, Housing, Jobshops for residents concerned with the rising cost of living. Support provided included debt advice and employment assistance
  - Compton Community Hub on 15<sup>th</sup> June 2023. 20 people attended.
  - Burmantofts Community Hub on 13<sup>th</sup> July 2023. 60 people attended.
- Leeds Apprenticeship Recruitment Fair (LARF) took place on 6<sup>th</sup> February 2023 at Leeds First Direct Arena. A total of 106 organisations participated and 8,000 visitors attended.
  - 78% of visitors were either more likely to start an Apprenticeship or more interested in an Apprenticeship since attending the event.
  - o 85% of visitors would recommend the event to a friend.
- **Family Learning Festival** was delivered on the 16<sup>th</sup> February 2023 at the Carriageworks Theatre, approx. 150 people participating along with 25 exhibitors from across the Community Learning sector. Local skills providers, colleges, universities, employment advisors attended to provide advice for anyone looking to develop their skills further or to plan their next steps.
- Reducing Re-Offending construction recruitment events took place on 24<sup>th</sup> January 2023 and 19<sup>th</sup> July 2023 at HMP Leeds, 5 construction companies attended offering employment opportunities. 77 serving prisoners engaged with the advisors who delivered employability support sessions.

## **Community Committee Health and Wellbeing Report**

## **World Suicide Prevention Day**

21. World Suicide Prevention Day is marked on September 10<sup>th</sup> each year to promote worldwide action to prevent suicides. Various events and activities are held during this time to raise awareness that suicide is a major preventable cause of early death. Every person lost to suicide is someone's partner, child, friend, neighbour and/or colleague and their death will hugely affect people in their family, workplace, and community. We can all play a vital role in reducing and preventing suicide by making people comfortable to talk about suicide and mental health through encouraging people to have these conversations.

22. The West Yorkshire Check in With Your Mate campaign aims to promote these conversations and to raise awareness of the factors and signs that may lead to suicide, inspiring people to start conversations about mental health with the men in their life - at home, in the community and at work – potentially saving lives.

#### Heatwave and Health: comms toolkit

- 23. The summer weather/heatwave comms toolkit has been available for use across the city with copy and assets for bulletins and social media.
- 24. The messages are based around the new impact based alert system. The heat health alert system is operated by UKHSA in partnership with the Met Office and is outlined below:
  - Green (summer preparedness) general preparedness and awareness raising.
  - Yellow (response) where impacts may be expected for those who are particularly vulnerable or where the confidence in the weather forecast for more severe periods of heat is low.
  - Amber (enhanced response) for situations where impacts are expected across the population.
  - Red (emergency response) significant risk to life for even the healthy population.
- 25. The toolkit was made available during the Heatwave campaign for use by agencies and groups to support residents.

# Winter vaccines rollout: Building vaccine confidence for higher risk populations

26. Free webinars were offered during August in preparation for the vaccine rollout which begins in September. Various dates and times were offered to raise awareness of the rollout programme and information that can be passed on to residents in the city.

## Climate change workshop 6 September, 2.00pm to 3.00pm

- 27. The directors of public health in Y&H have made climate change one of their priorities for collaboration across the 15 local authorities. A strand of the action plan is a CPD programme based on the insight and learning from the survey sent out to all DPH's earlier in the year.
- 28. Climate change is the single biggest threat to population health. Public health professionals have a key role to play in climate mitigation and adaptation and drawing attention to the health co-benefits of addressing the factors that drive

climate change. Their in-depth understanding of health inequalities is crucial to ensure that climate change does not further compromise the health of the most vulnerable.

# **Better Conversations**

29. Part of the Leeds Health and Care Academy, these skill sessions are open to anyone working in health and social care in Leeds. The workshops aim to enable health and care colleagues to deliver and encourage more collaborative conversations, primarily between a health and care professional and patient or service user, or when speaking to members of the public.

30. Three learning packages are on offer:

- Level 1 eLearning introducing the principles of better conversations a 60minute session.
- Level 2 virtual interactive workshop better conversations: reflective practice (28 September, 22 November and 14 December).
- Level 3 in-person workshop better conversations: a personalised approach to conversations (13 September and 17 October).

# **Rightsizing campaign**

31. People aged 50 and over living in West Yorkshire are being targeted with an innovative new campaign to help them 'rightsize' and find a home that's right for them. The aim of the 'rightsizing' campaign is to help people choose where they live before other factors, such as ill health, make that decision for them.

## **Drowning Prevention**

- 32. During the summer, the risk to young people through accidental drowning increases significantly. When the weather is hot young people can be tempted to go for a dip in the local river or reservoir, but swimming in open waters is extremely dangerous.
- 33. The Royal Life Saving Society <u>website</u> also provides information and resources on water safety education.

## Annual flu report

34. UKHSA's annual report has been published and summarises the levels of influenza (flu) across the UK for the winter period, 2022 to 2023. The analysis indicates that excess deaths in England associated with flu were higher (14,500) than the average figure (13,500) for the five years before the pandemic. This is the highest figure since the 2017 to 2018 season, when there were 22,500 excess deaths associated with flu.

- 35. Citywide Nuisance Vehicle PSPO is now live and enforceable, and it is hoped that this will help to address the ongoing vehicle related issues at adjacent to Roundhay Park (West Avenue etc).
- 36. Good partnership working from the case officer dealing with youth nuisance at Moortown Park.
- 37. Good partnership work in dealing with the issues around a fast food outlet on Chapeltown Road with involvement from Environmental Protection Team, Planning, Licensing, LASBT and the police - LASBT have served a Premises Closure warning.

#### Leeds HAP Panel

#### Engagement/Involvement

- 38. Your Place event (On-Line walkabout) is being planned. Community yet to be determined.
- 39. Awaiting information as to future of Team Beckhills. Maureen Lilleywhite assisting with transfer of leadership, name etc.
- 40. Button Hill group currently in danger of total collapse following resignation of the chair. Meeting to take place with residents to try to resurrect.

41.17 August sees Housing Leeds join other partners at an information event at Brackenwood Community Association including local housing staff and use of the mobile office.

# **Housing Advisory Panels**

- 42. INE HAP started the year in April 2023 with a budget of £27,897.97 following a reduction of 10% to budget (including a carry-over from last year of £1,018.19).
- 43. To date funding of £3,570.00 has been approved.
- 44. Still have vacancies for Housing Leeds residents on the Inner North East Housing Advisory Panel and they are actively looking to recruit.

# Community Payback/Skill Mill/Green Guardians

- 45. Community Payback Have now commenced completing projects and are now accepting new referrals though no contract with Housing Leeds.
- 46. Skill Mill Contract period now completed so currently no referrals being accepted.
- 47. Green Guardians Contract declined by INE HAP on cost £8,200 up from £7,000.

## **Working In Partnership**

- 48. Continued work with community organisations e.g., InterAct, BCA, Childrens Centre etc.
- 49. Continue to assist groups identifying funding opportunities through Funding Leeds.
- 50. Potential for a garden competition in one ward or whole area but will need early confirmation to allow planning. These have been held in other areas to some success and created positive news stories. Would need backing from ward members.
- 51. Potential work with both Meanwood Valley Urban Farm and Friends of Meanwood Park Playground to look at assisting with funding training.

## Estate Management Walkabouts/Home Visits

- 52. Quarter 1 Estate Walkabouts were completed during May June period and Quarter 2 Walkabouts are schedule to take place in October 2023.
- 53. In terms of the annual home visits 2766 have been completed in the Inner North East area. Of these 1972 were general home visits and 794 were priority visits.

## **Housing Anti-Social Behaviour**

54. There were 14 active ASB cases with Housing Leeds of these 3 were referred to LASBT. No major increase from previous months only a slight increase compared to the same period last year.

- 55. Housing Officers contacting tenants to review outstanding cases, and to close any historic cases where situations have improved.
- 56. Monthly audits/review of all active cases carried out monthly by Team Leaders this is on-going, recent audit completed June 2024.
- 57. Have police officers working within the team to share information at regular LASBT meetings. Maria Wheeler from LASBT also working closely with Housing Officers.
- 58. Partnership approach with LASBT continuing with monthly meetings to discuss casework.

## Environment: Councillor Jordan Bowden Cleaner Neighbourhoods Team (CNT)

- 59. Plans are in place for the Leeds West Indian Carnival which takes place on Monday 28th August 2023. The CNT team have been busy planning the logistics for the event and will be present during and after the event for the big clean up.
- 60. There has been ongoing work in the Inner North East area regarding cutting back on vegetation/cleaning the ginnels. Several ginnels have been cleaned up over the last few months.
- 61. Concerns have been raised by ward members about a number of unauthorised charity bins on Chapeltown Road. Cleaner Neighbourhoods Team will write to the owners for them to remove the bins within a certain time period. If they fail to do so the Council has powers to remove the bins.
- 62. Leeds Federated (Housing Association) organised a community litter pick around the Stonegate's area in Meanwood. Leeds Fed provided litter picking equipment and refreshments at Meanwood Community Centre. Leeds Fed tenants from the area assisted with the litter pick along with green fingered councillors from Moortown ward who helped the volunteers to make their area cleaner and greener.



# **Neighbourhood Centres Update**

63. A business is interested in seeing more activity underway by businesses to help Roundhay and Oakwood shopping areas. A more detailed discussion is being arranged for next month with the chair of Oakwood Traders and Residents Association to see what help the Neighbourhood Centres Co-ordinator can provide businesses in Chapel Allerton, Moortown and Roundhay wards, along with the other 30 wards around the city who receives the weekly update of news to help local businesses and develop local neighbourhood centres.

## **Climate, Energy and Greenspaces**

## **Streetscene Grounds Maintenance**

64. Grass cutting is progressing as expected. The contractor deployed additional resources (Saturday working and Monday – Thursday until 7pm) for a limited period during May and June following the spring flush of growth and to address the clearance of daffodil areas. Hedge cut 2 will commence towards the end of August after bird nesting season. Relaxed mowing within INE area has been completed (1.2m strip unless adjacent to residential properties).

- 65. Non-working days can cause some delays which will impact on mowing and spraying schedules. The last non-working day during mowing season will be the late August bank holiday. During the school summer holidays, parked cars and members of the public present on larger communal plots can cause minor impact to schedules or result in plots intentionally left where it is not possible to cut at the time of visit (or same working day).
- 66. The second round of weed spraying has recently commenced and should take around 6 weeks to complete with a further 6 weeks to fully die back. Teams are due in Chapel Allerton Ward (weather permitting) by 18<sup>th</sup> August and are then due to visit Moortown, then Roundhay wards. Recent wet weather will have an impact on progress.

## Leeds Quality Parks

67. Assessments are under way and including those in the Inner North East area -Chapel Allerton, Norma Hutchinson, Meanwood and Potternewton.

# Other Updates from the Inner North East Area Leeds 2023

- 68. My LEEDS 2023 is a celebration of all the people and stories that make up the City of Leeds. Who better to shine a light on the amazing communities of Leeds and tell their stories than the people themselves? My LEEDS 2023 will see people across Leeds come together in a city-wide celebration taking place in every ward.
- 69. My LEEDS 2023 is all about celebrating the power of community, they've been working collaboratively with local people to create a series of events across the wards. They are shining a spotlight on the wonderful people that make up our city.
- 70.33 Neighbourhood Hosts have been championing their local communities and have been developing a series of events across every corner in Leeds this summer.
- 71. The Neighbourhood Hosts have been vital to this project. They've been designing and delivering events in My LEEDS Summer and working with artist Keith Khan, who's created The Gift, an artwork for the city with a motif for each ward.

72. A number of events has already taken place in Moortown and Roundhay Wards and local ward members have attended them and engaged with the general public, key services, performers and stall holders. Events in Chapel Allerton ward are due to take place in August.



## Meanwood Olympics

- 73. Inspired by the London Olympics in 2012, the Meanwood Olympics held at Woodhouse Cricket Club invites families across the city to get involved with sports, games, arts and craft.
- 74. The summer of activities have already begun, the next fun day will be held on Wednesday August 16 from 12pm-3pm, after which every child who participated will receive a medal from the Lord Mayor and Leeds Rhinos players.
- 75. Maureen Lillywhite, a community development worker at InterACT, organised the first ever Meanwood Olympics 12 years ago, with every game from dodgeball to the egg and spoon race. Each year, more organisations have got involved to support the event and make the summer holidays more memorable for children and families.
