17 Apologies for Absence

18 Open Forum

In accordance with the Community Committee Procedure Rules, the Chair allowed a period of up to 10 minutes for members of the public to make representations or ask questions within the terms of reference of the Community Committee.

No matters were raised.

19 Minutes of the previous meeting - 12 June 23

RESOLVED – That the minutes of the previous meeting held 12th June 2023, be approved as an accurate record.

20 Best City Ambition Update

Due to staff illness, the committee resolved to defer this item until the scheduled Inner North East Community Committee meeting in November 2023.

Members touched upon the social index tool and requested that the next formal committee provide an opportunity to show how this tool is used and how the Best City Ambition and social index tool is used in conjunction with each other.

RESOLVED – To defer the item until the Inner North Community Committee meeting scheduled to take place in November 2023.

21 Lifelong Learning Community Courses Update

The report of the Head of Locality Partnerships introduced a verbal update on a presentation to be provided by Leeds University regarding an update on what the Community Outreach Team can provide in terms of courses in the community and adults who are wanting to return back to education.

Esther Bissell and Fiona Chapel (Leeds University Community and Partnerships Team) attended the meeting, and provided the Community Committee with a PowerPoint presentation including the following information:

- What the centre offer and the learning opportunities available to adults to undertake courses and a degree, particularly those who haven't been provided with similar opportunities in their life.
- The centre run their own degrees and courses, as well as providing pre-entry support.
- Esther and Fiona work in the Community and Partnership Team and provide useful advice to adults around the university and what it can offer. Community engagement aims to widens opportunities for adults to be able to access higher education.
- Key messages are shared in relation to adults being able to attend university at any stage in their life, and there is no 'standard' route for adults to access higher education. Myth busting has been undertaken around entry requirements, such as not needing a lot of A-Levels and GCSEs.
- The centre is keen to continue working with community groups to get them onboard and provide relevant taster sessions, as well as webinars to help people more informed decisions about higher education opportunities.
- An overview of full-time foundation years and part-time foundation vears.
- There is a student volunteering hub at the university.

Michelle, a student from the Lifelong Learning Centre attended the meeting and provided the Community Committee with her personal experience of attending the centre and undertaking her child and family studies. Michelle explained that she believed that she did not have the relevant qualifications or confidence to attend university. Michelle works in a school and wants to broaden her skillset and learn more about what she does in order to put this into practice. Michelle explained that the Lifelong Learning Centre helped her along her journey and provided the relevant support in order for her to do so. The Lifelong Learning Centre minimised any barriers Michelle believed would deter her from attending university and would encourage anybody to attend.

The Community Committee congratulated Michelle on her journey and acknowledged the great work of the Community Outreach Team, as well as the Lifelong Learning Centre

The committee discussed the following matters:

- Helping people understand that financial implications are not a barrier attending university nor is age. It was acknowledged that there is a big cost associated with courses, but it is important that people are provided with guidance and understand their options when considering higher education. It was also noted that you start repaying the tuition fee when you're in a job earning over 25k and after 40 years the remaining balance is cleared and will not get passed on to any other family member.
- The success of the Northern College who provide similar guidance and courses.
- Community engagement and making sure that the local community are aware of the opportunities provided by the Lifelong Learning Centre. Members were provided with leaflets to hand out to their constituents and community groups. Members were also encouraged to share details on social media.
- Discrepancies with the Government regarding tuition fees and providing people with the relevant information to help them choose the right option for them.
- It was reported that the Lifelong Learning Centre work with approximately 1,500 people aged 19+ every year and they also work with people in sixth form.
- Students have access to the relevant equipment they need when they are studying such as laptops and other associated support to help individuals.
- Following a suggestion from a member, it was confirmed that they will reconsider introducing shorter taster sessions for people.

Committee members thanked those in attendance and highlighted the positive step in the Community Outreach Team engaging with the local community. It was confirmed that the Community Outreach Team were happy for members to pass on details to community groups and centres to present similar information.

RESOLVED – To note the presentation provided by the Community Outreach Team and discussions during consideration of this item.

- The success of the Breeze in the Park event that took place on Monday 31st July.
- The number of people who are claiming Universal Credit (UC) due to unemployment, as of May 2023, in the Inner North East Community Committee area is 3,727. This is an increase of 106% since March 2020.
- World Suicide Prevention Day with planned various events and activities held during this time.
- Heatwave and Health: comms toolkit.
- There are currently 21 LASBT cases in Inner North East. There is also a citywide vehicle PSPO which is live and enforceable and has helped with ongoing vehicle related issues on West Avenue.
- Members requested HAP statistics in relation to void properties.
- Plans in place for the Leeds West Indian Carnival scheduled to take place on Monday 28th August 2023.
- There has been ongoing work in the Inner North East area regarding cutting back on vegetation/cleaning the ginnels. Further to this, it was requested that before and after pictures are taken as evidence, and to publicise the work the CNT are doing. It was confirmed that Councillor Rafique will feed back this suggestion at the upcoming environmental sub-group.
- The Meanwood Olympics held at Woodhouse Cricket Club invited families across the city to get involved with sports, games, arts and craft and it was reported that it was a successful event with a lot of attendance from young people.
- The Leeds 2023 event held at Roundhay Park was also successful and the neighbourhood host for this area is looking at hosting another event for the following year as part of its legacy work.

Inner North East Community Committee - Finance Report

Purpose of report

1. This report provides the Community Committee with an update on the budget position for the Wellbeing Fund, Youth Activity Fund as well as the CRIS and Community Infrastructure Levy Budget for 2023/24.

Main issues

- 2. Each Community Committee has been allocated a wellbeing budget (revenue and capital) and Youth Activities Fund which it is responsible for administering. The aim of these budgets is to support the social, economic and environmental wellbeing of the area and provide a range of activities for children and young people, by using the funding to support projects that contribute towards the delivery of local priorities.
- 3. A group applying to the Wellbeing Fund must fulfil various eligibility criteria, including evidencing appropriate management arrangements and financial controls are in place; have relevant policies to comply with legislation and best practice e.g., safeguarding and equal opportunities and be unable to cover the costs of the project from other funds.
- **4.** Wellbeing funding cannot be paid retrospectively. An application form must be submitted and approved by the Community Committee before activities or items being purchased through wellbeing funding are completed or purchased.

- **5.** The amount of wellbeing funding provided to each committee is calculated using a formula agreed by Council, taking into consideration both population and deprivation of an area.
- **6.** Capital (CRIS) injections are provided as a result of council assets being sold. 5% of the sale price (up to a maximum of £100k) of a council asset is pooled city-wide and redistributed to the Community Committee areas on the basis of deprivation. The Community Committee will receive a new capital injection every 6 months.
- 7. Each Community Committee has also been allocated a Community Infrastructure Levy budget. For each CIL contribution, Leeds City Council retains up to 70-80% centrally, 5% is needed for administration and 15-25% goes to be spent locally. The money will be vested with the local Town or Parish Council if applicable, or with the local Community Committee and spend decided upon by that body. This local money is known as the 'Neighbourhood Fund' and should be spent on similar projects to the Wellbeing Fund (capital).
- **8.** In the Inner North East Community Committee this means that the money for Chapel Allerton, Roundhay and Moortown will be administered by the Inner North East Community Committee.
- 9. It was agreed at the Inner North East Community Committee March 2018 that CIL monies for Chapel Allerton, Roundhay and Moortown would be spent in the Community Committee ward that it was generated in. At the INE Finance Sub Group meeting on 9 July 2020 it was agreed that decisions for CIL needs to be agreed at the relevant ward meeting or by contacting the 3 Ward Councillors. The exception is if the funding is over £25k it needs to be agreed at INE Finance Sub Group and ratified at INE Community Committee meeting.
- 10. Projects eligible for funding by the Community Committee could be community events; environmental improvements; crime prevention initiatives, or opportunities for sport and healthy activities for all ages. In line with the Equality Act 2010, projects funded at public expense should provide services to citizens irrespective of their age, disability, gender reassignment, marriage and civil partnership, pregnancy and maternity, race, religion or belief, sex, and sexual orientation; the fund cannot be used to support an organisation's regular business running costs; it cannot fund projects promoting political or religious viewpoints to the exclusion of others; projects must represent good value for money and follow Leeds City Council Financial Regulations and the Council's Spending Money Wisely policy; applications should provide, where possible, three quotes for any works planned and demonstrate how the cost of the project is relative to the scale of beneficiaries; the fund cannot support projects which directly result in the business interests of any members of the organisation making a profit.
- **11.** Any request for funding would involve discussions with appropriate ward members. Where projects do not have support from the Community Committee and are not approved, applicants are offered further discussions and feedback if this is requested.

- **12.** In order to provide further assurance and transparency of all decisions made by the Community Committee, any projects that are not approved will be reported to a subsequent Community Committee meeting.
- 13. Sometimes urgent decisions may need to be made in between formal Community Committee meetings regarding the administration of wellbeing and youth activity budgets and regarding the use of the Community Infrastructure Levy (CIL) Neighbourhood Fund which has been allocated to the Community Committee. Alongside the Committee, designated officers have delegated authority from the Director of Communities and Environment to take such decisions.
- **14.** The Community Committee has previously approved the following 'minimum conditions' in order to reassure Members that all delegated decisions would be taken within an appropriate governance framework, with appropriate Member consultation and only when the following 'minimum conditions' have been satisfied:
 - a. consultation must be undertaken with all committee/relevant ward members prior to a delegated decision being taken.
 - b. a delegated decision must have support from a majority of the Community Committee elected members represented on the committee (or in the case of funds delegated by a Community Committee to individual wards, a majority of the ward councillors).
 - c. Details of any decisions taken under such delegated authority will be reported to the next available Community Committee meeting for members' information.
- 15. Members are reminded that the necessary scrutiny of applications to satisfy our own processes, financial regulations and audit requires the deadline for receipt of completed applications to be at least five weeks prior to any Community Committee. Some applications will be approved via Delegated Decision Notice (DDN) following consultation with Members outside of the Community Committee meeting cycle.
- 16. Wellbeing Fund applications and Youth Activity Fund applications are considered at Finance and Policy Sub Group meetings, a sub group of the Community Committee. This group comprises a nominated Elected Member from each of the wards in the Inner North East Community Committee; Chapel Allerton, Moortown and Roundhay. The sub group makes the recommendations to award funding for projects which is then ratified by the Inner North East Community Committee.
- 17. Members are asked to review the minimum conditions as set out in paragraph 14 of this report, consider whether any amendments are required and approve such conditions for operation in 2023/2024. These conditions would need to be satisfied prior to an urgent delegated decision being taken in between formal Community Committee meetings in respect of the administration of Wellbeing and Youth Activity budgets and also the use of the CIL Neighbourhood Fund which has been allocated to the Committee.

18. The Inner North East Community Committee Finance Sub Group would like to make Members aware that in future years there may be a decrease in funds allocated to the ward pot funding due to the reduction in Wellbeing Budget over the last 5 years.

Wellbeing Budget Position 2023/24

- **19.** The total revenue budget approved by Executive Board for 2023/24 was £74,338.00 **Table 1** shows a carry forward figure of £90,769.56 which includes underspends from projects completed in 2022/23. £31,699.16 represents wellbeing allocated to projects in 2022/23 and not yet completed. The total revenue funding available to the Community Committee for 2023/24 is therefore £133,408.40. A full breakdown of the projects approved or ring-fenced is available on request.
- **20.** It is possible that some of the projects may not use their allocated spend. This could be for several reasons, including the project no longer going ahead, the project not taking place within the dates specified in the funding agreement, or failure to submit monitoring reports. Due to this the final revenue balance may be greater than the amount specified in Table 1.
- **21.**Community Committee is asked to note that, at the time of writing the report, there is currently a remaining balance of £7,439.79.
- **22.** A full breakdown of the projects is listed in Table 1 and is available on request.

Project Description: For the following concerts as part of 'Summer Bands in the Parks' series:

- -1 concert at Chapel Allerton Park taking place at the same time as the Family Picnic in the Park event.
- -1 concert at Gledhow Valley Woods (Friends of Gledhow Valley Woods have informed me that there are no plans for any Fun Days in the future and will let me know if the situation changes).
- -1 concert at Meanwood Park
- -1 concert at Moortown Park liaising with the Friends of Moortown Park to see when works best.
- -1 concert at Meanwood Valley Urban Farm taking place at the same time as the Meanwood Valley Urban Farm Summer Fair.

These concerts will benefit the communities in Gledhow, Moortown, Meanwood, Chapel Allerton as people will be able to experience free music in their local parks. It also encourages individuals to use and visit their local park and meet and engage with fellow residents and view their local green space as something for them and everyone.

Summer Bands in Leeds Parks series promotes Community Involvement as having these concerts in the park brings people together. Short term achievement: The community will be able to enjoy free music in their local area. Long term achievement: People can enjoy these concerts on a yearly basis.

□ Enhance the quality of our parks and public spaces. By putting on concerts in the Parks of Leeds we are keeping them active spaces where things are often happening, which contributes to them being well kept, by adding live music we are enhancing them by turning them from a park into an outdoor venue for everyone.
□ Develop and make better use of community assets. Where possible we combine our concerts with community events that might already be planned for a Sunday in the parks which brings more people to our free music as well as the community event, spreading the word about local goings on for the people in the area.
□ Support activities that make people and places feel safer. If a park has events in it, for families and people of all ages, then it will only reinforce the parks image as a safe space for people to be out and about in their community.

☐ Promote healthy lifestyles and tackle health inequalities.

Having concerts in the open-air encourages people to leave the house, get out and about and stay outside for the duration of the concert. Since the concerts are free and no booking is required, the concerts are completely inclusive of everyone, even those that can't usually book via internet or can't use a phone will be able to come to the concerts.

☐ Improve access and engagement in sport and cultural activities.

The concerts promote being in the outdoors which might not be sport but is definitely exercise, and hearing different bands in parks every Sunday promotes varied musical culture as the bands vary from brass bands to jazz and concert bands.

Inner North East Community Committee – Update Report

Purpose of report

- 1. To bring to members' attention an update of the work which the Communities Team is engaged in, based on priorities identified by the Community Committee. It also provides opportunities for further questioning, or to request a more detailed report on a particular issue.
- 2. This report provides regular updates on some of the key activities between Community Committee meetings and functions delegated to Community Committees, Community Champions roles, community engagement, partnership and locality working.

Main issues
Updates by theme
Children & Young People: Councillor Zara Hussain

- 3. On the 30th August the last multi-sport camp of the summer holidays took place at Scott Hall Leisure Centre, it was also the week after England Lionesses had done so amazingly well in the World Cup!
- 4. The coaches decided to run a football world cup themed day, 25 children split in to 5 teams with members of the Inner North East Community Committee, who kindly funded the camp, joining in the fun. Providing much needed support from the committee were Cllr Mohammed Rafique, Moortown Cllrs Mohammed Shahzad and Cllr Sharon Hamilton, without whom children in the community wouldn't be able to enjoy such a wonderful opportunity in safe environment.

5. Despite best efforts from a depleted Team Lionesses, losing only one match it was Team Seals that stormed to victory winning all their games!

Community Committee Health and Wellbeing Report

Heating on Prescription

6. Public Health Localities and Primary care have been successful in securing funding from Household Support Fund 4 to redeliver the Heating on Prescription scheme in primary and secondary care. The overarching aim of the scheme is to ensure that those most clinically at risk of ill health due to cold are able to stay well and warm at home this winter. The scheme is being delivered by third sector organisation Care & Repair, in partnership with Green Doctors and will be available until 31st March 2024. Heating on Prescription provides eligible patients financial assistance towards paying energy bills and practical solutions to reduce energy costs and tackle the causes of heat loss, damp and mould. Patients will also be supported with onward referrals to other organisations for additional support if needed. Referral pathways have been in-built into Primary and Secondary Care clinical systems to support a quick and efficient referral process and over the coming months we will be working with PCNs to raise awareness of the scheme at upcoming flu clinics.

Winter Wellbeing

- 7. Cold weather increases the risk of heart attacks, strokes, lung illnesses, flu and other diseases. People slip and fall in the snow or ice, sometimes suffering serious injuries. Some groups, such as older people, very young children, and people with long term conditions are particularly vulnerable to the effects of cold weather and living in deprivation.
- 8. Although there are several factors contributing to winter illness and death, in many cases simple preventative action could avoid many of the deaths, illnesses and injuries associated with the cold.

Key messages are as follows:

- Get vaccinated if you're eligible ensure you've had your flu jab and Covid booster.
- If you are able to, keep the inside of the house warm. If you can't heat the whole house then heat the room you're in.
- Seek help if you're struggling with fuel bills or energy efficiency.
- Keep active and seek support if you're worried about a fall.
- Have regular hot food, drinks and snacks.
- Connect to the local community.
- Be prepared for winter.

Flu and Covid update

- 9. The latest information from UKHSA shows that Covid case rates have slightly decreased, flu rates remain low and more people have come forward for both their Covid and flu vaccines. Those aged 75 and over continue to have the highest hospitalisation rates from Covid, although these have decreased from the previous week.
- 10. The national booking system for autumn Covid vaccines is open. Those eligible include all those aged 65 and over, pregnant women and those with an underlying health condition. These people will receive invitations from the NHS to encourage them to get their Covid and flu vaccines.

Innovative ABCD in Leeds programme celebrates milestone

- 11. An event marking a special birthday of a pioneering asset-based community development programme in Leeds took place recently.
- 12. Over 150 attendees, including members of third sector organisations, interested representatives of other local authorities and city councillors came together to celebrate the 10th birthday of the Asset Based Community Development (ABCD) programme.
- 13. Developed in partnership between Leeds City Council and third sector organisations, a key aim of ABCD in Leeds is to shift power back into the hands of local communities and provide them with the support and tools they need to make meaningful change in the areas they live through a variety of different projects. In doing so, ABCD has played its part in helping to improve the skills, learning, and health and wellbeing of residents, and the tackling of different issues such as loneliness and social isolation.

Campaigns

Lung cancer awareness month November

- 14. Lung Cancer is the third most common type of cancer in the UK. The symptoms are difficult to spot early on, so it's important to know what to look out for and how you can reduce your risk.
- 15. LTHT has a walk-in chest x-ray service for adults aged over 40 with signs of potential lung cancer. This service can be accessed without the need for a referral or appointment.

16. Extreme cold can have a significant impact on people's health. Reasons for the increased risk of ill-health during cold weather include poor quality housing, increased circulation of flu and other infectious diseases, physical hazards such as snow, and poor mental health related to isolation. Increases in the cost-of-living and the impact that food and fuel poverty can have on health especially during winter months is also a factor.

The webinar will cover:

- National Adverse Weather Plan and new weather alerts
- Key Public Health winter messages
- Organisations and services in Leeds to support the most vulnerable

- Winter vaccination messages
- Mental Health risk factors and support
- Cost-of-living support and signposting
- Resources and support links

The session will be delivered by staff from the Public Health team.

Success

- 17. On 11 October the ninth annual Public Health and Wellbeing Conference took place at Leeds Civic Hall A Bridge over Troubled Water: Public Health in a "cost of living crisis". The conference was aimed at anyone who works, volunteers or studies in Leeds and has a role or interest in promoting health and wellbeing and tackling health inequalities.
- 18. The event was a great success with over 80 delegates attending and there was a real buzz with great speakers including the Joseph Rowntree Foundation talking about their research into deep poverty and 28 local organisations holding stalls and able to promote the fantastic work they are doing in Leeds in response to the cost of living crisis. Delegates were also able to attend a range of interactive workshops including 'In Our Shoes: the impact of the COVID-19 pandemic on children in Leeds'; 'There's no self-care without self-empowerment mental health, money, power and the cost of living crisis' and 'Marmot and the Localities Public Health team practical application'.

Covid19 Vaccination Programme

- 19. The UK COVID-19 vaccination programme is now entering its third autumn season. Vaccination helps to protect against severe illness, hospitalisations and deaths from COVID-19. The advice for this autumn is to offer the vaccine to those at high risk of serious disease and who are therefore most likely to benefit from vaccination.
- 20. Specifically, Joint Committee on Vaccination and Immunisation (JCVI) advises the following groups to be offered a COVID-19 booster vaccine this autumn:
- residents in a care home for older adults
- If adults aged 65 years and over
- persons aged 6 months to 64 years in a clinical risk group, as laid out in the <u>Immunisation Green Book</u>, COVID-19 chapter (Green Book)
- frontline health and social care workers
- persons aged 12 to 64 years who are household contacts (as defined in the Green Book) of people with immunosuppression
- persons aged 16 to 64 years who are carers (as defined in the Green Book) and staff working in care homes for older adults

- 21. Further advice on the choice of vaccine products for use this autumn will be provided in due course. Professor Wei Shen Lim, Chair of COVID-19 immunisation on the JCVI, said:
 - The autumn booster programme will continue to focus on those at greatest risk of getting seriously ill. These persons will benefit the most from a booster vaccination.
 - It is important that everyone who is eligible takes up a booster this autumn –
 helping to prevent them from hospitalisations and deaths arising from the
 virus over the winter months.
- 22. Dr Mary Ramsay, Director of Public Health Programmes at the UK Health Security Agency (UKHSA), said:
- The COVID-19 virus has not gone away and we expect to see it circulating more widely over the winter months with the numbers of people getting ill increasing.
- The booster is being offered to those at higher risk of severe illness and by taking up the booster vaccine this autumn, you will increase your protection ahead of winter, when respiratory viruses are typically at their peak.
- 23. To optimise protection over the winter months, JCVI advises that the autumn programme should aim to complete vaccinations by early December 2023 ahead of winter, mindful that protection is highest in the first 3 months following vaccination. This will help maximise the potential benefits of the programme.
- 24. At the same time, JCVI recognises some need for operational flexibility in relation to when these vaccines will be offered, taking into consideration factors such as vaccine supply.
- 25. From autumn 2023, JCVI additionally advises that primary course COVID-19 vaccination for persons who have not had any COVID-19 vaccines before should consist of a single dose of COVID-19 vaccine. Eligibility for primary course vaccination will be the same as for the autumn 2023 booster.
- 26. Last year's autumn booster programme ended on the 20 February 2023. Data up to 12 March showed that 73.2% of people aged 65 to 70 years in England had been vaccinated and this increased in older cohorts rising to 83.7% (just under 2.5 million) in those aged over 80 years.

27. Data from last autumn's programme showed that those who received a booster were around 53% less likely to be admitted to hospital with COVID-19 in the 2 to 4 weeks following vaccination, compared to those who did not receive a booster.

- 28. De leafing for the wards Chapel Allerton, Moortown and Roundhay has now commenced. Due to staff leave and long-term sick of several staff members, litter picking will less of a priority during this time.
- 29. Number of new bins for INE to replace damaged/old bins. Referrals for this will be taken by the usual channels.
- 30. Large fly tips reported on Ridge Road- SECT team have retrieved evidence from first incident and are carrying out their investigations and well as further incidents have now been captured on CCTV installed by the team. Enquiries ongoing and awaiting update from SECT.
- 31. Ginnel to rear of Riviera Gardens This will be cut back by the team once de leafing has been completed.

- 32. Charity bins on Chapeltown Road Gaining evidence before visiting the business owner regarding these. We'll give opportunity to deal with them otherwise we can take action to have them removed.
- 33. Back Newton Grove quotes have been received and the Environmental Action Officer is in the process of sending a covering email out to all owners in the hope that they will all join together and meet the cost of installing new fencing.

Community Hubs Update

- 34. All Community Hubs and Libraries across Leeds are 'Welcome Spaces' this initiative is to provide a warm welcome with free hot drinks and games where residents can spend some time with company.
- 35. We are collaborating with Zero Waste Leeds on the Winter Coat appeal and are drop off and collection points for redistribution of winter coats/fleeces etc more information can be found here https://www.zerowasteleeds.org.uk/projects/leeds-winter-coat-appeal/
