## 1 APOLOGIES FOR ABSENCE AND ELECTION OF CHAIR

Apologies for the meeting had been received from the Chair, Councillor N Harrington. Councillor D Cohen was nominated and seconded to act as Chair for the meeting.

**RESOLVED** – That Councillor D Cohen act as Chair for the meeting.

## 2 WELCOMES AND INTRODUCTIONS

The Chair welcomed Councillor L Buckley and Councillor P Stables to the Community Committee and expressed thanks to Linda Richards and Peter Harrand for their years of dedicated service to the Committee and contributions to the City of Leeds.

#### 3 **APPEALS AGAINST REFUSAL OF INSPECTION OF DOCUMENTS** There were no appeals.

### 4 EXEMPT INFORMATION - POSSIBLE EXCLUSION OF THE PRESS AND PUBLIC

There was no exempt information.

#### 5 LATE ITEMS

There were no formal late items, but supplementary information was circulated to Committee Members in relation to item 9 – The Outer North East Community Committee Finance Report.

## 6 DECLARATION OF INTERESTS

Councillor R Stephenson declared an "other interest" in relation to a YAF funding application "Jubilee Games (Ringfence)" detailed in paragraph 41 of agenda item 9 "The Outer North East Community Committee Finance Report" (Minute 10 below). Councillor Stephenson did not participate in the determination of the funding application.

## 7 OPEN FORUM

There were no submissions received with respect to the "Open Forum".

## 8 MINUTES OF THE PREVIOUS MEETING 13th March 2023

**RESOLVED –** That the minutes of the meeting held on the 13<sup>th</sup> of March 2023 be confirmed as a correct record.

## 9 MATTERS ARISING FROM THE MINUTES

The following issues were raised during the ratification of the minutes of the previous meeting:

- Referenced at page 13 of the report regarding Minute 50, the legality of E-bikes and E-scooters was discussed. It was noted that E-bikes may be legal to use on highways and E-scooters only for use on private land, however, a request for an update from Highways for confirmation was requested.
- An update from Highways Officers on several issues raised, particularly regarding clarity regarding funding for operation SPARK, was requested.
- An alumnus of Shadwell Tennis Club had played as a quarter finalist for doubles at Wimbledon, showing positive results from well-funded youth activity provision. The Tennis Club had received funding as part of the Finance Report, referenced on page 15 of the report as part of Minute 54.

Additionally, Councillor L Buckley raised issues with the non-delivery of her agenda for the meeting and the presentation of her details on the agenda front. The Committee noted that these matters would be pursued in time for the next meeting.

## 10 OUTER NORTH EAST COMMUNITY COMMITTEE FINANCE REPORT

The Head of Locality Partnerships submitted a report to update the Community Committee on the budget position for the Wellbeing Fund, Youth Activity Fund (YAF), Capital Budget as well as the Community Infrastructure Levy Budget (CIL) for 2023/24.

The Localities Officer highlighted the following information:

- The Community Committee minimum conditions, for delegated decisions outside of formal Committee meetings, were detailed on page 19 at paragraph 14 of the report and were reviewed and agreed by Members.
- The Wellbeing budget financial position for the municipal year was detailed on page 19 at paragraph 19 of the report. The approved budget was £47,460 with the carry forward budget from last year as £91,178.73, including underspends from completed projects over 2022/23. £29,598.76 was the figure for wellbeing projects that had not been completed yet from 2022/23. The total revenue available to the Committee was £109,039.97
- The breakdown for Wellbeing revenue between the 3 Wards was detailed at Table 1 on page 20 of the report. For Alwoodley there was £24,841.65, for Harewood, £26,684.19 and for Wetherby £53,969.13. It was noted the Harewood balance will increase to £33,103.93 pending a project being closed.
- Paragraph 36, beginning on page 22 noted delegated decisions that had occurred since the last Outer North East Community Committee, with 3 projects approved.
- One YAF project had been declined under delegated decision which was Dance On.

- The YAF Budget position was available at Table 2 on page 23 with the total available sum for the Committee as £47,171.40. It was noted that £17,810 had been allocated to projects. The remaining balance for Alwoodley was £8,887.80, for Harewood it was £16,295.63 and for Wetherby £4,177.97. The Harewood figure will increase to £18,028.63 pending a project being closed.
- Table 3 at page 24 detailed the Capital Budget position with £31,995.01 available to the Committee. There had been an increase since the previous meeting with an injection of £3,800. £12,320.37 was available for Alwoodley, £10,854.32 for Harewood and £8,820.32 for Wetherby.

The Committee discussed the following:

## 11 OUTER NORTH EAST COMMUNITY COMMITTEE YOUTH ACTIVITY CONSULTATION REPORT

The report of the Head of Locality Partnerships provided an update on the outcomes from the Youth Activity Fund consultation which had been undertaken with children and young people, and arising from the results of that consultation, proposals for the priorities of the programme in 2023/24.

The Localities Officer highlighted the following information:

- 85 responses had been received through the email consultation process and surveys conducted at the Breeze Summer events in 2022.
- Consultation responses informed delegated YAF funding priorities with sports activities, outdoor adventure, coding/Minecraft and arts and crafts identified as the top choices for young people aged 8 to 17.

The Committee discussed the following:

- A separate consultation had been run through Members at School Council's within the locality which had identified sports, outdoor adventure and drama as their top priorities with approximately 100 young people consulted.
- The consultation process, scope and number of survey responses was noted to be limited. Consultations ran prior to the Covid-19 pandemic were outlined to have amounted to greater success.
- Alterative engagement measures were proposed to achieve better results using a variety of pathways, including Summer Sports Camps, Youth Groups, Schools, and local Scouts and Guides groups.
- Members requested a further breakdown of the consultation responses in order to attain more detail of the priorities for different age groups as the scope for ages 8 to 17 was broad.
- The voices of some younger people were noted to be harder to reach, so developing methods to hear from children less engaged with the consultation process was outlined.
- Informal settings will improve engagement with young people but the advantage for engagement through schools was noted as all children within the scope of the consultation within the locality should be registered at a school. It may be appropriate to re-establish the Youth Forum's with the schools encouraging young people less likely to engage to come forward with responses.

## **Outer North East Community Committee Finance Report**

## Purpose of report

 The report provides the Community Committee with an update on the budget position for the Wellbeing Fund, Youth Activity Fund, Capital Budget, as well as the Community Infrastructure Levy Budget for 2023/24. Financial decisions are taken to the Community Committee meetings to ensure transparency and that financial regulations are met.

## Main issues

- 2. Each Community Committee has been allocated a Wellbeing Budget (revenue and capital) and Youth Activities Fund which it is responsible for administering. The aim of these budgets is to support the social, economic and environmental wellbeing of the area and provide a range of activities for children and young people, by using the funding to support projects that contribute towards the delivery of local priorities.
- 3. A group applying for funding must fulfil various eligibility criteria, including evidencing appropriate management arrangements and financial controls are in place; have relevant policies to comply with legislation and best practice e.g. safeguarding and equal opportunities and be unable to cover the costs of the project from other funds.
- 4. Wellbeing funding cannot be paid retrospectively. An application form must be submitted and approved by the Community Committee before activities or items being purchased through wellbeing funding are completed or purchased.
- 5. The amount of wellbeing funding provided to each committee is calculated using a formula agreed by Council, taking into consideration both population and deprivation of an area.

- 6. Capital (CRIS) injections are provided as a result of council assets being sold. 5% of the sale price (up to a maximum of £100,000) of a council asset is pooled city-wide and redistributed to the Community Committee areas on the basis of deprivation. The Community Committee will receive a new capital injection every six months.
- 7. Each Community Committee has also been allocated a Community Infrastructure Levy budget. For each CIL contribution, Leeds City Council retains up to 70-80% centrally, 5% is needed for administration and 15-25% goes to be spent locally. The money will be vested with the local Town or Parish Council if applicable, or with the local Community Committee and spend decided upon by that body. This local money is known as the 'Neighbourhood Fund' and should be spent on similar projects to the Wellbeing Fund (capital).
- 8. In the Outer North East Community Committee this means that the money for the Alwoodley, Harewood and Wetherby ward will be administered by the following Parish Councils; Aberford & District, Alwoodley, Bardsey Cum Rigton, Barwick in Elmet & Scholes, Boston Spa, Bramham cum Oglethorpe, Bramhope and Carlton, Clifford, Collingham with Linton, East Keswick, Harewood, Scarcroft, Shadwell, Thorner, Thorp Arch, Walton and Wetherby.
- 9. It was agreed that CIL monies for Alwoodley, Harewood and Wetherby wards would be spent in the ward it was generated in.
- 10. Projects eligible for funding by the Community Committee could be community events; environmental improvements; crime prevention initiatives, or opportunities for sport and healthy activities for all ages. In line with the Equality Act 2010, projects funded at public expense should provide services to citizens irrespective of their religion, gender, marital status, race, ethnic origin, age, sexual orientation or disability; the fund cannot be used to support an organisation's regular business running costs; it cannot fund projects promoting political or religious viewpoints to the exclusion of others; projects must represent good value for money and follow Leeds City Council Financial Regulations and the Council's Spending Money Wisely policy; applications should provide, where possible, three quotes for any works planned and demonstrate how the cost of the project is relative to the scale of beneficiaries; the fund cannot support projects which directly result in the business interests of any members of the organisation making a profit.
- 11. Any request for funding would involve discussions with appropriate ward members. Where projects do not have support from the Community Committee and are not approved, applicants are offered further discussions and feedback, if this is requested.
- 12. In order to provide further assurance and transparency of all decisions made by the Community Committee, any projects that are not approved will be reported to a subsequent Community Committee meeting.
- 13. Sometimes urgent decisions may need to be made in between formal Community Committee meetings regarding the administration of budgets which have been allocated to the Community Committee. Alongside the Committee, designated officers have delegated authority from the Director of Communities, Housing and Environment to take such decisions.

- 14. At the first meeting of the 2016/17 municipal year, the Committee agreed the following 'minimum condition' in order to reassure Members that all delegated decisions would be taken with appropriate Member consultation and only when such a condition has been satisfied:
  - That all 3 Ward Members must be in agreement (unanimous) for a delegated decision to be approved. This was reiterated at the first meeting of 2023/24.
- 15. Members are reminded that the necessary scrutiny of applications to satisfy our own processes, financial regulations and audit requires the deadline for receipt of completed applications to be at least five weeks prior to any Community Committee. Some applications will be approved via Delegated Decision Notice (DDN) following consultation with Members outside of the Community Committee meeting cycle.
- 16. For the committee's awareness, urgent delegated decisions on wellbeing funding also covers small grant decisions. In agreement with the Executive Board Member for Communities, Community Committee Chairs and also in accordance with the communication that was sent out to all committees/Elected Members in March 2023, the approval threshold for small grants has now increased from the 1<sup>st</sup> April 2023; up to £1000 per ward. This approach will ensure consistency in terms of administering small grants, in accordance with the committees' minimum conditions.

## Wellbeing Budget Position 2023/24

- 17. The total revenue budget approved by Executive Board for 2023/24 was £47,460. Table 1 shows a carry forward figure of £91,178.73 which includes underspends from projects completed in 2022/23. £29,598.76 represents wellbeing allocated to projects in 2022/23 and not yet completed. The total revenue funding available to the Community Committee for 2023/24 is therefore £109,039.97. A full breakdown of the projects approved or ring-fenced is available on request.
- 18. The total amount approved on Table 1 includes all the projects the committee has approved in 2023/24. It is possible that some of the projects may not use their allocated spend. This could be for several reasons, including the project no longer going ahead, the project not taking place within the dates specified in the funding agreement, or failure to submit monitoring reports. Due to this the final revenue balance may be greater than the amount specified in Table 1.
- 19. The Community Committee is asked to note that there is currently a remaining balance of **£45,903.57.** A full breakdown of the projects is listed in Table 1 and is available on request.

## Main issues

## Updates by theme

## **Environment and Community Safety: Champion Cllr Lamb**

3. An update will be provided for the next committee meeting.

## Children & Families: Champion Cllr R Stephenson

4. Each Community Committee has been allocated a Youth Activity Fund which it is responsible for administering. The Youth Activity Fund has been made available to provide local activities for children and young people aged 8-17 years across the city.

- 5. The Youth Activity Fund requires the engagement and participation of children and young people in the decision making and evaluation of the fund. Children and young people are involved in the funding process and advise Community Committees on the activities they would like to take part in, in their respective areas.

## **Updates from Key Services**

## **Cleaner Neighbourhoods Team**

- If you have any unwanted items that are not suitable for donation and you cannot get to a Recycling Centre, you can book in a free unwanted items collection (bulky collection). If you live within the Leeds council tax area the service can collect up to 5 items per collection, with a maximum of 4 collections per year.
- 10. De-leafing is due to start week commencing the 2<sup>nd</sup> October 2023. If there are specific sweeping issues especially of a health and safety nature please continue to report in the normal way via the online portal or by emailing at <u>eneaction@leeds.gov.uk</u>.

## Parks & Countryside

11. The memorial benches for Queen Elizabeth II have been delivered to Parks & Countryside. Officers have therefore been working with Councillors and Parish Councils to identify suitable locations for the benches, so that they can be installed.

## **Public Health**

## **World Suicide Prevention Day**

- 12. World Suicide Prevention Day is marked on September 10<sup>th</sup> each year, to promote worldwide action to prevent suicides. Various events and activities are held during this time to raise awareness of the fact that suicide is a major preventable cause of early death.
- 13. Every person lost to suicide is someone's partner, child, friend, neighbour and/or colleague and their death will hugely affect people in their family, workplace and community. We can all play a vital role in reducing and preventing suicide by making people comfortable to talk about suicide and mental health, by encouraging people to have these conversations.
- 14. The West Yorkshire Check in With Your Mate Campaign aims to promote these conversations and to raise awareness of the factors and signs that may lead to suicide, inspiring people to start conversations about mental health with the men in their life at home, in the community and at work, potentially saving lives.
- 15. To support the Public Mental Health Team in promoting the <u>'Check in With Your Mate'</u> (CIWYM) campaign and help to prevent suicide, click <u>here</u> for a range of free resources. Colleagues are encouraged to download the CIWYM email signature to show support for the campaign throughout September and share/distribute campaign posters as appropriate.
- 16. For helpful guidance and support around language and to help prevent further harm when talking about suicide, we would recommend you familiarise yourself with the following <u>guide</u>. If you have been affected by suicide, at any point in your life, the <u>Leeds Suicide Bereavement Service</u> offers a safe space to talk and get support.

## Heatwave and Health: Communications Toolkit

- 17. The summer weather/heatwave comms toolkit has been available for use across the city, with assets for bulletins and social media. The messages are based around the new impact based alert system. The heat health alert system is operated by UKHSA in partnership with the Met Office and is outlined below:
  - Green: general preparedness and awareness raising.
  - Yellow: where impacts may be expected for those who are particularly vulnerable, or where confidence in the weather forecast for more severe periods of heat is low.
  - Amber: for situations where impacts are expected across the population.
  - Red: significant risk to life for even the healthy population.
- 18. The toolkit was made available during the Heatwave campaign for use by agencies and groups to support residents.

## Winter Vaccines Rollout: Building Vaccine Confidence for Higher Risk Populations

19. Free webinars were offered during August in preparation for the vaccine rollout which begins in September. Various dates and times were offered to raise awareness of the rollout programme and information that can be passed on to residents in the city.

## **Climate Change**

- 20. The directors of Public Health in Yorkshire & Humberside have made climate change one of their priorities for collaboration across the 15 local authorities. A strand of the action plan is a programme based on the insight and learning from a survey sent out earlier in the year.
- 21. Climate change is the single biggest threat to population health. Public health professionals have a key role to play in climate mitigation and adaptation and drawing attention to the health co-benefits of addressing the factors that drive climate change. Their in depth understanding of health inequalities is crucial to ensure that climate change does not further compromise the health of the most vulnerable.

## **Better Conversations**

- 22. Part of the Leeds Health and Care Academy, these skill sessions are open to anyone working in Health and Social Care in Leeds. The workshops aim to enable health and care colleagues to deliver and encourage more collaborative conversations, primarily between a health and care professional and patient or service user, or when speaking to members of the public, with three learning packages on offer:
  - Level 1: eLearning, introducing the principles of better conversations.
  - Level 2: virtual interactive workshop, better conversations, reflective practice (28th September, 22nd November and 14th December).
  - Level 3: in person workshop, better conversations, a personalised approach to conversations (13th September and 17th October).

## **Rightsizing Campaign**

- 23. People aged 50 and over living in West Yorkshire are being targeted with an innovative new campaign to help them 'rightsize' and find a home that's right for them. The aim of the 'rightsizing' campaign is to help people choose where they live before other factors, such as ill health, make that decision for them.
- 24. The campaign press release is <u>here</u> or alternatively you can visit the new website for more information <u>Your home, your choice</u>. If you wish to help promote the campaign a toolkit is also available here: <u>Rightsizing campaign toolkit</u>.

## **Drowning Prevention**

25. During the summer, the risk to young people through accidental drowning increases significantly. When the weather is hot young people can be tempted to go for a dip in the local river or reservoir but swimming in open waters is extremely dangerous.

26. A range of water safety campaign resources are available for digital channels. They can be downloaded <u>here</u>. The Royal Life Saving Society <u>website</u> also provides information and resources on water safety education.

## Annual Flu Report

27. UKHSA's Annual Report has been published and summarises the levels of Influenza (Flu) across the UK for the winter period, 2022 to 2023. The analysis indicates that excess deaths in England associated with Flu were higher (14,500) than the average figure (13,500) for the five years before the pandemic. This is the highest figure since the 2017 to 2018 season, when there were 22,500 excess deaths associated with flu. You can read more <u>here</u>.

### **Measles Action Cards**

- 28. The UK Health Security Agency (UKHSA) Yorkshire and Humber have recently circulated communications and guidance to acute trusts and primary care following a rise in the number of confirmed Measles cases both within Yorkshire and Humber and nationally during the first part of 2023.
- 29. Children and young adults continue to be susceptible to infection due to a gap in immunity, contributed to by the fall in vaccination uptake rates during the COVID-19 pandemic. Measles action cards for healthcare settings are available and inform staff of the symptoms to be aware of as well as the actions to be taken should a patient present with measles like symptoms.
- 30. The Health Publications Website contains UKHSA measles resources for settings which can be downloaded and printed or ordered (usually for free). To access all of the available resources visit <u>Publications Health Publications</u>.
- 31. The 'If you think you've got measles call ahead' poster can be printed <u>here</u> to be displayed in surgeries, or if you would like this to be posted to you please contact the Public Health Resource Centre <u>PHRC@leeds.gov.uk</u>. This poster can also be shared on social media platforms and GP practice websites to raise public awareness of measles symptoms and actions.

## National Energy Action: E-learning Courses

- 32. The National Energy Action training aims to equip people with the skills and knowledge to help mitigate against the impact of the energy crisis on vulnerable households.

- 33. Cases opened in the last 3 months by ward; Alwoodley = 5, of which 2 x Noise; 3 x ASB, 0 x Hate, 0 x DV; Harewood = 1, of which 1 x ASB, 0 x Noise, 0 x Hate, 0 x DV; Wetherby = 3, of which 3 x ASB, 0 x Noise, 0 x Hate, 0 x DV. Current active caseload in Outer North East = 14.
- 34. Citywide Nuisance Vehicle PSPO is now live and enforceable and it is hoped that this will help to address the ongoing vehicle related issues at King Lane Park and Ride and at the Wilderness Car Park in Wetherby. 20 Fixed Penalty Notices have already been issued to address this behaviour at other locations in the city. Signage has been erected at key "hotspots" and shortly to be extended to the main arterial routes into the city.

## **Community Hubs**

### Summer Reading Challenge 2023, Ready Set Read!

- 35. School engagement has taken place via library visits and school assemblies to promote this summer's challenge, Ready, Set, Read! Librarians visited Primrose Lane, St Joseph's, Carr Manor, Moor Allerton Hall, Wigton Moor, Manor Wood and St Paul's schools to deliver assemblies.
- 36. There has been a fantastic level of involvement to the challenge, with the following sign-ups to date:
  - Moor Allerton Community Hub and Library: 810 children
  - Wetherby Community Hub and Library: 231 children
  - Boston Spa Library: 64 children
- 37. There has been some excellent feedback received regarding the summer reading challenge, including, "We had a customer come into Wetherby Library whose daughter was currently participating in the Summer Reading Challenge. She said that her daughter was currently loving the books and now instead of her asking her mum to use her phone, she asks for a book instead".

#### April 2022 – March 2023

41. During April 2022 to March 2023 the service assisted with the following:

- 14,179 people accessed the service, 383 of whom were residents from the Outer North East.
- Supported 2,999 people into work, 90 of whom were residents from the Outer North East.
- Customers were supported into work across all sectors with the largest numbers in, arts, entertainment and recreation, construction, health and care, ICT, digital and communications.
- Supported 3,753 people to improve their skills, 126 of whom were from the Outer North East.
- 42. Leeds Employment Hub is a single point of contact for all funded programmes and jobshops which provides tailored and comprehensive support into employment or education to all Leeds residents. Employment Hub Advisors deliver the programme by providing one to one support, tailored preventative and remedial support to Leeds

residents who are disadvantaged in the labour market. The Employment Hub Advisors are co-located within the Jobcentre Plus centres across the city. Further funding has been secured which will see the role of the Advisors continue until at least March 2025. All Jobshops are open 5 days a week for face-to-face appointments which include the City Centre Community Hub.

- 43. Community Learning provision continues to deliver an effective, broad and inclusive curriculum to support the continuation of learning, in collaboration with subcontracted partners. Courses were delivered through a range of models which include face to face, online and through distance learning, opening new opportunities for adults to learn and develop their confidence. Between April 2022 March 2023, in the Outer North East, 5 courses were delivered at 4 venues. 164 residents have accessed a course. In addition, there were 50 courses delivered on-line.
- 44. Between April 2022 March 2023, 15 Developing You Health and Wellbeing courses, a pre-employability programme which helps people to become happier, healthier and move closer towards employment, were delivered across the city. 123 people completed the course, 24 of whom were supported into work. For further information on courses available both online and face to face at community venues, please visit: <a href="https://leedsadultlearning.co.uk">https://leedsadultlearning.co.uk</a>
- 45. The Connecting Communities to Health and Care Careers work focuses on narrowing inequalities with a one system approach across the sector, adapting recruitment methods and building on the good practice in the system, targeting the priority wards. The pathways that are being delivered provide people with a supported programme into Administration and Care roles within the NHS and Adult Social Care. There are functional skills (Maths, English and ESOL) support provided to upskill individuals to the required entry level for their pathway of choice. Since February 2022, 422 people, 51% of whom were from the priority wards have attended the information sessions, 167 have achieved a qualification and 174 people have been supported into work. New pathways that have been developed for children's residential, Care Practitioner and Care Navigators roles within GP practices, will be delivered from September 2023. For further information please visit: Health and Care Careers.
- 46. Within the last year the Employment & Skills Service has supported 342 new businesses, including recruiting new staff, providing support for staff facing redundancy, developing initiatives to address staff shortages and filling a high number of vacancies within key sectors.

## **Delivered Events & Activities**

47. The service delivered the following events & activities.

• **Informed Choices:** supported school careers events and parents evenings and delivered apprenticeship awareness sessions, engaging with 10,535 young people, 458 parents/carers and 409 teachers.

- **Next Steps:** support for young people following GCSE or A Level results hosted on Start in Leeds <u>Next Steps after School or College</u>.
- Connecting Communities to Health and Care Careers: delivered 28 information sessions between January and July 2023 at 7 venues across the city, 5 of the LCC Community Hubs, Age UK and One Community Centre.
- Jobs Fairs: 19 recruitment events delivered since April 2023 at 10 venues across the city, seven LCC Community Hubs, Wetherby Community Hub, Farnley Community Centre and the White Rose Shopping Centre.
- Leeds Community Learning and Employer Provider Apprenticeships Celebration Awards 2023: took place on 18<sup>th</sup> July 2023 at the Civic Hall to celebrate the accomplishments of all learners and tutors.
- SEND Next Choices Event: Getting Ready for Adult Life took place on 29th June 2023 at Leeds First Direct Arena. The event was aimed at supporting young people who have Special Educational Needs and Disabilities (SEND). A total of 67 exhibitors participated, offering jobs, apprenticeships, volunteering, training opportunities and leisure activities, along with other specific support. 2,200 young people attended with very positive feedback.
- **Financial Wellbeing Events:** delivered in partnership with Credit Union, Yorkshire Water and Leeds City Council, for residents concerned with the rising cost of living. Support provided included debt advice and employment assistance.
- Leeds Apprenticeship Recruitment Fair (LARF): took place on 6<sup>th</sup> February 2023 at Leeds First Direct Arena. A total of 106 organisations participated and 8,000 visitors attended.
- **Family Learning Festival:** delivered on the 16<sup>th</sup> February 2023 at the Carriageworks Theatre, with approximately 150 people participating, along with 25 exhibitors from across the Community Learning sector. Local skills providers, colleges, universities and employment advisors attended to provide advice for anyone looking to develop their skills further or to plan their next steps.
- **Reducing Re-Offending:** construction recruitment events took place on 24<sup>th</sup> January 2023 and 19<sup>th</sup> July 2023 at HMP Leeds. 5 construction companies attended offering employment opportunities. 77 serving prisoners engaged with the advisors who delivered employability support sessions.

#### **Planned Events & Activities**

48. The service is planning the following events & activities.

• The Leeds Digital Careers Fair (LDCF) 2023: will take place on 26<sup>th</sup> September 2023, at Leeds First Direct Arena. The event is aimed at those exploring a career in tech and digital. Attendees will be given an opportunity to engage with a range of tech training providers and employers to find out about the diverse career opportunities available. - **Reducing Re-Offending:** a jobs fair to take place at HMP Wealstun on 28<sup>th</sup> September 2023. The event will offer support to prisoners due for release. A range of employers from different sectors are attending alongside Employment and Skills Advisors.
- The Leeds Creative Skills Festival (LCSF): will take place on 20<sup>th</sup> November 2023 at Leeds First Direct Arena. The event will showcase the wide range of opportunities within the creative and culture sector. #### Ward Member Meetings

- 52. Ward Member meetings are taking place on a regular face to face basis, either in the locality or in the Civic Hall. Services attending those meetings include, the Cleaner Neighbourhood Team, Parks & Countryside, Forestry, Traffic Management and Highways Maintenance, the Anti-Social Behaviour Team and the Youth Service.
- 53. Councillors find this format of meetings useful, as it allows them to be briefed on what is happening in the service areas and also allows them to raise any questions with the service directly, which they can then relay back to their constituents.

#### Town and Parish Council Forum

54. An update will be provided for the next committee meeting.

## Leeds Festival Working Group

55. In 2022 a Leeds Festival working group was set up, with a purpose of looking at local concerns and ways that the event can improve matters for local residents and attendees of the festival. All parties involved found the meetings useful

and have decided to carry on the process again to discuss the festival in 2023.

- 56. The group is co-chaired by the Harewood and Wetherby Councillors. Invited to be part of the working group are Leeds City Council officers, Leeds Festival Event Management, the Police and Councillors from the Town and Parish Councils in both wards.
- 57. The first meeting for Leeds Festival 2023 took place on the 14th March, where items discussed included a review of 2022, the current plans for 2023 and potential challenges for this year.
- 58. Leeds Festival 2023 took place on the 25th, 26th and 27th August, with entertainment for those camping starting on Thursday 24th. A debrief and lessons learned meeting is due to take place on the 12<sup>th</sup> September 2023.

- 59. The Compassionate City Awards 2023 are open for nominations. The awards recognise the outstanding individuals and organisations who make a difference to their communities.
