Cllr Flynn wished it to be noted that the Neighbourhood Host for Adel and Wharfedale was excellent and had been in constant contact with him over two extremely successful art projects within his ward. He wished to commend her commitment and engagement.

• Members discussions during the consideration of applications included:

- More detail was required on some applications including numbers of people attending and from which areas.
- Applications from Youth Services requesting funding through the Youth Activity Fund were open to all young people engaging with Youth Services.
- It was noted that the application for the Neighbourhood Watch Fun Day was on the same day as Guiseley Carnival.
- In relation to the request by Art Camp UK, Otley & Yeadon Ward Members said that they would be happy to fund the project if it was found that young people were only attending from the Otley & Yeadon Ward.
- Members were advised that no projects had had been considered or approved by Delegated Decision Notice (DDN) since the last meeting on 6<sup>th</sup> March 2023. However, there was one project currently being processed via DDN in relation to SEND Activity Day – (YAF).
- Members noted that no projects had been declined since the meeting on 6<sup>th</sup> March 2023.
- Members reiterated the importance of monitoring information within the Finance Update report.
- Members asked to note the current remaining balance of £54,336.74 in the Youth Activity Fund with the breakdown of projects listed at Table 2 of the submitted report.
- Table 3 showed a breakdown of the proposed Small Grants and Skips budget by ward and the projects already approved.
- Members were asked to note the Capital allocation of £43,611.80 broken down by ward and summarised in Table 4. It was noted that not all figures had been received yet in relation to Capital Budget, but this information would be provided when received from Finance.
- The Committee were asked to note that currently available to spend in the Community Infrastructure Levy (CIL) budget there was £109,945.43. This allocation had been broken down by ward and summarised in Table 5. It was noted that an injection into the CIL budget was expected, and this would be provided to Members when it was available. Cllr B Anderson raised concerns that he was of the view the Community Committee were not getting all the CIL money that it was entitled to. He again requested information on CIL money provided to the Parish and Town Councils in the Outer North West area.

# **Outer North West Community Committee Finance Report**

# Purpose of report

1. This report provides the Community Committee with an update on the budget position for the Wellbeing Fund, Youth Activity Fund, Capital Budget, as well as the Community Infrastructure Levy Budget for 2023/24.

#### Main issues

- 2. Each Community Committee has been allocated a wellbeing budget (revenue and capital) and Youth Activities Fund which it is responsible for administering. The aim of these budgets is to support the social, economic and environmental wellbeing of the area and provide a range of activities for children and young people, by using the funding to support projects that contribute towards the delivery of local priorities.
- 3. A group applying to the Wellbeing Fund must fulfil various eligibility criteria, including evidencing appropriate management arrangements and financial controls are in place; have relevant policies to comply with legislation and best practice e.g. safeguarding and equal opportunities and be unable to cover the costs of the project from other funds.
- 4. Wellbeing funding cannot be paid retrospectively. An application form must be submitted and approved by the Community Committee before activities or items being purchased through wellbeing funding are completed or purchased.
- 5. The amount of wellbeing funding provided to each committee is calculated using a formula agreed by Council, taking into consideration both population and deprivation of an area.

- 6. Capital (CRIS) injections are provided as a result of council assets being sold. 5% of the sale price (up to a maximum of £100k) of a council asset is pooled city-wide and redistributed to the Community Committee areas on the basis of deprivation. The Community Committee will receive a new capital injection every 6 months.
- 7. Each Community Committee has also been allocated a Community Infrastructure Levy budget. For each CIL contribution, Leeds City Council retains up to 70-80% centrally, 5% is needed for administration and 15-25% goes to be spent locally. The money will be vested with the local Town or Parish Council if applicable, or with the local Community Committee and spend decided upon by that body. This local money is known as the 'Neighbourhood Fund' and should be spent on similar projects to the Wellbeing Fund (capital).
- 8. In the Outer North West Community Committee this means that the CIL money for Arthington Parish Council, Bramhope & Carlton Parish Council, Horsforth Town Council, Otley Town Council, Pool in Wharfedale Parish Council and Rawdon Parish Council will be administered by each Parish or Town Council, whereas monies for the parts of Adel & Wharfedale, Guiseley & Rawdon and Otley & Yeadon wards that do not have a Parish and Town Council will be administered by the Outer North West Community Committee.
- It was agreed at Outer North West on the 27th November 2017 that CIL monies for Adel & Wharfedale, Guiseley & Rawdon and Otley & Yeadon would be spent in the ward it was generated in
- 10. Projects eligible for funding by the Community Committee could be community events; environmental improvements; crime prevention initiatives, or opportunities for sport and healthy activities for all ages. In line with the Equality Act 2010, projects funded at public expense should provide services to citizens irrespective of their age, disability, gender reassignment, marriage and civil partnership, pregnancy and maternity, race, religion or belief, sex and sexual orientation: the fund cannot be used to support an organisation's regular business running costs; it cannot fund projects promoting political or religious viewpoints to the exclusion of others; projects must represent good value for money and follow Leeds City Council Financial Regulations and the Council's Spending Money Wisely policy; applications should provide, where possible, three quotes for any works planned and demonstrate how the cost of the project is relative to the scale of beneficiaries; the fund cannot support projects which directly result in the business interests of any members of the organisation making a profit.
- 11. Any request for funding would involve discussions with appropriate ward members. Where projects do not have support from the Community Committee and are not approved, applicants are offered further discussions and feedback if this is requested.
- 12. In order to provide further assurance and transparency of all decisions made by the Community Committee, any projects that are not approved will be reported to a subsequent Community Committee meeting.

- 13. Sometimes urgent decisions may need to be made in between formal Community Committee meetings regarding the administration of wellbeing and youth activity budgets and also regarding the use of the Community Infrastructure Levy (CIL) Neighbourhood Fund which has been allocated to the Community Committee. Alongside the Committee, designated officers have delegated authority from the Director of Communities and Environment to take such decisions.
- 14. The establishment of the following minimum conditions was to provide reassurance to Members that all delegated decisions would be taken within an appropriate governance framework, with appropriate Member consultation and only when such conditions have been satisfied:
  - a. consultation must be undertaken with all committee/relevant ward members prior to a delegated decision being taken;
  - b. a delegated decision must have support from the Elected Members represented on the Community Committee (or in the case of funds delegated by a Community Committee to individual Wards, the relevant Ward Councillors), however should an Elected Member not agree with a matter for delegated decision then this should be deferred to the next meeting of the Community Committee; and
  - c. details of any decisions taken under such delegated authority will be reported to the next available Community Committee meeting for Members' information.
- 15. For the committee's awareness, urgent delegated decisions on wellbeing funding also covers small grant decisions. In agreement with the Executive Board Member for Communities, Community Committee Chairs & also in accordance with the communication that was sent out to all committees/Elected Members in March 2023, the approval threshold for small grants has now increased from the 1st April 2023; up to £1000 per ward. This approach will ensure consistency in terms of administering small grants, in accordance with the committees' minimum conditions.
- 16. Members are reminded that the necessary scrutiny of applications to satisfy our own processes, financial regulations and audit requires the deadline for receipt of completed applications to be at least five weeks prior to any Community Committee. Some applications will be approved via Delegated Decision Notice (DDN) following consultation with Members outside of the Community Committee meeting cycle.

# Wellbeing Budget Position 2023/24

- 17. The total revenue budget approved by Executive Board for 2023/24 was £67,800. Table 1 shows a carry forward figure of £10,496.72 which includes underspends from projects completed in 2022/23. The total revenue funding available to the Community Committee for 2023/24 is therefore £78,296.72. A full breakdown of the projects approved or ring-fenced is available on request.
- 18. It is possible that some of the projects may not use their allocated spend. This could be for several reasons, including the project no longer going ahead, the project not taking place within the dates specified in the funding agreement, or failure to submit monitoring reports. Due to this the final revenue balance may be greater than the amount specified in Table 1.
- 19. The Community Committee is asked to note that there is currently a remaining balance of **£58,366.29.** A full breakdown of the projects is listed in Table 1 and is available on request.

- 24. The total available for spend in Outer North West Community Committee in **2023/24** including carry forward from previous year, was **£75,351.17.**
- 25. The Community Committee is asked to note that so far, one project has been partially approved pending a further meeting the Children's & Families sub group and a further project currently awaiting responses from ward councillors.

# Adel & Wharfedale (1 active case with LASBT)

• Long running ASB case where an injunction was put in place to tackle persistent ASB. Case will be closing this week as the accused has now moved from the area.

# Guiseley & Rawdon (13 active cases with LASBT)

- 5 cases in relation to noise complaints. 2 of these are complaints about barking dogs, 1 is of a man with substance issues shouting late at night & the other 2 are complaints about noise such as music, banging, shouting etc.
- 1 case in relation to persistent ASB due to parties. A partial closure order has put in place for this property to limit who can access the address which appears to have reduced the issues significantly.
- 3 cases which are all linked, are in relation to allegations of harassment. The victim feels they are being harassed by several neighbours due to their race. These 3 cases are linked to one of the dog barking noise cases.
- 2 cases in relation to threats being made.
- 1 case in relation to drug use & associated ASB.

# Horsforth (5 active cases with LASBT)

- 2 cases which are linked to one another. 1 which is a noise case & a counter allegation where the alleged perpetrator of noise has accused the neighbour (& complainant in the noise case) of threatening them.
- 1 case of noise issues which has been reopened this week due to new complaints. A S80 noise abatement notice has been issued previously on this case.
- 1 case of harassment/verbal abuse which since our involvement appears to have improved & the case is almost ready to be closed.
- 1 case of drug related ASB. A new case has recently come through to us where concerns have been raised over an adult male who is being visited by groups of teenagers & drugs are being used. Investigations are ongoing as to whether the adult is vulnerable & being cuckooed or is complicit in the issues.

# Otley & Yeadon (8 active cases with LASBT)

- 3 cases in relation to noise complaints. 1 of these is about dogs barking, the other 2 are complaints about noise such as music, banging, shouting etc.
- 1 case in relation to a male exposing himself in the street.
- 2 cases in relation to arguing & rowdy behaviour at addresses which is impacting on other residents. Closure warning letters have been issued in both cases.
- 1 case in relation to concerns the tenant of the property is suffering DV.
- 1 case in relation to allegations of assault. Accused is currently being held on remand so we are awaiting the outcome of the criminal investigation.

# NOTES FROM HEALTH SUB-GROUP MEETING HELD ON $17^{TH}$ JULY TOPIC – THE DANGERS OF VAPING

Attendees: Cllr. Caroline Anderson, Cllr. Ray Jones, Cllr. John Garvani, Cllr. Eleanor Thompson

Speaker: Heather Jones – Head of Public Health, Leeds City Council

We had a very interesting session with Heather, she was able to tell us fact from fiction and the legal side of promoting and selling vaping products to children.

The Action for Smoking and Health (ASH) campaign group have surveyed young people and found that 79% have never vaped.

The increase in the last few years is being attributed to brightly coloured displays. Young people who have tried vaping do not appear to have become addicted to nicotine. Public Health have collaborated with ASH and with Smoke Free Sheffield and developed animations and printed materials to use in presentations to a range of people who are working with young people.

Smoking is more dangerous than vaping but if you don't smoke, then don't vape is the message. Generally, it is found that if people don't smoke by the time, they are 21 then they will probably never smoke, it is the same with vaping.

Vaping is not risk free it delivers too much nicotine too quickly. The longer-term effects are not yet known because it's not been around long enough to test the impact.

The Regulations stipulate that sales to under 18s are illegal as is proxy purchasing (buying for children under 18) however giving a child a gift is not illegal. There is no licence needed to sell vaping products. There is no restriction on shop displays unlike cigarettes.

Vaping products must carry health warnings. They must have less than 2% nicotine. A 2ml disposable vape contains 40mg of nicotine whereas 20 cigarettes have 250mg. Puffs of a vape are not equivalent to cigarette puffs. Vapes do not contain the 7000 toxic chemicals and tars in cigarettes.

The advertising ban of nicotine-containing products on the broadcast media, newspapers, magazines, periodicals, online media, and other electronic media applies to vaping products as well.

There is no evidence that Vaping is a gateway to smoking.

In terms of recycling the vaping apparatus it is treated as household electronic equipment.

Next Steps

- A Scrutiny Board Working Group is proposed within the Children and Families Scrutiny Board.
- New Resource Packs for schools.
- Healthy Schools data and surveys to be obtained
- Public Health will work with Trading Standards because children are not finding it difficult to purchase vapes from shops.

#### What can Councillors Do?

Report underage sales where you see this happening, or someone reports it to you. Public Health need our help.

# World Suicide Prevention Day

World Suicide Prevention Day is marked on September 10<sup>th</sup> each year to promote worldwide action to prevent suicides. Various events and activities are held during this time to raise awareness that suicide is a major preventable cause of early death. Every person lost to suicide is someone's partner, child, friend, neighbour and/or colleague and their death will hugely affect people in their family, workplace, and community. We can all play a vital role in reducing and preventing suicide by making people comfortable to talk about suicide and mental health through encouraging people to have these conversations.

The West Yorkshire Check In With Your Mate campaign aims to promote these conversations and to raise awareness of the factors and signs that may lead to suicide, inspiring people to start conversations about mental health with the men in their life - at home, in the community and at work – potentially saving lives.

To support the Public Mental Health team in promoting the <u>'Check in With Your Mate'</u> (CIWYM) campaign and help to prevent suicide, click <u>here</u> for a range of free resources. Colleagues are encouraged to download the CIWYM email signature to show support for the campaign throughout September and share/distribute campaign posters as appropriate.

For helpful guidance and support around language and to help prevent further harm when talking about suicide, we would recommend you familiarise yourself with the following <u>guide</u>.

To coincide with World Suicide Prevention Day, the <u>Yorkshire Speak Their Name Memorial</u> <u>Quilt</u> will be at Kirkgate Market from 9<sup>th</sup>-15<sup>th</sup> September and we would encourage colleagues to find time to pay a visit to support us in reducing stigma when talking about suicide.

If you have been affected by suicide, at any point in your life, the <u>Leeds Suicide Bereavement</u> <u>Service</u> offers a safe space to talk and get support

# Heatwave and health: comms toolkit

The summer weather/heatwave comms toolkit has been available for use across the city with copy and assets for bulletins and social media.

The messages are based around the new impact based alert system. The heat health alert system is operated by UKHSA in partnership with the Met Office and is outlined below:

- Green (summer preparedness) general preparedness and awareness raising
- Yellow (response) where impacts may be expected for those who are particularly vulnerable or where the confidence in the weather forecast for more severe periods of heat is low
- Amber (enhanced response) for situations where impacts are expected across the population.
- Red (emergency response) significant risk to life for even the healthy population

The toolkit was made available during the Heatwave campaign for use by agencies and groups to support residents.

#### Winter vaccines rollout: Building vaccine confidence for higher risk populations

Free webinars were offered during August in preparation for the vaccine rollout which begins in September. Various dates and times were offered to raise awareness of the rollout programme and information that can be passed on to residents in the city.

The directors of public health in Y&H have made climate change one of their priorities for collaboration across the 15 local authorities. A strand of the action plan is a CPD programme based on the insight and learning from the survey sent out to all DPH's earlier in the year.

Climate change is the single biggest threat to population health. Public health professionals have a key role to play in climate mitigation and adaptation and drawing attention to the health co-benefits of addressing the factors that drive climate change. Their in-depth understanding of health inequalities is crucial to ensure that climate change does not further compromise the health of the most vulnerable.

Cat Pinho-Gomes shares the support available from the Faculty of Public Health and discusses how we can embed climate and health into our daily jobs.

The event was open to all public health staff with an interest in climate change.

#### **Better Conversations**

Part of the Leeds Health and Care Academy, these skill sessions are open to anyone working in health and social care in Leeds. The workshops aim to enable health and care colleagues to deliver and encourage more collaborative conversations, primarily between a health and care professional and patient or service user, or when speaking to members of the public.

Three learning packages are on offer:

- Level 1 eLearning introducing the principles of better conversations a 60-minute session
- Level 2 virtual interactive workshop better conversations: reflective practice (28 September, 22 November and 14 December)
- Level 3 in-person workshop better conversations: a personalised approach to conversations (13 September and 17 October)

### Rightsizing campaign

People aged 50 and over living in West Yorkshire are being targeted with an innovative new campaign to help them 'rightsize' and find a home that's right for them. The aim of the 'rightsizing' campaign is to help people choose where they live before other factors, such as ill health, make that decision for them. #### **Drowning Prevention**

During the summer, the risk to young people through accidental drowning increases significantly. When the weather is hot young people can be tempted to go for a dip in the local river or reservoir, but swimming in open waters is extremely dangerous.

#### Annual flu report

UKHSA's annual report has been published and summarises the levels of influenza (flu) across the UK for the winter period, 2022 to 2023. The analysis indicates that excess deaths in England associated with flu were higher (14,500) than the average figure (13,500) for the five years before the pandemic. This is the highest figure since the 2017 to 2018 season, when there were 22,500 excess deaths associated with flu.

#### Measles Action Cards

The UK Health Security Agency (UKHSA) Yorkshire and Humber have recently circulated communications and guidance to acute trusts and primary care following a rise in the number of confirmed Measles cases both within Yorkshire and Humber and nationally during the first part of 2023. Children and young adults continue to be susceptible to infection due to a gap in immunity, contributed to by the fall in vaccination uptake rates during the COVID-19 pandemic. Measles action cards for healthcare settings are available and inform staff of the symptoms to be aware of as well as the actions to be taken should a patient present with measles like symptoms.

#### Universal Credit

The number of people who are claiming Universal Credit (UC) due to unemployment, as of May 2023, in the Outer North West Community Committee area is 2,290. This is an increase of 112% since March 2020, and an increase of 19 claimants on the previous month.

- During April 2022 March 2023
  - 14,179 people accessed the Service, 566 of whom were residents from the Outer North West.
  - Supported 2,999 people into work, 111 of whom were residents from the Outer North West. Customers were supported into work across all sectors with the largest numbers in, construction, health and care including childcares, manufacturing, ICT, digital and comms.
  - Supported 3,753 people to improve their skills, 202 of whom were from the Outer North West.

Leeds Employment Hub is a single point of contact for all funded programmes and Jobshops which provides tailored and comprehensive support into employment or education to <u>all</u> Leeds residents. Employment Hub Advisors deliver the programme by providing one to one support, tailored preventative and remedial support to Leeds residents who are disadvantaged in the labour market. The Employment Hub Advisors are co-located within the Jobcentre Plus centres across the city. Further funding has been secured which will see the role of the Advisors continue until at least March 2025.

All Jobshops are open, 5 days a week for face-to-face appointments which includes City Centre and Hawksworth Community Hubs. There are also the following pop up Jobshops:

- Horsforth Community Hub, Town Street, LS18 5BL, Tuesday (every 2 weeks) 9:00-17:00
- Yeadon Community Hub, Town Hall Square, LS19 7PP, Wednesday (every 2 weeks) 9:00-17:00
- Otley Community Hub, Nelson Street, LS21 1EZ, Thursday (every 2 weeks) 9:00-17:00
- Holt Park Community Hub, Holtdale Approach, LS16 7RX, Friday 9:00 17:00

Community Learning provision continues to deliver an effective, broad, and inclusive curriculum to support the continuation of learning in collaboration with subcontracted partners. Courses were delivered through a range of models which include face to face, online and through distance learning, opening new opportunities for adults to learn and develop their confidence.

Between April 2022 - March 2023, in the Outer North West, 12 courses were delivered at 7 venues. 228 residents have accessed a course. In addition, there were 50 courses delivered on-line.

Between April 2022 - March 2023, 15 Developing You Health and Wellbeing courses, a preemployability programme which helps people to become happier, healthier and move closer towards employment were delivered across the city, 123 people completed the course and 24 of whom were supported into work. Developing You courses were developed and delivered to people with Learning Disabilities, 18 people completed the course and are being supported by the Employment Hub to support progression to further learning, employment or volunteering.

Delivering in partnership the Connecting Communities to Health and Care Careers work focuses on narrowing inequalities with a one system approach across the sector, adapting recruitment methods and building on the good practice in the system, targeting the Priority Wards. The pathways that are being delivered provide people with a supported programme into Administration and Care roles within the NHS and Adult Social Care. There are functional skills (Maths, English and ESOL) support provided to upskill individuals to the required entry level for their pathway of choice. Since February 2022, 422 people, 51% of whom were from the Priority Wards have attended the information sessions, 167 have achieved a qualification and 174 people have been supported into work. New pathways that have been developed for Children's Residential, Care Practitioner roles and Care Navigators within GP Practices and will be delivered from September 2023. Within the last year the Service has supported 342 new businesses including recruiting new staff, providing support for staff facing redundancy, developing initiatives to address staff shortages and filling a high number of vacancies within key sectors.

#### **Delivered Events and Activities**

- **Informed Choices** supported school careers events and parents evenings and delivered Apprenticeship awareness sessions, engaging with 10,535 young people, 458 parents/carers and 409 teachers.
- **Next Steps** support for young people following GCSE or A Level results is hosted on Start in Leeds <u>Next Steps after School or College</u>.

- Connecting Communities to Health and Care Careers delivered 28 information sessions between January and July 2023 at 7 venues across the city, five of the LCC Community Hubs, Age UK and One Community Centre
- Jobs Fairs 19 recruitment events delivered since April 2023 at 10 venues across the city, seven LCC Community Hubs, Wetherby Community Hub, Farnley Community centre and the White Rose Shopping Centre.
- Leeds Community Learning and Employer Provider Apprenticeships Celebration Awards 2023 took place on 18<sup>th</sup> July 2023 at Civic Hall to celebrate the accomplishments of all learners and tutors and embrace their future progression into further/higher education, volunteering and/or employment.
- **SEND Next Choices Event**, Getting Ready for Adult Life took place on 29<sup>th</sup> June 2023 at Leeds First Direct Arena. The event was aimed at supporting young people who have Special Educational Needs and Disabilities (SEND). A total of 67 exhibitors participated, offering jobs, Apprenticeships, volunteering, training opportunities, leisure activities and along with other specific support. 2,200 young people attended with very positive feedback.
- **Financial Wellbeing Events** delivered in partnership with Credit Union, Yorkshire Water and Leeds City Council, Housing, Jobshops for residents concerned with the rising cost of living. Support provided included debt advice and employment assistance
- Leeds Apprenticeship Recruitment Fair (LARF) took place on 6<sup>th</sup> February 2023 at Leeds First Direct Arena. A total of 106 organisations participated and 8,000 visitors attended.
  - 78% of visitors were either more likely to start an Apprenticeship or more interested in an Apprenticeship since attending the event.
  - 85% of visitors would recommend the event to a friend.
- **Family Learning Festival** was delivered on the 16<sup>th</sup> February 2023 at the Carriageworks Theatre, approx. 150 people participating along with 25 exhibitors from across the Community Learning sector. Local skills providers, colleges, universities, employment advisors attended to provide advice for anyone looking to develop their skills further or to plan their next steps.
- Reducing Re-Offending construction recruitment events took place on 24<sup>th</sup> January 2023 and 19<sup>th</sup> July 2023 at HMP Leeds, 5 construction companies attended offering employment opportunities. 77 serving prisoners engaged with the advisors who delivered employability support sessions.


