55 Inner West Community Committee Update Report

The report of the Head of Locality Partnerships presented an update of the work which the Communities Team was engaged in, based on the priorities identified by the Community Committee.

The Community Committee Champions provided updates by theme as follows:

Children and Families

 Cllr Bithell had already provided an update in relation to the members of the youth committee as part of Matters Arising. It had been noted that two members would be joining the Community Committee from September 2023.

Environment

- There was to be a city-wide meeting in relation to refuse and recycling with the Waste Strategy to be discussed. Members were informed that the Chief Officer for Environmental Services was due to attend the Environment Sub-Group.
- It was noted that within the next few weeks there was to be a campaign to Keep Leeds Tidy which is part of the nationwide campaign Keep Britain Tidy. Litter picks were to be arranged. Councillors thanked those who are already part of the litter pick teams within the three wards.

Employment

- It was noted that in previous years the Community Committee
 Champions had been invited to discuss issues in relation to
 employment at a city level meeting. However, this had not commenced
 after Covid. The Locality Officer offered to follow up on this with the
 Community Committee Team Manager.
- Within the Update Report, figures had been provided in relation to unemployment and the uptake of Universal Credit in the Inner West area.

 It was suggested that Employment and Skills be invited to attend a future meeting.

Community Safety

- It was noted that there was to be a briefing in relation to the removal of Alley Gates due to new legislation. The Alley Gates had been installed to address the issues of anti-social behaviour. Members were still awaiting the briefing.
- Police advice was to call 101 if members of the public see any suspicious activity. It was noted the Police do follow up on all calls, however, callers are not always informed of any actions taken or outcome.
- It was suggested that links included within the Update Report be added to the Community Committee social media pages.

Health Wellbeing and Adult Social Care

- Covid and Flu vaccinations are still available.
- Public Health are promoting projects for families and children in relation to overeating. Projects by BARCA delivered in Armley and the Wythers are to continue.

LEEDS 2023 Neighbourhood Hosts

The Neighbourhood Hosts for Armley and Bramley and Stanningley attended the meeting to introduce themselves and provide some information as to what would be happening within the Inner West area for LEEDS 2023.

The following points were noted:

- As part of Leeds 2023, events would be taking place in all 33 wards in the city as well as larger events in the city centre. LEEDS 2023 is due to go live on 31st March.
- The Armley Extravaganza would be taking place at the beginning of August. Once the date has been confirmed the event would be publicised. The community were encouraged to get involved in the event and publicising of Leeds 2023 had already been taking place on social media and with posters and stickers advertising the event in Armley.
- The Bramley event is due to take place on the August Bank holiday with Bramley Baths and BARCA already involved.
- It was noted that applications for grants for local organisations was due to open again and this would be publicised through Inner West Facebook page.

Members discussions included:

- Members suggested that the Neighbourhood Hosts should be invited to the July meeting for an update on events. The also suggested that the Neighbourhood Hosts could attend the local forums.
- In relation to publicity of LEEDS 2023 and the local events Members suggested the use of billboards.
- Members said that any organisation wishing to get involved but do not fit the criteria for grants should contact the Inner West Locality Officer to see if funding could be provided through the Councillors MICE money.

RESOLVED – To note the content of the report.

56 Highways - Leeds Safe Roads Vision Zero

The report of the Team Leader (Safe and Sustainable Travel) introduced an update on the recently adopted Vision Zero Strategy and its action plan.

The following attended this item:

- Rosie Revell, Team Leader, Road Safety
- Rebecca Murray- Transport Planner, Influencing Travel Behaviour

Members were provided with a PowerPoint presentation that touched on the following key points:

- Road accidents and safety statistics were compelling enough for a new approach and the need to bring in the Vision Zero Strategy. The Strategy and Action Plan was adopted in September 2022.
- There is an ambition that by 2040 no one will be killed or suffer serious injuries on roads in Leeds.
- The 4 guiding principles: road death and serious injury are not acceptable, humans make errors and are vulnerable to injury, safe system approach and everyone is responsible.
- The 5 safe system pillars of actions: safe speeds, safe roads, safe vehicles, safe behaviours and people and post-collision learning and care.
- The language used is to change to talking about victims and drivers (not vehicles).
- Date driven interventions in terms of police operations targeted the fatal 5 (speed, mobile phone usage, not wearing a seatbelt, distraction and careless driving). The approach to change these would be through behaviour change campaigns, education, infrastructure, targeted communications, funding bids and reporting.
- Highway Code updated 2022: hierarchy of road users those in charge of vehicles that can cause the greatest harm in the event of a collision bear the greatest responsibility to take care and reduce the danger they pose to others.
- Changes to speed camera criteria introduced in February 2023. There
 is additional flexibility in siting criteria and warning signage will not
 always be present.
- An overview of how Highways and Transportation aim to achieve Vision Zero: infrastructure changes, partnership with Leeds and West Yorkshire Safe Roads Partnership, awareness raising events and radio campaigning, Visual Messaging System (VMS) road safety messaging, school safety lessons, citywide targeted communications, Speed Indication Devices (SIDs), wheelie bin stickers, monitoring collision data and analysis and other data led interventions and trials.

 Promotion of 'Operation Snap' where photographic evidence showing driving offences that can be submitted to West Yorkshire Police (WYP) online.

In response to questions from Members of the Committee and members of public in attendance, the Community Committee were informed of the following:

- Information in relation to causation factors of accidents would be sent to Members with a breakdown by ward.
- The Action Plan would review speed limits and would also look to promoting 20mph restrictions in residential areas.
- It was noted that mobile phones were one of the major causes of distraction for drivers. However, the team acknowledge that there are other distractions such as children whilst they are passengers in a vehicle. The team would look at this as part of education to schools along with the use of E-Scooters. It was recognised that E-Scooters had become popular, and training was being included along with cycling for schools and the team were looking to build on this type of training at secondary schools.
- A member of the Peoples Forum was in attendance at the meeting and also raised the issue of causation factors and statistics. He wished to share ideas for safer roads. The officer offered to speak with him after the meeting.
- A member of the public attending the meeting wished to see the adoption of 20mph as a default on all residential roads. It was noted this issue was being looked at as part of the action plan.
- The 5 pillars of Safer Road System included Post Collision, Learning and Care. This was in response to those who were affected by road death as there were gaps in assistance and support after a fatality.
- It was noted that after a recent fatality on A647, Inner West Members had attended a meeting in relation to speed on a particular stretch of the A647 in Armley. As a result, a speed camera was to be added to this stretch of road. The Transport Officers were invited to attend a future Armley Forum.
- Members suggested using factual information about people's injuries and experiences of accidents rather than statistics to make a more powerful statement for road users.
- The Committee were advised that the new version of the Highway Code presented a new hierarchy of road users which had met with a hostile reception from some road users. The team hoped to open up dialogue with hard to reach groups. It was noted that more detailed analysis of accidents and statistical information could be accessed using Data Mill North.
- It was acknowledged that resources were not currently adequate in tackling road incidents such as speed, but the Police were on board with the Vision Zero Strategy and the action plan.
- In relation to speed check surveys the officers present were unable to provide information on chosen locations but offered to check this and report back.

 Members noted that on the Day of Remembrance as part of the Oak Leaf Service, names of those who had been in fatal accidents were read out at Leeds Minster.

The Chair thanked the officers for their attendance at the meeting.

RESOLVED – To note the content of the report and the presentation and Vision Zero Strategy and Action Plan.

57 Transport Strategy Investment Plans Local Update

The report of the Chief Officer (Highways and Transportation) introduced an update on a focused action plan that draws together funding proposals for new local area transport investment. The report also complements previous briefings on other aspects of the highways and transportation service by providing an update on funding and changes to the project pipeline for transport strategy focused schemes at a local level.

Appended to the submitted report included a briefing paper on Better Places: Leeds Healthier Streets, Spaces and Communities and prospective sites for "pilot" schemes, Healthier Streets, Spaces and Communities.

Attending for this item were:

- Andrew Hall (Project Consultant)
- Gwyn Owen Principal Transport Planner

The Community Committee were provided with a PowerPoint presentation that covered the following points:

- The main sources of funding for sustainable local area transport are received through the West Yorkshire Combined Authority (WYCA) through the government's City Regions Sustainable Transport Settlement (CRSTS) and Active Travel England.
- The proposed Local Area Transport Plans will be simple "informal" documents that set out key ambitions for mobility and transport investment for the wards in each community committee area.
- The early development and scoping of the project has commenced to identify potential sites and priorities using the settlements listed in the Local Development Framework, with an initial focus on the larger towns and centres, with Kirkstall, Armley and Bramley highlighted as potential areas for the pilot schemes.
- This is the initial stage of conversation, and it is intended that officers will attend additional Community Committee meetings to discuss in detail what will be incorporated into the Plan.
- The introduction to a new Leeds Healthier Streets, Spaces and Communities project for local sustainable mobility and the plans for a roll out to community committee areas. Seeking to identify best use of the 6.2 million capital fund.

In response to questions from Members and members of the public the following information was provided:

- Discussions will take place with Ward Members over the next few months to look at potential schemes for the area.
- The '20 minute neighbourhood' is a planning term used in relation to sustainable transport not requiring the use of a car, so looking at public transport, walking and cycling.
- 'Better Places' relates to funding from West Yorkshire Combined Authority (WYCA) who fund schemes in relation to mobility hubs and bike clubs.
- It was acknowledged that Armley Town Street already fits within the 20 minute neighbourhood thinking as it has access to shops, library, leisure facilities, and public transport links. However, some of the issues facing Armley are the type of shops on Town Street and Town street is not mobility aid friendly as there are no dropped kerbs. It was noted that all town centres and district centres would be considered to see which areas would benefit the most from the funding.
- It was acknowledged that Armley had missed out previously on funding
 to improve the shopping area. It was noted that the areas who would
 get funding need to show a good community support for the scheme
 and would look at how residents currently use the facilities on offer. It
 would consider effect on local journeys, local demographics,
 sustainable businesses, walking and cycling modes. The decision
 would be made by Executive Members after analysing all information
 presented to them.
- 'Common Place' is a communication product so communities can express views by letter, email and posts. More information can be accessed via Leeds City Council website and search Consultations.
- Cllr Illingworth suggested two possible sites for funding as St Ann's Mill and Red Cote Lane. These would provide better connectivity between the wards and provide opportunity for active travel and benefit for the local communities.

The Chair thanked the officers for their attendance and presentation.

Appointment of Co-optees to Community Committees

Purpose of report

1. This report invites Members to give consideration to appointing co-optees to the Community Committee for the duration of the 2023/24 municipal year.

Main issues

- 2. In considering this issue, the committee is invited to have regard to the following rules associated with Community Committee co-optees:
- 3. Article 10 of the Constitution states that by resolution Community Committees may appoint or remove non-voting Co-opted Members who may participate in the business of the Community Committee.
- 4. The relevant Community Committee Procedure Rules state that:

Co-opted representation on Community Committees, which enables representatives of the local community to engage in the decision making process is in line with the Council's Policies and City Priorities.

d. Legal implications, access to information and call in

In line with the Council's Executive and Decision Making Procedure Rules, the power to Call In a decision does not extend to those taken by Community Committees.

Conclusion

10. Given the provisions within the Constitution regarding the appointment of co-opted representatives to Community Committees, the Community Committee is invited to determine the appointment of non-voting co-optees for the duration of the 2023/24 municipal year.

Recommendations

11. The Community Committee is requested to approve the appointment of those proposed non-voting co-optees, as named within the report, for the duration of the 2023/24 municipal year, in order to support the work of the Committee.

Community Committee Appointments 2023/2024

Purpose of report

1 The purpose of this report is to note the appointment of Councillor Smart as Chair of the Community Committee for 2023/24 as agreed at the recent Annual Council Meeting, and also to invite the Committee to make appointments to those positions detailed in section 6 / the appendices.

Main issues

Noting Appointment of Community Committee Chair for 2023/24

1. Members are invited to note the appointment of Councillor Smart as Chair of the Community Committee for 2023/24, as agreed at the recent Annual Meeting of Council.

<u>Appointments to Outside Bodies including Cluster Partnerships, Housing Advisory</u> <u>Panels and Local Care Partnerships</u>

- 2. Attached at Appendix 1 is the current schedule of organisations as delegated to the Community Committee.
- 3. Most recently, Member Management Committee agreed in 2019 that appointments to Local Care Partnerships be delegated to Community Committees for determination.

Appointments to Community Committee 'Champions'

4. The Constitution requires that Community Committees appoint Member 'Champions' in several designated areas. Currently, these areas are: 'Environment & Community Safety'; 'Children's Services'; 'Employment, Skills & Welfare'; and 'Health, Wellbeing & Adult Social Care'.

Appointment to Corporate Parenting Board

5. In recent years Community Committees have been used as the appropriate body by which local Elected Member representatives are appointed to the Corporate Parenting Board.

Options

Outside Bodies

- 7. The Community Committee is invited to determine the appointments to those Outside Bodies as detailed within the table at section 6 / the appendices. The Council's Appointments to Outside Bodies Procedure Rules can be made available to Members upon request, however, a summary of the rules can be found at sections 8-13:
- 8. The Community Committee should first consider whether it is appropriate for an appointment to be of a specific office holder¹ either by reference to the constitution of the outside body concerned (if available), or in the light of any other circumstances as determined by the Community Committee. Such appointments would then be offered on this basis.
- 9. Nominations will then be sought for the remaining places, having regard to trying to secure an overall allocation of places which reflects the proportion of Members from each Political Group on the Community Committee as a whole.
- 10. All appointments are subject to annual change unless otherwise stated within the constitution of the external organisation, which will therefore be reflected on the table at Appendix 1. Each appointment (including in-year replacements) runs for the municipal year, ending at the next Annual Council Meeting.
- 11. A vacancy occurring during the municipal year will normally be referred to the Community Committee for an appointment to be made, having regard to the principles described above.
- 12. Community Committees may review the list of organisations to which they are asked to make appointments at any time and make recommendations, as the Committee feels appropriate.
- 13. Any appointments to those Outside Bodies detailed in the appendices / section 6 which are made by the Committee at today's meeting are subject to the authorised Committee approving at its first meeting of the municipal year that arrangements for such appointments remain unchanged and that they continue to be made by this Community Committee.

¹ For example it may be considered necessary or otherwise appropriate to appoint a specific Ward Member

Local Housing Advisory Panels

14. Ward Members play an important role in helping HAPs undertake their activity; sharing wider Community Committee priorities, giving updates about key pieces of work or projects, helping HAPs establish their priorities and by sharing local knowledge about community or environmental issues. Council nominations also help HAPs consider every opportunity to join HAP funding resources with local Community Committee or other funding sources for the benefit of communities.

The Inner West Community Committee in their 2023/24 round of nominations, is therefore requested to:

- a) Nominate up to 1 Ward Member per Ward within the x HAP area
- b) To undertake the above on the basis that all nominations are for full members, with HAP voting rights.
- c) Take into account the number of Council homes in each Ward. For Wards with relatively few Council homes, nominations are sought on an optional basis (see Appendix 2)

Local Care Partnerships

- 15. Local Care Partnerships (LCPs) bring health and care providers together with other partners and local communities to improve people's experience of care to be more personalised and joined up. The second purpose is to tackle the health inequalities that exist both within local communities and across Leeds. LCPs are aligned to Primary Care Network boundaries; NHS funded collaborations of GP practices working together locally to share resources and extend their offer. Further information on Local Care Partnerships and their current priorities can be found on their website: www.leedslcps.org.uk
- 16. From July 2019 forwards Community Committee meetings agreed individual arrangements for representation from Members at LCP meetings. Members raised that representation on LCPs could helpfully be aligned with the existing Community Committee Health Champion role for some committees, as well as consider how wider elected members were included. Community Committees recognised there were already good relationships in place between some Members and individual GPs but that the picture varied significantly from GP practice to GP practice.
- 18. In previous years, appointments to LCPs have been made using a 'best fit' approach to membership, mapping the geography of LCPs to Community Committee boundaries. Appendix 3 captures this best fit. Frequency of meetings varies from one LCP to another (current arrangements are captured in Appendix 3). Whilst some meet monthly, increasingly partners come together on a bimonthly or quarterly basis with working groups in between. All LCPs also have working groups or task and finish groups to take forward their key priority strands of work. During COVID, meetings were virtual which has resulted in a greater breadth of partners being able to attend and contribute regularly. This includes participation by Members. Moving forward, to strike a balance between attendance and ability to network and strengthen local relationships, the LCPs have moved to a model of a mix of in person meetings (at least three per year per LCP) and online meetings (mainly by Teams, some by Zoom).

19. Members are an integral part of LCPs and it is requested that the links between LCPs and Community Committees are retained and strengthened. Community Committees are therefore requested to nominate members to those LCPs aligned to their Committee.

Community Committee 'Champions'

- 20. The Community Committee Champions role aims to provide a local "lead" perspective and further facilitate local democratic accountability; particularly in conjunction with the relevant Executive Member. It is formally defined as covering the following areas:
- To provide local leadership and champion the agenda at the Community Committee;
- To represent the Community Committee at relevant meetings, forums and local partnerships;
- To build links with key services and partners;
- To provide a link between the Community Committee and the Executive Member to ensure local needs are represented, issues are highlighted, best practice is shared and to facilitate local solutions to any issues;
- To maintain an overview of local performance; and
- To consult with the Community Committee and represent local views as part of the development and review of policy.
- 21. As set out in the Constitution, the Community Committee is invited to appoint to the Community Lead Member roles detailed in section 6.
- 22. Given that these roles may need to be tailored to best reflect specific local needs and circumstances, Community Committees may wish to consider splitting 2 of the roles namely:
 - Environment & Community Safety with one Member focusing on the environment agenda and another on community safety.
 - Health, Wellbeing and Adult Social Care with one Member covering the public health and wellbeing agenda and another focusing upon adult social care.
- 23. Further to this, the Champions' Role Profile, as ratified at the Community Committee Chairs' Forum in 2022 and as presented to Community Committees last municipal year is detailed below for information:

- Lead on the oversight and delivery of a themed programme work across the Community Committee
 Area
- Work with elected colleagues, partners and local people to drive improvements across the committee area within the remit of the Champion theme
- To provide regular updates to the Community Committee and bring any emerging or priority issues relating to the theme to the attention of the committee
- To chair themed sub-groups, and where appropriate provide oversight on requests for grant funding relevant to the theme
- To lead on the dissemination of information and raise awareness of agreed issues relating to the theme
- Provide political influence in the delivery of the theme in the committee area
- To work with the relevant Executive Member and other themed champions across the city to address city wide priorities associated with the theme
- Support the development of local and cross committee themed projects where appropriate
- Attend and represent the Community Committee at themed events and other activities as appropriate

Corporate Parenting Board

- 24. Under the Children's Act 1989, all local Councillors are corporate parents, this means they have responsibilities relating to the quality of services for those children who have been taken into care by the local authority (children looked after).
- 25. Executive Board has previously agreed a clear framework for the corporate parenting role in Leeds which is set out in the Leeds Corporate Parenting Strategy 2021 2024. This includes ensuring a core group of councillors with a special interest in leading the work on Corporate Parenting who are nominated to the 'Corporate Parenting Board'. This Corporate Parenting Board includes representation from each of the 10 Community Committees alongside partners from relevant statutory and third sector organisation, and takes particular responsibilities relating to influencing, performance monitoring, and governance of those issues and outcomes that affect looked after children.
- 26. In 2021 Leeds published the City's Corporate Parenting strategy which sets out the priorities for ensuing that our children in care and care leavers receive the highest quality services and support. This strategy is overseen by our Corporate Parenting Board, which also ensures that our 'Promises' to children in care and care leavers are delivered. The Board considers information including fostering services, residential care, looked after children's educational attainment and their voice and influence across the city. Representatives on the board are expected to link back to their Community Committee and champion the importance of effectively supporting the work of the board. The Corporate Parenting Board is an important partnership within the overall framework of support and accountability for looked after children's services and is chaired by the executive member for children's and adult services.
- 27. The Community Committee is asked to appoint one representative to the Corporate Parenting Board for the duration of the forthcoming municipal year and to promote attendance and engagement with the Corporate Parenting Board. The Committee may consider it appropriate to combine the role with that of the Committee's Children's Services 'Champion'.
- 28. It should be noted that membership of the Corporate Parenting Board is encouraged for any Elected Members with a particular interest in the outcomes of looked after children, therefore whilst each Community Committee is asked to appoint one

Member (to ensure an even geographic spread), it is possible for additional Members to participate. Therefore, additional Members with a particular interest are advised to make the relevant officers aware.

Children's Services Cluster Partnerships

29. Clusters are local partnerships that include, amongst others: the Children's Social Work Service, schools, governors, Police, Leeds City Council youth service, Youth Offending Service, Children's Centres, Housing services, third sector, health, local elected members and a senior representative from children's services. Local clusters are key to the Leeds Children and Young People's Partnership arrangements.

30. They aim to:

- enable local settings and services to work together effectively to improve outcomes for children, young people and their families;
- build capacity to improve the delivery of preventative and targeted services to meet local needs:
- create the conditions for integrated partnership working at locality level;
- promote the Children & Young People's Plan and the ambition of a child friendly city across the locality.
- 31. A "well-coordinated locality and cluster approach results in early identification and extensive work with families according to need." (Ofsted report, March 2015).
- 32. Clusters began life as extended services for schools and have grown to engage a wide range of partners who provide early help and early intervention and prevention. In April 2011, the Children & Families Trust Board and Schools Forum agreed the adoption of a minimum standard for the terms of reference across the cluster partnerships, which included elected members as standing members of the governance group for each partnership.
- 33. Elected Members also sit alongside a senior leader (Local Authority Partner) from the Children's Services directorate to be part of the Council's representation on each cluster partnership.
- 34. In June 2013 Member Management Committee delegated the nomination of Elected Member representatives to local Children's Services Cluster partnerships to Community Committees. This was with the aim of establishing a clear formal link between those Committees and Clusters. It was also with the intention of building closer working arrangements to better support the needs children and families across the city.

Corporate considerations

a. Consultation and engagement

This report facilitates the necessary consultation and engagement with Community Committee Members in respect of appointments to the designated positions and Outside Bodies. Given that the Community Committee is the relevant appointing body, there is no requirement to undertake a public consultation exercise on such matters.

b. Equality and diversity / cohesion and integration

Both the Community Committee Champion roles and the Corporate Parenting role aim to champion, address and monitor issues arising in their respective fields, whilst also providing clear links with the relevant Executive Member, Council officers and partner agencies. As such, these roles would also look to address any equality, diversity, cohesion or integration issues arising in their specific areas.

Also, Council representation on Outside Bodies and Children's Services Cluster Partnerships will enable those appointed Members to act as a conduit in terms of promoting the Council's policies and priorities.

c. Council policies and city priorities

Council representation on, and engagement with those Outside Bodies, partnerships and organisations to which the Community Committee has authority to appoint, is in line with the Council's policies and priorities.

d. Legal implications, access to information and call in

In line with the Council's Executive and Decision Making Procedure Rules, the power to Call In decisions does not extend to those decisions taken by Community Committees.

If a Councillor is nominated to an Outside Body by the Council then that Councillor receives full indemnity from the Council. For example should someone attempt to take civil action against a Councillor personally in their role as a Council appointed trustee/director of an Outside Body; then the Council would cover the cost of defending the action against that Councillor, and if the action were successful the Council would cover any compensation which the Councillor had to pay. The only exceptions to this are for "fraud, or other deliberate wrongdoing or recklessness", or for a criminal offence (although the indemnity would cover defending criminal proceedings, if no conviction resulted). The indemnity applies to a company, trust, or charity and whether a Councillor is nominated as a director or trustee. If a Member becomes a trustee or director but has not been nominated by the Council, then the indemnity will not apply, and the Member should check that the trust, company etc. has got appropriate insurance cover for its trustees/directors.

e. Risk management

In not appointing to those Outside Bodies listed within the report, there is a risk that the Council's designated representation on such organisations would not be fulfilled.

Conclusion

35. The Community Committee is asked to consider and determine the appointments to those designated Outside Bodies, partnerships and organisations as detailed within the report and appendix.

Recommendations

- 36. The Community Committee is asked to consider and confirm appointments to those positions detailed in section 6 / the appendices, having regard to the Appointments to Outside Bodies Procedure Rules, as summarised in this report;
- 37. The Committee is also invited to note the appointment of Councillor Smart as Chair of the Community Committee for the duration of 2023/24, as agreed at the recent Annual Meeting of Council.

Inner West Community Committee - Finance Report

Purpose of report

1. This report provides the Community Committee with an update on the budget position for the Wellbeing Fund, Youth Activity Fund, Capital Budget, as well as the Community Infrastructure Levy Budget for 2023/24.

Main issues

- 2. Each Community Committee has been allocated a wellbeing budget (revenue and capital) and Youth Activities Fund which it is responsible for administering. The aim of these budgets is to support the social, economic and environmental wellbeing of the area and provide a range of activities for children and young people, by using the funding to support projects that contribute towards the delivery of local priorities.
- 3. A group applying to the Wellbeing Fund must fulfil various eligibility criteria, including evidencing appropriate management arrangements and financial controls are in place; have relevant policies to comply with legislation and best practice e.g. safeguarding and equal opportunities and be unable to cover the costs of the project from other funds.
- 4. Wellbeing funding cannot be paid retrospectively. An application form must be submitted and approved by the Community Committee before activities or items being purchased through wellbeing funding are completed or purchased.
- 5. The amount of wellbeing funding provided to each committee is calculated using a formula agreed by Council, taking into consideration both population and deprivation of an area.
- 6. Capital (CRIS) injections are provided as a result of council assets being sold. 5% of the sale price (up to a maximum of £100k) of a council asset is pooled city-wide and redistributed to

- the Community Committee areas on the basis of deprivation. The Community Committee will receive a new capital injection every 6 months.
- 7. Each Community Committee has also been allocated a Community Infrastructure Levy budget. For each CIL contribution, Leeds City Council retains up to 70-80% centrally, 5% is needed for administration and 15-25% goes to be spent locally. The money will be vested with the local Town or Parish Council if applicable, or with the local Community Committee and spend decided upon by that body. This local money is known as the 'Neighbourhood Fund' and should be spent on similar projects to the Wellbeing Fund (capital).
- 8. In the Inner West Community Committee this means that the money for the Armley, Bramley & Stanningley, Kirkstall wards will be administered by the Inner West Community Committee.
- 9. It was agreed at Inner West Community Committee on the 20th June 2018 that CIL monies for Armley, Bramley & Stanningley, Kirkstall would go where it is needed across the Inner West Community Committee area, to be decided by the elected members of the Inner West. Members will have mindfulness of the area where development is and local sensitivity around this.
- 10. Projects eligible for funding by the Community Committee could be community events; environmental improvements; crime prevention initiatives, or opportunities for sport and healthy activities for all ages. In line with the Equality Act 2010, projects funded at public expense should provide services to citizens irrespective of their religion, gender, marital status, race, ethnic origin, age, sexual orientation or disability; the fund cannot be used to support an organisation's regular business running costs; it cannot fund projects promoting political or religious viewpoints to the exclusion of others; projects must represent good value for money and follow Leeds City Council Financial Regulations and the Council's Spending Money Wisely policy; applications should provide, where possible, three quotes for any works planned and demonstrate how the cost of the project is relative to the scale of beneficiaries; the fund cannot support projects which directly result in the business interests of any members of the organisation making a profit.
- 11. Any request for funding would involve discussions with appropriate ward members. Where projects do not have support from the Community Committee and are not approved, applicants are offered further discussions and feedback if this is requested.
- 12. In order to provide further assurance and transparency of all decisions made by the Community Committee, any projects that are not approved will be reported to a subsequent Community Committee meeting.
- 13. Sometimes urgent decisions may need to be made in between formal Community Committee meetings regarding the administration of wellbeing and youth activity budgets and also regarding the use of the Community Infrastructure Levy (CIL) Neighbourhood Fund which has been allocated to the Community Committee. Concurrently with the Committee, designated officers have delegated authority from the Director of Communities, Housing and Environment to take such decisions.
- 14. The Community Committee has previously approved the following 'minimum conditions' in order to reassure Members that all delegated decisions would be taken within an appropriate governance framework, with appropriate Member consultation and only when such conditions have been satisfied:
 - a. consultation must be undertaken with all committee/relevant ward members prior to a delegated decision being taken;

- b. a delegated decision must have support from a majority of the Community Committee elected members represented on the committee (or in the case of funds delegated by a Community Committee to individual wards, a majority of the ward councillors), and;
- c. details of any decisions taken under such delegated authority will be reported to the next available Community Committee meeting for members' information.
- 15. Sometimes urgent decisions may need to be made in between formal Community Committee meetings regarding the administration of Wellbeing and Youth Activity budgets, and also regarding the use of the Community Infrastructure Levy (CIL) Neighbourhood Fund which has been allocated to the Committee. Concurrently with the Committee, designated officers have delegated authority from the Director of Communities, Housing and Environment to take such decisions.

The Community Committee has previously approved the following 'minimum conditions' in order to reassure Members that all delegated decisions would be taken within an appropriate governance framework, with appropriate Member consultation and only when such conditions have been satisfied:

- a) consultation must be undertaken with all committee/relevant ward members prior to a delegated decision being taken.
- b) a delegated decision must have support from a majority of the community committee elected members represented on the committee (or in the case of funds delegated by a community committee to individual wards, a majority of the ward councillors); and
- c) details of any decisions taken under such delegated authority will be reported to the next available community committee meeting for members' information.

For the committee's awareness, urgent delegated decisions on wellbeing funding also covers small grant decisions. In agreement with the Executive Board Member for Communities, Community Committee Chairs & also in accordance with the communication that was sent out to all committees/Elected Members in March 2023, the approval threshold for small grants has now increased from the 1st April 2023; up to £1,000.00 per ward. This approach will ensure consistency in terms of administering small grants, in accordance with the committees' minimum conditions.

- 16. As has been the case at the beginning of previous municipal years, the Committee is invited to review the conditions previously agreed and consider whether any amendments are required, prior to agreeing such conditions for operation in the forthcoming municipal year.
- 17. Members are reminded that the necessary scrutiny of applications to satisfy our own processes, financial regulations and audit requires the deadline for receipt of completed applications to be at least five weeks prior to any Community Committee. Some applications will be approved via Delegated Decision Notice (DDN) following consultation with Members outside of the Community Committee meeting cycle.

Wellbeing Budget Position 2023/24

18. The total revenue budget approved by Executive Board for 2023/24 was £129,546.00.

Table 1 shows a carry forward figure of £187,064.46 which includes underspends from projects completed in 2022/23. £158,650.92 represents wellbeing allocated to projects in

2022/23 and not yet completed. The total revenue funding available to the Community Committee for 2023/24 is therefore £316,610.46. A full breakdown of the projects approved or ring-fenced is available on request.

- 19. It is possible that some of the projects may not use their allocated spend. This could be for several reasons, including the project no longer going ahead, the project not taking place within the dates specified in the funding agreement, or failure to submit monitoring reports. Due to this the final revenue balance may be greater than the amount specified in Table 1.
- 20. The Community Committee is asked to note that there is currently a remaining balance of £55,641.26. A full breakdown of the projects is listed in Table 1 and is available on request.

20. CCTV also contributes towards Police enquiries as requests are made for footage which may not have been observed "real time". These incidents are not included in this report but can contribute towards arrests being made in the area.

Requests for new Cameras

- 21. The Surveillance Camera Commissioner is appointed by the Home Secretary to ensure that surveillance camera systems in public places keep people safe and protect and support them.
- 22. Following changes to Data Protection legislation the council needs to ensure that all its CCTV systems are managed in line with the Commissioner's recommendations to ensure there are no data breaches (this includes CCTV systems in all Leeds City Council assets including libraries, sports centres, council vehicles fitted with CCTV, etc.).
- 23. A dedicated CCTV compliance team has been established within Leeds City Council.
- 24. The compliance team also work closely with Information Governance to assist in ensuring all system owners are compliant with their codes of practice, policies, and procedures.

Anti-Social Behaviour

Armley

- 25. ASB Stats for Armley are below.
 - 12 Active cases
 - 4 are related to Threats/Actual Violence
 - There are 2 hate crime cases, one relating to Race and another relating to Disability
 - · Low case levels compared to other areas in West at this time
 - No significant issues for LASBT in Armley currently

Bramley and Stanningley

- 26. ASB Stats for Bramley and Stanningley are below
 - 30 Active cases
 - 11 are related to Threats/Actual Violence
 - 5 are related to Rowdy Behaviour
 - Issues remain regarding youth related ASB & Crime with a number of injunction orders in place
 - Despite above, issues have seemingly improved compared to previous months

Kirkstall

- 27. ASB stats for Kirkstall are below.
- 26 Active cases
- 7 of the cases are in relation to noise complaints.

- 3 of the cases are in relation to verbal abuse.
- For 5 of the cases (all unrelated to one another) we are awaiting the outcome of criminal
 investigations before we can decide whether we can or cannot act of our own in relation to the
 allegations we have received. These cases are either drug related, or violence related.
- 2 cases in relation to hate related complaints. 1 of these cases has led to a counter allegation being opened against the original complainant.
- 4 cases are for a group of youths who are causing a nuisance by throwing &/or kicking things (footballs, stones) at houses & cars so we'll be looking at putting some ABCs in place at this stage to try & nip things in the bud.
- 4 cases are in relation to cuckooing concerns. We already have a closure order in place for
 one case & we've applied to extend this. We have a closure application submitted to Court &
 are awaiting a hearing date, for a second case where we believe the property has possibly
 been cuckooed although the tenant denies this. We have two other cases which have come to
 us recently with ASB & cuckooing concerns so we're in the early stages of investigating

West Yorkshire Police

Armley

- 28. Partnership working in New Wortley due to increases in youth disorder, drug dealing and damage. We continue to work with partner agencies and are formulating an action plan to tackle the issue. The police have carried out several drug warrants over the last few weeks and increased visibility in the area.
- 29. Town Street has remained a focus and tackling street level drug dealing and criminality. Several proactive operations have taken place resulting in arrests for a wide range of offences. We are working with the Leeds Anti-Social Behaviour Team for exclusion orders against the key offenders. Team Leodis is seeking to obtain Criminal Behaviour Orders and Injunctions against key offenders.
- 30. In conjunction with Leeds City Council and the Canal and River Trust, Ward Officers are looking to tackle ASB along the canal tow path and surrounding area.

Bramley and Stanningley

- 31. Officers have focused on targeting Anti-Social vehicle use and off-road bike/quad use, speeding and inconsiderate parking in and around identified hot spot areas within the Bramley area. Partner agency work is ongoing with tenancy action being taken on addresses where off-road bikes are being stored. Numerous operations with traffic officers and the Off-Road Bike Team have taken place, with several stolen bikes having been recovered. More such operations are planned.
- 32. Officers continue to work to disrupt and engage with nuisance youths at the Bramley shopping centre, particularly utilising Misuse of Drugs and Anti-Social Behaviour legislation. Several individuals have been issued with Anti-Social Behaviour Injunctions with conditions to not attend the Shopping Centre, plus non-associations attached to the Injunction. Two individuals are now subject to Criminal Behaviour Orders and any breaches are proactively and swiftly pursued.

33. Partner agency work is ongoing to protect vulnerable victims of cuckooing. Several addresses now subject to Partial Closure Orders with compliance checks conducted on a regular basis. Several days of action around tackling ASB in the Bramley area have been organised with partner agencies.

Kirkstall

- 34. Over the coming months, Kirkstall ward councillors, members from Leeds City Council Anti-social behaviour team, Housing services and the police will be running some 'days of action' These days will involve partners visiting the local community and discussing any issues or concerns they may have. This is vital work as not everyone is able to come to community meetings.
- 35. ASB involving off road motorbikes and quad bikes is still a concern for residents in the local area, there are several operations planned with the Leeds Off Road motorbike team to target those committing a nuisance and offending on motorbikes.
- 36. There has been an increase in Arson offences in the ward whereby offenders have been setting fire to bins. The local NPT team are increasing patrols of the area and working with Fire to look at apprehending those responsible and ways to prevent the reoccurrence.

Health and Wellbeing & Adult Social Care: Champion formerly Cllr L Cunningham Food and Cost of Living Work

- 37. The Trinity Healthy Cooking project is continuing succesfully. This was described in detail in the last update. The project has three elements to it, in which it helps local people and families to learn about healthy cooking, nutrtion and accessible physical activity. We are still seeking some additional funding for the Cook-Grow-Move Project. The Recipe Station project which provides a free bag on ingredeints, recipe cards and access to services around household budget management and assistance has increased it's scope and details can be found here: West Leeds Recipe Station Aug 10 flyer (barca-leeds.org) and helpful video 'shorts' and recipe booklet for simple easy to understand can be found here West Leeds Recipe Station | Facebook and for more information on locations please contact: Rachel.Shaw@barca-leeds.org
- 38. For more information on the Trinity Weight Management projects contact: Jonathan.Hindley@leeds.gov.uk

New Leeds Stop Smoking Service

39. The new Leeds Stop Smoking Service will be supporting smokers to reduce their nicotine dependency and quit for good. With around 122,000 adult smokers in Leeds, this service aims to help reduce this number.

- 40. Smokers wishing to access the service will be given a choice of treatment based on need and preference, including nicotine replacement therapy and e-cigarettes. They will work with a trained smoking cessation coach to develop a personalised plan. Support extends to a year after each person's quit date to make sure people are given the best possible chance to stop smoking permanently. The Leeds Stop Smoking Service will be replacing the previous One You Leeds service which ended on 31 March 2023.
- 41. To register for the service, visit Leeds Stop Smoking Services.
- 42. We also have a range of leaflets and posters about smoking and vaping that are available to order and keep for free:
- 43. Vaping and e-cigarettes: the facts (order code P733)
- 44. Vaping and e-cigarettes: the facts for parents and carers (order code L318)
- 45. Quit smoking (order code L305)
- 46. Vaping is at least 95% less harmful than smoking (order code L319)
- 47. The service is holding several appointment venues in local wards, so residents do not have to travel. These can be accessed by registering with the service. For more details about venues contact: charlotte.orton@nhs.net
- 48. LEAP PROJECT- Leeds Encouraging Activity in People
- 49. The LEAP project is now live, and details can be found on **appendix 2**. This project is currently operating in Armley and Bramley and Stanningley wards and can be accessed through your local GP. If you live in a different ward, you can self-refer.

Priority Neighbourhoods

Armley Priority Ward Partnership Plan Workshop

- 50. Communities Team officers are leading work to develop a Partnership Plan for each of the six target wards in Leeds that contain the 12 Priority Neighbourhoods. In Armley, a workshop was held at New Wortley Community Centre on 7th March 2023 to bring key services, organisations, and stakeholders together to discuss the data, challenges, and opportunities, to enable priorities to be agreed and a Armley Ward Partnership Plan developed that will underpin locality and partnership working in the area.
- 51. The workshop was a positive event and well attended by a wide range of relevant partners and stakeholders including New Wortley Community Association, Armley Helping Hands, Barca, Armley Action Team, New Wortley Residents Association, Interplay, Active Leeds, Housing Leeds, Cleaner Neighbourhoods, LASBT, Police,

Elected Members, Parks & Countryside, Armley Community Hub, LCC Regeneration, Local Care Partnerships, Youth Services, Employment & Skills, Adults & Health, and more. Attendees commented on how discussions weren't overly focussed on the negatives and challenges, instead generating a lot of positive outcomes identifying local strengths, assets, and opportunities.

- 52. Communities Team officers have since collated all the information that came out of the table discussions and identified four key themes/priorities:
 - Safer, Cleaner, Greener Focussing on partnerships and initiatives that address community safety, crime, antisocial behaviour, and environmental issues.
 - Children & Families Focussing on partnerships and initiatives that support children, young people and families through play provision/facilities, and access to support services.
 - Armley Town Street Focussing on partnerships and initiatives that improve and contribute to a thriving commercial town centre that is safe, clean, and meets the needs of local people and businesses.
 - Health, Wellbeing and Welfare Focussing on partnerships and initiatives that support communities with cost-of-living pressures, reduce health inequalities, improve wellbeing and provide adequate access to support services.
- 53. A draft 'Armley Priority Ward Partnership Plan' document has been pulled together outlining the four themes/priorities, and the relevant challenges/opportunities for each. The draft plan will be shared with all stakeholders to get final feedback.
- 54. The Communities Team would like to thank all the partners and stakeholders for their valuable contributions to this important piece of work and in particular New Wortley Community Centre for being such great hosts for the day.

Armley Forum

- 55. Armley Forum took place on Tuesday 16th May 2023 at Armley Community Hub. The meeting was chaired by Cllr Jim McKenna who was joined by approximately 20 residents as well as Cllr Alice Smart and newly elected Cllr Andy Parnham.
- 56. Officers from the Neighbourhood Police Team provided the forum with recent statistics on crime and antisocial behaviour in the area. Questions were also fielded on a range of local concerns.
- 57. Paul Hodges, Local Housing Manager, gave the forum an update from Housing Leeds. Information was provided on recent work to install water heaters to high rise blocks for cleaners' use; conclusion of the EDRF funded external wall insulation scheme on local back-to-back properties; planned communications to high rise

residents regarding waste management and recycling; progress on annual tenancy visits (ATCs); estate walkabouts; and plans to install thermoplastic play markings to external communal areas of high-rise blocks to encourage informal play for children.

- 58. Paul also provided an update on the District Heating/Ground Source Heat Pump scheme. Work is ongoing to the Wortley blocks but should be concluded by the end of June, including all making good. The remaining two Burnsall blocks in Croft and Grange will now be on GSHP Phase 5, which will be delivered at the earliest in the next financial year 2024/25 due to budget constraints.
- 59. Cost of Living events led by Housing Leeds continue to be supported by a wide range of partner services and organisations with the aim of supporting communities with everything from financial pressures, food, benefits advice, housing and tenancy issues, employment, social isolation and much more. Details were given of the next event which was due to take place on Wednesday 31st May (separate update to follow).
- 60. Rosie Revell from LCC's Safe and Sustainable Travel Team provided the forum with a briefing on the Vision Zero 2040 strategy which was previously presented to the Inner West Community Committee at the March meeting. The strategy sets out a bold ambition that by 2040 nobody will be killed or suffer serious injury on roads in Leeds. The strategy has five pillars Safe Behaviours and People; Safe Speeds; Safe Roads; Safe Vehicles; Post-collision Learning and Care. Rosie explained how the council and partners will work towards the Vision Zero ambition and the role that citizens can play.
- 61. For the final agenda item, Victoria Kortekaas from New Wortley Community Centre spoke to the forum regarding Asset Based Community Development (ABCD). ABCD work is based on the principle that communities know what works best for them. As the ABCD Coordinator for Armley, Victoria identifies and works with local people to start projects that will support local people or meet an identified need. ABCD work encourages community involvement and volunteering, builds capacity and is truly community led. Small amounts of funding (called Small Sparks) can be provided to support any set-up costs for projects and Victoria provided the forum with details of how she can be contacted if anyone has any project ideas.
- 62. The next Armley Forum date is 11st July 2023 with the full agenda yet to be decided.

Leeds City Council Youth Service

NYA Ministerial Meeting – Youth Consultation

63. Young people from Pudsey and Calverley represented Leeds Youth Service and met The Minister for the Department for Digital, Culture, Media & Sport. The roundtable event gave young people the chance to express their views and make

recommendations to leaders within the youth sector. They also got chance to meet representatives from members of the Back Youth Alliance (British Youth Council, Centre for Youth Impact, Duke of Edinburgh's Award, Girlguiding, National Citizen Service Trust, National Youth Agency, OnSide, The Prince's 1 Trust, The Scouts, UK Youth, YMCA, Youth United Foundation). Their views will now be considered when making decisions on Youth Services at Government level.

Violence Against Women and Girls Week

64. In March Officers attended Horsforth Youth Group and held a Quiz for the young people attending. The quiz was based on statistics on: Harassment, grooming, stalking & all offences relating to Violence Against Women and Children. This was a very educational session for the young people, in a safe environment to discuss sensitive issues. The young people really engaged and enjoyed the session. The week saw a continued focus on tackling some of the main contributing factors to VAWG offences, as well as raising public awareness and providing personal safety education

February Half Term Holiday Fun

65. A great half-term holiday with young people from across WNW Leeds enjoying the challenges at Herd Farm, gaming, bowling, climbing and other outdoor fun activities.

International Women's Day

66. On March 8th Youth Workers incorporated International Women's Day in their youth work sessions highlighting issues such as equality, reproductive rights, and violence and abuse against women.

Supporting Schools

- 67. The WNW Team continues to support schools and settings to improve attendance and positive behaviour by working in partnership with local schools delivering a variety of issue-based sessions.
- 68. The Saturday Motorbike Project delivered in partnership with the Localities Team and West Leeds Activity Centre has seen several groups achieve their level 1 and level 2 motorbike certificates.

Community Cohesion

69. The Youth Service continues to run centre-based provision supporting young people with additional needs. We continue to run provision in Armley specifically targeting young people from the Eastern European Community.

ITV Emmerdale workshop

70. In March young people took part in an ITV Emmerdale Workshop. Young budding actors brushed up on their acting and performing skills by taking part in workshop organised by Emmerdale and The Youth Service. The Emmerdale Team comprised

of Jane Hudson (Exec Producer), Ezra Tren-Humphries (Senior Casting Assistant) Roxy Shahidi and Martelle Edingborough (cast members).

71. There was a real connection with the audience and the Q & A session is sure to have inspired the young people to believe in themselves, build resilience and to keep pursuing their dreams despite what obstacles may be in their path. The aim of the project was to reach out to young people from backgrounds that are underrepresented in the tv and film industry.

Town Centres Update

- 72. The April Street market arranged by Armley Action Team attracted large numbers of shoppers and socialites to Town Street to see the activities including street entertainers and nearly 30 stalls. It was a well-attended, positive day for Armley which was especially welcome following the taxi murder two days previous.
- 73. A similar response was forthcoming when a Leeds Live article at the end of May branded Armley Town Street the scariest area of Leeds. Immediately the Action Team invited Leeds Live to come and meet some of the people living and working in the area to get their views.
- 74. The responses were very positive including a shopkeeper saying Armley is full of "beautiful" people and the chair of Armley Common Rights Trust noting: "You get crime everywhere and if you choose to concentrate on problems, then you're going to see problems. But if you choose to concentrate on all the good stuff that's happening then that's Armley." The quick response from the Action Team managed to paint a far more positive picture for the street and this publicity is ongoing with the action team doing weekly press releases on good things happening around Armley.
- 75. Businesses in Bramley, Kirkstall and Armley, along with the other 30 wards around the city, receive the weekly update of news to help local businesses and develop local neighbourhood centres.

Updates from Key Services

Community Hubs

76. An update will be provided for the next meeting.

Housing Leeds

Annual Tenancy Contact Update

77. The new Annual Tenancy Contact process continues to go well within Inner West. We are now in year two of our three-year program to visit all residents in their home. We continue to pick up support and safeguarding issues highlighted from these visits and have put some important intervention in place for these residents. We have a two-pronged approach to visits, we will visit 33% of our tenants this year as well as all those believed to require additional support, this roughly equates to a further 11%. Plans are in place with local housing teams to ensure we meet these targets.

Tenancy Support

78. Our Housing Officer Support team are actively monitoring the cases and are working with partners in assisting residents to live independently and ensuring that they have the adequate support required for them to maintain their tenancy.

Walkabouts

- 79. Walkabouts booked in for next two quarters across Inner West.
- 80. Local Team have invited Local Ward members and residents who wish to attend.
- 81. Common theme highlighted is the delay in grass cutting this season which has been fed back to Parks who administer the grounds maintenance contract.
- 82. The purpose of an estate walkabout is to ensure Housing Leeds provide an excellent and consistent estate management service to all our tenants and communities. The walkabout provides opportunity for all customers and interested parties to walk around their estate with members of staff from Housing Leeds, and other Leeds City Council departments to monitor our performance and recommend improvements to the environment of our estates.
- 83. Should you wish to get involved or are interested in becoming a 'block champion' for your High-Rise block/ walkabouts, you can help in coming along and pointing out areas of concern or sharing your ideas on how to improve your estate/Block. If you are interested, please contact Housing Leeds on 0113 378330, or via email on housinginvolvement@leeds.gov.uk . Alternatively, you can talk to your local Housing Officer.

Block Sweeps/Inspections and Fire Safety

- 84. Weekly block sweeps continue to be carried out on all high-rise blocks. These inspections help look for things that will improve the block such as ordering repairs, removing items that have been left in communal areas, or identifying improvements that could be made.
- 85. Low rise blocks inspections are also being carried out now on a quarterly basis in line with the fire safety checks.
- 86. We continue to receive daily stage 1 fires safety reports from our cleaning contractors. The recommendations are action and log on our computer system in line with our Fire Safety procedure. Local Teams also carry out regular stage 2 fire safety checks and report all the findings and raise the necessary repairs required.

Anti-Social Behaviour

- 87. All teams within Inner West continue to work together with LASBT and West Yorkshire Police to help tackle and reduce crime related activity and Anti-social behaviour within our areas.
- 88. Team Leodis was recently deployed to deal with an increase in ASB in the New Wortley area of Armley. This has had the desired effect of reducing the issues and level of criminality that arose in this area.
- 89. We still encourage all residents to report all Anti-Social Behavior breaches by calling 0113 222 4402 (Weekdays, 9am to 5pm, except Wednesdays when we're open from 10am), Outside of office hours (6pm 3:30am and weekends) call 0113 376 0337 or reporting this online via Report antisocial behaviour or hate crime leeds.gov.uk If you've been a victim of crime you should report this to the police on 101, or 999 if it's an emergency.

Area updates/Good news stories

Armley

- 90. Work still ongoing to the Wortley blocks. It's hoped works should be concluded there by the end of June 2023 (should have been April) including all making good. The remaining two Burnsall blocks in Croft and Grange will now be on GSHP Phase 5. Which will be delivered at the earliest in the next financial year 24/25 due to budget constraints.
- 91. COL events Our Cost of Living (COL) events continue to grow from strength to strength! Since our last communities committee update, we have had two success COL events one at Armley helping and one undertaken on 31st May outside Burnsall Gardens. The event held at Armley Helping Hands/Strawberry Lane CC along with Partners was very successful and well received. It was an excellent day and very well attended by the residents of Armley. The community centre arranged some activities for the young, families and elderly residents of Armley, we had an entertainer and a band, the music was loved by all and even some residents got up and had a dance. Kids face painting this was free for the children funded by the community centre all the kids looked fantastic and really enjoyed themselves, Retirement life residents attended and came for their fish and chips and joined in on the event dancing, laughing, and meeting new people. It was such a fantastic day.
- 92. Housing officers have been submitting referrals to community payback and cleaner neighbourhood teams to help improve our estates visually. One area which had a lot of investment recently which has seen some positive improvements is the Wythers Estate which has received some good feedback.
- 93. Action Days it was agreed at the Armley Forum that locals partners and stakeholders will work with Housing to deliver a more actions days this year.
- 94. Local officers have been looking at ways to improve their estates and have started to complete the capital justification forms for our low-rise buildings to see what works are

- possible and how much this will cost. We are currently looking at windows and doors and for the A1f type flats to improve the communal stairwells.
- 95. External Wall Insulation on the back-to-back properties in Armley. This project has now come to an end as funding from the European Regional Development Fund (ERDF) was stopped in March this year. In total the scheme should have delivered 246 homes with EWI but only managed to complete 56 in total with a further 12 refusals.

Bramley

- 96. Bramley have welcomed a new Housing Officer to the team.
- 97. Multi agency approach and partnership working with, Police, Adult Social Care, LASBT, Housing and Youth services to help maximise resources into reducing ASB on the Snowden's following reports from residents. Action morning set up for the 8thJune to help increase calls to service and for all partners to show presence on the estate to help reduce ASB.
- 98. Planned works roofing scheme continues to various properties across Bramley.
- 99. Bramley continue to support residents with the cost-of-living crisis, including supporting via assistance with food banks, fuel vouchers, support referrals and working closely with the HOI for income checks.
- 100. Ongoing training is being provided to new starters including, ASB, Arrears, Environmental to help improve the level of service provided to customers
- 101. Cost of living/Action Day to be organised on the Ganners estate to help residents manage with the cost-of-living crises and access support available.

Kirkstall

- 102. Works ongoing at Queenswood Heights and Court are almost complete should be finished by the end of W/C 5th June, including intercoms and boxing in of pipework from sprinkler systems.
- 103. Action day arranged on St. Matthias in June with Cllrs. 2 furthers action days also to be held on Lea Farms and Hawkswood estate in July.
- 104. Walkabouts in full swing and many issues that were not picked up due to vacant patches have now been dealt with.
- 105. Kirkstall/Weetwood had a flying start on ATCI's, with Kirkstall being highest in the city this year so far, which is promising for us to hitting ATCI targets this year.
- 106. Jack is our next new starter who we are expecting W/C 5th June. Hearing good things about him so looking forward to welcoming him to the team.
- 107. Housing Officer Income working hard to support tenants in financial hardship to maximise their income, tapping into food parcels and fuel vouchers.

108. Housing attended QTARA meeting and will continue to do so every few months now we have more staff in place on those patches.

Smokers wishing to access the service will be given a choice of treatment based on need and preference, including nicotine replacement therapy and e-cigarettes. They will work with a trained smoking cessation coach to develop a personalised plan. Support extends to a year after each person's quit date to make sure people are given the best possible chance to stop smoking permanently. The Leeds Stop Smoking Service will be replacing the previous One You Leeds service which ended on 31 March 2023.

LEAP PROJECT- Leeds Encouraging Activity in People

The LEAP project is now live, and details can be found below. This project is currently operating in Armley and Bramley and Stanningley wards and can be accessed through your local GP. If you live in a different ward you can self-refer.

Background

West Yorkshire Health and Care Partnership (WYH&CP) was allocated £10,724,000 to target areas with the greatest health inequalities. Funding bids were invited via the LCP's in the city, with a focus on Core20PLUS5. This is the NHS approach to tacking health inequalities in areas and within subpopulations of greatest need with an additional focus on clinical areas requiring accelerated improvement.

LEAP will be based within Armley, Middleton & Hunslet and West PCN's which are areas of high deprivation (10% most deprived nationally) IMD 2019). These areas have extremely high prevalence rates of obesity, diabetes, and COPD. These conditions are associated with Hypertension, and as such, presents the opportunity to contribute to addressing long term conditions associated with obesity.

Aim and Implementation

The aim of LEAP is to support those living with a Long-Term Condition to become active or more active and create independent exercise with the purpose to help improve quality of life.

Active Leeds will provide a Clinical Exercise Facilitator (CEF) to support people within Middleton & Hunslet, Armley and West PCN areas to become physically active. The CEF will hold consultation clinics within medical centres and community venues supporting people that suffer from long term conditions such as, hypertension, COPD, diabetes and obesity. Referrals will be made by healthcare professionals.

Following an initial health and medicine assessment, the exercise specialist will provide guidance on the type of exercise permitted (given prescription) preference of exercise and make an introduction to a provider partner. Regular support and motivation will be given throughout a 12-month period to ensure new habits are successfully embedded and incorporate behavioural techniques like motivational interviewing, SMART goal setting, and MECC.

There will be a menu of local low cost and no cost activity options for the client to choose from and each client will go away with an individual plan and agreed goals. The menu of activity opportunities will include a range of local and 3rd sector providers, for instance, gardening projects, walking groups and cycle hub at Middleton Park and Active Leeds will provide support through the local leisure centres. Each client will have the option of an ultra-low-cost membership £5 per month for 6 months. At their 6 months review (where mid-term metrics will be collected), a further discounted membership for 6 months will be offered at £12. This will allow the client access to any mainstream activities but also the Active Leeds Health programme that have L4 Clinical Exercise Instructors that can support people with a range of health conditions including hypertension, CHD, COPD, Obesity, Mental Health, Cancer and Diabetes.

Health Measures

Each client will be supported for 52 weeks with contact points at week 4, week 8, week 26 and week 52. There will be measures taken at each of the contact points. Health Measures to be used on this project are.

- Demographic information and protected characteristics
- IPAQ International Physical Activity Questionnaire
- SWEMWEBS Short Warwick Edinburgh Wellbeing Questionnaire
- Blood pressure and resting heart rate
- Body composition, weight, BMI, Body fat% and lean muscle
- Peak flow lung function.

Partners and prospective partners

Public Health and Active Leeds jointly produced this bid, however, to make this pilot project a success we would be seeking to establish partnerships with activity and exercise providers within Middleton Park ward, Armley ward and West PCN which could accept referrals from clients wishing to move or exercise more. Groundworks is one such partner.

Referral pathway

Following a diagnosis of a LTC (such as diabetes, hypertension, or COPD) from a GP, the patient will be referred to a nurse based within the surgery. The nurse will conduct Health Care Assessment (HCA) part 1 (blood tests, healthy lifestyle questions) and then recall the patient for HCA part 2, whereby a conversation on condition management and improvement will be initiated with the patient. At this stage the nurse will be able to make a referral into LEAP via the CCPS template on both Systemone and Emis.

In addition to the newly diagnosed patients, the surgery also conducts annual reviews of people with a range of long-term conditions, including diabetes, hypertension and COPD. As part of the review, patients will also be offered a referral into LEAP. LEAP will also take referrals directly from the Specialist Diabetes Service delivered by Leeds Community Healthcare Trust.





Community Committee Youth Summit/Youth Activity Fund Consultation Report

Purpose of report

- 1. The report provides the Inner West Community Committee with an update on the Community Committee Youth Summit.
- 2. The report provides the Inner West Community Committee with an update on the Youth Activity Fund Consultation.
- 3. The report asks the Inner West Community Committee, that consultation with young people, conducted via the Youth Summit and Youth Activity Fund survey, informs the Youth Activity Fund spend for the 2023/24 financial year.

Main issues

- 4. Each Community Committee has been allocated a Youth Activity Fund which it is responsible for administering. The Youth Activity Fund has been made available to provide local activities for children and young people aged 8-17 years across the city.
- 5. The Youth Activity Fund requires the engagement and participation of children and young people in the decision making and evaluation of the fund. Children and young people are involved in the funding process and advise Community Committees on the activities they would like to take part in, in their respective areas.
- 6. The Youth Activity Fund can provide money for activities that offer opportunities for play, arts, sport and culture, which enable young people to have fun, get creative and have new experiences both after school and during the school holidays.

- 7. Youth Summits are an opportunity for young people aged 8-17 years living in Leeds to learn about local democracy, as well as influence the decision making of the Youth Activity Fund, by taking part in a consultation exercise that informs the Community Committee's budget spend.
- 8. Building on a commitment to engage and involve children and young people in decision making in their own communities, young people get involved in choosing which activities should be supported by the committees.

The Future of Youth Summits

- 9. Amongst other things, the pandemic provided us with an opportunity to reflect upon the Youth Summit model and consider how we adapt responses and approaches to meet the needs of young people in our respective communities, as well as reviewing the aims and objectives for the Community Committee Youth Summits.
- 10. As the Government removed all remaining domestic restrictions in law from Thursday, 24th February 2022, there was an appetite from schools/youth groups and Elected Members to reflect upon the Youth Summits and develop an approach for this municipal year.
- 11. Following meetings with various officers from the Communities Team, the Voice & Influence Lead for Children & Families and the Youth Service, a standardised baseline approach was agreed, that set out clear aims and objectives, as well as demonstrating measurable and specific outcomes.
- 12. These aims and objectives were subsequently agreed with our Executive Board Member, Community Committee Champions and Community Committee Chairs and discussed with Children & Families Sub Groups.

Aims/Objectives from the Youth Summits and Youth Activity Fund Consultation

- 13. Standardised baseline for all Youth Summits/Youth Activity Fund consultation are the following:
 - Age range of young people 8 17 years (links to the Youth Activity Fund Budget delegation to the Community Committees).
 - Opportunity to learn about local democracy & take part in the decision-making process/influence Youth Activity Fund Budget spend for the Community Committees.
 - Promote the Youth Council and the various Youth Matters Groups throughout the city.
 - Build relationships with schools/partners and provide an opportunity for networking.
 - Consult with as many young people as possible (hybrid approach) by ensuring that alongside the Youth Summits, other YAF consultation is coordinated (i.e., via online consultation/Breeze Summer Events).

- Ensure we are engaging with a diverse range of young people from different backgrounds and not just young people who are academically inclined, or naturally engaged with these types of events.
- Provide feedback on Youth Summits/other consultation methods via a "You Said, We Did" Youth Summit Report, that clearly outlines in each respective committee area, exactly what projects have been funded, or proactively commissioned from the Youth Activity Fund Budget.

How we Measure Success

- 14. Standardised baseline for all Youth Summits/ Youth Activity Fund consultation are the following:
 - How many young people have been involved in the physical summits?
 - How many young people have been involved in other forms of Youth Activity Fund consultation?
 - How many schools/organisations have been involved in bringing young people along to the Youth Summits and/or involved in any other consultation?
 - How many projects have been funded, or proactively commissioned from the Youth Activity Fund Budget as a result of the Youth Summits/and or Youth Activity Fund consultation?
 - Has the "You Said, We Did" Youth Summit Report been prepared and delivered?

Reflections from the Youth Summits/Youth Activity Fund Consultation

Youth Summit

- 15. Localised conversations have been taking place regarding the Inner West Community Committee Youth Summit, in accordance with the Children's Champion and Children & Families Sub Group.
- 16. As we appreciate and understand that each community is different, the specific arrangements for the summit have been worked through, using a collaborative approach, and progressed by relevant officers in the Communities Team, the Voice & Influence Team and the Children's Champion, with the Inner West Community Committee Youth Summit taking place on the 5th of October.
- 17.A key objective for the Inner West Community Committee is that we engage with a wide variety of young people and that this engagement reflects the true diversity of the area, not just young people who are academically inclined, or naturally engaged with these types of events.
- 18. With this in mind the Communities Team attended the SEND Youth Summit, alongside the Voice & Influence Team, to consult with young people that have special education needs & disabilities. At the SEND Youth Summit which took place in November 2022, the Community Committees engaged with 56 young people that have special educational needs & disabilities.

- 19. We're aware that at one of the Youth Summit events that took place recently, we had a small number of young people that were home schooled, and this is an avenue we would like to explore for future events.
- 20. Another key objective for the Inner West Community Committee Youth Summit is that we promote the Youth Council and the various Youth Matters Groups throughout the city. This was done at the event on the 5th October, with some positive results, as there have been 25 Leeds Youth Council sign ups.
- 21. Primary schools continue to find it easier to make the commitment to attend the Youth Summits, which is understandable, although at the Inner West Community Committee Youth Summit we had good representation from Secondary Schools. All wards have been represented by schools and organisations that make up the committee area.
- 22. At the Inner West Community Committee Youth Summit, we engaged with 29 young people.

Testimonials/Feedback from the Youth Summit

23. Below are comments/feedback from the Inner West Community Committee Youth Summit.

Tony Barraclough, Leeds West Academy:

"A great trip today! A truly fantastic idea for young people to voice their thoughts, opinions and ideas around their local community. Lots of different Councillors and city figures appeared for the young people to fire questions at. None other than the Lord Mayor himself was in attendance in full regalia, taking plenty of time with the students to respond to questions and concerns, as well as photo opportunities. There were engaging activities giving the young people a virtual public spending on youth events and amenities. The day really felt like the students were being put in the driving seat of community change."

Youth Activity Fund Consultation

24. Alongside the physical Youth Summit, the Communities Team also created a consultation survey for young people, as another objective is that we, "consult with as many young people as possible (hybrid approach), by ensuring that alongside the

summits, other consultation is coordinated; for example, online consultation, Breeze Summer Events": https://surveys.leeds.gov.uk/s/YouthActivities2022/

25. This online survey has been circulated far and wide throughout the committee area and has been created using some new & innovative ways of engaging with young people, such as creating a QR code that directs young people straight to the survey, after being scanned with a Smartphone.



- 26. The Inner West Community Committee received 29 survey responses to the Youth Activity Fund Consultation Survey. The vast majority of these were completed online, however some of the survey responses were completed in paper format at the Breeze Summer Events in 2022.
- 27. An additional online survey was also created to engage with young people that have special educational needs and disabilities. In relation to this survey, we had 12 responses.
- 28. The consultation survey ran from September 2022 and stayed open until the 31st March 2023, with the feedback from young people collated. This will, in principle, inform the Youth Activity Fund Budget spend for 2023/24.

Measurement of Success

- 29. Below are some key facts and figures from the Inner West Community Committee Youth Summit and Youth Activity Fund Consultation. These are provided in response to the standardised baseline measurement of success, agreed with Children's Champions and Community Committee Chairs.
 - How many young people have been involved in the physical summits?
 - How many young people have been involved in other forms of Youth Activity Fund consultation? 41
 - How many schools/organisations have been involved in bringing young people along to the Youth Summits and/or involved in any other consultation?
 - The number of projects have been funded, or proactively commissioned from the Youth Activity Fund Budget as a result of the Youth Summits/and or Youth Activity Fund consultation will be reported at the end of the next financial year.
 - Has the "You Said, We Did" Youth Summit Report will be produced ahead of next year's Youth Summit.

- 30. The report, referenced as the Youth Summit/Youth Activity Fund Consultation Report, is the Community Committee "You Said, We Did" Youth Summit Report outlined in the list above. Further conversations will take place with young people at appropriate opportunities over the coming months, regarding the Youth Summits and Youth Activity Fund Consultation, after the report has been discussed with the Inner West Community Committee.
- 31. As time progresses, the Communities Team will be able to assess "How many projects have been funded, or proactively commissioned from the Youth Activity Fund Budget as a result of the Youth Summits/and or Youth Activity Fund consultation?" so updates will be provided to Children and Families Sub Groups throughout the course of the financial year.

Lessons Learned

- 32. All feedback from the Community Committee Youth Summits will be analysed, with a review taking place once all the events have finished, in a Community Committee Youth Summits: Lessons Learned meeting, with the Executive Board Member and Children's Champions.
- 33. A report will also be taken to the Community Committee Chairs Forum in April 2023.
- 34. As we are keen that we continue to work closely with the Children's Champions to develop the Youth Summits across the Community Committee areas, these conversations and feedback will help inform the Youth Summits in the next municipal year.

Youth Activity Fund Consultation Survey Recommendations

- 35. The consultation surveys submitted by young people from the Youth Summit and online survey in the Inner West Community Committee area, suggest the following Youth Activity Fund priorities for 2023/24:
 - a. Youth activities on offer in both local and away venues such as community centres, youth clubs and sport centres as well as activities to be delivered evenly between indoors and outdoors.
 - b. Majority of provision taking place during the school holidays and on the weekend.
 - c. Ensure the activities are fun, active, create new friendships and provide children and young people more options. Good quality staff should be delivering the events.
 - d. Popular activities included;
 - 1. Sport
 - 2. Music/Cooking/Outdoor Adventures
 - 3. Arts and Crafts

- 36. It is recommended that any projects funded by the Inner West Community Committee from the Youth Activity Fund, focus on these key themes and activities in 2023/24.
- 37. To ensure that the Inner West Community Committee can make an informed decision when being asked whether they support funding for projects from its Youth Activity Fund, the Communities Team will advise the committee if the project meets the priorities identified by young people as a result of consultation that has taken place.
