#### **EXECUTIVE SUMMARY**

This report informs Members of an application for the grant of a premises licence for Challenge Sandwiches, 35 North Lane, Headingley, Leeds, LS6 3HW. The Licensing Authority is under a duty to determine this application.

#### 1.0 PURPOSE OF REPORT

1.1 To advise Members of an application made under section 17 of the Licensing Act 2003 ("the Act") for a Premises Licence in respect of Challenge Sandwiches, 35 North Lane, Headingley, Leeds, LS6 3HW.

#### 2.0 HISTORY OF PREMISES

This is the first application for the grant of a premise licence.

This application was originally submitted on April 2006 but was returned as an incomplete application. It was returned to the Licensing Office on 23<sup>rd</sup> May 2006 but was deemed invalid due to incorrect advertising. The application eventually became valid on 2<sup>nd</sup> August 2006.

#### **Cumulative Impact Policy**

Members will recall the Council's Licensing Policy was approved in January 2005 and that the Council is applying a special cumulative impact policy to certain areas of the Leeds district. These areas are part of the City Centre, Headingley, Woodhouse Lane and Chapel Allerton.

These premises fall within the Cumulative Impact Policy Area.

Members will be aware that the number and concentration of licensed premises in these areas have been found to have an adverse affect on the specific licensing objectives:

- > The prevention of crime and disorder
- > The prevention of public nuisance

The policies apply only to premises of a particular type. Members should note that this policy does not allow applications for premises licences from these areas to be rejected automatically. Instead the cumulative impact policy creates a presumption that where relevant representations are made the Council will refuse an application from the relevant areas.

It is for the applicant in such cases to persuade Members that the proposals will not add to the cumulative impact of the premises in the area.

- 6.2 Members of the Licensing sub committee are asked to note that they may not modify the conditions or reject the whole or part of the application merely because it considers it desirable to do so. It must actually be <a href="necessary">necessary</a> in order to promote the licensing objectives.

### **Executive Summary**

To advise Members of an application for the certification of films to be shown at the Leeds International Film Festival

#### 1.0 Purpose of the Report

1.1 This report informs Members with the background, history and issues of an application made under the Licensing Act 2003 ("the Act") for the certification of films that do not currently have a BBFC (British Board of Film Classification) certification. Finally, this report informs Members of the options available to them when considering an application for the certification of films.

#### 2.0 Background Information

- 2.1 The Licensing Act 2003 applies to premises which provide film exhibitions. At present there are a total of 7 cinemas licensed in the Leeds District.
- 2.2 The majority of films shown in Cinemas will carry a Certificate from the British Board of Film Classification (BBFC), the categories of which are as follows:

Category `U' Passed for general exhibition

Category `PG' Passed for general exhibition but parents/guardians are

advised that the film contains materials they might prefer

children under fifteen years not to see.

Category `12'

Passed as suitable only for exhibition to persons of twelve years and over. When a programme includes a `12' film, no persons under twelve years can be admitted.

Category '12a'

Passed as suitable for children under the age of 12 if accompanied by an adult.

Category `15'

Passed as suitable only for exhibition to persons of fifteen years and over. when a programme includes a `15' film, no persons under fifteen years can be admitted.

Category `18'

Passed as suitable only for exhibition to adults. When a programme includes an `18; film no persons under the age of eighteen years can be admitted.

2.3 In addition to licensing premises for film exhibitions, the Licensing Authority has a duty under Section 20 of the Licensing Act 2003 to categorise a film which is absent of a Certificate from a film classification body such as the BBFC. The Licensing Authority may also reject or modify a film which has received a Certificate from the BBFC.

#### 3.0 Main Issues

- 3.1 A request has been received from the Leeds International Film Festival Office to have a number films certified by the Licensing Panel.
- 3.2 Details of the films which require certification are attached hereto for Members attention at Appendix 'A'.
- 3.3 The Festival Film Director Mr C Fell will attend the meeting to give members additional information in respect of the proposed films.

#### 4.0 HISTORY

4.1 This is an annual request for the Leeds International Film Festival. The initial request of this nature was in 1986.

#### 5.0 Implications for Council Policy and Governance

5.1 There are no implications for Council Policy and Governance in respect of determining this application.

#### 6.0 Recommendations

All certificates mentioned below are recommendations by the festival team according to British Board of Film Classification guidelines.

**Grain in Ear** – Chinese drama about a Korean woman struggling to raise her son on the margins of society when her husband is in prison. Incl. non-explicit sex scenes and mild violence. Screened at East End London Film Festival Spring 2006. Recommended Cert 15.

**Taking Father Home** – Chinese drama about a country teenager going to the city to look for his father. Occasional strong language and one scene of climactic violence. Screening at London Film Festival before Leeds in October. Recommended Cert 15.

**Glue** – Warm and realistic Argentine coming of age drama about a teenage boy finding out about the adult world. Incl strong language and scenes of experimentation with sex and drugs. Screening at London Film Festival before Leeds in October. Recommended Cert 18.

**Time** – Satire on Korean society's obsession with appearances featuring a woman undergoing extensive plastic surgery to save her relationship. Adult themes, nudity and surgery footage. Screened at Cannes and Karlovy Vary International Film Festivals. Recommended Cert 18.

**Frozen City** – Finnish drama about a taxi driver whose life spirals out of control after his marriage breaks up. Incl. some strong language, non-explicit sex and one scene of mild violence. Screened at Gothenberg Film Festival. Recommended Cert 15.

**Mutual Appreciation** – American drama about the relationship between a young musician and his friends. Some strong language. Screened at Edinburgh Film Festival in August. Recommended Cert 15.

**Several People, Little Time** – Polish communist era true life drama about the relationship between a famous poet and his blind female assistant. Recommended Cert. PG.

**The Girl is Mine** – French drama about a disturbed middle aged business woman who thinks she has found her 10 year old daughter, kidnapped as a baby and never found. Some strong language. Recommended Cert 15.

A Crude Awakening: The Oil Crash – Swiss documentary about the many problems arising from depleting oil reserves and likely effects of a future crash. Screening at Edinburgh and Sheffield Film Festivals. Recommended Cert PG.

The Case of the Grinning Cat – French documentary about Parisian graffiti arising after 9/11 and its connection with groups of activists campaigning against the war against terror. Has been screened in London. Recommended Cert PG.

Al Franken: God Spoke – American documentary about comic turned democratic political campaigner Al Franken in the run up to the last American election. Incl. some strong language. Screened in Edinburgh Film Festival in August. Recommended Cert 15.
