20 Minutes - 17 July 2024

RESOLVED – That the minutes of the meeting held on 17 July 2024 be confirmed as a correct record.

21 Open Forum

In accordance with the Community Committee Procedure Rules, the Chair allowed a period of up to 10 minutes for members of the public to make representations or ask questions within the terms of reference of the Community Committee.

On this occasion no members of the public wished to speak.

22 Update from West Yorkshire Police

Draft minutes to be approved at the meeting to be held on Tuesday, 10th December, 2024

Inspector Nicholls gave the Committee an update on policing issues in the Outer East area. It was reported that serious acquisitive crime had reduced by 20% across the area. There had been significant reductions in burglaries across Temple Newsam and Halton Moor and also a drop in anti-social behaviour in Garforth & Swillington. There had been an increase in nuisance vehicles in Temple Newsam and there was an ongoing working group to tackle this.

Local policing priorities remained the same with a focus on serious organised crime and targeting persistent offenders.

In response to questions from Members, the following was discussed:

- Inspector Nicholls and his team were thanked for the work in tackling anti-social driving and car meets as highlighted at the previous meeting although the problem had now moved to a different area between Swillington and Great Preston.
- Reference was made to a serious incident that had recently occurred on Kippax High Street. The incident was considered to be a one off and work was ongoing with local licensed premises to review the need for door supervisors.
- It was proposed that an Anti-Social Behaviour Sub-Group be stablished to pick up priorities from each ward in order to inform West Yorkshire Police and the Anti-Social Behaviour team.

Inspector Nicholls was thanked for his attendance.

23 Outer East Community Committee Community Safety Report

The report of the Head of Locality Partnerships provided an opportunity for members to raise concerns with officers from Leeds Anti-Social Behaviour Team and Housing, and share ideas on possible solutions to reduce incidents of anti-social behaviour in the Outer East area.

Beth Shaw, Housing Manager and Martin Denison Anti-Social Behaviour Case Officer were in attendance.

Members were informed that here had been a reduction in the number of cases that Housing were currently involved with. There were currently 6 open cases mainly relating to noise nuisance. Other work included preparations for bonfire night and work with the local neighbourhood policing team.

The majority of cases dealt with by LASBT involved neighbour disputes and problem addresses and families. With regards to these there were ongoing court cases which would involve proceedings to take possession.

There had been other problems in the area with an increase in shoplifting and anti-social behavior at the Co-op store in Swarcliffe. There had also been some disturbance at the Britannia Hotel following the riots.

Further discussion included the reporting of anti-social behaviour and people were encouraged to keep a log of any incidents and to keep reporting them.

Beth and Martin were thanked for their attendance.

24 Outer East Community Committee Finance Report

The report of the Head of Locality Partnerships provided the Community Committee with an update on the budget position for the Wellbeing Fund, Youth Activity Fund, Capital Budget as well as the Community Infrastructure Levy budget for 2024/25.

Stuart Byrne, Localities Programme Manager presented the report.

The following was discussed:

- Members were informed of funds available in the Wellbeing, Youth Activities Fund, Capital and Community Infrastructure Levy budgets. A ward by ward breakdown of funds was given.
- Members were asked to consider the following funding applications:
 - Blands Recreation Ground £5,000 was requested. Members were supportive of this application and requested that Capital funding was used.
 - Public Space CCTV Cameras Outer East £3,000 for Cross Gates & Whinmoor; £4,000 for Garforth & Swillington, £2,000 for Kippax & Methley and £3,000 for Temple Newsam requested. Members were supportive of these applications and advised that CIL monies could be used.
 - Community Engagement Activities & Support to the Wider Community – Cross Gates & District Good Neighbours Scheme
 £14,887 had been requested. It was proposed to fund £5,000 from Cross Gates and Whinmoor.
 - Security fencing for outdoor practice nets This had previously been agreed via delegated decision.
 - Youth Service Autumn/Winter Programme £2752.50 was requested – Members were supportive of this application.

Title: Leeds Streets for All consultation - public responses

Purpose of report

- 1. To provide the Outer East Community Committee with an update following the Leeds Streets for All consultation which ran 15th January 25th February 2024.
- 2. Members are asked to read the detailed report (attached) ahead of the community committee meeting on 10th December.
- 3. A short presentation (attached) will be used to frame discussions at the meeting.

Main points

- 4. The report provides the Outer East Community Committee with the findings of what the public told us are their main issues under the themes of vehicles & parking, walking & wheeling, cycling, accessing bus stops & rail stations and the street environment.
- 5. Nearly 2,300 people visited the consultation website, and 182 respondents left 442 contributions. A total of 665 relevant comments (which included additional 'free text' comments) were analysed in this report
- 6. Of the responses received 50% were related to vehicles and parking, 18% cycling, 20% wheeling and walking, 8% street environment and 4% accessing bus and rail stations.
- 7. Common themes for vehicles and parking include inconsiderate parking, speeding, congestion/volume of traffic, not enough parking.
- 8. Common themes for cycling include cycle provision feels unsafe/inadequate, no provision for people cycling, no or unclear sinage for cycling, cycle path shared with pedistrians.
- 9. Common themes for wheeling and walking difficult to cross the road, pavement too narrow/damaged, inconsiderate parking, no pavement.

- 10. Common themes for accessing bus stops and rail stations include hard to cross the road to access bus stop/rail station, No street lighting, difficult to get on/off the bus/train with wheelchair/pushchair.
- 11. Common themes for street environment include anti-social behaviour, lack of greenery, plants and trees, speeding, overgrown shrubs.
- 12. A map on pg 15 provides a visual display of the key locations where people have highlighted issues in the Inner Northwest area.

Recommendations

- 13. A local plan with a list of potential interventions is in (appendix 1) which can only be developed as funding opportunities become available.
- 14. Elected Members are asked to note the contents of the full report and provide feedback regarding:
 - the findings and if they tie in with ward members' knowledge or are there any gaps
 - officer's recommendations for potential future schemes (subject to funding)
 - how findings can be fed back to residents

Section 1: Why Have a Local Area Transport Plan?

We are developing Local Area Transport plans (LATP) after the city-wide Connecting Leeds Transport Strategy has been developed and approved in October 2021.

An important goal for the City Council is to prioritise streets for all, putting healthy streets at the heart of our Connecting Leeds Transport Strategy. It gives the opportunity for large cities such as Leeds to develop an overall Strategy and then still have a forum where we can put more local-led issues forward and help secure more funding in the future.


In recent years Leeds has enjoyed a massive increase in the funding available for transport improvements, which has predominantly been spent in the City Centre and on other large highway schemes notably including the East Leeds Orbital Route (ELOR). This has allowed Leeds to catch up with other cities as significant investment in the city centre has been long overdue. We now want to focus our efforts on improving travel in our local neighbourhoods.

An online <u>Leeds Streets for All</u> survey, has helped people record what type of improvements they want to see and where in their local areas.

The Survey




Nearly 2,300 people visited the consultation website of which 182 respondents left over 400 comments. These comments were received for the four wards of Cross Gates & Whinmoor, Garforth & Swillington, Kippax & Methley, and Temple Newsam but we received fewer comments regarding the Kippax & Methley ward (see chart below). There was a total of 665 comments analysed in this report. The chart below shows the breakdown across the wards:



Most of the comments received are from people who live within the Outer East area, but the many people who travel through the area have also commented.

LCC have developed an accompanied interactive mapping tool to support analysis of the 'Leeds Street for All' scheme which also includes Stats 19 collisions data. This allows you to view the feedback across the Outer East to help build up a picture of what issues people told us.

We have had a range of comments from people of all ages, which this Report looks to develop into a Local Area Transport Plan (LATP).

Section 3: What we are already doing in your area.

Healthy Streets and Better Places scheme interventions in Crossgates.

A scheme that involves several walking, wheeling, and cycling improvements that better connect nearby communities to in Crossgate:

- Create a new segregated cycle route westbound along Barwick Road.
- Upgrading the junction at Church Lane/Eastwood Lane for pedestrians and cyclists
- Upgrade footpaths/junctions on sections of Barwick Road, Church Lane, Austhorpe Road and Penda Way to improve accessibility for residents.
- Create a safe cycling/walking route through the Poole Estate to Crossgates Centre

A6120 (old ring road) improvements

Our design teams are actively planning a transformative project for the A6120 (former ring road), following the completion of the East Leeds Orbital Relief (ELOR). The focus will be on upgrading the stretch from the York Road/A64 Roundabout (Seacroft) to the Colton Lane/Selby Road Roundabout. This project is currently in the preliminary phase of development.

Our Annual Programme of Works

Many of these proposed improvements will form part of the various forward district work plans, with the most current included in this year's **Annual Programme of Works**. The works can be viewed on an interactive map, where you can search by street, town and area - <u>Connecting Leeds Annual Programme of Works 2024-2025 (arcgis.com)</u> - Some of the key highway improvements planned for the Inner West are shown in table 1 which are all fully funded and designed ready to deliver in 2024/25 (April to April).

Potential new local cycle and walking routes in Outer East.

We are required by national Government to produce a Local Cycling and Walking Infrastructure Plan (LCWIP).


In Leeds we have worked with our partners at the West Yorkshire combined authority (WYCA) to create a longlist of cycle routes that would most effectively strategically link different parts of Leeds, and beyond into neighbouring authorities like Bradford & Wakefield.

Ongoing work will consider the role of Walking. This will involve studies such as that conducted for Armley Town Street where we will consider improvements that can be made to key destinations and centres in local areas across Leeds. This phase of the LCWIP will really benefit from the views expressed in the streets for all consultation

We also will do more work to consider cycling. To supplement the longer distance more strategic routes developed with WYCA. We need to do more work to look at shorter routes that plug vital gaps in our growing network of cycle routes in Leeds. Again, this project will be able to consider the feedback given by Streets for All.

The map below shows existing cycle routes in the Inner West and the indicatively planned strategic routes we have developed in partnership with WYCA.


As we move forward with our LCWIP plans we will seek to develop improved ways of sharing these plans with communities and those interested in our walking and cycling networks.




Map 2 – Examples of potential new LCWIP routes in Outer East

Road collision data in Outer East

The last 5 years collision data has also been analysed and mapped to see if the location of the responses correlates with existing collision hotspots. The locations where killed or serious injury (KSI) occurred are shown on the mapped below, which also highlight the IMD.





Proposed list of new transport improvement schemes in Outer East

Consultation feedback has been reviewed to refine existing transport enhancement proposals and detect new possible projects. The aim is to prepare a pipeline of ready-to-implement cycling and walking initiatives to seize upcoming financing opportunities.




Figure 2 – Outer East survey response heatmap.

The attached heatmap (figure 2) was produced with data gathered from the 'Leeds Streets for All' consultation. The areas with concentrated colors indicate the places in the Outer East that attracted the most feedback. This map visually presents the principal spots where residents have identified problems within the Outer East region.

List of potential new schemes identified from the LATP survey in the Outer East The following list of potential new interventions have been identified from the responses which would improve transport connectivity in the local area. More details on this list can be found in Table 4 below.

It is important the remember that none of LCWIP or the new scheme suggestions are currently funded but the list does provide an indication of what potential types of transport improvement could be prioritised and delivered if future funding opportunities became available. This list isn't exhaustive and should be treated as a guide to show what could be achieved.

Appendix 1: Proposed schemes - The Local Plan



Sources of Funding

All areas of Leeds (including Outer East) benefit from the Maintenance and Traffic Signal funding, which is already allocated separately across Leeds. Information obtained from the Leeds Streets for All' surveys will be shared within highways to help.

The main source of available central funding is from the City Region Sustainable Transport Fund (CRSTS). The £830 million City Regional Sustainable Transport Settlement (across West Yorkshire) is aimed at providing an integrated and inclusive transport network which was made possible thanks to the West Yorkshire Mayoral devolution deal.

The Active Travel Fund (ATF) has more of a single focus on sustainable travel is also being used in local areas. All these funds are designed to invest in transport schemes which improves people everyday lives. Table 5 below illustrates this funding, and how we may attain more.

Some funding has already been received via the Network North which has £19.8M overall, to cover a wide variety of difference transport initiatives. More is expected in the coming months.

Outer East Community Committee - Finance Report

Purpose of Report

1. The report provides the Community Committee with an update on the budget position for the Wellbeing Fund, Youth Activity Fund, Capital Budget, as well as the Community Infrastructure Levy Budget for 2024/25. Financial decisions are taken to the Community Committee meetings to ensure transparency and that financial regulations are met.

Main Issues

- 2. Each Community Committee has been allocated a wellbeing budget (revenue and capital) and Youth Activities Fund which it is responsible for administering. The aim of these budgets is to support the social, economic, and environmental wellbeing of the area and provide a range of activities for children and young people, by using the funding to support projects that contribute towards the delivery of local priorities.
- **3.** A group applying to the Wellbeing Fund must fulfil various eligibility criteria, including evidencing appropriate management arrangements and financial controls are in place; have relevant policies to comply with legislation and best practice e.g., safeguarding, and equal opportunities and be unable to cover the costs of the project from other funds.
- **4.** Wellbeing funding cannot be paid retrospectively. An application form must be submitted and approved by the Community Committee before activities or items being purchased through wellbeing funding are completed or purchased.
- **5.** The amount of wellbeing funding provided to each committee is calculated using a formula agreed by Council, taking into consideration both population and deprivation of an area.

- 6. Capital (CRIS) injections are provided as a result of council assets being sold. 5% of the sale price (up to a maximum of £100k) of a council asset is pooled city-wide and redistributed to the Community Committee areas on the basis of deprivation. The Community Committee will receive a new capital injection every 6 months.
- 7. Each Community Committee has also been allocated a Community Infrastructure Levy budget. For each CIL contribution, Leeds City Council retains up to 70-80% centrally, 5% is needed for administration and 15 25% goes to be spent locally. The money will be vested with the local Town or Parish Council if applicable, or with the local Community Committee and spend decided upon by that body. This local money is known as the 'Neighbourhood Fund' and should be spent on similar projects to the Wellbeing Fund (capital).
- 8. In the Outer East Community Committee, the CIL money for Allerton Bywater Parish Council, Great and Little Preston Council, Kippax Parish Council, Ledsham Parish Council, Micklefield Parish Council and Swillington Parish Council will be administered by each individual Parish Council, whereas monies for Cross Gates & Whinmoor, Garforth, Methley and Temple Newsam will be administered by the Outer East Community Committee.
- 9. It was agreed at Outer East Community Committee on the 02 October 2018 that CIL monies for Cross Gates & Whinmoor. Garforth, Methley and Temple Newsam would be spent in the ward it was generated in.
- 10. Until the UK left the European Union, the EU's State Aid rules controlled how UK and discretionary EU funding was provided to enterprises and entities that engage in economic activities. Now the UK has left the EU, it is no longer bound by the State Aid rules and has developed its own domestic subsidy control regime, The Subsidy Control Act 2022. As the Subsidy Control Act 2022 has potential implications for the Community Committees as funding bodies, a 'subsidy control' assessment will be undertaken on all funding requests received by the Community Committees.
- 11. Projects eligible for funding by the Community Committee could be community events; environmental improvements; crime prevention initiatives, or opportunities for sport and healthy activities for all ages. In line with the Equality Act 2010, projects funded at public expense should provide services to citizens irrespective of their age, disability, gender reassignment, marriage and civil partnership, pregnancy and maternity, race, religion or belief, sex, and sexual orientation: the fund cannot be used to support an organisation's regular business running costs; it cannot fund projects promoting political or religious viewpoints to the exclusion of others; projects must represent good value for money and follow Leeds City Council Financial Regulations and the Council's Spending Money Wisely policy; applications should provide, where possible, three quotes for any works planned and demonstrate how the cost of the project is relative to the scale of beneficiaries; the fund cannot support projects which directly result in the business interests of any members of the organisation making a profit.
- **12.** Any request for funding would involve discussions with appropriate ward members. Where projects do not have support from the Community Committee and are not approved, applicants are offered further discussions and feedback if this is requested.

- **13.** In order to provide further assurance and transparency of all decisions made by the Community Committee, any projects that are not approved will be reported to a subsequent Community Committee meeting.
- 14. Sometimes urgent decisions may need to be made in between formal Community Committee meetings regarding the administration of Wellbeing and Youth Activity budgets, and also regarding the use of the Community Infrastructure Levy (CIL) Neighbourhood Fund which has been allocated to the Committee. Concurrently with the Committee, designated officers have delegated authority from the Director of Communities, Housing and Environment to take such decisions.
- **15.** The Community Committee has previously approved the following 'minimum conditions' in order to reassure Members that all delegated decisions would be taken within an appropriate governance framework, with appropriate Member consultation and only when such conditions have been satisfied:
 - a) consultation must be undertaken with all committee/ relevant ward members prior to a delegated decision being taken:
 - b) a delegated decision must have support from a majority of the community committee elected members represented on the committee (or in the case of funds delegated by a community committee to individual wards, a majority of the ward councillors); and
 - c) details of any decisions taken under such delegated authority will be reported to the next available community committee meeting for members' information.
- 16. Members are reminded that the necessary scrutiny of applications to satisfy our own processes, financial regulations and audit requires the deadline for receipt of completed applications to be at least five weeks prior to any Community Committee. Some applications will be approved via Delegated Decision Notice (DDN) following consultation with Members outside of the Community Committee meeting cycle.
- 17. Members are reminded that urgent delegated decisions on wellbeing funding also covers small grant decisions. In agreement with the Executive Board Member for Communities, Community Committee Chairs & also in accordance with the communication that was sent out to all committees/ Elected Members in March 2023, the approval threshold for small grants has now increased from the 01 April 2023; up to £1000 per ward. This approach will ensure consistency in terms of administering small grants, in accordance with the committees' minimum conditions.

Wellbeing Budget Position 2024/25

- 18. The total revenue budget approved by Executive Board for 2024/25 was £72,183.00 for the Outer East Community Committee. Table 1 shows a carry forward figure of £80,681.40 which includes underspends from projects completed in 2023/24. Allocated wellbeing projects in 2023/24 is £68,613.66 and not yet completed. The total revenue funding available to the Community Committee for 2024/25 is therefore £84,250.74. A full breakdown of the projects approved or ring-fenced is available on request.
- 19. The total amount approved on Table 1 includes all the projects the committee has approved in 2024/25. It is possible that some of the projects may not use their allocated spend. This could be for several reasons, including the project no longer going ahead, the project not taking place within the dates specified in the funding agreement, or failure to submit

- monitoring reports. Due to this the final revenue balance may be greater than the amount specified in Table 1.
- **20.** The Community Committee is asked to note that so far, a total of £45,210.80 has been allocated to projects and there is a remaining balance of £39,559.94 in the Wellbeing Revenue Fund. A full breakdown of the projects is listed in Table 1 and available on request.

- <u>Cookery classes:</u> Weekly session to support people to make best use of food from the Community Fridge.

Monitoring Information

24. As part of the funding agreements, all projects which have had funding approved by the Community Committee are required to provide update reports on the progress of their project. These reports are so that the Community Committee can measure the impact the project has had on the community and the value for money achieved.

Since the last Community Committee meeting, the following project monitoring reports have been submitted:

a) Breeze in the Park,

Wards Covered: Cross Gates & Whinmoor and Temple Newsam.

Project Monitoring Summary: Following the success of 2023 delivery model, Breeze in the Park events were delivered over the school summer holidays in 2 x 2.5-hour sessions and took place as follows:

Manston Park: 11 August 2023.

Primrose: 16 August 2023.

Sessions times slots: 12:00: -14:30 and 15:00 – 17:30. Sessions were bookable online via the Breeze website at 50p per child. Capacity for tickets online were capped at five hundred per session.

As a response to the challenges facing families not having access to internet or not being able to afford the 50p charge two hundred free places were made available. This opportunity was promoted and made available through the Cluster teams working across all the schools in the area. Although there was a good response in young people being allocated the tickets, Breeze Leeds do not always see a huge uptake in those children attending and will continue to develop this offer to maximise the opportunity in 2025.

Manston Park was identified as a new venue for our relaxed programme for the first year introducing a relaxed session in Outer East area. This proved popular with 65 children with SEND attending the quieter hour.

Attendance breakdown across both Breeze events:

• Total number of young people: 1,096

Estimated number of parent/ carers: 1,644

• Total number of attendees: 2,740

Breeze in the Park events are made up of six zones with activities available in each zone for all age ranges. The following activities were delivered in each zone:

- <u>Inflatable Zone:</u> Giant Obstacle Course Inflatable, Large Superdome Bouncy Castle, Jungle Slide Inflatable, Demo Ball Inflatable, Bounce & Slide Inflatable, Jungle Gym, Interactive Play Zone, Pillow Wars, Sumo Wrestling.
- <u>Play Zone:</u> Giant Connect 4, Giant Jenga, Skip Ropes, Lawn Darks, Hoops, Diablo building blocks, Mud and Sand play pits. *This area continues to grow each year and is extremely popular with young children (under three's). This is also the area Breeze will focus on improving and growing for the 2024 events.*
- New for 2024: As promised in 2023 we grew the under 5s area with addition
 of our Mini Gymnastics zone delivered as part of a partnership piece of work
 with Active Leeds. This particular area received some really positive feedback
 and we'd like to continue to grow this area with an over 5s gymnastics cause
 in 2025.
- Arts Workshops: Arts & Crafts including eco crafts, Imagination Gaming delivering math based fun puzzles, Claymation workshops for young people to learn how to make digital animations. Messy Play/ Creative Crafts delivering a make it and take it activity. Beauty workshops including nail art, hand and head massages, Lego Master workshop with Lego experts Brik Box.
- <u>Breeze Presents Performance Arena:</u> For 30 to 45 minutes at each event a
 paid performer delivers a fun, interactive show for all the family. Performances
 varied from event to event but included one of the following performers:
 - Professor Pumpernickel: Science show with bags, explosions.
 - o Gecko: Ukulele Workshops.
 - Magic Show with Chris.

- o Teddy Bear Picnic: Children's Entertainers.
- o Suitcase Pete: Circus Skills Workshop.
- o Magic Show & Balloon Modelling.
- o Boom Chika Boom: Dance, sing, rave workshops.

This area was phenomenally successful with lots of parents and children relaxing on the grass watching and interacting with each performance.

- <u>Sports Zone:</u> A small section of the event for children to play sports including mini football and Cricket Skills providing an open free play area for all the family to get involved. This was a great area for our young volunteer team to support.
- <u>Info Zone:</u> Opportunities were made available for voluntary and private sector organisations to come along to each event to promote their service/ offer, as a result, fifty-five organisations attended Breeze events to engage with the local community.

26. Since the last Community Committee, held on 17 September 2024, no projects have been declined.



Youth Activities Fund Position 2023/24

1.0 Introduction

3.0 GDPR - Information Sharing

The introduction of the GDPR 2018 regulations reviewed the area of information sharing and therefore restricted the detail of what can be provided. As a result, the content of this report may not have the detail of specific incidents previously reported but provides a summary of the types of incidents within the area.

4.0 Incidents captured by CCTV operators: see appendix 1

CCTV also contributes towards Police enquiries as requests are made for footage which may not have been observed "real time". These incidents are not included in this report but can contribute towards arrests being made in the Outer East Area.

5.0 Requests for new Cameras

The Surveillance Camera Commissioner is appointed by the Home Secretary to ensure that surveillance camera systems in public places keep people safe and protect and support them.

Following changes to Data Protection legislation the council needs to ensure that all its CCTV systems are managed in line with the Commissioner's recommendations to ensure there are no data breaches (this includes CCTV systems in all Leeds City Council assets including libraries, sports centres, council vehicles fitted with CCTV, etc.).

A dedicated CCTV compliance team has been established within Leeds City Council.

The compliance team also work closely with Information Governance to assist in ensuring all system owners are compliant with their codes of practice, policies, and procedures.

Current Local Priorities Outer East:

Partners and Public can access Leeds East local priority updates at: <u>Leeds East | West Yorkshire</u> <u>Police</u>

Community and Policing Priorities are reviewed frequently and will be amended in line with community concerns, raised issues at Police and Community Together (PACT) meetings, identified risks and information obtained from local policing analysis.

We will frequently share news updates on Social Media channels, Community Alert and via the West Yorkshire Police Website.

Ward Area - Crossgates and Whinmoor

To address reports of anti-social behaviour and reports of theft from shop, with a particular focus around the Co-op and surrounding businesses in Swarcliffe.

To continue our focus on addressing the use of stolen and off-road motorcycles driving illegally and in an anti-social manner in Swarcliffe, Stanks, Whinmoor and Crossgates.

- Neighbourhood Policing Team (NPT) officers continue to address the repeat and
 persistent reports of Anti-Social Behaviour and Theft at the Co-op, Swarcliffe. Several
 CPNS Community Protection Notices have been issued to offenders, involved in offences
 at the store. Officers have forged positive working relations with management at the site,
 we will continue to engage with the store, gather evidence and take action against those
 involved in such behaviours and criminality.
- We have worked in partnership with Leeds City Council Youth Services, to reach out to
 young people in order to signpost them into local provisions available, whilst advising
 young people of the consequences of being involved in such behaviour. Officers and
 PCSO's have also been attending local youth provisions to engage with young people in
 the locality, to re-iterate these messages and to forge positive relations with young
 people.
- The team continue to work collaboratively with their neighbourhood colleagues at Inner East Leeds and the Off-Road Bike Team, to tackle the off road and stolen motorbikes



being seen regularly in and around the ward areas. A significant number of motorcycles, scooters and E-bikes continue to be recovered, due to a combination of officer's commitments to reduce demands and community intelligence. We are regularly reviewing call demands, to deploy officers to repeat demand locations to identify and disrupt offenders.

• In addition to the above, we have worked closely with a range of Housing providers to address properties involved in persistent anti-social behaviour resulting in tenancy enforcement actions taken, and have been engaging with a number of Beauty Salons, Hairdressers, and similar outlets as part of an ongoing Domestic Violence campaign.

Ward Areas – Garforth and Swillington, Kippax, Methley and Villages – set February 2023

- To address public concerns of youth anti-social behaviour demands, including alcohol and drugs use in parkland areas.
- To target and address multiple road safety concerns including speeding and parking offences across the ward areas.

Updates:

- We have continued to conduct multiple targeted high visibility and plain clothes patrols, across the identified location to address reports of anti-social behaviour and suspected drugs use, inclusive of The Graveyard in Garforth and Station Road, Allerton Bywater following concerns raised in the PACT meetings. We will continue to deploy across the locations, to identify young people involved in anti-social behaviour and to disrupt suspected drugs and alcohol misuse.
- A multi-agency operation with Leeds City Council Taxi Licensing was conducted in August 2024, with multiple vehicles stopped and checked. No vehicles were prohibited during the operation and advice was given to several motorists.
- On the 29th September 2024, officers deployed to reports of a car meet on Astley Lane, Swillington. Officers will continue to monitor the location and will utilise and enforce the City-wide Vehicular Nuisance PSPO (Public Spaces Protection Order), where applicable.
- To address ongoing parking and road safety concerns at Great Preston Primary School, which is part of the School Streets programme whereby parking time restrictions are in place, officers and PCSO's have conducted proactive deployments on a morning. The deployments resulted in further tickets being issued on the 1st October 2024, for dangerous and illegal parking, which follows on from previous warnings and tickets issued.
- On the 13th November 2024, officers conducted a Close Pass road safety operation alongside Leeds City Council Influencing Travel Behaviour Team on Selby Road, Garforth. A total of ten motorists were stopped and spoken to regarding the safe passing of cyclists, which is at least 1.5 meters when passing at speeds of 30mph.
- The Leeds District Off-Road Bike Team have been deploying across the ward to address
 raised concerns of nuisance motorcycle demands and dangerous riding. Officers seized a
 dirt bike under S59 of the Police Reform Act, for anti-social and dangerous riding on Great
 North Road and they located a moped stolen from North Yorkshire, in Micklefield
 following reports from the local community.



Ward Area - Temple Newsam and Halton - set August 2023

- To address road safety concerns and road related offences, across the Temple Newsam and Halton ward with a particular focus on Temple Newsam Park and The Springs Retail Park.
- To address reports of urban street gangs and organised criminal groups involved in the supply of drugs and serious violence, particularly across the Wykebecks and Halton Moor sections of the ward.

Updates:

- As part of Operation Anthenmill and Operation Shield, the dedicated youth violence engagement officer alongside Leeds City Council Youth Services continue to conduct proactive diversionary patrols, to engage with identified young individuals and divert them away from criminality.
- In line with Operation Doleedge, we continue to engage with local communities to gather
 intelligence in relation to the supply and production of drugs. We have executed several
 Misuse of Drugs warrants, in response to information received resulting in arrests and
 drugs and money seized.
- Multiple Road Safety and proactive deployments have been conducted with recent
 activities focused on and around the Temple Newsam estate, to address reports of
 vehicular nuisance. Operations were recently held with the Off-Road Bike Team, to
 tactically deploy the stinger, gather intelligence and enforce the city-wide Vehicular
 Nuisance Public Spaces Protection Order (PSPO). You can read more about the PSPO
