1.0 PURPOSE OF REPORT

To advise Members that Entertainment Licensing have received notification of three proposed temporary events ("the Notice") made under the Licensing Act 2003 ("the Act").

2.0 BACKGROUND

- 2.1 Members should note that the most important aspect of the system of temporary events is that no authorisation as such is required for these events from the Licensing Authority.
- 2.2 In general, only the Police may intervene to prevent such an event taking place or to agree a modification of the arrangements for such an event. The system of temporary event notices are characterised by "an exceptionally light touch bureaucracy".
- 2.3 Such a light touch is possible because of the limitations directly imposed on the use of the system by the Act. The limitations apply to:
 - the number of times a person (the "premises user") may give a temporary event notice. In this case it is 50 times per year for a personal licence holder and 5 times per year for those without a personal licence
 - the number of times a temporary event notice may be given in respect of any particular premises is limited to 12 times in a calendar year
 - the length of time a temporary event may last

- the maximum aggregate duration of the period covered by temporary event notices at any individual premise (15 days); and
- the scale of the event in terms of the maximum number of people attending at any one time. This is limited to less than 500.

3.0 THE TEMPORARY EVENT NOTICE

- 3.1 Mr Peter John Grantham, the premises user, has given notice of his intention to hold three separate temporary events at The New Inn, 68 Otley Road, Leeds, LS6 4BA.. The premises can be seen on the map provided, members attention is drawn to **Appendix A.**
- 3.2 Mr Grantham has given notice of the temporary event under s.100 of the Act. A copy of the Notice is attached as **Appendix B** to this report.

Proposed Licensable Activities:

The applicant proposes to carry out those licensable activities at the premises identified at **section 3** of the Notice.

Proposed hours of licensable activities:

The premises user proposes that three separate events will take place at the premises. The first event is proposed to begin at 00:00 on Thursday the 23^{rd} of November, running until 11:00 on Saturday the 25^{th} of November. The second event begins at 00:00 on Wednesday the 1^{st} of December, and is to run until 11:00 on Friday the 3^{rd} . Finally, Mr Grantham proposes to hold a third event, running from 00:00 on the 14^{th} of December, until 11:00 on the 16^{th} of December, 2006.

4.0 Police Objections to the notice

- 4.1 The West Yorkshire Police have received a copies of Mr Grantham's Notices. They consider that allowing the premises to be used in the manner set out in the Notice will undermine the crime prevention objective. The police have therefore given Mr Grantham and the licensing authority an objection notice.
- 4.2 A copy of this objection notice is attached to this report at **Appendix "C**":-

5.0 MATTERS RELEVANT TO THE TEMPORARY EVENT NOTICE

- 5.1 Members of the Licensing Sub Committee must make decisions with a view to promoting the crime prevention licensing objective.
- 5.2 In making their decision Members are obliged to have regard to the national guidance and the Council's Licensing Policy. Members will be aware they must also have regard to the objection notice and evidence they hear.

6.0 OPTIONS AVAILABLE TO MEMBERS

- 6.1 If having heard the evidence Members are satisfied that the event will undermine the crime prevention objective the Licensing Sub Committee must issue the premises user with a counter notice.
- 6.2 Issuing the counter notice has the effect of preventing the event from taking place.
- 6.3 Having heard the evidence, Members are advised that they may allow the event to go ahead, as proposed, if they are satisfied that the event will not undermine the crime prevention objective.

6.3 Members of the Licensing Sub Committee are asked to note that they may not modify, restrict or seek to attach conditions to the proposed licensable activities.

- H Anything of a similar description to that falling within (e), (f) or (g)
- J Provision of facilities for dancing

 ${\rm K}-{\rm Provision}$ of facilities for entertainment of a similar description to that falling within I or J

- L Late night refreshment
- M Sale of alcohol

Proposed hours of licensable activities:

The applicant proposes to provide licensable activities from 11.00hrs to 06.00hrs, with additional hours for "non-standard timings".

Times when the premises is open to the public.

If the application is granted the applicant proposes to open the premises as described in box "O".

5.0 MATTERS RELEVANT TO THE APPLICATION

5.1 Members of the Licensing sub committee must make decisions with a view to promoting the licensing objectives which are:

- the prevention of crime and disorder
- public safety
- the prevention of public nuisance
- the protection of children from harm
- 5.2 In making its decision Members are obliged to have regard to the national Guidance and the Council's Licensing Policy. Members will be aware they must also have regard to the relevant representations made and evidence they hear.
- 5.3 Members will find attached at appendix 'D' a table which acts as an aide memoir of relevant sections of the Guidance and the Council's Licensing Policy which will be of assistance when considering the application and the representations.

6.0 OPTIONS AVAILABLE TO MEMBERS

- 6.1 The licensing sub-committee must take such of the following steps as it considers necessary for the promotion of the licensing objectives:
 - Grant the application while imposing new conditions or altering in any way the existing the operating schedule.
 - Exclude any licensable activities to which the application relates
 - Refuse to specify a person as the premises supervisor
 - Reject the application
- 6.2 Members of the Licensing sub committee are asked to note that they may not modify the conditions or reject the whole or part of the application merely because it considers it desirable to do so. It must actually be <u>necessary</u> in order to promote the licensing objectives.
