CONFIDENTIAL AND EXEMPT ITEMS

The reason for confidentiality or exemption is stated on the agenda and on each of the reports in terms of Access to Information Procedure Rules 9.2 or 10.4(1) to (7). The number or numbers stated in the agenda and reports correspond to the reasons for exemption / confidentiality below:

9.0 Confidential information – requirement to exclude public access

9.1 The public must be excluded from meetings whenever it is likely in view of the nature of the business to be transacted or the nature of the proceedings that confidential information would be disclosed. Likewise, public access to reports, background papers, and minutes will also be excluded.

9.2 Confidential information means

- (a) information given to the Council by a Government Department on terms which forbid its public disclosure or
- (b) information the disclosure of which to the public is prohibited by or under another Act or by Court Order. Generally personal information which identifies an individual, must not be disclosed under the data protection and human rights rules.

10.0 Exempt information – discretion to exclude public access

- 10. 1 The public may be excluded from meetings whenever it is likely in view of the nature of the business to be transacted or the nature of the proceedings that exempt information would be disclosed provided:
 - (a) the meeting resolves so to exclude the public, and that resolution identifies the proceedings or part of the proceedings to which it applies, and
 - (b) that resolution states by reference to the descriptions in Schedule 12A to the Local Government Act 1972 (paragraph 10.4 below) the description of the exempt information giving rise to the exclusion of the public.
 - (c) that resolution states, by reference to reasons given in a relevant report or otherwise, in all the circumstances of the case, the public interest in maintaining the exemption outweighs the public interest in disclosing the information.
- 10.2 In these circumstances, public access to reports, background papers and minutes will also be excluded.
- 10.3 Where the meeting will determine any person's civil rights or obligations, or adversely affect their possessions, Article 6 of the Human Rights Act 1998 establishes a presumption that the meeting will be held in public unless a private hearing is necessary for one of the reasons specified in Article 6.
- 10. 4 Exempt information means information falling within the following categories (subject to any condition):
 - 1 Information relating to any individual
 - 2 Information which is likely to reveal the identity of an individual.
 - Information relating to the financial or business affairs of any particular person (including the authority holding that information).
 - Information relating to any consultations or negotiations, or contemplated consultations or negotiations, in connection with any labour relations matter arising between the authority or a Minister of the Crown and employees of, or officerholders under the authority.
 - Information in respect of which a claim to legal professional privilege could be maintained in legal proceedings.
 - 6 Information which reveals that the authority proposes
 - (a) to give under any enactment a notice under or by virtue of which requirements are imposed on a person; or
 - (b) to make an order or direction under any enactment
 - Information relating to any action taken or to be taken in connection with the prevention, investigation or prosecution of crime

Executive Summary

To advise Members of an application for the certification of nine short films to be shown at South Leeds Youth Hub, Middleton Road, Belle Isle LS10 3JA. The films will be shown as part of Leeds Young Film Festival on Tour, taking place throughout August 2024 during Breeze's Healthy Holiday Summer Camp.

1.0 Purpose of this Report

1.1 This report informs Members with the background, history and issues of an application made under the Licensing Act 2003 ("the Act") for the certification of films that do not currently have a BBFC (British Board of Film Classification) certification. Finally, this report informs Members of the options available to them when considering an application for the certification of films.

2.0 Background Information

- 2.1 The Licensing Act 2003 applies to premises which provide film exhibitions. At present there are a total of 8 cinemas licensed in the Leeds district.
- 2.2 The majority of films shown in cinemas will carry a certificate from the BBFC, the categories of which are as follows:

Category U Universal. Suitable for all.

A U film should be suitable for audiences aged four years and over, although it is impossible to predict what might upset any particular child. U films should be set within a positive framework and should offer reassuring counterbalances to any violence, threat or horror.

Category PG

Parental Guidance. General viewing, but some scenes may be unsuitable for young children.

A PG film should not unsettle a child aged around eight or older. Unaccompanied children of any age may watch, but parents are advised to consider whether the content may upset younger or more sensitive children.

Category 12A/12 Suitable for 12 years and over.

Films classified 12A and video works classified 12 contain material that is not generally suitable for children aged under 12.

No one younger than 12 may see a 12A film in a cinema unless accompanied by an adult. Adults planning to take a child under 12 to view a 12A film should consider whether the film is suitable for that child. To help them decide, the BBFC recommend that thy check the ratings info for that film in advance.

No one younger than 12 may rent or buy a 12 rated video work.

Category 15 Suitable only for 15 years and over.

No one younger than 15 may see a 15 film in a cinema.

No one younger than 15 may rent of buy a 15 rated video work.

Category 18 Suitable only for adults.

No one younger than 18 may see an 18 film in a cinema.

No one younger than 18 may rent of buy an 18 rated video work.

Category R18

To be shown only in specially licensed cinemas, or supplied only in licensed sex shops and to adults only.

The R18 category is a special and legally restricted classification primarily for explicit works of consenting sex or strong fetish material involving adults. Films may only be shown to adults in specially licensed cinemas, and video works may be supplied to adults only in licensed sex shops. R18 video works may not be supplied by mail order.

- 2.3 In addition to licensing premises for film exhibitions, the licensing authority has a duty under Section 20 of the Licensing Act 2003 to categorise a film which is absent of a certificate from a film classification body such as the BBFC. The licensing authority may also reject or modify a film which has received certification from the BBFC.
- 2.4 A copy of the current BBFC Classification Guidelines are available <u>here</u>.

3.0 Main Issues

An application has been received from Leeds Young Film to have a total nine short films certified as they are not currently certified by the BBFC. The films will be shown at South Leeds Youth Hub, Middleton Road, Belle Isle LS10 3JA. The films will be shown as part of Leeds Young Film Festival on Tour, taking place throughout August 2024 during Breeze's Healthy Holiday Summer Camp.

- 3.1 A list detailing each film requesting certification can be found at **Appendix A**, which includes links to view the films online, a synopsis for each film and the applicant's recommended classification. The published document includes redactions as the links supplied by the applicant direct the observer toward unclassified content and an original copy has been provided to Licensing Sub Committee Members in advance of the hearing.
- 3.2 A representative from Leeds Young Film will be available via phone to answer any questions that the Licensing Sub Committee may have.
- 3.3 To assist members with their deliberation officers have viewed each film and have no concerns with the recommended certification. Officer comments can be found at **Appendix B**.

4.0 Implications for Council Policy and Governance

4.1 There are no implications for Council policy and governance in respect of determining this application.

5.0 Legal and Resource Implications

5.1 There is no right of appeal to the Magistrates' Court against the decision of the Licensing Sub Committee.

6.0 Recommendations

- 6.1 Members are requested to consider this request for the certification of the films as attached hereto.
- 6.2 Members may take the decision to view any of the films prior to the issue of a Certificate.

7.0 Options Available to Members

7.1 The Licensing Authority has the authority to categories a film which is absent of a Certificate from the BBFC.

1 Purpose of this report

- 1.1 To advise Members of an application made under section 17 of the Licensing Act 2003 ("the Act") for a new premises licence in respect of the above mentioned premises.
- 1.2 Members are required to consider this application due to the receipt of representations.

2 History of the premises

2.1 This is the first application for a premises licence for these premises.

3 The application

- 3.1 The applicant's name is T.J. Morris Limited.
- 3.2 The proposed designated premises supervisor is Gary Egerton.

Sale by retail of alcohol

Every Day 06:00 - 00:00 for consumption off the premises.

- 3.3 A redacted version of the application has been attached at **Appendix A**.
- The applicant proposes to promote the licensing objectives by taking the steps identified in the document attached at **Appendix B**.

4 Location

4.1 A map which identifies the location of this premises is attached at **Appendix C**.

5 Representations

5.1 Under the Act representations can be received from anyone but they must be relevant and, in the case of a member of the public, must not be frivolous or vexatious.

Representations from Responsible Authorities

5.2 There have been no representations from responsible authorities.

Other representations

- The application has attracted representation from members of the public (described as 'other persons' in the legislation).
- 5.4 The licensing authority is in receipt of one letter of objection which is opposed to this application on the grounds of public safety, crime & disorder and protection of children from harm.

In order to protect personal data, redacted copies of the representations are attached at **Appendix D**. Unredacted copies will be available at the hearing for Members consideration.

6 Licensing hours

- 6.1 Members are directed to paragraphs 6.8 to 6.15 of the Statement of Licensing Policy which states the criteria that will be applied to any decision for new applications or variations which include extending hours.
- 6.2 In brief the Policy states at 6.14 that restrictions may be made to the proposed hours of use where, after receiving relevant representations, the council considers it appropriate for the promotion of the licensing objectives to do so.
- 6.3 The council will take into account the existing pattern of licensed premises in an area when considering what is appropriate to promote the objectives. Applications which are significantly out of character for a locality will need to demonstrate that granting the hours sought will not adversely impact on the licensing objectives.
- A list of premises in the local area and their licensed hours and activities is provided at **Appendix E**.

7 Equality and diversity implications

7.1 At the time of writing this report there were no implications for equality and diversity. Any decision taken by the licensing subcommittee will be in accordance with the four licensing objectives as prescribed by the Licensing Act 2003.

8 Options available to Members

- 8.1 The licensing subcommittee must take such of the following steps as it considers appropriate for the promotion of the licensing objectives:
 - Grant the application as requested.
 - Grant the application whilst imposing additional conditions and/or altering in any way the proposed operating schedule.
 - Exclude any licensable activities to which the application relates.
 - Refuse to specify the said person as the designated premises supervisor.
 - Reject the whole or part of the application.
- 8.2 Members of the licensing subcommittee are asked to note that they may not reject the whole or part of the application merely because they consider it desirable to do so. It must be appropriate in order to promote the licensing objectives.







Summary of Main Issues

This is an application for the grant of a premises licence made by Wenham Home Ltd., for The Hut, 147 Kirkstall Lane, Kirkstall, Leeds, LS5 3LF.

The application explains the premises is a wooden hut and proposes to serve customers, via a service hatch, for the consumption of alcohol in a designated external seating area. The application also explains that access to the internal part of the premises, "The Hut", will be prohibited to members of the public.

Responsible authorities and Ward Members have been notified of this application and it has attracted representations from West Yorkshire Police and other persons.

An agreement has been reached with West Yorkshire Police resulting in a reduction to the terminal hour for alcohol sales from 23:00 to 22:30 hours (30 minutes drinking-up time) and the adoption of additional conditions to promote the crime prevention objective.

With regards to other persons, representations have been received from the local ward councillors and local residents which a remain a matter outstanding for the Licensing Sub Committee's consideration.

1 Purpose of this Report

- 1.1 To advise Members of an application made under section 17 of the Licensing Act 2003 ("the Act") for a new premises licence in respect of the above mentioned premises.
- 1.2 Members are required to consider this application due to the receipt of representations.

2 History of the Premises

2.1 This is the first application for a premises licence for these premises.

3 The Application

- 3.1 The applicant's name is Wenham Home Ltd.
- 3.2 The proposed designated premises supervisor is Natalie Stocking.
- 3.3 On submission, the licensable activity/hours proposed were:

The sale by retail of alcohol (for consumption both on and off the premises)

Every Day 11:00 - 23:00

- 3.4 The applicant proposes to promote the licensing objectives by taking the steps identified under Section M of the application form.
- 3.5 A redacted version of the application is attached at **Appendix A**.

4 Location

4.1 A map which identifies the location of the premises is attached at **Appendix B**.

5 Representations

5.1 Under the Act representations can be received from anyone but they must be relevant and, in the case of a member of the public, must not be frivolous or vexatious.

Representations from Responsible Authorities

A representation has been received from West Yorkshire Police in their capacity as a Responsible Authority. Any representation may be negotiated prior to the hearing and in this instance the operating schedule has been amended to reduce the terminal hour of alcohol sales, from 23:00 to 22:30 hours, and to adopt a number of agreed measures. A copy of the representation and the agreement may be found at **Appendix C**.

Other Representations

5.3 The application has attracted representation from Local Ward Councillors and six local residents, inclusive of one on behalf of a residents' association (described as

- 'other persons' in the legislation), all of which are opposed to the application mainly on the grounds of public safety and public nuisance.
- In order to protect personal data, redacted copies of the representations are attached at **Appendix D** and original versions will be provided to the Licensing Sub Committee Members in advance of the hearing.

6 Licensing Hours

- 6.1 Members are directed to paragraphs 6.8 to 6.15 of the Statement of Licensing Policy which states the criteria that will be applied to any decision for new applications or variations which include extending hours.
- 6.2 In brief the Policy states at 6.14 that restrictions may be made to the proposed hours of use where, after receiving relevant representations, the council considers it appropriate for the promotion of the licensing objectives to do so.
- 6.3 The council will take into account the existing pattern of licensed premises in an area when considering what is appropriate to promote the objectives. Applications which are significantly out of character for a locality will need to demonstrate that granting the hours sought will not adversely impact on the licensing objectives.
- A list of premises in the local area and their licensed hours and activities is provided at **Appendix E**.

7 Equality and Diversity Implications

7.1 At the time of writing this report there were no implications for equality and diversity. Any decision taken by the licensing subcommittee will be in accordance with the four licensing objectives as prescribed by the Licensing Act 2003.

8 Options Available to Members

- 8.1 The Licensing Sub Committee must take such of the following steps as it considers appropriate for the promotion of the licensing objectives:
 - Grant the application as requested.
 - Grant the application whilst imposing additional conditions and/or altering in any way the proposed operating schedule.
 - Refuse to specify the said person as the designated premises supervisor.
 - Reject the whole or part of the application.







A note of the action taken, and where relevant a note of the actions to prevent any reoccurrence should also be included. I totally support the points that Cllr Venner has made. I would add that in reality, this appears to be an application to operate a pop-up bar, probably with an emphasis on match days at the stadium, whilst ingeniously getting round the requirement to provide free toilet facilities accessible to all customers. The argument that it's an off-licence that just happens to have a seating area outside is not convincing – even if people cannot drink inside the building, the applicant is still seeking to provide a place where you can drink on the premises.

I would like to formally object to this license application. I would also strongly request that the Licensing Officer who will be making a decision about this application goes to visit the premises as this will enable them to see how inappropriate this application is – it is basically a shed. I would, also, dispute that the premises is currently operating as anything. Both myself and Cllr Rontree live near the site and neither of us have ever seen it open or operating – including during the potentially peak times of rugby or cricket matches at the nearby Headingley Stadium.

The location is entirely unsuitable to sell alcohol from a hatch into an outdoor space. It is at the junction of three residential roads (Kirkstall Lane, St Anne's Lane and Queenswood Drive). There are other shops selling alcohol in the immediate vicinity (convenience stores on Kirkstall Lane and Queenswood Drive and Morrisons nearby).

The outdoor seating area has been erected in the last couple of weeks and is plonked on the junction. The fence is low and does not in any way protect neighbouring properties from the noise of people sitting in the area drinking. I also cannot see how it would stop people spilling on to the public highway as the applicant suggests. If you were having a drink whilst sitting there, you would be drinking whilst sitting on the junction of three residential streets. The seating is clearly designed for customers to purchase food and/ or drink and sit there whilst they consume their purchases. It is, therefore, entirely inappropriate not to provide a toilet and is likely to lead to people urinating in the street.

This is a bizarre and inappropriate application in an area with several pubs. I cannot see why anyone would want to sit on a busy junction next to a shed without access to a toilet while having a drink and I can only foresee huge disturbance to local residents.
