CONFIDENTIAL AND EXEMPT ITEMS

The reason for confidentiality or exemption is stated on the agenda and on each of the reports in terms of Access to Information Procedure Rules 9.2 or 10.4(1) to (7). The number or numbers stated in the agenda and reports correspond to the reasons for exemption / confidentiality below:

9.0 Confidential information – requirement to exclude public access

9.1 The public must be excluded from meetings whenever it is likely in view of the nature of the business to be transacted or the nature of the proceedings that confidential information would be disclosed. Likewise, public access to reports, background papers, and minutes will also be excluded.

9.2 Confidential information means

- (a) information given to the Council by a Government Department on terms which forbid its public disclosure or
- (b) information the disclosure of which to the public is prohibited by or under another Act or by Court Order. Generally personal information which identifies an individual, must not be disclosed under the data protection and human rights rules.

10.0 Exempt information – discretion to exclude public access

- 10. 1 The public may be excluded from meetings whenever it is likely in view of the nature of the business to be transacted or the nature of the proceedings that exempt information would be disclosed provided:
 - (a) the meeting resolves so to exclude the public, and that resolution identifies the proceedings or part of the proceedings to which it applies, and
 - (b) that resolution states by reference to the descriptions in Schedule 12A to the Local Government Act 1972 (paragraph 10.4 below) the description of the exempt information giving rise to the exclusion of the public.
 - (c) that resolution states, by reference to reasons given in a relevant report or otherwise, in all the circumstances of the case, the public interest in maintaining the exemption outweighs the public interest in disclosing the information.
- 10.2 In these circumstances, public access to reports, background papers and minutes will also be excluded.
- 10.3 Where the meeting will determine any person's civil rights or obligations, or adversely affect their possessions, Article 6 of the Human Rights Act 1998 establishes a presumption that the meeting will be held in public unless a private hearing is necessary for one of the reasons specified in Article 6.
- 10. 4 Exempt information means information falling within the following categories (subject to any condition):
 - 1 Information relating to any individual
 - 2 Information which is likely to reveal the identity of an individual.
 - Information relating to the financial or business affairs of any particular person (including the authority holding that information).
 - Information relating to any consultations or negotiations, or contemplated consultations or negotiations, in connection with any labour relations matter arising between the authority or a Minister of the Crown and employees of, or officerholders under the authority.
 - Information in respect of which a claim to legal professional privilege could be maintained in legal proceedings.
 - 6 Information which reveals that the authority proposes
 - (a) to give under any enactment a notice under or by virtue of which requirements are imposed on a person; or
 - (b) to make an order or direction under any enactment
 - Information relating to any action taken or to be taken in connection with the prevention, investigation or prosecution of crime

Summary of Main Issues

This is an application to vary a premises licence made by Mr. Jonathan Charles Steeples, for the Fenton Hotel, 161 - 163 Woodhouse Lane, Leeds, LS2 3ED.

This application is made to extend the hours for Sale by Retail of Alcohol and Regulated Entertainment, as noted at 3.3 of the report.

Responsible authorities and Ward Members have been notified of this application.

The application has attracted representations from West Yorkshire Police and the Environmental Protection Team, objecting to the application outright. These representations remain a matter outstanding for the Sub Committee's consideration.

1 Purpose of this Report

- 1.1 To advise Members of an application made under section 34 of the Licensing Act 2003 ("the Act") to vary a premises licence in respect of the above mentioned premises.
- 1.2 Members are required to consider this application due to the receipt of representations.

2 History of Premises

- 2.1 These Premises have had the benefit of a Premises Licence since the introduction of the Licensing Act in 2005. The licence at that time was held by Mr. Mark Lawn and the Designated Premises Supervisor (DPS) was Mr. Jonathan Steeples.
- 2.2 An application to specify a new DPS was received and granted in September 2011.
- 2.3 An application to specify Mr. Jonathan Steeples as the DPS for a second time was received and granted in May 2014.
- 2.4 In December 2014 an application to vary the licence was submitted proposing to extend the existing hours and licensable activities. With no representations received, the licence was duly granted as applied for.
- 2.5 In July 2018 an application was made to transfer the premises licence to Mr. Jonathan Steeples. The application was granted as requested.
- 2.6 A copy of the existing licence is attached at Appendix A.

3 The Application

- 3.1 The applicant is Mr. Jonathan Charles Steeples.
- 3.2 Briefly the application is to vary:

Sale by Retail of Alcohol, Live Music, Recorded Music and Entertainment of a similar Description

From: Monday to Wednesday 10:00 - 01:00 and Thursday to Sunday 10:00 - 02:00

To: Monday to Sunday 10:00 - 02:00.

Late Night Refreshment and the opening hours are to remain as existing.

- 3.3 A copy of the redacted application form is attached at Appendix B.
- 3.4 No additional measures have been offered to promote the licensing objectives, however the Applicant has provided information under 'Section M' of the application form and a 'Safer Spaces Policy' attached at Appendix C.

4 Location

4.1 A map which identifies the location of the premises is attached at Appendix D.

5 Representations

5.1 Under the Act representations can be received from anyone but must be relevant and, in the case of members of the public, must not be frivolous or vexatious.

Representations from Responsible Authorities

- A representation has been received from West Yorkshire Police in their capacity as a responsible authority. The representations objects to the application outright and a copy of the representation may be found at Appendix E for the Sub Committee's consideration.
- 5.3 The application has attracted an outright objection from the Environmental Protection Team. The matter remains outstanding and a copy is available at Appendix F.

Other representations

5.4 There are no other representations.

6 Licensing Hours

- 6.1 Members are directed to paragraphs 6.8 to 6.15 for the Statement of Licensing Policy which states the criteria that will be applied to any decision for new applications or variations which include extending hours.
- 6.2 In brief the Policy states at 6.14 that restrictions may be made to the proposed hours of use where, after receiving relevant representations, the council considers it appropriate for the promotion of the licensing objectives to do so. The council will take into account the existing pattern of licensed premises in an area when considering what is appropriate to promote the objectives. Applications which are significantly out of character for a locality will need to demonstrate that granting the hours sought will not impact on the licensing objectives.
- 6.3 A list of premises in the local area and their licensed hours and activities is provided at Appendix G.

7 Equality and Diversity Implications

7.1 At the time of writing this report there were no implications for equality and diversity. Any decision taken by the Licensing Sub Committee will be in accordance with the four licensing objectives as prescribed by the Licensing Act 2003.

8 Options Available to Members

8.1 The Licensing Sub Committee must take such of the following steps as it considers appropriate for the promotion of the licensing objectives:

- Grant the variation as requested.
- Grant the variation whilst imposing additional conditions and/or altering in any way the proposed operating schedule.
- Exclude any licensable activities to which the application relates.
- Reject the whole or part of the application.
- 8.2 Members of the Licensing Sub Committee are asked to note that they may not modify the conditions or reject the whole or part of the application merely because it considers it desirable to do so. It must actually be appropriate in order to promote the licensing objectives and relevant to the application.



Annex 1 – Mandatory Conditions

- 1. Only individuals licensed by the Security Industry Authority may be used at the premises to quard against:
 - a. unauthorised access or occupation (e.g. through door supervision), or
 - b. outbreaks of disorder, or
 - c. damage
- 2. No supply of alcohol may be made under this licence
 - a. At a time when there is no designated premises supervisor in respect of the premises licence, or
 - b. At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 3. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 4. The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises -

- a. games or other activities which require or encourage, or are designed to require or encourage individuals to
 - i. drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - ii. drink as much alcohol as possible (whether within a time limit or otherwise);
- b. provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- c. provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- d. selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorize anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- e. dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- 5. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

6. The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date or birth and either -

- a. a holographic mark, or
- b. an ultraviolet feature.
- 7. The responsible person must ensure that
 - a. where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures:
 - i. beer or cider: ½ pint;
 - ii. gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - iii. still wine in a glass: 125 ml;
 - b. these measures are displayed in a menu; price list or other printed material which is available to customers on the premises; and
 - c. where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.
- 8. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

For the purposes of the condition set out in paragraph 1 of this condition -

- a. "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- b. "permitted price" is the price found by applying the formula $P = D + (D \times V)$ where
 - i. P is the permitted price,
 - ii. D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
 - iii. V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- c. "relevant person" means, in relation to premises in respect of which there is in force a premises licence
 - i. the holder of the premises licence,
 - ii. the designated premises supervisor (if any) in respect of such a licence, or
 - iii. the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- d. "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

e. "value added tax" mean value added tax charged in accordance with the Value Added Tax Act 1994.

Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

- (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Annex 2 - Conditions consistent with the operating schedule

The prevention of crime and disorder

- 9. A zero tolerance policy towards the use of illegal drugs will be in operation at all times when the premises are open.
- 10. If a CCTV system is installed on the premise, it must stay operational at all times when the premises are open.

Public Safety

- 11. Regular safety checks of the premises including decorative and functional fixtures, floor surfaces and equipment (including electrical appliances) to which the public may come into contact, must be undertaken. Records of these safety checks must be kept and made available for inspection by an authorised officer.
- 12. During opening hours the cellar door must be kept locked or adequately supervised to prevent unauthorised access by the public.
- 13. Electrical installations will be inspected on a periodic basis (at least every 3 years or at a frequency specified in writing) by a suitably qualified and competent person. Inspection records/certificates will be kept. These will be made available at the request of an authorised officer.
- 14. Regular safety checks of guarding to stairs, balconies, landings and ramps will be undertaken, a supervision policy will be maintained to prevent people from inappropriate behaviour including climbing which may lead to a fall from height.
- 15. Safety glass that is impact resistant or shielded to protect it from impact will be used in all areas where the public come into contact with it.
- 16. All floor surfaces will be suitably slip resistant, kept in good condition and free from obstructions to prevent slips, trips and falls.
- 17. Where strobes, lasers, smoke machines and any other special effects equipment may be used, a written health and safety policy covering all aspects of their use will be provided, and staff will be appropriately trained.

The prevention of public nuisance

- 18. Ensure that no nuisance is caused by noise or vibration emanating from the premises.
- 19. Noise shall be inaudible at the nearest noise sensitive premises after 23:00 hours and when entertainment takes place on a regular basis.
- 20. Clear and legible notices shall be displayed at exits and other circulatory areas requesting patrons to leave the premises having regard to the needs of local residents, in particular the need to refrain from shouting, slamming car doors, sounding horns, loud use of vehicle stereos and anti social behaviour. The activity of persons leaving the premises shall be monitored and they shall be reminded to leave quietly where necessary.
- A facility shall be provided for customers to order taxis and telephone numbers for taxi firms shall be displayed in a prominent location. Where possible there shall be a liaison with a local taxi firm to ensure a ready supply of transport and thereby reduce disturbance. To prevent disturbance, a waiting area within the premises shall be provided.
- 22. A cooling down period with reduced music volume shall be operated before the premises close.

Protection of children from harm

- 23. All children that are permitted onto the premises must be accompanied by an adult (being a person who has attained the age of 18) at all times.
- 24. A suitably designated non-smoking area must be provided on the premises.

The Fenton Safer Spaces Policy

If you feel unsafe or encounter any of the behaviours below, please inform a member of staff as soon as possible. Alternatively, you can email us at a platforms or phone us at a second as well as message us via our social media platforms.

The safety, wellbeing, and comfort of everyone in The Fenton, including our staff, is our highest priority. It is our aim that everyone feels welcome in the venue, however we do acknowledge this will not always be the case. This statement outlines unacceptable behaviours and how we will respond in cases where guests do not act in line with our expectations.

It is important these policies represent everyone in the venue and we welcome any constructive feedback on this document via the details above. Our Safer Spaces Policy remains under regular review.

Examples of behaviours that will not be tolerated include; aggressive, violent, and non-consensual sexual behaviours. This includes threat, harassment and any other actions taken purposefully to make another feel unsafe. Acting in such a way is grounds for immediate removal and a ban from the pub.

In addition, the disregard of a persons expressed or clearly implied wishes, intrusion upon another's personal space, deliberately insulting or demeaning language and bullying are all actions that are unacceptable. This list is not exhaustive.

Prejudice and discrimination of any form is not abided. Examples of grounds for which this could happen include, but are not limited to; race, sex, age, disability, sexuality, gender/gender history, nationality, ethnic origin, mental health, marital status, pregnancy/parental status, immigration status, criminal conviction, care responsibilities, socioeconomic class, homed status and religious beliefs.

Often, discrimination is unintentional, as such The Fenton team tries to facilitate open and productive discussion when it is appropriate – "discussion" is distinct from "debate". At its core; we require everyone to treat each other with mutual respect.

We encourage the community around The Fenton to continue to represent these values, but it is key the staff always be informed of instances where they are not upheld, however minor. This way we can support our community as effectively as possible, both at the time of any incident and going forward.

Our safeguarding procedures have informed consent at the heart of them and we always aim to empower victims to decide what response is appropriate in each unique case, so long as the safety of everyone in the venue is upheld.

At the time of improper behaviour there are a range of actions we can take:

- Supporting a discussion led by an offended party
- Leading a discussion supported by an offended party
- > A private conversation with the party acting inappropriately explaining our expectations

- ➤ Expulsion of those behaving out of line with our values
- > In extreme cases the involvement of external organisations, such as the police.

In cases where an offending party is engaged in conversation regarding their behaviour, they must be receptive and respectful. Any continuation of their prior disregard for the rules shall result in their expulsion.

We will always respect your confidentiality and this will remain the case throughout the entire safeguarding process. Staff members may inform or share details with (other) members of management when necessary, only with the consent of the victim.

However, in certain cases where we feel there is significant risk to a party's safety, particularly those involving vulnerable persons, we are unable to maintain confidentiality and may contact the relevant external agencies.

What actions to take after an incident is typically decided by our management team, any non management staff whom may have handled the situation at the time, and any victims who opt to involve themselves. This does not need to be the case if a higher level of confidentiality has been requested and we shall not take actions without first ensuring that it shall not put any victims at risk of harm.


If the decision is made to temporarily ban a party from the pub, when this period comes to an end our management team shall discuss with the party to ensure they understand why they had been barred and that they respect this policy and know what is expected of them going forward. Any further infractions are highly likely to result in a permanent ban.

The Fenton believes in forgiveness. Bans can be challenged and, on rare occasions, permanent bans can be revoked if the persons barred are shown to have significantly reformed themselves. Before this would happen, the management team would discuss whether this is appropriate. After which, we would meet with the banned persons, take an expressed period of time (typically 7 days) to come to a decision privately and then inform the relevant parties of our decision. In cases where there has been a victim this will not happen without their consent. We shall not involve any victim without management first making the decision as to whether it is appropriate and could affect their wellbeing. If it is deemed irresponsible to involve a victim, the banned party shall remain banned.



APPLICATION TO VARY PREMISES LICENCE – LICENSING ACT 2003: POLICE – LETTER OF REPRESENTATION – outright objection

West Yorkshire Police are in receipt of an application to vary the premises licence for the above venue. The application seeks to extend opening hours to 2 am everyday with the sale of alcohol, live music and recorded music until 2 am also.

West Yorkshire Police make an outright objection to the variation on the grounds of public nuisance and public safety.

West Yorkshire Police officers and staff work on the same terrace as The Fenton. The terrace of properties in which The Fenton is situated in the middle of, consists of two empty premises, UNIPOL student housing office and Woodhouse Lane Police station. Therefore, within this parade it is only the Police station that has people working within outside the hours of 9am-6pm. However, directly opposite is Broadcasting Tower which is a Leeds Beckett University building containing 241 student residence. It is fair to presume that those who live within the city centre come to expect some night life noise on a

weekend, however the noise pollution coming from the pub itself and the customers while queuing to enter and when leaving up until 2am every night will surely have an impact on these residents.

The amended guidance issued under section 182 of the Licencing Act 2003 states "It is important to remember that the prevention of public nuisance could therefore include low-level nuisance, perhaps affecting a few people living locally, as well as major disturbance affecting the whole community. It may also include in appropriate circumstances the reduction of the living and working amenity and environment of other persons living and working in the area of the licensed premises".

In terms of those working in the area of the licensed premises- as stated above, Woodhouse Lane Police Station is the only open working environment during all the hours that The Fenton are applying to be open for. Officers have previously contacted Leeds City Council Environmental Protection Team due to the volume of the music playing from the premises and in their back yard that would shake the police station windows and make it an impossible place to work. An issue was also raised regarding the extension of the 'beer garden' directly up to the rear entry to the police station meaning officers are constantly coming across intoxicated customers urinating and leaving litter in the rear of the police station and blocking the rear exit. After raising the issues with the Environmental Protection Team, The Fenton did make efforts to reduce the noise which was appreciated. However, it is still an incredibly loud venue to attempt to work next to especially when officers are completing important court paperwork for cases, without high levels of concentration could result in mistakes being made. If The Fenton is open until 2am every night this will no doubt have a significant impact on the working environment of the police station. The issues have been going on for a number of years now.

The area is covered by the PSPO (Public Space Protection Order) which was introduced due to the levels of disorder and alcohol related ASB which areas of Inner North West Leeds encountered, and this licensing extension does not help the aims of the PSPO to be fulfilled, in fact it would be a hindrance. The 'beer garden' still remains up to the rear of the police premises, this rarely appears to have any security staff managing and customers are often found intoxicated leaving the premises with open containers of alcohol. It is highly unlikely that the Fenton will put Security staff on mid-week to manage this.

A great deal of police effort and time has been diverted into addressing these concerns; additional patrols have had to be moved from other areas of policing to enforce the PSPO and assist with night-time economy. Police officers regularly are committed and tied up for several hours with drunken individuals who are being abusive or passed out in the street.

The regular complaints encountered in the area include: -

Litter and untidiness around the area from drink related objects including beer bottles and cans. Broken glass littering pavements and around bus stops.

Public safety concerns around people urinating and vomiting in the street. Often pools of urine and vomit are found on the police station doorstep and around the bus stop.

Abuse and verbal threats to members of the public walking by and to police staff by drunken individuals. The area has complaints regarding misogynistic comments from drunken males and this has now been specifically written into the PSPO to try and address. Allowing this premise to serve alcohol into the night on all days of the week only stands to make this worse, especially given this area is near the universities and student accommodation so there is high footfall of people at all times of the day and night. There is also a bus stop located very close to The Fenton, this can be intimidating for females, especially alone when waiting for public transport. Female police staff have also experienced misogynistic comments

when they have been walking towards the police station past the large crowds queuing up to enter the pub or leaving, if these males are comfortable enough to speak in such a way to uniformed officers, then it puts into question how they would be with lone civilian females.

Therefore, West Yorkshire Police object to the extension of the hours proposed as it will put the licensing objectives of the prevention of public nuisance and public safety into further jeopardy.

We refer to your licensing application for the above premises. We believe that your application does not give enough information about how you intend to meet an important objective of the licence, which is to prevent public nuisance. We therefore confirm that we are submitting a formal objection to your application.

We base our objection on the following matters:

- The potential for noise disturbance associated with licensable activities passing through the fabric of the building to cause noise and vibration in adjoining residential/business premises.
- The potential for noise disturbance associated with licensable activities to break out of the premises or pass through the fabric of the building to cause noise disturbance to nearby residential/business premises.
- The potential for noise disturbance from the use of outside areas whilst smoking/drinking in the area/s provided/whilst arriving/leaving, including that from vehicles.
- The potential for the alleged sources of nuisance described in items 1 to 3 above to continue into hours where such disturbance may adversely affect sleep and other loss of the use and enjoyment of a property.
- The potential for disturbance from

Conclusions reached:

Prior to the variation to extend hours granted January 2015 there were no nuisance complaints associated with the venue. The 2015 increase in hours has coincided with regular issues with music and patron noise. Increasing hours further into night could increase/exacerbate existing issues.

We recommend that the Sub-Committee refuse the application.

We understand that the Sub-Committee may take a different view and grant the application. We recommend that if that is the case we should be given the opportunity to suggest measures as conditions on the licence. We do not say that conditions would effectively prevent public nuisance but that they may go some way to reducing the potential impact.

Executive Summary

To advise Members of an application for the certification of eleven short films to be shown at The Carriageworks LS2, Hyde Park Picture House LS6 and Lotherton Hall LS25. The films will be shown as part of Leeds Young Film Festival on Tour – Christmas.

1.0 Purpose of this Report

1.1 This report informs Members with the background, history and issues of an application made under the Licensing Act 2003 ("the Act") for the certification of films that do not currently have a BBFC (British Board of Film Classification) certification. Finally, this report informs Members of the options available to them when considering an application for the certification of films.

2.0 Background Information

- 2.1 The Licensing Act 2003 applies to premises which provide film exhibitions. At present there are a total of 8 cinemas licensed in the Leeds district.
- 2.2 The majority of films shown in cinemas will carry a certificate from the BBFC, the categories of which are as follows:

Category U Universal. Suitable for all.

A U film should be suitable for audiences aged four years and over, although it is impossible to predict what might upset any particular child. U films should be set within a positive framework and should offer reassuring counterbalances to any violence, threat or horror.

Category PG

Parental Guidance. General viewing, but some scenes may be unsuitable for young children.

A PG film should not unsettle a child aged around eight or older. Unaccompanied children of any age may watch, but parents are advised to consider whether the content may upset younger or more sensitive children.

Category 12A/12 Suitable for 12 years and over.

Films classified 12A and video works classified 12 contain material that is not generally suitable for children aged under 12.

No one younger than 12 may see a 12A film in a cinema unless accompanied by an adult. Adults planning to take a child under 12 to view a 12A film should consider whether the film is suitable for that child. To help them decide, the BBFC recommend that thy check the ratings info for that film in advance.

No one younger than 12 may rent or buy a 12 rated video work.

Category 15 Suitable only for 15 years and over.

No one younger than 15 may see a 15 film in a cinema.

No one younger than 15 may rent of buy a 15 rated video work.

Category 18 Suitable only for adults.

No one younger than 18 may see an 18 film in a cinema.

No one younger than 18 may rent of buy an 18 rated video work.

Category R18

To be shown only in specially licensed cinemas, or supplied only in licensed sex shops and to adults only.

The R18 category is a special and legally restricted classification primarily for explicit works of consenting sex or strong fetish material involving adults. Films may only be shown to adults in specially licensed cinemas, and video works may be supplied to adults only in licensed sex shops. R18 video works may not be supplied by mail order.

- 2.3 In addition to licensing premises for film exhibitions, the licensing authority has a duty under Section 20 of the Licensing Act 2003 to categorise a film which is absent of a certificate from a film classification body such as the BBFC. The licensing authority may also reject or modify a film which has received certification from the BBFC.
- 2.4 A copy of the current BBFC Classification Guidelines are available <u>here</u>.

3.0 Main Issues

An application has been received from Leeds Young Film to have a total eleven short films certified as they are not currently certified by the BBFC. The films will be shown at The Carriageworks LS2, Hyde Park Picture House LS6 and Lotherton Hall LS25. The films will be shown as part of Leeds Young Film Festival on Tour – Christmas.

- 3.1 A list detailing each film requesting certification can be found at **Appendix A**, which includes links to view the films online, a synopsis for each film and the applicant's recommended classification. The published document includes redactions as the links supplied by the applicant direct the observer toward unclassified content and an original copy has been provided to Licensing Sub Committee Members in advance of the hearing.
- 3.2 A representative from Leeds Young Film will be available via phone to answer any questions that the Licensing Sub Committee may have.
- 3.3 To assist members with their deliberation officers have viewed each film and have no concerns with the recommended certification. Officer comments can be found at **Appendix B**.

4.0 Implications for Council Policy and Governance

4.1 There are no implications for Council policy and governance in respect of determining this application.

5.0 Legal and Resource Implications

5.1 There is no right of appeal to the Magistrates' Court against the decision of the Licensing Sub Committee.

6.0 Recommendations

- 6.1 Members are requested to consider this request for the certification of the films as attached hereto.
- 6.2 Members may take the decision to view any of the films prior to the issue of a Certificate.

7.0 Options Available to Members

7.1 The Licensing Authority has the authority to categories a film which is absent of a Certificate from the BBFC.
